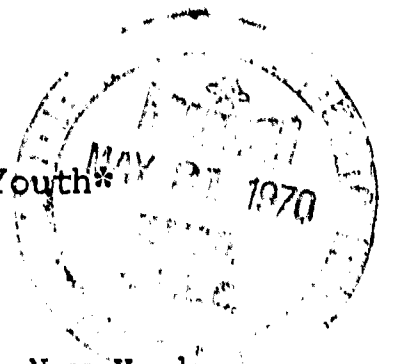

ABSTRACT
