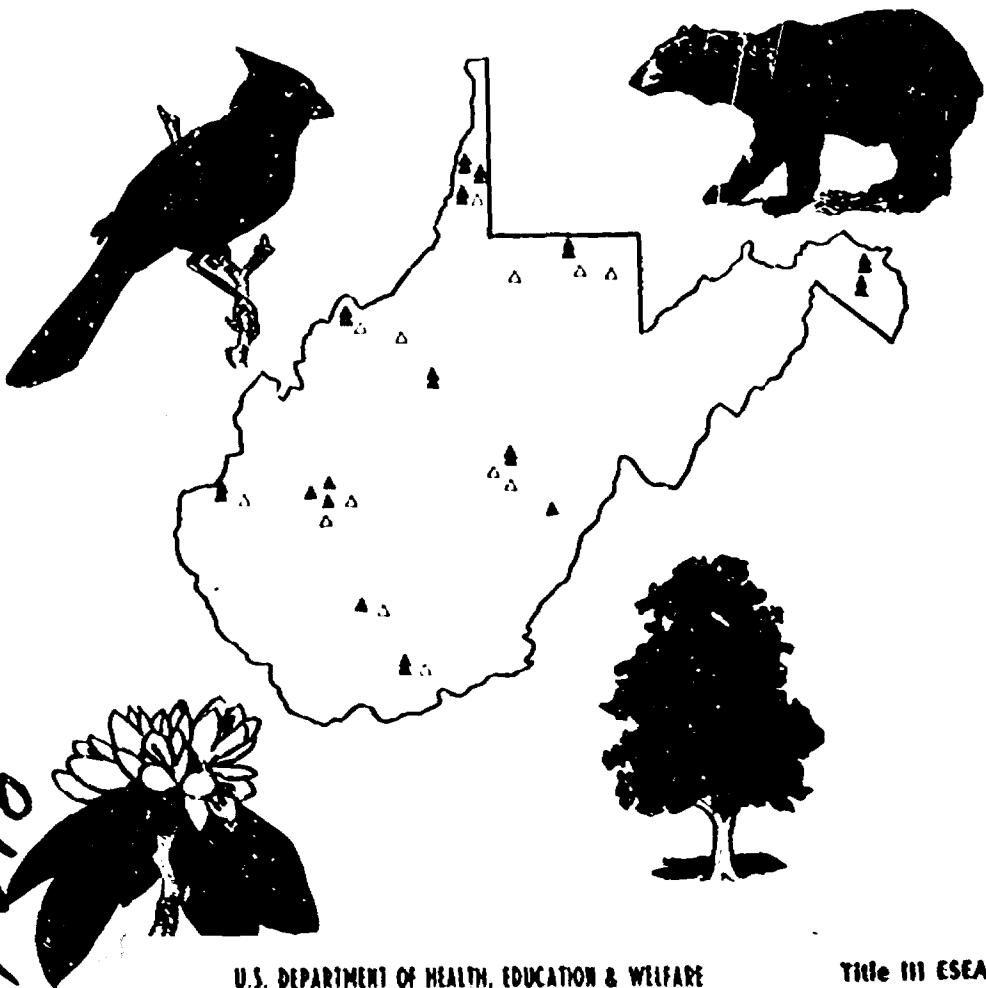
ABSTRACT

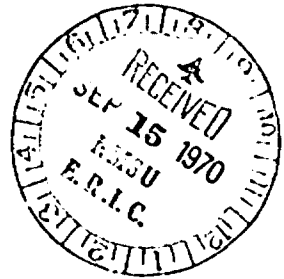

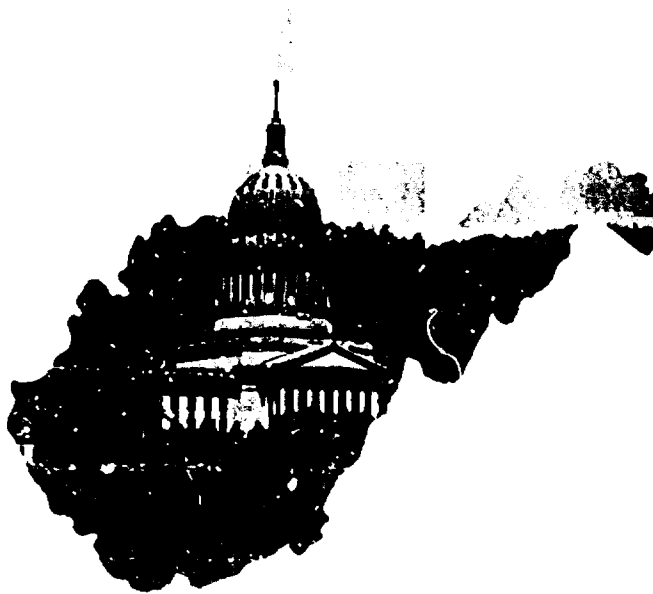

PREFACE

INTRODUCTION

—ESEA Title III funds for Supplemental Centers and Services, in West Virginia, has served as a change agent for innovative and exemplary programs far too numerous to be listed in a publication of this size. For the most part, Title III's effort was and is concentrated in programs serving multi-county areas. This effort is justified in that many of our LEAs (county units) are small in area and sparsely populated. Seven educational regions were established in the mid-1950s by the voluntary action of the county superintendents. Within each of these regions, Title III has placed a PACE Center. These Centers are not to be confused with Education Centers as defined by the U. S. Office of Education. The following pages briefly describe West Virginia's ESEA-III projects through June 30, 1970.

PROJECT DESCRIPTION:

This project uses the systems approach in the development of innovative or exemplary programs or services to the educational needs which have been identified in the region. The project provides a comprehensive regional educational service center. The project serves the children, teachers, administrators and boards of education of Region I. It acts as the focal point for cooperative program planning, curriculum resource personnel, media coordination, cooperative resources acquisition and distribution, and inter-agency coordination.

Assistance is given to district inservice programming, planning-developing-implementing new curricular activities in the local schools, providing resource production capabilities and assessment and evaluation services.

The project provides leadership in the development of special education classes for handicapped children. The problems of curriculum design and resource development in vocational education is a program component. A unique process for providing academic and vocational guidance is being demonstrated. The continued growth of the use of educational television is being promoted. The project operates a 16mm regional film library and additionally demonstrates appropriate utilization of this resource.

PROJECT DESCRIPTION:

The curriculum improvement center presently serving Region II in eastern West Virginia is based on the needs revealed by research connected with the previous project number 242. The new project is two months old and is moving rapidly into the objectives.

The area served by the project is in need of educators who are able to introduce modern practice into the schools. Seven specialists and the director have programs starting which can change the approach to instruction in industrial arts, language arts, mathematics, art and special education. Specialists in secondary and elementary school administration are introducing new patterns of organization and scheduling.

The overall purpose of the project is to act as a catalyst in initiating curriculum improvement, changes in organizational structure, changes in staff utilization and introduce innovative educational practices in the schools of the Eastern Panhandle.

PROJECT DESCRIPTION:

The project area is comprised of eight county school systems in Region III. The central aim of the project is to establish eight pilot and/or exemplary programs in the region, where emphasis is given to developing, implementing, and evaluating a personalized educational program for each child. The project has two basic objectives: (1) To help teachers discover and develop potential in each pupil, and (2) To facilitate discovery and development of potential in teachers themselves.

Attention is being given to the skills and attitudes of the teachers in order that they may go beyond the personalization usually found in the regular classroom. Each school is being treated in a different manner due to the differences in staff, student body and community makeup. In each case, the curriculum, school organization patterns, materials and the development of a decision-making team are areas of concern. Each pilot program has, as target groups, the students, the teachers and other professionals, the parents and other members of the community who have a relationship with the school.

PROJECT DESCRIPTION:

The Educational Resource Center is an outgrowth of a previous project which served this region. The region served is made up of seven central West Virginia county school systems having a combined enrollment of some 28,000 public school pupils.

The overall objective of this project is to raise the educational and cultural level of the students of the area by introducing curriculum change, providing innovative ideas for use by the classroom teacher, giving assistance to administrators and involving the general public in a school improvement program. A central library of super 8 sound film and other materials is providing educational media. A mobile van is used to transport materials to the schools.

The director and four specialists are developing inservice programs for teachers and teacher aides. At the same time consultants are brought in from outside the region to provide expertise in curriculum areas where needs have been recognized.

PROJECT DESCRIPTION:

This innovative guidance project was located in Region V of West Virginia, in an area serving 44,000 school children. This project was an elementary school counseling program with specific emphasis on a unique program of milieu group counseling. In the elementary counseling center dysfunctioning students, those with social, academic, or adjustment problems, were met weekly in groups of six to eight. Their teachers met in separate groups to receive help in understanding the students and in how to work with them in the school. Groups of parents met weekly with the counselor who worked with their children.

In addition to establishing a program for children and their parents, the project laid major emphasis on inservice training for teachers and principals in preventive mental health techniques.

PROJECT DESCRIPTION:

A Fine Arts Center for Talented Students in a five-county area is designed to provide specific opportunities for study and guidance in music, art and speech for talented secondary students. This approach is based on the concept of specialized training for talented students who may find a career in one of the arts.

Student participants from private and public schools are recommended by their teachers on the basis of their talents and their needs. The project operates through the summer on a five-day week schedule. Instruction is both individual and group; a counselor is available to the enrollees.

Each school system sends a staff member to the project who may observe or serve as consultant or assistant, whichever is appropriate.

PROJECT DESCRIPTION:

The purpose of this project is to develop a fixed point of referral for getting assistance for school-age exceptional children who reside in the five counties making up the Northern Panhandle of West Virginia. There are 44,370 school-age children in the project area.

A center for diagnostic, evaluation, and treatment services for exceptional children has been developed. The staff of five professional pupil personnel specialists work directly with the exceptional children and provide consultant services to schools and parents in the development of programs for them.

A social worker and a special education specialist work in the schools screening students for special classes and furnishing consultive services in the development of special education classes. Inservice training is designed to bring about understanding of the characteristics of exceptional children, teaching techniques, developmental curriculum procedures, and handling exceptional children in regular classrooms.

PROJECT DESCRIPTION:

The new project has been in operation two months and is an out-growth of the previous project number 245, which served the region the past three years. Geared to the environment in which the pupil and teacher will work and learn the project will develop innovative ways to meet the needs identified during the preceding three years.

Most of the professional functions of the project will be carried out in the classrooms of the schools in the area. Materials will be housed and distributed from the center, but the chief input from the center will be the leadership talents of the staff. The aim will be to initiate, to create, to meditate, to translate, to communicate and to innovate. Pilot projects in the subject matter areas are underway so that the teachers can study the latest approaches to instruction.

A major aim of the center is the involvement of laymen in curriculum planning. Evening courses for interpretation and explanation of new programs have been organized for adults in the area. This is an innovation in the area and should result in a positive attitude toward educational programs.

This project is designed to improve the reading program in Region VI through diagnostic procedures, and will provide a central clinic at the PACE Center in Parkersburg, plus two mobile units to be operated in the seven-county area. Testing and diagnosis of reading problems will be accomplished through the clinic and mobile units. Inservice training for classroom teachers and remedial reading teachers will also help overcome the reading deficiencies of students that are tested.

The project also provides a speech therapist who provides service to children and gives training to teachers to enable them to work with their own students. A social worker is available, working with parents who have children who have reading or speech problems.

PROJECT DESCRIPTION:

Ninety-three thousand boys and girls and 4,000 teachers in this eight-county region are served by the Learning Resource Center. The project is designed to improve classroom instruction throughout the region by improving the knowledge and skill of teachers. Educational change is taking place in an area where the approach to teaching has been somewhat traditional.

The operation of the project consists entirely of services to the schools. A staff of specialists in mathematics, science, language arts, social studies, music, audio-visual education, special education and educational information provide services and leadership in the area.

The introduction of ideas, which are innovative in the region, is followed by workshops, use of consultants, and demonstration teaching. Local school personnel are being informed of the happenings in education.

PROJECT DESCRIPTION:

George Washington High School is one of thirty-six schools in the United States which was selected by the Kettering Foundation's Institute for the Development of Educational Activities as a national demonstration school. Supported under ESEA Title III, schools were selected which had already made substantial progress in implementing innovative organizational changes in the direction of increased student responsibility.

The Demonstration Schools Project represented an effort to combine the energies and abilities of the Federal Government and foundations in an attempt to accelerate the pace of change in the nation's schools. The Title III project staff engaged in the continuous upgrading of the program at George Washington High, nation-wide dissemination, and inservice training of county school personnel. The staff received, selected and applied ideas from other schools in the consortium, and involved members of the school community in the program of the school.

PROJECT DESCRIPTION:

This project is a cooperative undertaking of the Kanawha County school system, seven colleges, two universities — or arms of the universities, two educational organizations and various business, industrial and cultural agencies in the State. It is a research project designed with rigid criteria in which 330 (13%) Kanawha County teachers, 120 student teachers, nine reading clinicians, approximately 8,000 (14%) Kanawha County students, and 570 non-public students will be involved.

Also, one high school, four junior high feeder schools, and twenty-six elementary schools in conjunction with the reading clinic and other facilities will serve as a laboratory for the region, state, and out-of-state. Specifically, this project encompasses pre-and-in-service training for seven classifications of educational personnel and clinical aid for exceptional (special education) students with reading difficulties, grades 1-12 with 1-3 emphasized, and concentrated effort in (1) promoting productive thinking and problem-solving skills; (2) developing emotional management skills; and (3) developing approach responses to subject matter and learning in all project students, grades 1-12.

PROJECT DESCRIPTION:

The Charleston Children's Museum, of the Sunrise Foundation, cooperates in the science project. The planetarium, belonging to the museum, is being used as the focal point. A committee of classroom teachers, with the assistance of the project director, has written lessons for presentation to children who are bused to the planetarium. The science supervisors for the county school system have also been involved in the preparation of the lessons. Preparatory lessons and follow-up lessons are prepared by the aforementioned groups.

In connection with this project, one six-hour inservice course has been presented. The director of the project also taught an Introductory Astronomy Course to selected secondary students.

All teachers of elementary science and mathematics and librarians receive weekly tips for observing current events in the sky, notices of relevant activities, suggestions of resource materials, and helps for teaching space-related science. Star parties, open to the public, are held weekly.

PROJECT DESCRIPTION:

Project HUM serves five special education classes in two of West Virginia's county school systems. Seventy-five children are involved.

A music specialist provides the instruction, using the Orff approach. The music specialist also provides instruction in games and activities which complement the music. The regular classroom teachers are receiving in-service training which will enable them to carry on the music and activities in their classrooms when the specialist is not available.

As part of the project the children are taking field trips which include visitation to pageants, musical performances and plays.

It is anticipated that the music and related activities will enhance the self-image, develop self-confidence, and improve the general attitude of these children.

This project is proposed for a one-year period.

PROJECT DESCRIPTION:

The purpose of the project is to provide a program of outdoor education for all seventh-grade pupils in the Raleigh County school system. A museum and a biological service center are being developed as part of this resident outdoor education program. The center provides for scheduling of educational and cultural activities for lay groups and organizations to use the complex. Year-round educational activities are carried on in this sylvan setting.

The staff of four professional educators provides inservice training for teachers in the schools. These specialists also visit the schools to help teachers and students prepare for their week of residency at the center. Teachers accompany the youngsters and carry out a program of regular classroom instruction, relating their work in the core subjects to outdoor education in accordance to a guide prepared for this purpose. Physical education, through the regular camping activities, adds to the enjoyment.

This exemplary resources center was designed to aid the schools of the region in overcoming the educational and cultural deprivation in the area. A library of 16mm film and other audio-visual media was maintained for teachers who either walked in and selected materials or ordered by mail.

Five educational specialists were on the staff and were available to help school systems develop programs, develop materials as requested, and provide inservice training for school staffs. An important development was the microfilming of records in each county school system.

Through expertise provided by the PACE Center, teachers in the region were prepared for ETV which was developed by West Virginia University.
