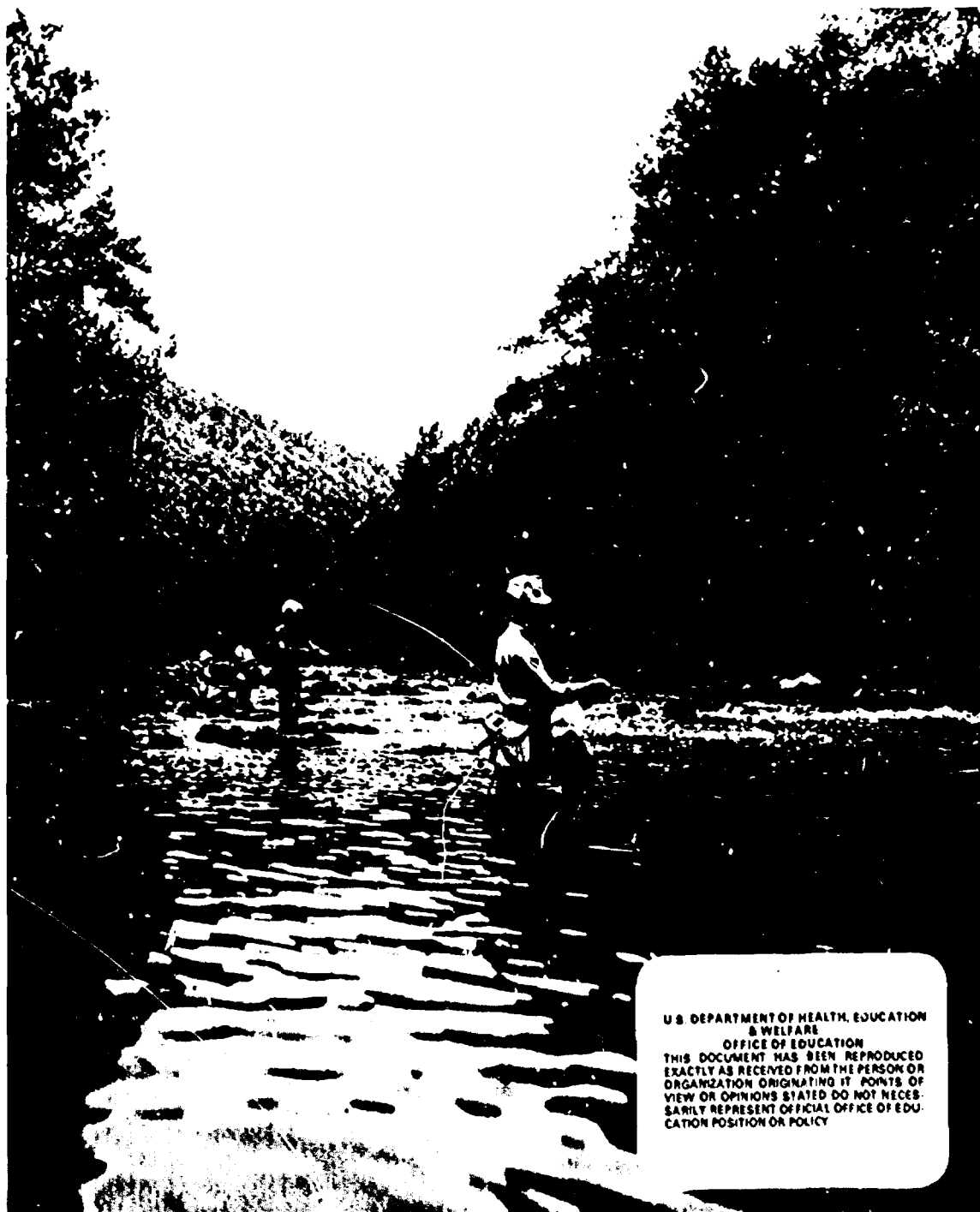
ABSTRACT
