ABSTRACT

During fiscal year 1970, the states received \$1.1 million for research under Section 131(b) of Part C of the Vocational Education Amendment. This amount was sufficient for states to keep their Research Coordinating Units (RCU's) functioning, but provided very little for new research. The main activities of the RCU's were to disseminate results of research, answer inquiries, assist in the use of ERIC materials, assist in the preparation of proposals, assist in state program planning and development, and conduct research studies when monies were available. Evaluation studies were conducted by 13 RCU's. Thirteen states reported studies for the implementation of guidance systems or curriculum development, and 10 states reported research projects directed at problems of the disadvantaged and handicapped. Seminars and educational personnel development were frequently noted as research-related activities. This document contains summaries of quarterly reports from all 50 states. (GEB)

I N T R O D U C T I O N

In fiscal year 1970, the States received a total of \$1.1 million for research under Section 131(b) of Part C of the Vocational Education Amendments of 1968. These funds could be used for paying up to 75% of the costs of the State Research Coordinating Unit (RCU) and for grants and contracts covering 90% of the costs of research and/or developmental projects. The funds were not released until April 1970, due to the timing of the Congressional appropriation.

Most States received the minimum allotment of \$15,000. Only seven States received more than \$30,000 for research, with the maximum amount received by the largest State being \$61,000. Thus for FY 1970, Part C funds were provided at a level barely adequate to help States maintain an RCU staff, with little left to carry on a research program for vocational education.

The States did manage to keep their RCU's functioning during fiscal year 1970, conducting some in-house studies with their own staff and funding some research projects, mostly with Part B and State monies. Some States were able to accomplish some valuable and needed research, but others, particularly the smaller States, were not able to carry on very significant programs because of the extremely limited funding. Only 9 States funded grants or contracts out of the Part C allotment.

The main activities performed by the RCU's this year were: dissemination of the results of research, answering inquiries, assisting in the use of ERIC materials, and assisting in preparation of proposals. Over 22 States reported these activities. Research studies to determine the need for facilities, instructional staff, and manpower in local or State areas were sponsored in 19 States.

Another major effort of RCU staffs was that of assisting in State program planning and development. Providing statistics for State program plans and assisting in the preparation of the plans were two such activities. Evaluation studies were undertaken by 13 RCU's during the year. In addition, 13 States reported studies for the implementation of guidance systems or the development of curriculums. Follow-up studies were usually conducted by RCU's for one of two reasons: to evaluate effectiveness of programs or to gather ideas for making changes in existing programs. This type of study was reported by 12 States.

Research projects directed at problems of the disadvantaged and handicapped were undertaken in 10 States. Other frequently mentioned areas of concentration were: securing the cooperation of industry in programs of vocational education, pre-vocational training programs, public relations for the image of vocational education, and projects for vocational education in rural areas. Seminars and other educational personnel development activities were among the most frequently noted of research-related activities.

The outlook for State research activity in fiscal year 1971 is an improvement over FY 1970 in that for FY 1971 the States received \$17.5 million under Section 131(b) of Part C in October 1970. The minimum amount received was \$23,000 by Alaska and the maximum was \$1,389,000 by California. Over 75% of the States received more than \$100,000 for research. Many States actually have FY 1971 proposals in hand at this time and are in the process of reviewing the proposal documents and awarding grants.

The Annual Report which follows is a compilation of State Quarterly Reports which have been received from RCU's. The reports are uneven in quantity of work reported due to three main factors: the late date at which the FY 1970 fundings became available, the small size of allotments, and the Tydings Amendment which authorized carry-over funds in educational allotments to the next fiscal year. Thus, States could obligate all or part of their FY 1970 allotments during FY 1971 and the State report might show no activities or projects for FY 1970.

All reported research projects administered by the State educational agency were included in this report, whether or not they were funded under Part C.
