ABSTRACT

This test is intended for use with a two-volume, 32-lesson set of materials for rural disadvantaged kindergarten children. The lessons are designed to help alleviate language deficiencies of the children by providing them with school-related activities, communication and cultural experiences, and other readiness instruction through language experience. The criterion-referenced test is tied to activities required of children by the program and assesses individual children's activities to accomplish individual tasks. Of the 28 test items, many involve some physical activity response and some involve a verbal response statement. The lessons are described in RE 003 856 and RE 003 857. (MS)
