ABSTRACT

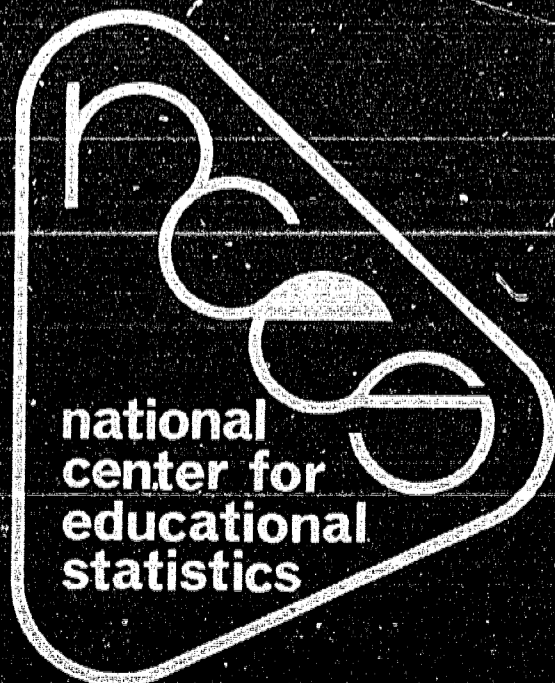

FOREWORD

This is the third in a series of annual publications providing information on the adult basic education programs sponsored by the United States Office of Education under Public Law 89-750, as amended. These publications have been based upon data compiled from annual reports on adult basic education filed with the U.S. Office of Education by each State, the District of Columbia, and participating outlying areas.

The series of publications has presented information on adult basic education enrollments, student characteristics, completions, separations, teachers, classroom facilities, and inservice training. Based upon the two prior publications and 2 years of unpublished data, this publication presents comparative statistics for the 5 years.

As a result of differing State laws concerning the collection of data, some States were unable to report specific items; therefore, each table so affected shows the total enrollment, a nonclassified total, and a total of those enrollees whom the States were able to classify by specific category.

This publication consists of nine tables showing trends during the 5-year period, 14 tables reporting fiscal year 1970 programs, and brief descriptions of illustrative State programs offered during the year. The publication was prepared by the Adult and Vocational Education Surveys Branch of the National Center for Educational Statistics with the cooperation of the Division of Adult Education Programs of the Bureau of Adult, Vocational, and Technical Education. Key to the development of this publication was the assistance of Paul V. Delker, Division Director; Morris L. Brown, Chief, Adult Basic Education Branch; John D. INTRODUCTION

The adult basic education program administered by the U.S. Office of Education was established under the Adult Education Act of 1966. This program offers to persons 16 years ^{1/} of age and older the opportunity to overcome English language difficulties and attain reading, writing, and computational skills through the 8th-grade level of instruction.

This is a State-operated program with the U.S. Office of Education allotting grants to States and outlying areas of the United States for the development and operation of adult basic education programs.

Each of the 50 States, the District of Columbia, and each of the outlying areas, with the exception of the Trust Territory of the Pacific Islands, must provide 10 percent of program costs and retain total responsibility for planning, supervisory services, teacher training, curriculum development, evaluation, and all essential services for enrollees through the 8th grade. In fiscal year 1970 each State, the District of Columbia, and four outlying areas conducted adult basic education programs.

The Office of Education also awards grants to schools, colleges, universities, and public and private nonprofit organizations for special projects and teacher-training projects. In some cases, the 1966 Act authorizes direct contracts with institutions and organizations to develop new teacher-training techniques and special experimental and demonstration projects.

Data contained herein were compiled from each State's annual program report, except for reference data on the total population and its distribution. The national figures used in comparisons were taken from the Statistical Abstract of the United States, 1970. ^{2/} Fiscal year 1970 refers to the period July 1, 1969, to June 30, 1970.

^{1/} As of June 30, 1969, the minimum age limitation was reduced from 18 to 16 years (included in the Vocational Education Amendments of 1968).

Teacher Training and Special Experimental Demonstration Projects

Fiscal year 1970 funds supported inservice and preservice training opportunities for 1,727 teachers, teacher-trainers, counselors, para-professionals, and administrators. The primary objective of the teacher-training projects was to provide the participants with current techniques in teaching adult basic skills.

During 5 years of operation with Federal funding, the adult basic education programs have supported a series of national institutes for 6,075 teachers, teacher-trainers, administrators, and counselors. The training program grew from three institutes with 165 participants in 1965 to 31 institutes with 1,727 participants in 1970.

The central purpose of Special Experimental Demonstration Projects is to increase the effectiveness of the adult basic education program. In 1970, the fourth year of special projects, the Office awarded grants totaling \$7,899,838 to 41 special projects. The experimental categories included urban, rural migrant, and resource development. Public and private educational agencies, a labor union, and model cities agencies conducted special experimental demonstration projects in fiscal year 1970.

National Advisory Council

Plans for Fiscal Year 1971

The 15-member National Advisory Council on Adult Education authorized by Public Law 91-230 and appointed by the President on July 15, 1970, was created to (1) advise the Commissioner in the preparation of general regulations with respect to policy matters arising in the administration of the adult education programs, (2) review the administration and effectiveness of the programs, and (3) make annual reports to the President of its findings and recommendations. The Council held its first meeting in March 1971.

Section I.

FIVE YEARS OF ADULT BASIC EDUCATION, FISCAL YEARS 1966-70

This section reviews and analyzes adult basic education program statistics for the past 5 years based upon data compiled from annual program reports for fiscal years 1966 through 1970. Tables showing financial statistics, total number of persons enrolled, and new enrollees reflect actual figures reported. Percentage tables show annual enrollment distribution by sex, age, race, and ethnic group. A table on reasons for separation from the program during the 5 years also is included. (See tables 1-9.)

During this 5-year period, \$163 million in Federal funds was expended to provide adult basic education to approximately 2,250,000 enrollees.

Several States were unable to classify all adult basic education enrollees by specific categories. Consequently, only those enrollees classified by specific categories were used in determining the percents for this section. The reader is requested to view with caution trend data over the 5-year period as reported in this section. Data on race and ethnic groups may be particularly affected.

A number of conclusions can be drawn from this information.

The number of students reported as whites, excluding ethnic group members, comprised 50 percent of the adult basic education enrollment in 1970, 1969, and 1968.

The ethnic group enrollment, defined on the report form as consisting of Cubans, Mexican-Americans, Puerto Ricans, and Spanish-surnamed Americans (as reported by one State) increased from 13.6 percent of the total enrollment in 1966 to 15.3 percent in 1970. The percentage of Cubans enrolled in adult basic programs fluctuated from year to year as did the figures for Mexican-Americans and Puerto Ricans. The percentage of Negroes enrolled decreased from 43 percent in 1968 to 38 percent in 1970.

Females enrolled in adult basic education programs increased from 53 percent of the total enrollment in 1967 to 57 percent in 1970. Female enrollment was always more than 50 percent and increased each year.

Programs offered the last 5 years had increasingly higher enrollments each year in the 18-24 age group. The increase was from 15 percent of the total enrollment in 1966 to 26 percent in 1970. The 45-54 age group showed the largest decrease, from 20 percent of the total enrollment in 1966 to 13 percent in 1970. Persons 35-44 and 55-64 constituted a smaller percent of the enrollment each year. The 65-and-over age group remained relatively constant, between 2 and 4 percent.

Enrollees in correctional, hospital, and other types of institutions increased from 6 percent of the adult basic education enrollment in 1967 to 11 percent in 1970, with a high of 15 percent reported in 1968.

The number completing the program through the advanced level of instruction increased from 12 percent of the total enrollment in 1967, the first year complete data were available, to 17 percent of the total enrollment in 1970. This indicates a 104-percent increase in completions from 1967 to 1970, while the increase in separations was only 62 percent during the same years.

If one combines the various reasons for separation from the program into two groups, one group consisting of those separated for employment reasons and the other a group separated for other reasons, he will find that in 1967 there were twice as many separated for other reasons as those separated for employment. The same ratio is true for 1970.

Section II.

ADULT BASIC EDUCATION, FISCAL YEAR 1970

This section reports on statistics obtained from the Adult Basic Education report for fiscal year 1970. Each State files its program report annually with the U.S. Office of Education. Tables in this section related to fiscal year 1970 display enrollments by age, sex, race, an ethnic group, grade levels, and completions. Tables showing the number separated from the program for various reasons, the number of adult basic education teachers, and the number of teachers receiving training are also included. Adult basic education classes not only are offered in schools, churches, and community buildings but also are offered at hospitals and correctional institutions as herein indicated. (See tables 10-23.)

A review of reports showed that two States (Texas and California) each had over 50,000 enrolled in adult basic education programs during fiscal 1970. Four States (New York, North Carolina, Florida, Illinois) had from 20,000 to 49,999 enrolled. Thirteen States and one outlying area had from 10,000 to 19,999 enrolled. Nine States had 5,000 to 9,999 enrolled. The remaining States and outlying areas had less than 4,999 enrolled. These reports totaled approximately 536,000 enrolled during fiscal year 1970, up 51,000 or 11 percent from the preceding year.

The number of completions through the advanced level of instruction reported by two States (West Virginia, Alaska) was equal to 49 percent of their annual enrollment, 15 States reported between 25 and 48 percent, and the remaining 38 States and outlying areas reported less than 24-percent completions. Thirty-one States reported program completions through the eighth-grade level equal to or greater than the 17-percent national average.

Programed instruction classes were offered to the entire enrollment in four States and one outlying area, 16 States reported 50 percent or more, and four States and one outlying area reported no programed instruction enrollees. Programed instruction is defined on the report form as "instruction utilizing a workbook, textbook, or mechanical and/or electronic device which has been programed to help students attain a specified level of performance by (a) providing instruction in small steps, (b) asking one or more questions about each step in the instruction and providing instant knowledge of whether each answer is right or wrong, and (c) enabling students to progress at their own pace."

Even though 57 percent of the total adult basic education enrollees in fiscal year 1970 were females, 13 States reported 50 percent or more of their total enrollment as males. Seventy percent was the highest female enrollment in any State (Mississippi), while 62 percent (in Pennsylvania) was the highest male enrollment. Region I, comprising the States of Connecticut, Maine, Massachusetts, New Hampshire, Rhode Island, and Vermont, was the only region to show more males than females enrolled. However, two of these six States showed more females enrolled than males.

Region IV--comprised of the States of Alabama, Florida, Georgia, Mississippi, South Carolina, and Tennessee 1/--showed the largest percentage of female enrollees. Each of these States had more than a 50-percent female enrollment, one of which was the national high with 70 percent.

The 25-34 age group had the largest enrollment with 144,513; second was the 18-24 age group with 139,904. Then enrollment decreased for older age groups. Age group 25-34 represented 27 percent of the adult basic education enrollment, in contrast to its 12 percent of the total U.S. population. A combined age group of 18- through 34-year-olds represented 53 percent of the total adult basic education enrollment, in contrast to 23 percent of the total population.

The number of whites enrolled in adult basic education programs represented only 0.1 percent of the total white population, whereas the combined enrollment of all other races and ethnic groups represented almost 1 percent of the total.

Region IV also had more adult basic education students enrolled than any other region. The 63-percent Negro enrollment in this region represented the highest percent and the largest actual number of Negroes enrolled in any region.

Five States (California, Florida, Illinois, North Carolina, and Texas) with the largest number of adult basic education students had a combined enrollment of 184,431, or 34 percent of the United States total. This five-State enrollment consisted of 49 percent whites, excluding ethnic group members; 37 percent Negroes; and 14 percent of all other racial and ethnic groups. The five States (Alaska, Delaware, North Dakota, New Hampshire, and Wyoming) with the smallest enrollment, excluding the outlying areas, had a combined total of 5,318 students, consisting of 62 percent whites, 22 percent Negroes, and 16 percent of all other racial and ethnic groups. Nine States were not able to classify 39,842 of their enrollees by race.

The ethnic group total of 114,638 was composed of 7,208 Cubans, 39,166 Mexican-Americans, 36,298 Puerto Ricans, and 31,966 with Spanish surnames. Increased enrollment of 16,277 represented a 16.5-percent growth over the previous year.

Fifty-three percent (92,293 students) of the number enrolled at the advanced, or 7th- and 8th-, grade level of instruction completed the program, an increase of 8 percent over the 85,659 completions reported the preceding year. Forty-eight percent of those enrolled at the intermediate level completed that level. Only 31 percent of the enrollees completed their level of instruction at the beginning level.

The States reported 49 percent of total enrollment as new enrollees. Since there were 262,114 new enrollees during fiscal year 1970 and only 186,790 enrolled at the beginning level, the balance of 75,324 entered the program at the intermediate or advanced level of instruction.

Under the column "other reasons for separation," table 17, are included such known reasons as follows:

Thirty-three States reported separations because enrollees moved.
Thirty States reported separations due to health problems.
Eighteen States reported separations as a result of their enrollees' experiencing transportation problems.
Thirteen States reported separations because enrollees had family problems.
Various other reasons were listed by five States or less.
Each State reported separations for unknown reasons.

The total number of all adult basic education classes decreased from 49,516 in 1969 to 30,402 in 1970, while the number of programmed instruction classes increased from 10,141 to 13,164. For all classes there was an average of 10 students per class in 1969 and an average of 17 per class in 1970, whereas programmed instruction classes averaged 8 students per class in 1969 and 14 per class in 1970. Since student-teacher ratios only increased from 23.8 in 1969 to 24.7 in 1970 while class size almost doubled, one could assume that teacher experience, more effective programs, and improved scheduling made larger classes possible.

While the number of teachers, State administrators, and other adult basic education staff increased over the previous year, the number of counselors and local supervisors decreased. The number of teachers increased from 20,291 to 21,693, the number of counselors decreased from 2,495 to 1,965, local supervisors decreased from 3,056 to 2,961, and State administrators increased from 168 to 183. Other local-level personnel increased from 4,919 to 5,948, and other State-level personnel increased from 114 to 137.

Adult basic education teacher workshops increased at both the State and local levels over the previous year. Personnel receiving training at the national level decreased, while the number at the State and local levels increased. Adult basic education personnel averaged participation in more than one training session, as indicated by comparing the number who received training (35,000) with the total number of State and local staff (33,000). The total number receiving training increase by 24 percent over the previous year, when 28,000 received training out of approximately 32,000 total staff.

The decrease in the number of classes, previously mentioned, was reflected in a decrease in the types of facilities which housed the classes. Public school buildings, for example, decreased from 36,062 in 1969 to 23,202 in 1970, and all other buildings decreased from 13,454 to 7,200. The decrease in public school classes was only 36 percent, whereas all others decreased by 54 percent.

Adult basic education offered at various types of institutions showed total enrollment decreasing from 68,832 in 1969 to 61,226 in 1970. However, the 32,536 enrolled at correctional institutions was an increase of 30 percent over the previous year, and the 9,571 enrolled at hospitals was a 47-percent increase. Enrollment of 19,119 at all other institutions was a 49-percent decrease over the previous year, thus contributing to the overall decrease.

Section III.

ILLUSTRATIVE STATE PROGRAMS, FISCAL YEAR 1970

This section contains brief descriptions of State adult basic education programs selected from the narrative portion of the States' annual reports for fiscal 1970. The selections are indicative of the imaginative and unique methods employed by States in providing adult basic education. Selected State programs receiving a Certificate of Merit Award for excellence are also described.

Massachusetts

Several daytime learning centers have been established by local school systems. They are staffed by regular school teachers and provide instruction in the daytime as well as evening. The city of Boston has several full-time centers. The adult learning centers provide a variety of instructional resources to individualize instruction.

New Jersey

Adult Education Resource Centers have been established in four colleges to provide ABE teacher training and materials development. Each center focuses on different areas of ABE so that they are mutually supportive and provide comprehensive services to the State grant program.

West Virginia

The West Virginia "School House on Wheels" began operation as a mobile classroom to enable adult students to attend classes in areas where school room facilities were not available. A 60-passenger school bus was converted into a self-contained ABE classroom. In fiscal year 1970, a total of 162 students attended the mobile classrooms in six different geographic areas.

Florida

ABE classes are made available to undereducated adults in a variety of settings to make instruction convenient to the learner. In FY 1970, classes were held in correctional institutions and seafood processing plants. Employers made space available for classroom purposes after normal working hours.

Michigan

Kentfields in Grand Rapids began an ABE program for boys who were wards of the court. These out-of-school youth had previously been assigned to menial tasks. The ABE program has proven successful in work training, job placement, and followup activities.

New Mexico

Videotape equipment was used in five centers to demonstrate teacher methodology as well as to show students the progress they were making in English-as-a-second-language classes. A comprehensive program of developing videotapes for statewide use has been initiated.

Nebraska

An innovative program was conducted in the city of Macy on the Winnebago Indian Reservation in which typewriters were employed to teach English as a second language along with reading, spelling, and punctuation. Interest in the project was high, as shown by the number of adults who attended and their regularity of attendance.

Wyoming

The University of Wyoming has implemented a graduate assistance program for the State Department of Education. The University will provide inservice education for ABE teachers and administrators. Eighty-eight teachers and 12 administrators attended workshops in fiscal year 1970.

California

The State Department of Education has contracted with the data processing center of a school district to establish a data-collection system for the ABE program. The demonstration project will be funded on a continuing basis. In fiscal year 1970, a 25-percent sample was included in the data-collection system, which will provide evaluative information to assist State and local program administrators in making decisions.

Oregon

The McMinnville Adult Learning Center, in cooperation with the Southwest Cooperative Educational Laboratory in Albuquerque, N. M., developed English-as-a-second-language materials in the areas of consumer buying, prereading readiness programs for Mexican-Americans, and job application instructional materials. The materials were validated with adult Mexican-American students attending the Mapar Learning Center.

Certificate of Merit Programs

Idaho

Idaho State University at Pocatello, Idaho, received a certificate for outstanding coordination efforts. Their ABE program served several ethnic groups in cooperation with the department of labor, vocational rehabilitation courts, and mental health institutions within the State.

Pennsylvania

The Lancaster County Adult Enrichment Center was selected because of its recruitment efforts and the quality of instruction. Classes are conducted in schools, churches, and local industries during the day and evening hours. The center is located in the Model Neighborhood area of Lancaster City and works closely with the Model Cities Program.

New York

The New York State Department of Education has established an Advisory Council for Continuing Education which provides an organizational mechanism for the delivery of adult education services. The council is also preparing a policy statement on a 10-year adult education program to meet the most urgent needs of adults.

Kansas

The Butler County Community Junior College of El Dorado, Kans., has installed a complete reading laboratory to diagnose and treat visual and eye-movement problems of undereducated adults. New methods and techniques of teaching adults are readily adapted to individualized instruction.

HIGHLIGHTS

FY 1966-70

The adult basic education programs sponsored under the Adult Education Act of 1966 as amended have provided basic education to approximately 2,250,000 adult students throughout the United States and outlying areas from 1966 through 1970.

Enrollment of the 18-24 age group showed an increase each year, from 15 percent in 1966 to 26 percent in 1970, while the 45-54 age group showed the largest decrease, from 20 percent to 13 percent.

The number completing the program through the advanced level of instruction increased from 12 percent of the total enrollment in 1967, the first year complete data were available, to 17 percent of the total enrollment in 1970. This indicates a 104-percent increase in completions from 1967 to 1970, while the increase in separations was only 62 percent during the same years.

FY 1970

Approximately 536,000 adult students attended adult basic education programs throughout the United States and outlying areas during fiscal year 1970. This reflects an increase in enrollment of approximately 51,000 students or 11 percent over the previous year.

New enrollees represented about 49 percent of the total enrollment during fiscal year 1970. Three States reported enrollments in the 16-17 age group.

A total of 92,293 students successfully completed the program through the advanced or 8th-grade level of instruction. This represents an 8-percent increase over the 85,659 who completed the program through the 8th-grade level during the previous year.
