FOREWORD

This report summarizes information received from State Research Coordinating Units (RCU's) regarding research activities conducted under Section 131(b) of the Vocational Education Amendments of 1968. This report covers the second six months of fiscal year 1971, and includes a final analysis of the entire fiscal year. The purpose of the report is to provide information that will assist States to be aware of research and development conducted by other States, thus facilitating exchange of information and reducing duplication of effort.

This Semiannual Report has been prepared by Marsha Golden of the Program Development and Operations Branch. This is the third in a series of reports on the activities of State RCU's. The first report was entitled Annual Report on State Research Coordinating Unit Activities for Fiscal Year 1970, and covered the period from July 1, 1969 to June 30, 1970. The second report was entitled Semiannual Report on State Research Coordinating Unit Activities for the Period July 1, 1970 to December 31, 1970. INTRODUCTION

For fiscal year 1971, the States received \$17.5 million under Section 131(b) of Part C of the Vocational Education Amendments of 1968. These funds could be used for paying up to 75 percent of the costs of the State Research Coordinating Unit (RCU) and for grants and contracts covering 90 percent of the costs of research and/or developmental projects. The minimum amount received was \$23,000 by Alaska and the maximum was \$1,389,000 by California. Over 75 percent of the States received more than \$100,000 for research.

By the end of the fiscal year, only six States reported funding no new projects. Most States were very active in setting research priorities, inviting and reviewing proposals, and awarding grants and contracts. Approximately 20 percent of the \$17.5 million was used to support the States' RCU's.

RCU activities covered a wide range, with the main function being administration of the State's R&D program — both inhouse studies and contracted research — and the dissemination of research findings to assist administrators, teachers and counselors, and teacher educators. Many RCU's have been operating extensive information retrieval and dissemination systems and others are in the process of developing such systems. Other RCU functions have included the performance of a good deal of Statewide evaluation, as well as evaluation for local districts. The RCU's have been assisting the States in planning efforts and, in some States, they coordinate the State-administered Exemplary Projects under Part D. Training of local researchers and assisting local district and university personnel in proposal development have been other RCU activities.

Research projects contracted by the States during fiscal year 1971 centered on seven main fields of interest: career education, the disadvantaged and handicapped, vocational guidance and counseling, evaluation of program effectiveness, program development in new and emerging occupational fields, improved instructional methods, and investigation of new and improved methods of educational administration. An encouraging trend is that of States picking up programs which have been developed through research projects supported by other States or by the Federal government.

The RCU's have been instrumental in many States in promoting and assisting adoption of practices and programs developed elsewhere. For example, Project VIEW, (Vocational Information on Education and Work) was originally developed under an Office of Education grant in California and now has spread to 23 States throughout the country. The "World of Construction" and "World of Manufacturing" exploratory career education programs designed for junior high students were



originally developed under U. S. Office of Education R&D grants at Ohio State University and are now in use in some local school districts in nearly every State. A project developed by the Illinois State RCU, "Computerized Vocational Information System," has served as a model for other computerized guidance systems being developed and has been implemented in various school districts throughout the country.

The types of projects and studies funded during fiscal year 1971, as well as final reports from projects funded during fiscal year 1970, indicate that the State research projects are providing important contributions to the research literature and are developing useful programs directed to the construction and validation of more effective instructional systems in vocational education. Fiscal year 1971 has seen the RCU's becoming mature administrative units firmly established as the R&D arm of the State vocational programs. The RCU's have been very responsive to national priorities, moving quickly to develop innovative projects and sponsoring studies in priority areas such as career education and education for the disadvantaged, thus relating national priorities to the particular needs of their State.

The report which follows is a compilation of State Quarterly Research Activity Reports covering the last two quarters of fiscal year 1971 which have been received from the States. Additional information on projects listed under the category of "new projects funded" may be located in the "Research Projects in Progress" section of Abstracts of Research and Related Materials in Vocational and Technical Education (ARM), published quarterly by the ERIC Clearinghouse on Vocational and Technical Education. Final reports of the "projects completed" are abstracted in the monthly issues of Research in Education and/or in the quarterly issues of ARM.

A compilation of the activities reported for the first two quarters of fiscal year 1971 has been published as the <u>Semiannual Report on State Research Coordinating Unit Activities for the Period July 1, 1970 to December 31, 1970</u>, and is available as ED 052 381 from the ERIC Document Reproduction Service. All reported research projects administered by the State educational agency were included in these reports, whether or not they were funded under Part C.
