ABSTRACT

The Office of Institutional Research of the National Association of State Universities and Land Grant Colleges (NASULGC) has assembled in this publication policy statements by its member institutions on how they administer gifts and grants. Each of the 92 universities listed has specific procedures for administering and safeguarding gift funds. Others have special accounting practices which require complete separation of state and gift funds. INTRODUCTION

Public higher education deserves and needs contributions and other forms of voluntary support today more than ever in its history. Most state universities now receive less than half their operating budgets from state tax funds. Tax funds generally can support the basic necessities for public higher education. They can construct and maintain buildings for classroom use, libraries, and laboratories. They can supply salaries for adequate faculty and staff.

But private gifts and grants supply the ingredients for real academic excellence—new and challenging courses of study, great libraries, cultural programs, continuing research, dedicated and outstanding professors.

The purposes to which private gifts may be devoted are as numerous and varied as the research, teaching, student aid and public service activities of the public university itself. State colleges and universities have strict policies which keep voluntary contributions separate from state appropriations and guarantee the use of these funds in accordance with the wishes of the donor.

The Office of Institutional Research of the National Association of State Universities and Land-Grant Colleges has assembled in this publication policy statements by its member institutions on how they administer gifts and grants.

Each of the institutions listed has specific procedures for administering and safeguarding gift funds. Others have special accounting practices which require complete separation of state and gift funds. Still others have set up special foundations to receive and administer contributions for the benefit of the university.

But no matter what technique or combination of techniques they use, the 92 universities listed in this report assure prospective donors with absolute fidelity that contributions received by them:

- will be used in strict accordance with the wishes of the donor
- will be kept entirely separate from state appropriated funds
- will, under no circumstances, revert to the state treasury
- will not be used to displace tax funds.

The five institutions not included in this report can also provide the above assurances, but did not submit a statement in time to be included in this report.

From the ranks of state and land-grant university alumni have come more than half of all living American Nobel Prize winners, half of the Nation's governors, Senators, and Congressmen; half of the nation's supply of school teachers; two-fifths of its civilian federal executives; more than one-third of the nation's leading corporation executives; and many outstanding labor leaders. From their campuses have come massive contributions to the development of agricultural techniques, the peace-time use of nuclear energy, and the space program. From their research laboratories have also come such wide ranging discoveries as streptomycin, the television tube, helium, hybrid corn, the isolation of the first enzyme, and the test tube synthesis of a ribonucleic acid.

Since 1952, public institutions have educated more than half of all students acquiring a higher education. They currently enroll about two-thirds of all college and university students, and their responsibilities will continue to grow. As the public sector of higher education expands, it will look more than ever to private gifts and grants for help in meeting the dual challenge of handling increased enrollments and providing students with meaningful and rewarding educational experiences. Private investments have in the past helped make possible educational innovations to meet this challenge. The difference between good and great universities, the vital "margin for excellence," rests upon private support.

AUBURN UNIVERSITY

The Auburn University Foundation was set up in 1960 to receive and manage gift funds, which are kept separate from public funds and applied only to projects approved by the directors of the foundation. Address: Director, Development Program, Auburn University, Auburn, Ala.

UNIVERSITY OF ALABAMA

Absence of legislative or constitutional restrictions permits the university to use gifts in accordance with the terms under which they are accepted. Donors are assured of this by letter from the university's president and by a receipt from the university's treasurer, indicating the specific account in which the gift has been placed and the specific expenditure of the funds. State law does not require that such donations be reported as part of the university's general operating funds. Address: President, University of Alabama, University, Alabama.

ALABAMA AGRICULTURAL AND MECHANICAL COLLEGE

Any gift accepted by Alabama Agricultural and Mechanical College will be placed in a restricted fund and accounted for by an audit. The college will accept the responsibility, through its business manager, of using a gift in accordance with the wishes of the donor. Address: President, Alabama Agricultural and Mechanical College, Normal, Alabama.

UNIVERSITY OF ALASKA

The university is subject to no legislation governing the acceptance of gifts, and offers complete assurance that they will be used as designated by the donor. Strict accounting procedures are followed for expenditure and accounting of gift funds, and none revert to the state treasury. Address: President, University of Alaska, College, Alaska.

ARIZONA STATE UNIVERSITY

Arizona State University has stated university policies and procedures whereby gifts may be made directly to the University or through the Arizona State University Foundation. The wishes of the donor are respected and upon acceptance these gifts are placed in special accounts. Under no circumstances do they revert to the state treasury or displace tax funds. Address: Office of Development and Public Affairs, Arizona State University, Tempe, Arizona.

UNIVERSITY OF ARIZONA

Contributions and donations are not placed in the general university budget at all, but are placed in local accounts and treated separately. There is no approval required from the state auditor or treasurer in making payments and funds are expended entirely on the basis of terms that are agreed upon at the time of the donation. Unexpended balances do not revert to the state treasury and gift funds have never displaced appropriated money.

Funds that are donated as permanent endowments, with only the income therefrom to be expended for specific purposes, are treated as Trust Funds and are invested under the direct supervision of the University Committee on Investments established by the governing Board of Regents. Address: President, University of Arizona, Tucson, Arizona.

AGRICULTURAL MECHANICAL AND NORMAL COLLEGE

Arkansas A & M assures prospective donors that the terms of their gifts will

be carried out, that no gift funds can revert to the state treasury or displace tax funds. Address: President, Arkansas A&M College, Pine Bluff, Arkansas.

UNIVERSITY OF ARKANSAS

The University of Arkansas Endowment and Trust Fund receives and administers gift funds following the specific purpose designated by the donor. In addition, the university has the legal power to keep gift funds separate from appropriated tax funds, and its accounting procedures are set up to accomplish this. No gifts from private sources revert to the treasury, nor are any donations used to displace tax funds. Address: President, University of Arkansas, Fayetteville, Arkansas.

UNIVERSITY OF CALIFORNIA

The state constitution gives the university authority to accept and use funds in accordance with donors' wishes, without reversion to the state treasury or displacement of tax funds. Each of the Chief Campus Officers at the nine campuses of the university has the authority to accept gifts and grants under the same terms. In addition, three campuses have independent fund agencies which receive gifts directly in support of the university. These are the California Alumni Foundation for the Berkeley campus, the California Aggie Alumni Foundation, Inc. for the Davis campus, and the UCLA Progress Fund, Inc. for the Los Angeles campus. Address: President, University of California, Berkeley 4, California.

COLORADO STATE UNIVERSITY

Gifts to Colorado State University may be made directly to the University or through the Colorado State University Development Fund. Wishes of the donor are respected, and such gifts are placed in special accounts from which there is no reversion to the state treasury. These funds do not displace tax funds. Address: Director, Development Fund, Colorado State University, Fort Collins, Colorado 80521.

UNIVERSITY OF COLORADO

The university assures prospective donors that gifts will be used only in accordance with their wishes and that contributions will not revert to the state treasury or displace tax funds. Address: President, University of Colorado, Boulder, Colorado.

UNIVERSITY OF CONNECTICUT

A special act of the General Assembly permits the University to receive and administer all gift funds and property within certain limits prescribed by the State. In addition, The University of Connecticut Foundation is also available to receive gifts on behalf of the University. All such gifts will be used fully in accordance with the wishes of a donor. Address: The University of Connecticut Foundation, Storrs, Connecticut.

UNIVERSITY OF DELAWARE

Under its charter, the university Board of Trustees has complete control over all gifts and private funds. The state does not require an accounting of endowment funds and they are kept separate from state-granted money. Gift funds are deposited in the university's own account and do not revert to the

state if they are not spent. Address: President, University of Delaware, Newark, Delaware.

DELAWARE STATE COLLEGE

The college assures donors that gifts will be used in accordance with their wishes. Gift funds do not revert to the state treasury but become a part of the Special Fund or the College Endowment Fund of Delaware State College. Only unused state appropriations are required to revert to the state treasury. Address: President, Delaware State College, Dover, Delaware.

FLORIDA AGRICULTURAL AND MECHANICAL UNIVERSITY

The university assures donors that gifts will only be used in accordance with their wishes and that contributions will not revert to the state treasury or displace tax funds. Address: President, Florida Agricultural and Mechanical University, Tallahassee, Florida.

UNIVERSITY OF FLORIDA

The University of Florida uses gifts in strict accordance with the wishes of the donor and no part of any gift or contribution reverts to the state treasury or displaces tax funds. The Division of Development Services has responsibility for receipt and handling of gifts and bequests. Its director also serves as secretary of the University of Florida Foundation, Inc. The Foundation, successor to the University of Florida Endowment Corporation, is a non-profit corporation dedicated to the development of the University through encouragement of private support. Gifts by will or bequest, trusts and gifts of property are made to the University through the Foundation. Address: Director, Development Services, University of Florida, Gainesville, Florida 32601.

FLORIDA STATE UNIVERSITY

Gifts made to the Florida State University Foundation will be used strictly in accordance with donors' wishes, with the assurance that such funds will not be used to displace tax funds and will not revert to the state treasury. In addition, gifts made to Florida State University, with or without specific terms as to their use, are handled as trust funds and do not revert to the state treasury. Address: President, Florida State University, Tallahassee, Florida.

FORT VALLEY STATE COLLEGE

All contributions to be used for specific purposes are deposited to the school's agency account, which sets them apart from funds to be used for educational and general purposes. Donors are assured that gift funds will be used only in accordance with their wishes and that contributions will not revert to the state treasury or displace tax funds. Address: President, Fort Valley State College, Fort Valley, Georgia.

GEORGIA INSTITUTE OF TECHNOLOGY

Gifts may be given directly to the institution or through the Georgia Tech Foundation, a non-profit, separately incorporated foundation which exists for the purpose of assisting the institution. The school has no interference of any kind in the administration of gifts or trusts, and is able to fulfill the wishes of the donors without difficulty. Address: President, Georgia Institute of Technology, Atlanta, Georgia 30332.

THE UNIVERSITY OF GEORGIA

Gifts may be made directly to the University or to the University of Georgia Foundation, a non-profit foundation incorporated to assist the institution. The University asks that gifts made directly to the institution be conveyed with written instructions. Funds do not revert to the state treasury, nor do they displace tax funds. Donors may earmark gifts to the Foundation or they may give to the unrestricted fund. Foundation trustees administer gifts and trusts as requested by donors. Address: President, The University of Georgia, Athens, Georgia 30601.

UNIVERSITY OF HAWAII

The regents of the university are authorized by law to accept gifts, grants and donations for specific purposes. Funds may be deposited in restricted trust accounts in the state treasury or in regular commercial savings banks as the donor wishes. They must be expended only for the purpose prescribed by the donor. The University of Hawaii Foundation is also authorized to receive gift and grant funds, which are deposited in restricted sub-accounts and held for the project underway. Funds granted to the university or the foundation for specific purposes could not be reverted to the state treasury or be used to displace tax funds. Address: President, University of Hawaii, Honolulu, Hawaii.

UNIVERSITY OF IDAHO

The Regents of the University of Idaho are a separate constitutional body, and gifts made to the school in the name of the regents are under their full and exclusive jurisdiction. Instructions of donors are specifically carried out. Address: President, University of Idaho, Moscow, Idaho.

SOUTHERN ILLINOIS UNIVERSITY

The Southern Illinois University Foundation is a not-for-profit organization chartered by the State of Illinois in 1942.

It is authorized to solicit and receive gifts for the benefit of Southern Illinois University in the advancement of scientific, literary, and educational purposes. The officer and Board of Directors of the Foundation adhere strictly to the provisions of the State charter by utilizing the resources of the Foundation only to supplement and not to supplant funds available from the State of Illinois.

As a separate non-profit corporation, the funds of the Southern Illinois University Foundation are in no way co-mingled with those of Southern Illinois University; and the funds of the Foundation may not revert to the State of Illinois. Address: Executive Director, Southern Illinois University Foundation, Carbondale, Illinois.

UNIVERSITY OF ILLINOIS

The university is authorized by state statute to hold in its own treasury endowment, gift and trust funds. These funds are not subject to appropriation by the General Assembly and may be expended as authorized by the university's Board of Trustees.

The University of Illinois Foundation was established in 1935 as an agency through which alumni and other friends of the University can make gifts to the University of Illinois. The Foundation legally is a separate entity but

functions as an arm of the University. The affairs of the Foundation are governed by a Board of 16 Directors who include the President of the University, the President of the Board of Trustees of the University and the President of the Alumni Association. Every year the Foundation becomes more and more central to the giving program of the University.

INDIANA UNIVERSITY

The Indiana University Foundation, a corporation with perpetual existence, was chartered in 1936 "to receive, hold, manage, use, and dispose of properties . . . for the benefit of Indiana University." Its purposes are further stated in its by-laws to be "more specifically to finance research work, to hold and exploit patents, to subsidize publications, to found and establish fellowships, and to endow scholarships, and, finally, to supplement all of the services which the University should render to society." The officers and board of directors of the Foundation exercise strict adherence to these provisions by utilizing the resources of the Foundation only to supplement and not to supplant public funds. As a separate corporation the Foundation's funds are in no way co-mingled with those of the University and may not revert to the state. Address: President, Indiana University Foundation, Bloomington, Indiana.

PURDUE UNIVERSITY

Gifts to the university are used strictly in accordance with the donor's wishes and no part of gift contributions reverts to the state treasury or displaces tax funds. Gifts may be made to the university directly, to the Purdue Research Foundation or the Purdue Alumni Scholarship Foundation. Address: Vice President and Treasurer, Purdue University, Lafayette, Indiana; or: Vice President and General Manager, Purdue Research Foundation, Lafayette, Indiana.

IOWA STATE UNIVERSITY

The university uses private and corporation gifts for the specific purposes indicated by donors, putting the funds into a special category which is never used for the general operation of the school. In addition, the Alumni Achievement Fund administers gift funds, following the donor's wish, and holds them separately from state-appropriated funds. Address: President, Iowa State University, Ames, Iowa; or: Director, Alumni Achievement Fund, Iowa State University, Ames, Iowa.

UNIVERSITY OF IOWA

The University of Iowa Foundation receives and manages gifts for the benefit of the institution. Gift funds are used for the purposes specified by the donor. They are accounted for separately and never become subject to the regulations governing general university funds. There is no possibility of reversion or of displacement of tax funds. Address: President, University of Iowa, Iowa City, Iowa.

KANSAS STATE UNIVERSITY

The Kansas State University Endowment Association receives and administers gifts in accordance with the wishes of the donor and in no case do any of these funds ever revert to the state or displace tax funds. Address: President, Kansas State University, Manhattan, Kansas.

UNIVERSITY OF KANSAS

Gifts and bequests are managed by the Kansas University Endowment Association, a corporate entity whose resources are entirely divorced from state funds. Gifts are used in accordance with the donor's wish, and gift funds do not revert to the state treasury or displace tax funds. Address: Chancellor, University of Kansas, Lawrence, Kansas.

KENTUCKY STATE COLLEGE

The college is required by state law to turn into the State Treasurer any funds received through gifts or otherwise. Such funds, however, are placed in special accounts separated from appropriated tax funds. They are used for the purpose for which they were given and do not revert to the state treasury. Address: President, Kentucky State College, Frankfort, Kentucky.

UNIVERSITY OF KENTUCKY

The Kentucky Research Foundation was established in 1945 to serve as a depository for restricted or private funds, which are used in strict accordance with the wishes of the donor. No part of gift contributions reverts to the state treasury or displaces tax funds. Address: President, University of Kentucky, Lexington, Kentucky.

LOUISIANA STATE UNIVERSITY

The Louisiana State University Foundation was incorporated in 1960 to receive and administer grants and bequests. Donations with specific provisions for their use are set up in a restricted fund and accounted for individually. Funds donated for a specific purpose are used for that purpose and do not revert to the state treasury. Address: President, Louisiana State University, Baton Rouge, Louisiana.

SOUTHERN UNIVERSITY

The university assures prospective donors that gifts will be used only in accordance with their wishes and that contributions will not revert to the state treasury or be used to displace tax funds. Address: President, Southern University, Baton Rouge, Louisiana.

UNIVERSITY OF MAINE

State statute gives the university the authority to manage gift funds according to the terms of the gift. Such funds are kept separately from appropriated funds and are not transmitted to the state treasury. In addition, a 1935 legislative act established the University of Maine Foundation, which accepts funds for the benefit of the university. Address: President, University of Maine, Orono, Maine.

UNIVERSITY OF MARYLAND

State statute provides that all gifts are to be received and managed by the university. They are held as dedicated or restricted funds in the university's accounting procedures and are specifically accepted by the Board of Regents in assurance of trust. Address: President, University of Maryland, College Park, Maryland.

UNIVERSITY OF MASSACHUSETTS

Under its Board of Trustees, the university has the authority to administer

gifts and grants in accordance with the terms and provisions of the donor. The Trustees also have the power to enter directly into agreements or contracts with individuals, foundations, corporations and other organizations. In addition, the Associated Alumni of the University, a separate, incorporated, non-profit organization, is empowered to accept gifts. Address: President, University of Massachusetts, Amherst, Massachusetts.

MICHIGAN STATE UNIVERSITY

The university's Board of Trustees is granted by law exclusive control of all the university's funds, with no requirement for transmitting gift funds to the state treasury. Each gift is treated as part of the Board's agenda, with all conditions incorporated into the official minutes. The terms of the donor are compiled with exactly. Address: President, Michigan State University, East Lansing, Michigan.

UNIVERSITY OF MICHIGAN

The Regents of the University of Michigan make up a constitutional body which receives and administers gifts, following the wishes of the donors. All gifts are under the direct and sole control of the Regents, and do not revert to the State Treasury. It is the University's policy to keep such contributions separate. Address: President, University of Michigan, Ann Arbor, Michigan.

WAYNE STATE UNIVERSITY

State law gives the university's board of governors the power to receive and manage gifts and to direct and control all university funds. In addition, the alumni-established Wayne State Fund receives and administers gifts for the benefit of the university, in accordance with donors' wishes. Address: Vice President and Treasurer, Wayne State University, Detroit 2, Michigan.

UNIVERSITY OF MINNESOTA

The state constitution makes the Regents of the university a legislative body which has the responsibility for passing the laws that govern the university. Gifts are administered as a trust by the regents of the university, in conformance with the wishes of the donor, and trust funds do not revert to the state treasury. Address: President, University of Minnesota, Minneapolis, Minnesota.

MISSISSIPPI STATE UNIVERSITY

The university's accounting system provides for restricted funds, which are handled separately and cannot revert to the state treasury. Such funds are used for the purpose for which they were given. The Mississippi State University Development Foundation, Inc. also accepts gift funds to be used according to the wishes of the donor and in no case to revert to the state treasury. Address: Director of Development and Public Relations, Mississippi State College, State College, Mississippi.

UNIVERSITY OF MISSISSIPPI

A resolution of the state legislature specifically prohibits using gift funds as a replacement for or a reason to reduce appropriated funds. It also instructs the appropriate state agencies to assure that gifts are used to benefit the institution chosen by the donor. In addition, the university considers each gift for a specific purpose as a trust to be honored in the specific manner designated by the donor. Address: Director of University Development, University of Mississippi, University, Mississippi.

UNIVERSITY OF MISSOURI

The constitution of Missouri provides that the government of the university shall be vested in the Board of Curators. The Board of Curators, therefore, and the administration of the university, is able to guarantee each donor that funds and other bequests given to the university will be used in accordance with the terms agreed upon by the donor and university and that such funds and bequests will not at any time revert to the state treasury. Address: President, University of Missouri, Columbia, Missouri.

MONTANA STATE UNIVERSITY

The Endowment and Research Foundation at Montana State University was established in 1947 as a separate corporate entity to handle gifts and grants. Funds are used in strict accordance with the wishes of the donor and with the assurance that none will revert to the state, become mixed with state funds or be used to displace state tax funds. Address: President, Montana State University, Bozeman, Montana.

UNIVERSITY OF MONTANA

The University of Montana Foundation administers all gifts to the university, keeping them separate from state funds. Gifts are used according to the wishes of the donors and are not used for projects for which state funds are available. Contributions made to the foundation do not revert to the state treasury. Address: President, University of Montana, Missoula, Montana.

UNIVERSITY OF NEBRASKA

The University of Nebraska Foundation, a separate corporation, handles gifts made to the university. The governing board of the university also receives funds directly and these are placed in a trust fund, as authorized by state statute. Address: Chancellor, University of Nebraska, Lincoln, Nebraska.

UNIVERSITY OF NEVADA

By state law and by interpretations of the state Attorney General, the university has the authority to maintain and manage its own endowment funds. The Board of Regents maintains the restrictions under which it has accepted gift funds and such funds are held in separate trust or bank accounts. They are not mingled with appropriated tax funds and under no circumstances revert to the state treasury. Address: President, University of Nevada, Reno, Nevada.

UNIVERSITY OF NEW HAMPSHIRE

Gifts to the University of New Hampshire will be used only in accordance with the terms under which they are accepted and may be received and used in such a way to keep them separate from appropriated tax funds or from reverting to the state treasury. Address: Director of Development, University of New Hampshire, Durham, New Hampshire.

RUTGERS, THE STATE UNIVERSITY

Since 1956, a state statute gives the Board of Governors of the university the right to receive all gifts, grants and bequests. Gifts are used in accordance with the terms under which they are accepted. Gift funds are kept separate

from appropriated tax funds and cannot possibly revert to the state treasury. Address: President, Rutgers, The State University, New Brunswick, New Jersey.

NEW MEXICO STATE UNIVERSITY

Gifts for New Mexico State University are handled in accordance with the wishes of donors, and do not revert to the state treasury or displace state funds. Address: President, New Mexico State University, University Park, New Mexico.

UNIVERSITY OF NEW MEXICO

By state law, the university is entitled to receive all donations and the Board of Regents empowered to administer them in the best interests of the university. Money donated for a specified use is placed in a special section of the university's auditing and accounting system and may be used only for the purpose outlined by the donor. Unused funds do not revert to the state treasury. Address: President, University of New Mexico, Albuquerque, New Mexico.

CORNELL UNIVERSITY

Cornell University is a privately endowed, land-grant institution incorporated in the state of New York. All charitable contributions are received and used in accordance with the wishes of the donor and do not revert to the state treasury or displace tax funds. Address: Director of Development, Cornell University, Ithaca, New York.

STATE UNIVERSITY OF NEW YORK

The Research Foundation of State University of New York receives and administers gifts and grants for the university following the wishes of the donor. Gift funds do not revert to the state treasury and are not used to displace tax funds. Address: President, State University of New York, Albany, New York.

AGRICULTURAL AND TECHNICAL COLLEGE OF NORTH CAROLINA

The Endowment Fund of the Agricultural and Technical College of North Carolina receives and administers gifts strictly in accordance with the wishes of the donor. No part of gift contributions reverts to the state treasury or displaces tax funds. Address: President, Agricultural and Technical College of North Carolina, Greensboro, North Carolina.

UNIVERSITY OF NORTH CAROLINA

State law authorizes the university to accept gifts and apply them strictly in accordance with the wishes of the donor. Such gifts do not revert to the state treasury, but are kept separately from appropriated tax funds and are held and invested under the authority of the Board of Trustees. In addition, the university has assisted in the development of several foundations which operate in specific fields and to which gifts may be made. These are in the areas of Business, Broadcasting, Medicine, Dentistry, Education, Law, Pharmacy and Journalism. Address: Chancellor, University of North Carolina, Chapel Hill, North Carolina.

NORTH CAROLINA STATE UNIVERSITY

All gift funds are handled strictly in accordance with the donor's wishes, which is provided for under State law. In no way do gifts revert to the state treasurer. These funds are handled as trust funds, and unused portions accumulate from year to year. Gift funds are kept separately from State

appropriated funds. Address: Director of Foundations and Development, North Carolina State University, Raleigh, North Carolina.

NORTH DAKOTA STATE UNIVERSITY

The North Dakota Code provides that gifts received by North Dakota State University be used for the purposes specified by the donors. Under these same conditions, the North Dakota State University Alumni Association and the NDSU Memorial Foundation also receive gifts benefiting the University. Address: President, North Dakota State University, Fargo, North Dakota 58102.

UNIVERSITY OF NORTH DAKOTA

State law directs that the university use all gifts which it receives for the purpose specified by the donor. The University of North Dakota Alumni Development Fund, managed by a Board of Directors appointed by the Alumni Association, receives and manages gifts for the benefit of the university. Such gifts are also used as the donors specify. The University Memorial Corporation may hold in trust gifts made for the benefit of the university. Address: President, University of North Dakota, Grand Forks, North Dakota.

KENT STATE UNIVERSITY

The Kent State University Foundation is an independent, non-profit corporation under the management of a Board of Trustees. The Foundation is designed to provide those resources, financial and other, which cannot be obtained through state appropriations to meet the needs and long-range goals of the University. The university welcomes all forms of private support. Gifts will be used in direct accord with the donors' wishes. Address: The Kent State University Foundation, Development Office, Kent State University, Kent, Ohio 44240.

MIAMI UNIVERSITY

A state statute gives the university's Board of Trustees the power to receive and administer gifts in accordance with the directions of the donor. In addition, a ruling of the state Attorney General exempts the receipts of the Alumni Fund from auditing by the auditor of state, even when these receipts are in effect a gift to the university and not to a separate corporation. The Miami University Foundation, a separate private non-profit organization, also receives and holds funds for the benefit of the university. Gifts do not revert to the state treasury and do not displace state tax funds. Address: President, Miami University, Oxford, Ohio.

OHIO STATE UNIVERSITY

The Ohio State University Development Fund, an arm of the Board of Trustees, is the official gift-receiving unit of the university. Gifts designated for a particular purpose are deposited by the fund in separate accounts in the university's business office and are not mingled with other money. The donor is assured that his money will be used for purposes of the grant only, and it is possible to make a refund to the donor if all the gift should not be used, rather than having the remainder revert to the general fund or the state treasury. Address: Ohio State University Development Fund, Alumni House, 230 West Seventeenth Ave., Columbus, Ohio.

OHIO UNIVERSITY

The Ohio University Fund, Inc., receives and manages all gifts for the

university. The Fund Board is completely free of state control or influence in spending these funds. Gifts are used to achieve exactly the goals of the donor. Address: The Ohio University Fund, Inc., Ohio University, Athens, Ohio.

LANGSTON UNIVERSITY

The Langston University Development Foundation, set up in 1961, holds and administers donations in the interest of the university. Gifts are used in accordance with donors' wishes and no part of their contribution reverts to the state treasurer or displaces tax funds. Address: President, Langston University, Langston, Oklahoma.

OKLAHOMA STATE UNIVERSITY

The Oklahoma State University can and will give prospective donors definite assurance that any gifts given to the university will be used in strict accord with the wishes of the donor. Such funds would not revert to the state treasury or be used to displace tax funds. Address: President, Oklahoma State University, Stillwater, Oklahoma.

UNIVERSITY OF OKLAHOMA

Gifts to the University of Oklahoma are received in a separately incorporated foundation which guarantees that they will be used according to the donor's wishes. Gift funds do not displace tax funds and are never co-mingled with them. Address: President, University of Oklahoma, Norman, Oklahoma.

OREGON STATE UNIVERSITY

All gifts made to the university are deposited with the State Treasurer, but such funds are restricted and used strictly in accordance with the wishes of the donor. They do not revert to the State Treasurer and are not used to displace tax money. Gifts and grants may also be made to the Oregon State University Foundation, a separate entity, and such gifts are not placed with the State Treasurer. Address: President, Oregon State University, Corvallis, Oregon.

UNIVERSITY OF OREGON

The Administrative Code of the State System of Higher Education, of which the University is part, assures that gift funds will be used for the purposes for which they were donated and will be kept separate from state funds. In addition, the University of Oregon Development Fund, a non-profit corporation of the State of Oregon, handles gifts in strict accordance with the wishes of the donor and maintains separation from state funds. Address: President, University of Oregon, Eugene, Oregon.

PENNSYLVANIA STATE UNIVERSITY

The Board of Trustees is empowered by the university's charter to receive and administer gifts, provided that the annual income from each gift shall not exceed \$25,000. Address: President, Pennsylvania State University, University Park, Pennsylvania.

UNIVERSITY OF PUERTO RICO

The university is set up as a corporate body and manages its own finances. Donated funds are deposited in special accounts with the university treasurer and are drawn on as required for the agreed purpose. Gifts are used only in accordance with the terms under which they are accepted and in no event revert to the state treasury. Address: Chancellor, University of Puerto Rico, Rio Piedras, Puerto Rico.

UNIVERSITY OF RHODE ISLAND

The University of Rhode Island Foundation was incorporated in 1957 to assure that gifts would be used entirely in accordance with the wishes of donors and that no part of gift funds would revert to the state treasury or be used to displace tax funds. Address: Development Officer, University of Rhode Island, Davis Hall, Kingston, Rhode Island.

CLEMSON UNIVERSITY

The University has complete jurisdiction over all donated funds and uses them strictly in accordance with donors' wishes. Also the Clemson University Foundation, a separately incorporated body, serves as custodian for contributions made through the Alumni Loyalty Fund annual giving program and of various special funds. Address: President or Vice President for Development, Clemson University, Clemson, South Carolina 29631.

SOUTH CAROLINA STATE COLLEGE

All gifts accepted by the College are placed in a special trust fund account and disbursed strictly in accordance with the wishes of the donor. Under no circumstances will gifts revert to the state treasury, nor will they be used to displace tax funds. Address: President, South Carolina State College, Orangeburg, South Carolina.

UNIVERSITY OF SOUTH CAROLINA

Gifts made to the university are placed in a trust fund account completely separate from tax funds and are used in accordance with the wishes of the donor. Gift funds are not used to displace tax funds and do not revert to the state treasury. In addition, the University of South Carolina Educational Foundation accepts gifts for use according to the wishes of the donor and places them in an endowment fund. Address: Director for Development, University of South Carolina, Columbia, South Carolina.

SOUTH DAKOTA STATE UNIVERSITY

Grants and gift funds are kept separate from appropriated tax funds and set up in a special auxiliary account. The university has the authority to spend these funds in compliance with the donors' wishes. Gift funds do not come under the general jurisdiction of legislative control. In addition, the Alumni Division of the South Dakota State College (University) Foundation through its Greater State Fund, was set up as a non-profit and tax-exempt corporation to accept gifts and administer them according to the donors' wishes for the benefit of South Dakota State University. Funds handled by the Alumni Division do not go through the State Board of Regents, are not deposited in the State Treasury and are not subject to the control of the state. Address: Director of Development, South Dakota State University, Brookings, South Dakota 57007.

UNIVERSITY OF SOUTH DAKOTA

Donors of gifts to the university are assured that these will be used in accord with their wishes and will not revert to the state treasury or displace tax funds. This is possible since all such gifts are administered through the University Endowment Association, which is incorporated under the laws of South Dakota. Address: President, State University of South Dakota, Vermillion, South Dakota.

TENNESSEE AGRICULTURAL AND INDUSTRIAL STATE UNIVERSITY

The W. J. Hale Alumni Scholarship Foundation accepts and administers gift funds for scholarship use, with the guarantee that such funds will not revert to the state treasury nor will be used merely to displace state-appropriated funds. Address: Director, Bureau of Public Relations and Alumni Affairs, Tennessee Agricultural and Industrial State University, Nashville, Tennessee.

UNIVERSITY OF TENNESSEE

The university sets up separate accounts covering the types of functions or activities which donors wish to sponsor. Funds in these accounts belong to the university and will in no way revert to the state government. Gifts are used in accordance with donors' wishes and contributions do not revert to the state treasury or displace tax funds. Even funds provided by the state do not revert to the state treasury, but remain in the university's possession, under the control of the board of trustees. Address: President, University of Tennessee, Knoxville, Tennessee.

TEXAS A&M UNIVERSITY

The university is authorized by state statute to accept gifts and contributions. These funds are not regarded as state funds but are maintained separately under the control and administration of the Board of Directors. Gift funds are used in strict accordance with the wishes of the donors. Address: President, Texas A&M University, College Station, Texas 77843.

TEXAS TECHNOLOGICAL COLLEGE

Existing legislative authorization permits acceptance of gifts and contributions for purposes stipulated by the donors. Such funds are separately accounted for and are not subject to restrictions imposed on appropriations. Address: President, Texas Technological College, Lubbock, Texas or The Vice President for Development at the same address.

UNIVERSITY OF TEXAS

The Texas state legislature has specifically exempted gifts from funds that must be deposited in the state treasury. Gift funds are administered by the university, according to the terms stipulated by the donor. These funds are kept in separate accounts and are not mixed with general revenue (tax appropriations), or added to the University Endowment Fund. Address: Chancellor, University of Texas, Austin, Texas.

UTAH STATE UNIVERSITY

The Utah State University Development Fund, established in 1958, accepts and administers grants, gifts and donations, following the wishes of the donor. Address: Director, Utah State University Development Fund, Logan, Utah.

UNIVERSITY OF UTAH

The state constitution gives the university's Board of Regents full authority to accept and administer contributions and gifts, without danger of reversion to the state treasury or displacement of tax funds. Address: President, University of Utah, Salt Lake City, Utah.

UNIVERSITY OF VERMONT

Under its charter, the university's status is that of an individual corporation, with all corporate rights and powers. All gifts are used strictly in accordance with the donors' wishes and no part of their contribution reverts to the state treasury or is used to displace tax funds. Address: Vice President for Financial Affairs, University of Vermont, Burlington, Vermont.

VIRGINIA POLYTECHNIC INSTITUTE

The Virginia Polytechnic Institute Educational Foundation, Inc., was established in 1948 in order to receive gifts made to the Institute. Gift funds are kept separate from appropriated tax funds and are handled according to the wishes of the donor. No part of private or corporate contributions reverts to the state treasury or is used to displace tax funds. Address: President, Virginia Polytechnic Institute, Blacksburg, Virginia.

VIRGINIA STATE COLLEGE

With the prior, written approval of the governor, the college may accept and administer gifts, donations and grants in accordance with the purpose of the donor. Such gift funds are not used to displace tax funds. Address: President, Virginia State College, Petersburg, Virginia.

UNIVERSITY OF VIRGINIA

The university is empowered by state law to use gift funds in accordance with the wishes of the donors. The law includes the provision that such endowment funds will not be regarded as a reason for reducing state payments. There are, in addition, certain endowment funds, chiefly for the professional schools, incorporated separately from the university, which receive gifts. Address: President, University of Virginia, Charlottesville, Virginia.

UNIVERSITY OF WASHINGTON

The Board of Regents has the statutory power to receive and manage gifts, which are used as stipulated by the donor. Address: Director of Development, 400 Administration Building, University of Washington, Seattle, Washington 98105.

WASHINGTON STATE UNIVERSITY

The Board of Regents has statutory authority to receive restricted gifts and to keep them separate from appropriated tax funds. Address: President, Washington State University, Pullman, Washington.

WEST VIRGINIA UNIVERSITY

Gifts to the West Virginia University Foundation, incorporated in 1954, are used strictly in accordance with the wishes of the donor. These contributions have no connection with state funds, cannot revert to the state treasury and are not used to displace tax funds. Address: President, West Virginia University, Morgantown, West Virginia.

UNIVERSITY OF WISCONSIN

The University of Wisconsin Foundation accepts gift funds for use according to the wishes of the donor. No money given to the foundation can be diverted to the state treasury and the legislature has never attempted to have the foundation use gift funds for projects which should be state-supported. Address: Executive Director, University of Wisconsin Foundation, P.O. Box 5025, Madison, Wisconsin 53705.

UNIVERSITY OF WYOMING

The University of Wyoming assures prospective donors that gifts received will be used only in accordance with their wishes and that contributions will not revert to the state treasury or displace tax funds. In many cases, the university's pledge to carry out the donor's wishes is made a part of the official minutes of the Board of Trustees. Address: President, University of Wyoming, Laramie, Wyoming.
