## FOREWORD

This report summarizes information received from State Research Coordinating Units (RCU's) regarding research activities conducted under Section 131(b) of Part C of the Vocational Education Amendments of 1968. This report covers the second six months of Fiscal Year 1972. The purpose of the report is to provide information that will assist States to be aware of research and development conducted by other States, thus facilitating exchange of information and reducing duplication of effort.

This semi-annual report has been prepared by Carol McDonald of the Program Development and Operations Branch of the Division of Vocational and Technical Education. This is the fifth in a series of reports on the activities of State RCU's. The first report was entitled Annual Report on State Research Coordinating Unit Activities for Fiscal Year 1970 (ED-053-293), and covered the period from July 1, 1969 to June 30, 1970. The second report was entitled Semiannual Report on State Research Coordinating Unit Activities for the Period July 1, 1970 to December 31, 1970 (ED-052-381). The third report was entitled Semiannual Report on State Research Coordinating Unit Activities for the Period January 1, 1971 to June 30, 1971 (ED-067-463). The fourth report was entitled Semiannual Report on State Research Coordinating Unit Activities for the Period July 1, 1971 to December 31, 1971. ## INTRODUCTION

For Fiscal Year 1972, the States received \$9 million under Section 131(b) of Part C of the Vocational Education Amendments of 1968. These funds could be used for paying up to 75 percent of the costs of the State Research Coordinating Unit (RCU) and for grants and contracts covering 90 percent of the costs of research and/or developmental projects. The minimum amount received was \$12,039 by Alaska and the maximum was \$705,568 by California. About 62 percent of the States received more than \$100,000 for research and development.

By the end of the Fiscal Year, more than half of the States reported the expenditure of 1972 funds for grants and contracts. Although a number of States continued to fund projects with carry-over monies from their 1971 allotments, the reduction in funds from the 1971 level had serious consequences for the number of projects funded. Approximately 38.5 percent of the \$9 million was used to support the States' RCU's.

In carrying out their main function of administering the States' R&D programs, the RCU's have provided extensive consultant services to a variety of persons and agencies within the States; provided research findings to interested parties; and assisted the States in long range planning. They have also been instrumental in providing the States with information on States' vocational needs and in evaluating the States' efforts to meet those needs.

In Fiscal Year 1972, reports reflected six research priorities. Career Education ranked high on the list with the States funding component projects, curriculum projects and evaluation projects among others relevant to the concept. The development of educational materials also received a great deal of attention. The States seemed particularly interested in the use of individualized instruction units and multi-media materials. Other areas of research activity included followup studies, programs for the disadvantaged and handicapped, studies to determine manpower and training needs, and programs related to health occupations. In addition to these areas, the States have continued their interest in evaluating, expanding and improving their ongoing vocational programs.

The reports and the approved proposals received from the States by the U.S. Office of Education in Fiscal Year 1972 continued to indicate that the RCU's are providing leadership and guidance in the States' vocational research efforts. Through their dissemination, consultant, and funding activities, the RCU's have been serving increasing numbers of people in their States.

The Semiannual Report which follows is a compilation of State Quarterly Research Activity Reports covering the last two quarters of Fiscal Year 1972 which have been received from the States. Additional information on projects listed under the category of "new projects funded" may be located in the "Research Projects in Progress" section of Abstracts of Research and Related Materials in Vocational and Technical Education (ARM), published quarterly by the ERIC Clearinghouse on Vocational and Technical Education. Final reports of the "projects completed" are abstracted in the monthly issues of Research in Education and/or in the quarterly issues of ARM.

A compilation of the activities reported for the first two quarters of Fiscal Year 1972 has been published as the Semiannual Report on State Research Coordinating Unit Activities for the Period July 1, 1971 to December 31, 1971, and is available from the ERIC Document Reproduction Service. All reported research projects administered by the State educational agency were included in these reports, whether or not they were funded under Section 131(b) of Part C.
