Introduction

A Bibliography of Doctoral Research on the Negro, 1967-1969 is a supplement to the bibliography combiled by Earle H. West, and published by University Microfilms in 1969. Like the original, it lists dissertations covering every aspect of study relating to the Negro in the United States, and extends coverage of the subject through 1969.

The major source used in compiling this bibliography was <u>Dissertation Abstracts International</u>, a monthly publication of Xerox University Microfilms; and the retrospective search of this source material was made through the DATRIX® computer retrieval program.

Dissertations are listed alphabetically by author. Each entry contains, in addition to the name of the author, the full title of the dissertation, the name of the accepting institution, and the date of publication. Also included is a page and volume reference for <u>Dissertation Abstracts International</u>, and the Xerox University Microfilms order number.

PRICES

The price for each dissertation, produced electrostatically, is \$10.00, regardless of length. These are perfect bound, paper covered copies.

If you prefer, books may be ordered bound in cloth, with author and title stamped in gold on the spine, for an additional \$2.25 per volume. If "cloth binding" is not specified in your order you will be shipped and billed for the standard 65 pound paper cover.

FORMAT

The pages are electrostatically copied in numerical sequence. Since we print on one side of a continuous sheet, the finished copy will have printing on the right hand pages only.

Charts, graphs, line drawings and similar data reproduce quite well. Upon request, photographic reproductions, at 50 cents each, can be made of pages where halftone and continuous tone enlargements of higher quality are required.
