
ABSTRACT

The Ohio Program Review for Improvement, Development, and Expansion (PRIDE) in Vocational Education is a comprehensive program review system designed to define, secure, and provide useful information relative to selected vocational education objectives. This document was designed to assist the local vocational education personnel in planning and conducting the self-review activity and is to be used with individual Instructional Program Review Guides developed for each vocational education program. The instructional program self-review and the program review report are described and suggested report outlines provided. Flow charts, implementation phases and other dates for the school year 1970-71, and lists of service representatives, district assignments, coordinators and vocational programs are included. (KP)

Ohio PRIDE in Vocational Education

Purposes and Objectives

Purpose

The primary purpose of this self review program is to improve the quality of vocational education in the State of Ohio. Ohio PRIDE in Vocational Education is a comprehensive system designed to assist vocational teachers, educational planning district administrators and supervisors, plus state personnel as they plan and implement quality vocational education. This program will require group discussion and involvement among the instructional staff, school administration, planning district personnel and state department of education representatives.

Objectives

To provide information relative to vocational education programs for improvement, development, and expansion.

To review the educational process and ascertain the adequacy of the variables identified as (1) curriculum and instruction, (2) facilities and equipment, (3) instructional staff, and (4) students.

To implement procedures for the review of the instructional program product.

To develop a cost analysis procedure which will assist decision-makers in determining priorities for program improvement.

To examine the administrative organization and its contribution to the adequacy of the educational program.

To review the availability of vocational education and its impact upon the community.


To ascertain the community acceptance of the vocational education program.

To recommend by instructional program the need and direction for program improvement.


To assist and report to the educational planning district information for the decision-making process.


To give direction for sound state-wide decision-making to the state vocational division and the service areas.

FOR VOCATIONAL EDUCATION IN OHIO




COMPONENTS OF THE PROGRAM REVIEW SYSTEM
