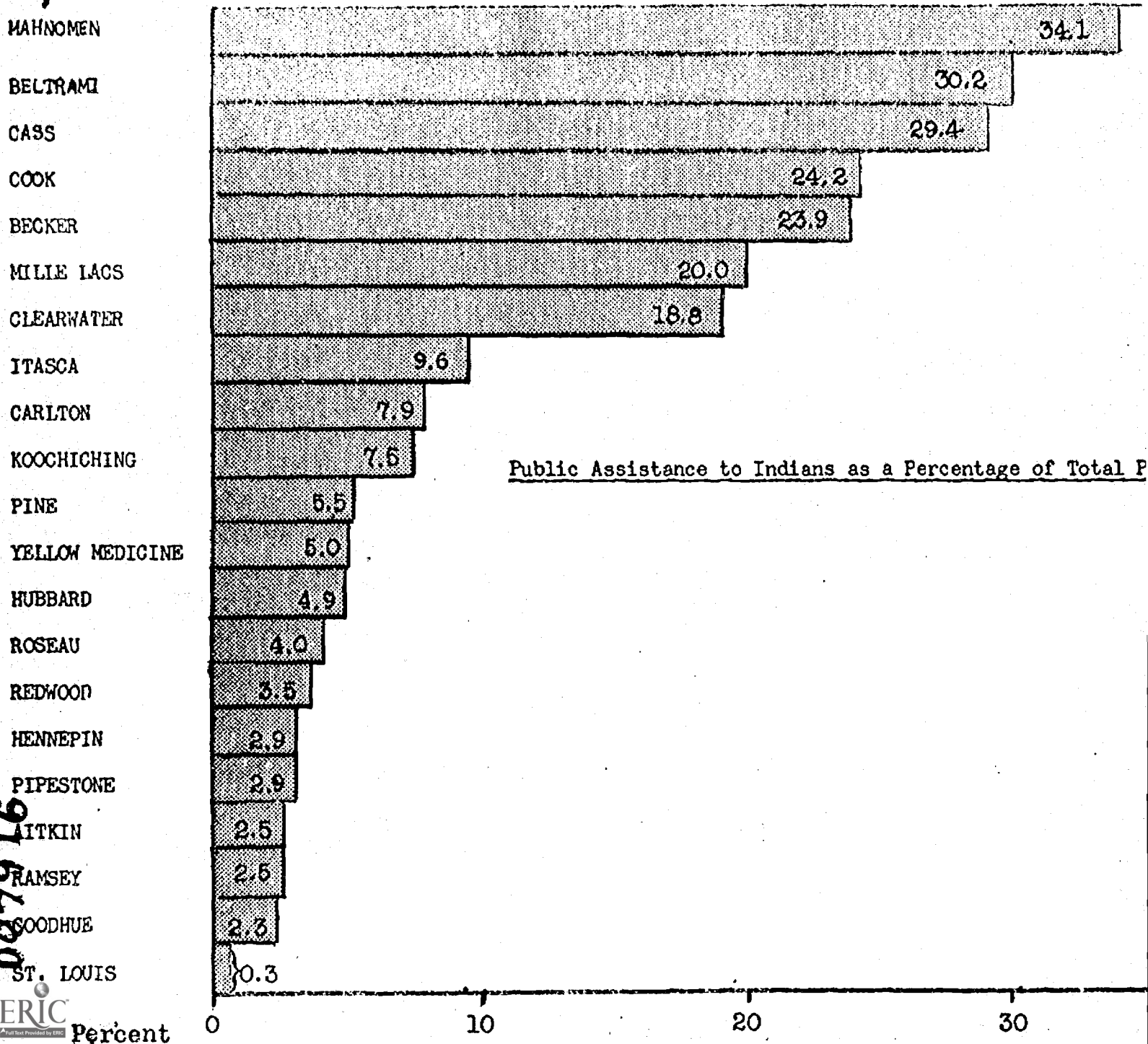
ABSTRACT

The Research and Statistics Section of the Minnesota Department of Public Welfare prepared this 1970 annual report on public assistance for American Indians. Data were gathered from the 21 counties containing a majority of Indians and the City of Minneapolis Department of Public Relief. The report includes data on the State's expenditures for medical assistance, general relief, and federally aided maintenance programs, such as Aid for Dependent Children, Old Age Assistance, Aid to the Blind, and Aid to the Disabled. Data are given in tabular form. (NQ)

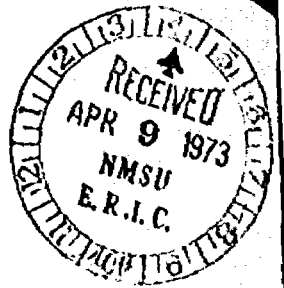

Cost of Care of Minnesota Indians

Calendar Year 1970

Total Public Assistance

The number of Indian recipients of Public Assistance in Minnesota rose 28.8% during the 1970 calendar year. This brings to 18,184 the total number of Indians receiving Public Assistance. In December alone, 6,458 of an estimated 20,000 Indians received PA, a decrease of 7.7% from December, 1969.

Total expenditures during calendar year 1970 were \$7,221,680, an increase of 12.0% from the 1969 total of \$6,447,062. Increases occurred in AFDC, OAA, and AD. GR, AB, and MA dropped. The total PA expenditure to Indians was 4.1% of the total Public Assistance in Minnesota. Average annual cost per recipient during 1970 was \$397.28, a decrease of \$59.31. Money payments to Indians by county in the 21 counties covered in this report ranges from a high of \$2,366,435 in Hennepin County, which includes Minneapolis DPR, to Pipestone County which allocated \$15,885 to Indian Aids.

This report includes data from the 21 counties containing a majority of Minnesota Indians and City of Minneapolis Department of Public Relief. Hennepin County is a Township County, and as such, does not report General Relief. Minneapolis DPR reports GR but none of the aid programs or medical programs. In instances where Minneapolis DPR is not specifically indicated it will be included with Hennepin County. The 1970 GR data for St. Louis County are actual, although no report was received on the aid programs or medical programs. In 1969, St. Louis County was estimated for all programs. Trends reported will be without St. Louis County since historical data is approximate and the new data is incomplete.

General Relief

General Relief expenditures accounted for 17.9% of the total. Including St. Louis County, the \$1,296,337 is a decrease of 22.3% from 1969. Without St. Louis County, the number of families and persons decreased by 3.9% and 9.2% respectively. The average annual payment was \$231.74. Maintenance Relief amounts to 31.6% of GR, while medical care is 13.2%. Decreases in MR are caused by persons transferring from MR to AFDC Unemployed Father. Drops in other aspects of GR can be attributed to transfers of foster care from GR Foster Care accounts to AFDC Foster Care.

Medical Assistance

cal care for Indian recipients totaled \$2,044,325, excluding Louis County, with 7,606 persons receiving payment for an age payment \$268.78 per person. MA Only accounted for \$652,596 (9%) of all medical payments. In the related programs, OAA received \$105,406 (5.2%); AFDC, \$881,887 (43.1%); AB, \$21,710; AD, \$219,268 (10.7%); and GR, \$163,457 (8.0%). In the related programs, substantial increases occurred in AFDC, OAA, and along with GR. AB medical payment dropped 25.9% which was due to one fewer case in 1970 than in 1969. MA Only showed a slight increase with a large drop in the 65+ category offset by smaller increases in 21-64 and under 21 age groups. The three age groups showed a decrease in number of persons. The decrease in 65+ group is caused by transfers of ICF cases from MA Only to AD, and to a small extent OAA, thus accounting for increases in medical care for AD and OAA. Persons in the less than 21 category may be transferred to AFDC Foster Care and AFDC Unemployed Father, thus, the decrease in MA Only Under 21 and the increase in AFDC medical care.

erally Aided Maintenance Programs

Expenditures in the Federally Aided maintenance programs increased each program to a total of \$4,044,475, an increase of \$908,067 (22.7%). Expenditures in each were: AFDC, \$3,542,972 or 87.2% of total; OAA, \$245,852 or 6.1%; AB, \$30,502 or 0.8%; and AD, \$65,149 or 1.6%. The number of persons aided increased 425 to 1,747, 40.0%. This increase reflects a large increase, 434 (44.9%), in AFDC, a small increase from 3 to 5 in AB and decreases of 9 and 1 respectively in OAA and AD. In maintenance AFDC is the controlling program with 87.6% of the expenditure and 94.2% of the recipients. The increase in maintenance is caused by transfers to AFDC from MA Only Foster Care and Unemployed Father cases along with other changes within the programs. How these trends might change in the future of St. Louis County were included both in Maintenance and Medical Assistance programs can only remain speculation but should be accurately reflected.
