Youth for Understanding is a tax exempt, non-profit, educational organization which makes it possible for approximately 5,000 students per year between the ages of 15 and 18 to have an overseas family living experience. More than 2,000 students, primarily from Europe, Asia and Africa, arrive for a year's home stay in August and attend local high schools throughout the United States, and approximately 1,500 Latin Americans arrive for a six month home stay in January. The American students go overseas to live with a family either for two months during the summer or a full year. In the latter case they attend a local school. Youth for Understanding was founded in 1951 and has exchanged more than 45,000 students from 50 countries. The organization seeks students and host families in this country and abroad who are interested in fostering greater international understanding through a family living experience.
