ABSTRACT

This report is an analysis, by nationally accepted classification, of current operating revenue and expenditures for the West Virginia state system of higher education for fiscal year 1973-74. Data are presented for total operating revenue expenditures, regular educational and general revenue and expenditures, percentage distribution of regular educational and general revenue and expenditures to eight sources, regular educational and general revenue and expenditures per full-time-equivalent (FTE) student, sponsored research revenue and expenditure, auxiliary enterprise revenue, student aid revenue, and West Virginia University Medical Center revenue. INTRODUCTION

Since its establishment in 1969 as the governing board for the state system of higher education, the Board of Regents has worked to develop complete data on many aspects of the state system. This annual report is an analysis, by nationally accepted classifications, of current operating revenue and expenditures for the West Virginia state system of higher education for fiscal year 1973-74.

By design, this Current Fund analysis does not include other fund groups, such as Loan Funds (student loans), Agency Funds (institution acting as fiscal agent on behalf of payor), Plant Funds (property acquisition, bond principal payments, new construction, etc.), and the like.

The tables presented in the report attempt to group similar institutions; however, the reader should note that institutions differ even within subcategories and are often not peers for many kinds of comparisons. Such factors as enrollment differentials, scope and levels of programs, funding levels, geographic locations, and others must be taken into consideration.

In West Virginia, the community colleges are considered a peer group and the four-year colleges form another peer group. Marshall University, West Virginia University, the West Virginia College of Graduate Studies, and Potomac State College of West Virginia University are not comparable with each other or with any other West Virginia institution of higher education. Peers for these institutions are found in other states.

This fourth annual financial report, as in the three previous reports, classifies operating revenue and expenditures according to three major categories--Educational and General, Auxiliary Enterprise, and Student-Aid. Data for the Medical Center of West Virginia University are shown separately and constitute another category.

It should be noted that no standard ratio or relationship is expected to exist among the major categories, as institutions vary with respect to the degree to which they undertake to feed, house, and provide services for students, faculty, and staff.

The introduction tables which follow summarize, by institution and by category, operating revenue and expenditures for 1973-74. They show that operating revenue for the state system in 1973-74 totaled 149.5 million dollars and that 148.5 million dollars was spent for current operations.

Following the Introduction, Section One of the report presents and discusses detail data relating to revenue, and Section Two of the report presents and discusses detail data relating to expenditures. The Appendix presents supplemental data concerning regular educational and general revenue and expenditures.

SECTION ONE: REVENUE

EDUCATIONAL AND GENERAL

Educational and general operating revenue or resources are typically classified according to source. This report presents data according to eight sources; a listing and brief description of each follows:

1. State General Fund--Allocations to the colleges and universities by the Board of Regents from the Legislature's annual state system operating appropriation. These allocations are restricted only by West Virginia State Budget Categories of Personal Services, Current Expenses, Repairs and Alterations, Equipment, Individual Accreditation, New Programs, and Unclassified. Amounts that reverted to the State Treasury at the end of the fiscal year are deducted from totals.

2. Student Fees--Revenue available for use by an institution from fees assessed against students for educational and general purposes, plus the amount from the specific "non-resident undergraduate student service fee" allocated to each institution by the Board of Regents. The fees assessed against a student for educational and general purposes include those prescribed fees that must be paid by the student as a condition for (a) applying for admission to the institution, (b) enrolling in the institution, (c) enrolling in specific courses, and/or (d) graduating from the institution. The "non-resident undergraduate student service fee" is a special fee charged to all non-resident undergraduate students attending West Virginia's four-year colleges and universities. Proceeds from this fee are deposited in a special revenue account and allocated by the Board of Regents to the individual institutions primarily for the purpose of eliminating library deficits. The report excludes all fees restricted by West Virginia statute from use as operating revenue.

3. Work-Study Federal--Revenue received from the federal government to be used for the purpose of employing students on a part-time basis.

4. Organized Activities Related to Instructional Departments--Revenue from activities organized and operated in connection with instructional departments primarily for the purpose of providing professional training to students. This includes revenue from specific facilities organized for the purpose of carrying on activities that simulate external enterprises for which students are preparing themselves in college (examples: home economics cafeterias and dental clinics).

5. Community, Public, and Extension Services--Revenue collected and available for use by the institution as a result of extension teaching activities and the operation of public and community service projects.

6. Gifts and Grants--Revenue from private individuals, businesses, industries, foundations, state government, and the federal government which is available for expenditure for educational and general purposes.

This also includes West Virginia legislative earmarked appropriations for the Regional Research Institute, the Bureau for Coal Research, etc.

7. Indirect Cost Reimbursement on Grants--Revenue from the recovery of indirect costs accruing from organized research and other sponsored programs.
8. Other--Revenue for educational and general purposes not included elsewhere (examples: endowment revenue and sales and services of educational departments). Detail information concerning sources of "Other" revenue can be found in Appendix Table D.

State System Analysis

Regular educational and general revenue totaled approximately \$9.7 million dollars for 1973-74 and is detailed in Table 1, by institution, according to the eight sources.

One helpful approach in analyzing operating income for regular educational and general activities is to consider the percentage relationship of a particular income source to the total net income. This technique reflects the comparative degree of support provided by a specific income source. Such analysis, by institution, is provided in Table 2 and is graphically illustrated for the state system in Figure 1.

Another approach in analyzing regular educational and general operating income is to consider income on a per full-time-equivalent (FTE) student basis. The FTE student is the nationally accepted means to translate student credit hours produced by an institution into a more manageable statistic. This approach, which is shown in Table 3, is best used when comparing peer institutions. It should be noted that regular education revenue increased less than \$30 per FTE student in 1973-74 over 1972-73.

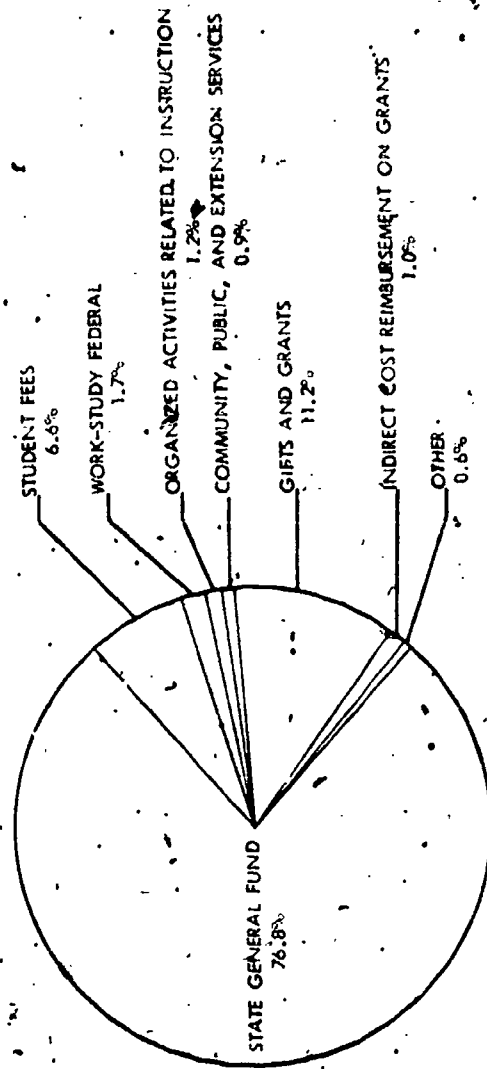

State General Fund

As previously shown graphically, over three-fourths of all educational and general revenue for the public colleges and universities was appropriated from the State General Fund.

This major source of revenue totaled \$1,420.09 per FTE student in 1973-74, up only 2.5 per cent from the previous year. The dependency of West Virginia's state system of higher education on State General Fund tax support cannot be denied. See Appendix Table A for additional detail.

Student Fees

In West Virginia, the amount of student fee revenue available for regular educational and general purposes at the public colleges and universities (except at the community colleges) is quite low when compared to other states. The primary reason for this is that most student fees collected at the state colleges and universities (except at the community colleges) are restricted as to use by state statute. In some situations, the pledge is to capital outlay; in others, the collected fee is required to be deposited directly in the State General Fund. In either situation, the use of the fee collections for educational and general operations is prohibited.

The fees charged students attending the state's three community colleges are retained to provide financial support to the respective institutions. Predictably, the three community colleges show a higher percentage of revenue from student fees than the other institutions whose student fees are restricted as to use.

It should be noted that the West Virginia policy of restricting most student fee income for capital outlay or for direct deposit in the State General Fund differs from the traditional method of financing public higher education in most states and consequently causes West Virginia's revenue pattern to be skewed when compared to other states or to national averages.

Appendix Table B provides additional information concerning student fee revenue, including a detail of fees collected and retained for use by the institutions, as well as amounts of "special fee" revenue reallocated by the Board of Regents. Early in its operation the Board was made aware of the extensive deficit in library holdings of the state colleges and universities. In 1971 a six phase plan was developed to eliminate existing deficiencies and a special "Non-Resident Undergraduate Student Service Fee" was established to provide the required financing.

Gifts and Grants

Revenue from Gifts and Grants, which approximated 10 million dollars in 1973-74, represented 11.2 per cent of the total for the state system of higher education and was the second largest source of income. However, revenue from gifts and grants declined by 4.1 per cent from 1972-73. Amounts reported from this source under the heading "Regular Educational and General Revenue" include all gifts and grants earmarked for general administration, instructional programs, community, public,

and extension services, and libraries. Restricted gifts and grants for research are reported as sponsored research and are reflected in Table 4. Appendix Table C details regular educational and general gifts and grants income of nature (restricted, land grant,

Other Sources

A few comments are appropriate concerning three of the five remaining sources of revenue.

The amount of funds available for Work-Study Federal, while only 1.9 million dollars or 1.7 per cent of total, showed a decrease of 11.5 per cent from 1972-73.

Income from Organized Activities Related to Instructional Departments represented 1.2 per cent of total and was slightly more in 1973-74 than in 1972-73.

Income from Community, Public, and Extension Services totaled .8 million dollars systemwide, a decrease of 30.4 per cent over 1972-73.

Transfers

Also shown in Table 1, by institution, is the total amount of regular educational and general revenue transferred for other uses. These transfer actions reflect decisions, by the respective institutions, to use regular educational and general revenue for other purposes. Examples of transfers made in the state system are to auxiliary enterprise operations, to capital outlay accounts, and similar transfers.

IMPACT OF SPONSORED RESEARCH

Sponsored research includes amounts from governmental agencies or other outside organizations or individuals for specific research projects for which payment is made in accordance with contracts, grants, or other written agreements.

As stated previously, sponsored research, even though an educational and general activity, is presented and analyzed separately from the regular educational and general component.

There are basically two reasons for separating sponsored research revenue from regular educational and general revenue. First, sponsored research revenue typically flows on a project-by-project basis with no generally predictable revenue pattern. To include such revenue with regular educational and general revenue may lead to distortions and incomparability of data on a year-to-year basis. Second, there is considerable variation in the extent to which comparable institutions seek sponsored research; therefore, to include sponsored research revenue as regular educational and general revenue would make meaningful comparisons difficult.

As shown in Table 4, most sponsored or contractual research was undertaken by West Virginia University, the state's comprehensive land-grant university. Sponsored research for 1973-74 decreased over 16 per cent from the previous year.

AUXILIARY ENTERPRISE REVENUE

Included here is all revenue for the enterprises operated by the institutions primarily for the purpose of providing services of a non-educational nature to students, faculty, and staff.

Table 5 shows auxiliary enterprise revenue, detailed by operation, for 1973-74. Each operation is further detailed showing gross receipts, transfers, and net revenue. Gross receipts represent the total income "earned" by the operation during 1973-74. This includes revenue from earmarked fees (example: athletic fee) as well as collections for services rendered (example: meal charges). Transfers represent a change in the use of funds. This is accomplished by moving assets from one fund group to another (example: current funds to plant funds) or from one category to another within a fund group (example: educational and general to auxiliary enterprise). Net revenue is gross receipts plus or minus any transfers.

West Virginia's colleges and universities transferred funds both "in" and "out" of auxiliary enterprise operations during 1973-74. In the state system, the transfers "in" primarily represented direct educational and general revenue subsidies to certain auxiliary enterprise operations, while the transfers "out" primarily represented transfers to plant funds for board principal and interest payments.

When the situation exists whereby educational and general revenue is used to support an auxiliary enterprise activity, it should be recognized that the users of the auxiliary enterprise service (e.g., those who attend intercollegiate athletic events) are being subsidized by those (students) who do not. Conversely, when auxiliary enterprise revenue is used to support an educational and general activity, those users (students) are being subsidized by non-users (intercollegiate athletic spectators).

Each institution varies in the degree to which it endeavors to provide housing, dining, and other non-educational services to its students, faculty, and staff. As revealed in Table 5, the bulk of net revenue from auxiliary enterprise operations was derived from housing and dining (50.9 per cent), bookstore (24.1 per cent), intercollegiate athletics (13.9 per cent), and student union (10.7 per cent). It should be noted that several institutions provide cafeteria services within the operation of the student union. Therefore, the student union enterprise is not comparable among the institutions.

STUDENT AID

Student aid revenue includes all gifts, grants, endowments, etc., specifically designated for scholarships, fellowships, prizes, and other forms of student assistance. It does not include revenue for student loans, student employment, and service scholarships when service is required of the recipient.

Table 6 shows total student aid revenue for 1973-74. Revenue for 1973-74 decreased \$58,170 or 1.7 per cent over the previous year.

Revenue for the West Virginia University Medical Center as shown above accounted for 21.6 per cent of the total revenue for the state system. During 1973-74 the Medical Center generated about one-half per cent more revenue than was needed to cover expenditures.

Revenue for the West Virginia University Medical Center is shown in Table 7 according to source. A listing and brief description of each source follows:

State Appropriation: State General Fund--Includes amount from the State General Fund appropriated by the Legislature for the West Virginia University Medical Center.

State Appropriations: Soft Drink Tax--Includes amount collected and available for the West Virginia University Medical Center from the dedicated tax assessment on soft drinks.

Hospital Receipts--Includes revenue collected in connection with providing patient care in the teaching hospital.

Research and Development Contracts, and Other--Includes revenue from private individuals, businesses, industries, foundations, state government, and the federal government available to the Medical Center for restricted use for educational, research, and general purposes. Also includes miscellaneous income such as tuition and fee charges.

Medical Center Staff Gifts--Includes revenue, from the Professional Fees Office, generated by members of the Medical Center staff.

Operated in conjunction with the Medical Center is an auxiliary enterprise operation--university hospital cafeterias.

SECTION TWO: EXPENDITURES

EDUCATIONAL AND GENERAL

Included in this category are expenditures for the educational, research, and community, public, and extension service activities of the state system of higher education as well as the necessary supporting activities of general administration, general institutional expenses, student services, libraries, and physical plant operation and maintenance.

The report classifies educational and general expenditure data according to eight functional categories. They are:

1. General Administration and General Expenses--Includes all expenditures of the general executive and administrative offices serving the institution as a whole as well as those expenditures of a general character not relating to any specific division or segment of the institution.
2. Student Services--Includes all expenditures for services to students, such as admissions and registrar's office, guidance and counseling service, placement service, health service, dean of students' office, and the like.
3. Instruction--Includes all expenditures of the instructional departments and schools of the institution, such as instructional salaries, office expenses, laboratory expenses and replacement equipment, student teaching, and other related operating expenses. Also includes departmental research which is not separately budgeted or financed.
4. Organized Activities Related to Instructional Departments--Includes all expenditures for enterprises organized and operated in connection with instructional departments and conducted primarily for the purpose of giving professional training to students, such as home economics cafeterias and dental clinics.
5. Libraries--Includes the total expenditures of the institution for separately organized libraries, both general and departmental.
6. Community, Public, and Extension Services--Includes all expenditures for educational and other activities designed primarily to serve the general public. Also reported here are the costs of all extension activities including courses offered for extension credit.
7. Physical Plant Operation and Maintenance--Includes all expenditures for the operation and maintenance of the physical plant, such as the care and maintenance of grounds, utilities, custodial service, etc.
8. Organized Research--Includes all expenditures for separately organized research divisions, such

as research, bureaus, research institutes, and experiment stations. Includes all research separately budgeted or financed by an institution, but excludes departmental research not separately budgeted or financed. The report presents contractual research separately from institutionally organized research.

A statement regarding four institutions--the West Virginia College of Graduate Studies, Parkersburg Community College, Southern West Virginia Community College, and West Virginia Northern Community College--must be made prior to any detail analyses of the expenditure patterns for these particular institutions or for the state system.

The College of Graduate Studies began operation July 1, 1972. It is a master's degree granting institution with a predominately part-time enrollment, a sizeable part-time or shared faculty, and utilizes the physical facilities of other institutions. As such, it would not be expected to have the same expenditure pattern as a traditional institution.

The three community colleges are developing institutions in a transitional status from single-purpose branch colleges to comprehensive community colleges. Parkersburg and Southern West Virginia Community Colleges were in their third year of operation during 1973-74, whereas West Virginia Northern was in its second year of operation. Expenditure patterns during these developmental years are expected to deviate from norms for established institutions.

State System Analysis

Table 8 shows regular educational and general expenditures for 1973-74, by institution, by the eight functional categories. Expenditures totaled 89.4 million dollars in 1973-74, up 4.8 million dollars from the previous year. On a percentage basis, this increase was 5.7 per cent, less than the annual rate of inflation.

One method used to analyze regular educational and general expenditures is to divide the dollar expenditure for each of the functional categories by total expenditures to arrive at a "per cent of total" statistic for each functional category. This technique reflects not only the adequacy of support for one function compared to that given another function, but it also reflects the emphasis a particular institution places on the various functions.

Studies by statewide coordinating and governing boards, the United States Office of Education, Dr. John Dale Russell, and others provide a useful base for interpreting "percentage distribution" data. The following distribution is a synthesis based on these studies and is suggested as a helpful guide to the reader:

7-10 per cent for general administration and general expenses

5-6 per cent for student services

53-60 per cent for instruction and departmental research (for comprehensive universities, percentage may be less, because of emphasis on community, public, and extension services and on organized research)

0-6 per cent for organized activities related to instructional departments

3-7 per cent for community, public, and extension services (for comprehensive universities, percentage may be more)

0-2 per cent for organized research, excluding sponsored research (for comprehensive universities, percentage may be more)

5-6 per cent for libraries

10-15 per cent for physical plant operation and maintenance

Figure 2 graphically illustrates the systemwide "percentage distribution" of regular educational and general expenditures to the eight functional areas. As shown in Table 9, institutional distributions fall generally within the above guides.

Another method of analyzing regular educational and general expenditures is on an expenditure per unit of service basis. One unit of service commonly used in higher education is the student credit hour. West Virginia, like other states, translates student credit hours into the more manageable statistic "full-time-equivalent (FTE) student."

Dividing total educational and general expenditures by the number of FTE students yields a statistical expenditure per FTE student. Table 10 shows the expenditure per FTE student detailed by functional category. This statistic is most useful in comparing similar institutions.

Using the student credit hour as the unit of service reflects the impact of size on similar institutions; in

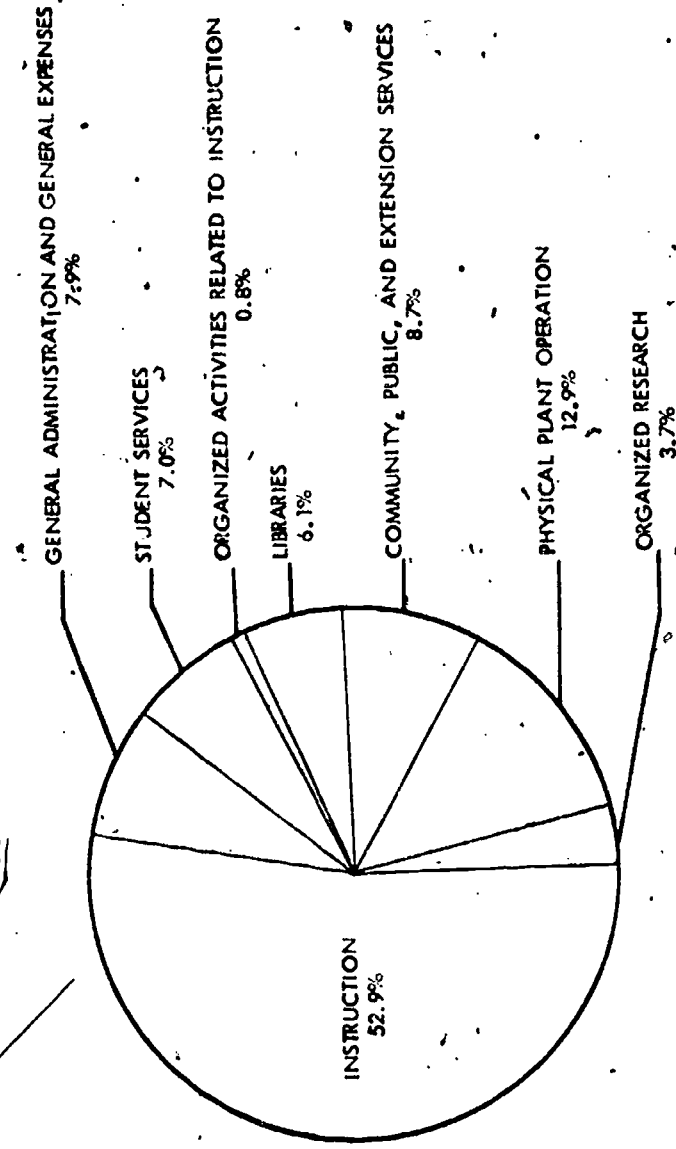

fact, this technique more than any other shows the inherent high costs associated with small institutions.

General Administration and General Expenses

Systemwide, expenditures for this functional category totaled approximately seven million dollars in 1973-74. The analysis Tables 9 and 10 show that, as a per cent of the total expenditure dollar, this category increased slightly over the previous year to 7.9 per cent. The amount shown per FTE student is \$144.65, up 13.5 per cent from 1972-73.

Appendix Tables E, F, and G contain detail information concerning expenditures in this functional category.

Student Services

Expenditures in this functional category totaled approximately 6.2 million dollars in 1973-74, an increase of 2.7 per cent over the previous year.

A review of Appendix Table H, which details Student Services data by various activities, shows that approximately one-third of all expenditures for student services were incurred for student activities.

Instruction and Organized Activities Related to Instructional Departments

In 1973-74 the state system spent 47.2 million dollars in the functional category Instruction. This represented, for the fourth year in a row, over 50 per cent of the total regular educational and general expenditure dollar. Systemwide, the expenditure on a per FTE student basis was \$972.75, up 3.1 per cent from 1972-73.

In March 1973, the Board of Regents published an in-depth study related to instructional costs entitled Volume and Cost of Instructional Activity, Public Colleges and Universities in West Virginia, Fall Term 1972. This document can provide the reader with additional data concerning costs of instructional programs.

Five institutions reported expenditures in 1973-74 for Organized Activities Related to Instructional Departments. Such activities vary greatly among the several institutions; however, very little impact was made upon the expenditure pattern for the state system. As revealed in Table 9, less than one per cent of total expenditures was devoted to this category.

Libraries

Because of the impact of the Board of Regents' plan (initiated in 1971-72) to eliminate existing library deficiencies, it would be expected that expenditures for libraries at West Virginia's public colleges and universities would exceed the 5-6 per cent suggested guideline. However, reference to Table 9 reveals a wide variation among institutions in per cent of regular educational and general expenditure dollar devoted to libraries--ranging from a low of 3.8 per cent to a high of 15.7 per cent.

Three points should be emphasized regarding expenditures by West Virginia public colleges and universities for libraries in 1973-74:

- (1) Existing deficiencies would justify greater-than-normal-year expenditures to move toward minimum standards.
- (2) Developing institutions would have immediate large outlays in order to achieve recommended standards as quickly as possible.
- (3) Expenditures at the desired level might not be beneficial because of limited physical facilities available for technical services (cataloging and shelving of books, etc.).

Detail information concerning library expenditures can be found in Appendix Table I.

Physical Plant Operation and Maintenance

During 1973-74, the state system spent 11.5 million dollars or 12.9 per cent of the total regular educational and general expenditure dollar for physical plant operations. Institutional detail in Table 9, however, reveals a substantial variation in expenditure patterns among the institutions. Partially by design and partially because of their developing nature, expenditures by the three community colleges and the College of Graduate Studies are expected to be less than the 10-15 per cent suggested guideline for this functional category.

The failure of an institution to spend necessary funds annually in this category, particularly in the area of preventive maintenance, results in extensive long-range costs. A building quality survey of the facilities at institutions in the state system was conducted for the Board by an independent consulting firm. This survey revealed numerous facilities in poor condition and a variety of safety deficiencies. The institutions have made progress towards improving these conditions; however, more "catch-up" is required.

A detail of physical plant expenditures is provided in Appendix Table J.



Community, Public, and Extension Services

Expenditures for the functional category Community, Public, and Extension Services totaled 7.8 million dollars in 1973-74, down 7.5 per cent from the previous year. However, recognizing the current national interest in community and public services, and assuming adequate financial resources, future expenditure patterns at most institutions will show increasing emphasis on this functional area. West Virginia University, the state's land-grant and comprehensive university, can also be expected to continue to exceed the general guideline.

Organized Research

Only West Virginia University incurred expenditures in the functional category Organized Research in 1973-74. As reflected in Tables 8 and 9, West Virginia University increased expenditures in this category 21.5 per cent over 1972-73. However, in terms of actual dollars and as a percentage of total expenditures the 1973-74 expenditures in this function were less than in 1971-72.

IMPACT OF SPONSORED RESEARCH

Just as sponsored research revenue is shown separately as an addition to regular educational and general revenue to arrive at grand total educational and general revenue, Table 11 reflects the impact of sponsored research expenditures on regular educational and general expenditures.

As shown in Table 11, over 95 per cent of all sponsored or contractual research was undertaken by West Virginia University.

AUXILIARY ENTERPRISE EXPENDITURES

Auxiliary enterprise services are intended to be "self-supporting;" that is, each auxiliary activity should generate sufficient revenue to defray all operational costs.

Application of the "self-support" test has two interpretations. The first, or individual test, holds that each service should be wholly self-supporting. The second, or group test, applies the "self-support" concept to the auxiliary enterprise operations as a group; thus, the surplus revenue from one operation is used to subsidize less profitable activities.

As was mentioned in earlier discussion, during 1973-74 regular educational and general revenue was transferred to certain auxiliary enterprise operations as a subsidy to these operations. Such transfers are not uncommon when auxiliary enterprise expenditures exceed revenue; however, it does indicate the need for detailed studies of both charges for services and methods of operations.

Table 12 indicates that the College of Graduate Studies had no auxiliary enterprise operations during 1973-74 and the three community colleges sponsored only minimal operations. Since the student bodies of these institutions are commuting students rather than resident students, the necessity for these services is vastly reduced.

Expenditures for the West Virginia University Medical Center, as shown above, are reported according to the categories listed below; a brief description of each follows:

General Administration and Supporting Services--Includes expenditures of the general and administrative offices serving the entire Medical Center and expenditures of support services, such as Animal Quarters, Electronics Lab, etc., serving the entire Medical Center.

Instruction: Morgantown Center--Includes expenditures of the instructional departments of the schools of the West Virginia University Medical Center. Includes such items as instructional salaries, office expenses, laboratory expenses and replacement equipment, and other related operating expenses.

Instruction: Charleston Division--Includes expenditures in connection with the establishment of a division office of the Medical Center in the Charleston area to bring about an expanded production of health professionals. Note: 1972-73 was the first year of operation as the "Charleston Division."

Hospital Operation--Includes expenditures in connection with the operation of a teaching hospital. The hospital is an integral part of the West Virginia University Medical Center.

Public Service--Includes expenditures for educational and other activities designed primarily to serve the general public.

Physical Plant Operation and Maintenance--Includes expenditures for the operation and maintenance of the physical plant, such as custodial service and the care and maintenance of grounds.

Operated in conjunction with the Medical Center is an auxiliary enterprise operation--university hospital cafeterias.
