

ABSTRACT

This directory of all postsecondary career-technical programs offered in West Virginia is divided into three major sections. The first section includes information about programs offered by proprietary institutions, by program type; institution name and address, chief officer's name and title, accreditation and/or affiliation, time required in weeks and hours, and type of award are listed. The second section includes information about programs offered in area vocational-technical centers; location, name of facility, programs offered, time required in hours and months, and type of award are listed. The third section lists information about programs offered in two- and four-year institutions of higher education; institution name and address, programs offered, and types of awards are included. All data were accumulated during the latter months of 1974 and reflect existing institutions and programs as of December 31, 1974. (DC)

## INTRODUCTION

BEST COPY AVAILABLE

Section 1202 of the Federal Higher Education Act of 1965, added by the Education Amendments of 1972, authorized the establishment of a Postsecondary Education Commission in each of the States, with broad authority to conduct planning for postsecondary education. The enabling legislation specified that the membership of the Commission should be, "broadly and equitably representative of the general public and public and private non-profit and proprietary institutions of postsecondary education in the State including community colleges (as defined in Title X), junior colleges, postsecondary vocational schools, area vocational schools, technical institutes, four-year institutions of higher education and branches thereof."

The West Virginia Postsecondary Education Commission was established in 1974 by Executive Order Number 4. At its August 13, 1974 meeting, the Commission specified three planning activities to be accomplished during the 1974-75 academic year. This publication, an inventory of all two-year career technical programs offered in West Virginia, represents the first of these three projects to be completed.

The objective throughout the formulation of this booklet was to bring together in one place essential information pertaining to all postsecondary educational opportunities in formal education, normally consisting of two years or less duration, offered throughout the State. This concept was applied to institutions in the proprietary, private and public sectors.

The directory should be of value to counselors at all levels throughout the State, to administrators, and to student or potential students seeking information as to programs available to them.

The data reflected in this publication were accumulated during the latter months of 1974, and reflect existing institutions and programs as of December 31, 1974.
