ABSTRACT

Developed by the Housing and Urban Development (HUD) library to meet the recent surge of interest in ethnic minorities and their problems, this annotated bibliography on community development relative to American Indians is divided into two parts. Utilization material published between 1969 and 1974, Part 1 presents 403 citations which are author indexed and organized under the following subjects: (1) Background (sociocultural); (2) Government Relations; (3) Legal Aspects; (4) Demographic Distribution; (5) Cultural and Social Indicators; (6) Community Development and Economic Conditions; (7) Education; (8) Health; (9) Housing; and (10) Problems of Urbanization. Specialized bibliographies at the end of each subject section supply sources for further research. Part 2 presents a special section of 365 publication citations produced via Comprehensive Planning Assistance Program funds which may be found in HUD's regional offices, the Headquarters Library, and various State and university libraries. Indexed geographically, these publications on planning are also indexed via the Key Word in Context (KWIC) index which includes an accession number, a title (key word or words), report date, State, and geographic place name. FOREWORD

The recent surge of interest in ethnic minorities and their problems has prompted the publication of this bibliography, developed by the HUD Library at the request of the Assistant Secretary for Equal Opportunity.

A selection of items detailing the North American Indians' history and relations with the Federal and State governments precedes the sections of recent materials that concentrate on current social, economic, health and education concerns, and community development. Specialized bibliographies at the end of each section supply sources for further research.

HUD has no legislated programs dealing specifically with Indian housing and community development. However, the 1974 Housing and Community Development Act does particularly provide, from the aggregate of public housing contracting, a "set-aside" for housing in Indian areas. An Indian Housing Handbook is currently in preparation.

In addition, HUD makes community block grants, and, through the Comprehensive Planning Assistance (701) Program, furnishes funds to tribal councils and State agencies for planning and management assistance. A special section of publications produced with Planning Assistance funds is included as Part II. These may be consulted in HUD's Regional offices, the Headquarters Library, and various State and university libraries.

Please consult your local library for all other items, or order from the publisher, or bookstores, since HUD distributes only its own publications. Numbers in parentheses following the book citations are HUD Library call numbers.
