ABSTRACT

The United States Office of Education has funded under ESEA V, Section 505, a network of regional projects called the Interstate Projects for State Planning and Program Consolidation since January 1968. The participants in the projects include all 50 state education agencies and the departments of education in U.S. possessions and territories. The purposes of the network are: (1) to identify, analyze, and work cooperatively on current and emerging educational problems of common concern to all or most of the participating states and territories; (2) to innovate, pilot, and develop methods that can be used by state education agencies to strengthen their leadership and service capabilities; (3) to plan, develop, and implement staff development programs that will improve state education agency personnel skills in solving identified problems; and (4) to improve and stimulate intercommunication and dissemination of promising solutions to educational problems among participating agencies and the U.S. Office of Education. The purpose of this document is to improve interproject communication by presenting the regional Interstate Projects in a concise form. 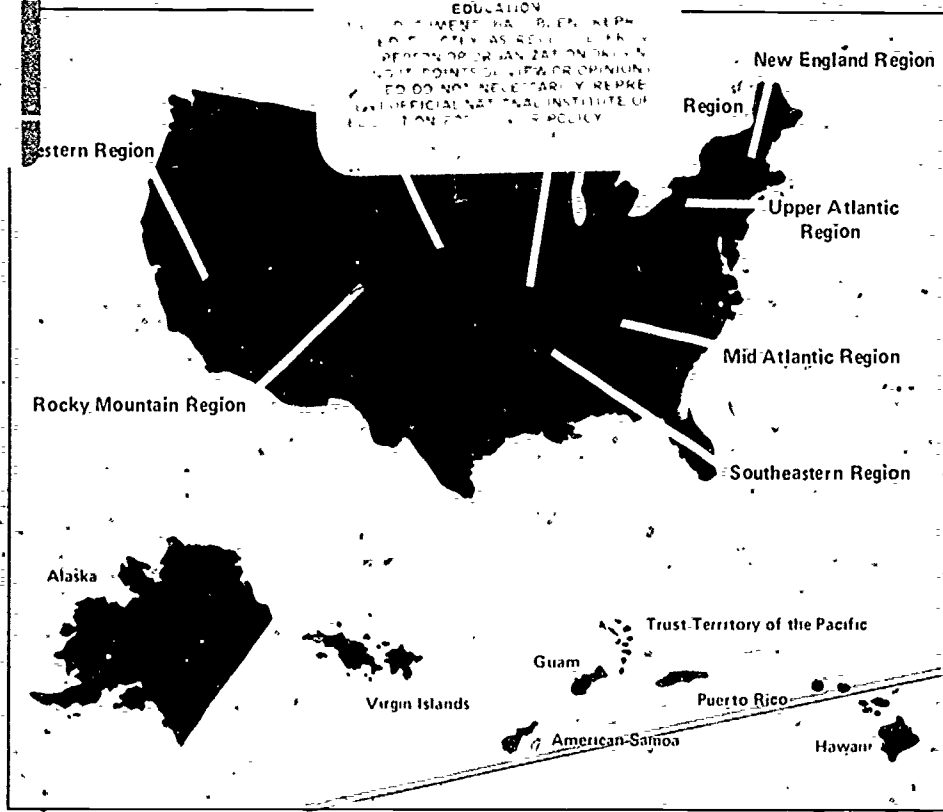

Project Products of Previous Years

The Interstate Project has been partially responsible for two of the participating states in submitting applications to the National Center for Educational Communications. Both of these projects are currently operational and providing information services to local schools.

A user needs survey to identify information needs in each of the six states has been completed. Mid Continent Regional Laboratory is processing the questionnaires and the final report should be forthcoming. Interviews of a representative sample of SEA personnel were conducted in each of the state agencies in an attempt to identify communication problems. Regional Project Objectives

1974

1. At the end of the year state governing boards, departments of education, local boards of education, legislative committees, and organized groups of administrators, teachers, parents and students in the participating states will have determined their respective, shared responsibilities for public education and will have adopted statements of acceptance, such statements to be developed by at least five of the above agencies or groups in each state.

2. At the end of the year the project will have developed a pilot plan and specifications for material to be used in the training of personnel from selected agencies and organizations having shared responsibilities for public education in a program of shared accountability.
3. At the end of the year a dissemination plan will be developed, designed to familiarize agencies, groups and individuals in the Mid-Atlantic Region, and other SEA's and interested agencies and groups throughout the nation, with: (a) the concept of shared accountability, (b) the process of involving people and securing commitments to the concept, and (3) the materials to be used.
4. At the end of the year evaluations, including quarterly and an annual formative evaluation, will be completed and a three year summative evaluation will have been planned.

Project Products of Previous Years

During the first year of operation of the Project, 1968, the focus was on the preparation of State Plans for state administration of ESEA, Title III. The result was that each state in Region III produced an approvable State Plan which is still the basis of the administration of Title III. Some attention was given, also, to planning activities and techniques appropriate to State Departments of Education.

During the second year of operation attention was centered on a discussion of the elements involved in the educational planning process, the development of a planning capability in each State Department of Education, and the relationship of State Departments of Education planning to planning in local education agencies.

In 1970, the Project Steering Committee and the Chief State School Officers decided to focus their attention on educational planning in general with particular attention to four main areas. These areas were:

- a. The development of management information systems.
- b. Evaluation systems.
- c. Assistance by SEA's to LEA's in educational planning.
- d. The development and use of objectives in educational planning.

Certain states assumed the leadership in each of these four areas in view of work which had been or was being done in their various departments.

One conference was held during the year devoted to each of the four topics mentioned above and appropriate consultants were employed to assist in these conferences.

While results of the activities during 1970 are not completely clear, it is recognized that North Carolina and West Virginia have benefited as they have attempted to develop more effective management information systems, that Virginia, Kentucky, and Puerto Rico have expanded and refined their capabilities for extending assistance to local agencies in planning and developing useful materials in this field. The District of Columbia has initiated an evaluation system which has been improved as a result of the work of the project, and Maryland and the Virgin Islands have benefited from their work in training staff members in the preparation of measurable objectives.

Project Products of Previous Years

The 505 model is an articulation of the theme *Futures Management* as it developed from the reference frame of futures planning techniques and humanistic management techniques. The model results from the effort of the trainers to present a coherent, cogent explanation that draws together the threads presented in the first two training sessions and the original proposal. The model should be considered a first approximation and thus subject to improvement through actual implementation.

Another major product of this interstate project continues to be ongoing and expanding communication networks, trust, and an exchange of expertise among the trainees across state lines. The willingness of persons within each state department to initiate coherent change has been developed and continues to be reinforced.

Among the papers produced and circulated among the SEA's participants in the conferences and workshops on student unrest are reports from *Massachusetts Summary Report of the Massachusetts 505 Conference on Student Unrest*, a comprehensive report on identification of issues and discussion groups by the Rhode Island Department of Education, *Student Unrest and New Hampshire Public Schools*, Dr. Allan R. Cohen, an analysis of four educational activities in New Hampshire that tend to decrease student unrest, Position Paper, Dr. Joseph Ferreira, an analysis of the same four activities from a sociological point of view, Position Paper, Dr. Otto Lerbinger, an analysis from a communication point of view of the same activities, and *Interstate Activities on Student Unrest*, a complete summary of instate activities and interstate conference on student unrest.

A descriptive summary of the project activities during 1969 and 1970 is provided in a publication entitled *Interstate Activities on Student Unrest, 1970*. This paper is available on request from the New Hampshire Department of Education, or the Wisconsin Department of Public Instruction.

Regional Project Objectives

1. To inventory all existing alternative schools and programs in the seven state area, and to list and describe exemplary programs outside that area. (To be directed by the New Jersey and New York State Department of Education.)

2. To provide an annotated bibliography of resources relating to alternative education. (To be directed by the New Jersey State Department of Education.)
3. To provide an in depth appraisal of selected alternative programs. (To be managed by the Pennsylvania State Department of Education.)
4. To develop position papers on policy issues relating to alternatives in education, particularly their financial, legal, political, and professional implications. (To be directed by the New Jersey State Department of Education.)
5. To design a dissemination strategy for the ICEIT television-managed instruction program, a media approach to alternative education developed by the New York State Department of Education.
6. To refine a bicultural alternative model developed by the Connecticut State Department of Education.
7. To plan a three day conference on alternatives in education. (To be managed by New York and New Jersey State Department of Education.)

Anticipated Products, Outcomes

The study will identify five types of literature concerning alternatives in education, including:

1. The literature that provides a critical analysis of the existing educational process in contemporary society (critical interaction);
2. The theoretical considerations of a progressive reform of the school in terms of alternatives in education (reform literature);
3. The reconstructionist literature that facilitates and enables transformation to occur, and provides examples of that change in demonstrated alternatives (reconstructional literature);
4. The experiential literature that portrays varieties of alternative methods in education (experimental literature);
5. The directories, manuals and clearinghouse information.

Several specific publications are being prepared for dissemination this spring in the seven states and territories comprising the Upper Atlantic Interstate Region.

1. *Basic Bibliography on Alternative Education* – a four page brochure containing the basic literature in the field with an emphasis on usage by local school districts for policy formation and workshop discussion (May, 1974).

2. *An Annotated Bibliography on Alternative Education* – a 24 page booklet containing an introductory essay on alternative literature and comprehensive reviews of publications in the field. The intended use of this piece is for local and state level persons wishing to deal with in depth material and policy formation (June, 1974)
3. *Catalogue of Alternative Schools* – an 84 page, descriptive catalogue of alternative schools and programs in the seven states and territories.

This catalogue will provide typological and descriptive information on identified alternative schools in the states as compiled by survey and be supplemented by on-site visits in a separate report.

4. *An Issue Paper on Alternatives in Education* – this paper is a 50 page policy paper prepared in two parts. Part I considers the alternatives movement and the implications for local and state education leaders, Part II outlines four hypothetical positions that might be taken by state departments of education on alternatives in education.
