ABSTRACT

This selective bibliography is divided into 2 main sections. The first deals with Chinese-English contrastive studies and lists 8 books, or sections in books, and 19 journal articles. The second section deals with error analysis for Chinese speakers learning English and lists 4 articles. The entries range in date from 1948 to 1974 with the majority published since 1965. The books cited are mostly Chinese or American publications and the articles appeared in well-known Chinese or American pedagogical language journals.
