ABSTRACT

Included in this document are two competency-based tests created to evaluate candidates for Basic Media Endorsement and Professional Media Endorsement. There are two forms for each test, and each test emphasizes the skills required to evaluate and select media materials. Questions can be answered in writing, orally, or on audio cassette tapes, and answers are intended to be evaluated by a team of three judges. (EMH)

EVALUATION AND SELECTION

These criterion based competency tests for evaluation and selection have been developed in such a way that the candidate taking the test may complete it either in written form, orally, or with the aid of an audio cassette tape. It is up to the candidate to decide which medium he/she chooses to utilize when taking the test.

#### FORMS ONE AND TWO

Two forms of this test have been created for Basic Media Endorsement with two additional test forms developed for Professional Media Endorsement. Before qualifying to take the Professional Media Endorsement test, the candidate must have successfully completed the test dealing with Basic Media Endorsement.

In order to "pass" one of the tests, the candidate must have scored, to the satisfaction of the evaluator's, satisfactorily on every question within that individual test. As stated above, competency will be decided by the team of evaluator's analyzing the results of the tests.

The candidate may choose the form of the particular test category (i.e. Basic Media Endorsement and Professional Media Endorsement) he/she is taking. Two forms of each testing category have been provided.

#### TIME LIMITS FOR TESTING

A two hour time limit has been set for the Basic Media Endorsement test with a forty-five minute time limit allotted for the Professional Media Endorsement test.

### EVALUATION

Because there are so many possible answers for each test item, only sample answers have been provided in efforts to give the panel of evaluator's a general idea of the type of answer the candidate should respond with.

A panel of three evaluator's will analyze the responses of the candidate. Following this evaluation, it is suggested that the panel meet personally with the candidate to discuss results of the test.

Because of the nature of the tests, it is imperative that the evaluator's have an adequate background in the field of evaluation and selection.

### MATERIALS NEEDED FOR TESTING

In order to complete these tests certain materials, available at each testing location, will be needed. These necessary materials include a variety of selection tools, (Booklist, Library Journal, etc.), for objective One of the Basic Media Endorsement test, and audio tapes, books, periodicals, newspapers, reference books and 16MM films for Objective One of the Professional Media Endorsement test.

In addition, the following hardware will be needed for Objective One of the Professional Media Endorsement test:

Form One: One - 16MM Sound Movie Projector

Form Two: One - 35MM Slide Projector  
One - Cassette Tape Recorder

BIBLIOGRAPHY

An individual, objective based, bibliography has been prepared for the Basic Media Endorsement test with another developed for the Professional Media Endorsement test.

The individual bibliographies provide background information on the objectives included with each test form.
