ABSTRACT The dissertations, theses, and studies included in this list are concerned with one or more of the following four factors in high school journalism: instruction in journalism, mass media, and related areas; production of student publications and similar media; the human equation--staff members and teacher/advisers; and public-relations aspects of student media. The list includes 42 annotated entries for 1974 and 67 annotated entries for the seven years from 1966 through 1973 (data on studies prior to 1974 are incomplete). (JM)

Is there anything new under the sun - so far as high school journalism is concerned in 1976? The inquirer who wants to conduct a modest study or survey usually can't find out whether his proposed investigation duplicates a recent study similar in purpose. Nor can the student who expects to write his master's thesis or doctoral dissertation about high school journalism.

Today there is no source comparable to the monumental study of Dr. Edward H. Redford whose Bibliography of Secondary School Journalism was published in 1941 by Quill and Scroll Foundation. This comprehensive compilation of journalistic source material for high school journalists and their advisers has not been matched in more than three decades.

To remedy the situation to some extent, Quill and Scroll Studies is attempting to develop a yearly report of relevant inquiries concerned with:

- 1) Instruction in journalism, mass media, and related areas
- 2) Production of student publications and similar media
- 3) The human equation - staff members and teacher-advisers
- 4) Public relations aspects of student media

For several years Quill and Scroll Studies has invited schools of journalism to report such studies. Some have responded. Others have not - perhaps because they have nothing to report, perhaps because they don't care to bother. Accordingly few inquiries receive the attention they deserve.

This report is tentative. It has been developed with the cooperation of ERIC in Florida and with the assistance of Sharon McClellan and Barbara Ortiz, both graduate students at Florida State University. It is being circulated in this form to invite comment, correction, addition.

An improved plan will be used in assembling data for 1975 which will be undertaken when the data are available. We hope that the tentative report can be circulated in 1976. Data on studies prior to 1974 are incomplete, but are included for the convenience of the reader.

Through interviews with student editors, a questionnaire survey, and an analysis of editorials in high school newspapers, this study attempted to (1) discover the relative importance of, or interest in, certain topics through quantification; (2) rank these topics in order of importance; (3) determine the editorial attitude toward each topic; and (4) determine the explicit and implicit pressures or controls placed upon editorial writers by sources outside the newspaper. A survey of 95 Arizona high schools and their problems with school newspaper censorship indicates that whether limitations are imposed before or after publication, the essential conflict is one between viewing the student newspaper as an opportunity for education, or seeing the paper as a public relations agent for the school.
