ABSTRACT

Activities to date are summarized for the California Education Information System (CEIS), a data processing service which provides county and regional offices with a series of automated applications capable of meeting the majority of standard pupil and business information processing requirements. The following components are included: an outline of the system design; a brief historical background; summary figures on funding and expenditures; and data on utilization of CEIS and on distribution and implementation of processing packages. Gathering of Data, Surveys; Reports

479 The system is intended to provide a basic package of services to school districts that will facilitate the gathering of data required for reporting to the state. An annual survey shall be made of school district participation in the system. The results of such surveys shall be annually reported to the Legislature, and the first such report shall be submitted no later than the fifth legislative day of the 1970 Regular Session of the Legislature.

Report on CEIS

The California Education Information System (CEIS) was developed to provide school districts, offices of county superintendents of schools, and regional educational data processing centers with a series of integrated automated applications capable of meeting the majority of standard pupil and business information processing requirements of California school districts. More specifically, the developmental effort was undertaken to:

- a. Expand the processing capability of regional EDP centers, thereby broadening the scope of automated services available to participating customer districts.
- b. Provide system and programs to school district data processing operations, thereby reducing the requirement for total systems development on an individual basis.
- c. Develop an information base for information reporting, on a manual or machine-readable basis, to the Department of Education.

Historial Background of CEIS

Highlights of the tasks and projects performed during the CEIS project are presented chronologically as follows:

1959-60	Study of automated processing of pupil personnel data
1960-63	Richmond pilot project
1962-65	Development of CDIS automated pupil services (version ι) and establishment of regional centers
1965-68	Design of CEIS business and upgraded pupil services (version II) subsystems
1968-70	Contract with Computer Applications, Inc., to program, test and document business subsystem and upgraded pupil subsystem (version II)
1971-72	Contract with Boothe Resources, Inc., to program, test and document business subsystem and upgraded pupil subsystem (version II)
1972-73	Distribution of business and pupil applications and system maintenance
1973 - 75	Coordination of system acquisition

Since the inception of the CEIS project, the primary funding support has been from federal sources, with supplemental funding provided from the state General Fund and county School Service Fund. The total funding, by source, for the project period of 1959 through 1974 follows:

Utilization of the CEIS System

The original CEIS system, which was completed in 1965, included the pupil personnel applications, as indicated on page 5. This subsystem, which has been identified as CEIS-Version I, has been fully operational for approximately nine years. During this period, regional centers have continually increased the number of customers voluntarily using their services, and they now number in excess of 500 districts throughout the state serving approximately three-quarters of a million students, as indicated-by the following chart.

After the completion and distribution of CEIS-Version I, efforts were commenced to increase the overall capability of the system through the addition of automated business services and to improve and expand the operational capabilities of the originally released pupil services applications. These new and upgraded applications have been identified as CEIS-Version II.

The upgraded system was completed and released for field implementation in 1972. Included in the system were the following new processing applications:

System Implementation - CEIS-Version II

California local educational agencies involved in the initial implementation of upgraded CEIS applications include:

Butte County Schools
Oakland City School District
Orange County Schools
Riverside County Schools
Santa Clara County Schools
Whittier Union High School District

While at this time no LEA has implemented all of the available new CEIS applications, the scope of CEIS utilization has expanded to include individual school districts and offices of county superintendents of schools, as well as regional centers.

CEIS Status as of December 1, 1975

Due to the wide range of computer configurations at CEIS-using installations in California, the Department no longer actively maintains or distributes programs and documentation. CEIS maintenance involvement by the state is limited to (1) indicating to prospective purchasers alternative system sources licensed to provide appropriate documentation and programs; and (2) providing CEIS program source tapes and documentation to computer vendors for conversion purposes.

In order to ensure the continued availability of CEIS from a source other than the state, a nonexclusive licensing agreement allows purchasers to modify, copy, and distribute their version of CEIS programs and documentation. Total charges for the licensee's version of CEIS is at a price mutually agreed upon between the licensee and the system recipients, with a \$100 installation fee paid to the state by the licensee.
