Dissertation Abstracts International. A monthly compilation of abstracts of doctoral dissertations from over 310 cooperating institutions; domestic and foreign, this publication of Xerox University Microfilms publishes abstracts only of those dissertations submitted to it and available from it on microfilm or as a xerographic print. Two sections, Humanities (A) and Sciences (B), are issued each month paged individually and cumulatively, with an author index and a keyword-in-title index which cumulates in Part II of issue 12, Sections A and B. Prices and order blanks are available in each issue.

The Education Index. Library has V.1 (1929)+. An alphabetical author and subject index to periodicals, proceedings, yearbooks, bulletins, monographs and U.S. Government material in education. It covers pre-school, elementary, secondary, higher and adult education, teacher education, counseling and guidance, curriculum and education in various subjects, and education for special groups. Book reviews are listed under the subject heading "Book Reviews".

Educational Administration Abstracts. Library has V.1 (1966)+. A quarterly index which abstracts 92 journals in the field of educational administration and the peripheral sociology, management, business and human relations journals which apply. Abstractors' names are listed and abstracts signed. Abstracts are arranged numerically in broad subject groupings with many cross-references provided. Each issue also contains a cumulative author index and a cumulative journal title index.

Produced by the Clearinghouse on Exceptional Children of ERIC this tool reflects that Clearinghouse's additional role as a Center in the Special Education IMC/RMC Network. Documents and journal articles are abstracted in each quarterly issue with access provided by cumulative author, title or subject indexes.

Gage, Nathaniel Lees, ed. *Handbook of Research on Teaching*. Chicago, Rand McNally, 1963. Purpose is to "improve the conceptual and methodological equipment used in research on teaching". Articles by well-known educators on how to design, or select a design, for research in education or in a specific area or subject field of education, how to conduct the research, and how to evaluate or measure the results. An extensive name and subject index is provided.

Travers, Robert Morris William, ed. *Second Handbook of Research on Teaching*. Chicago, Rand McNally, 1973. A new edition which, in a somewhat altered arrangement, seeks to explore the new educational technology, the effect of the psychologist and physiologist on classroom teaching, the use of game theory from the behaviorists, and the application of the computer to research. Bibliographies follow each chapter, and an extensive index is included.

Research in Education (ERIC). Library has No. 1 (1966)†. Abstracts of research and related reports in education. Abstracts are arranged by ED (Eric Document) number. There are indexes to the abstract by subject, author, institution and accession number. Indexes cumulate semiannually and annually. The ERIC documents themselves are arranged by the ED number and can be found on microfiche or hard-copy in the Documents Room of the library. With V.1 no.1 (Jan.1975) title became *Resources in Education*

Sociology of Education Abstracts. Library has V.2 (1966--V.7 (1971) with a new subscription to begin with V.8 starting late in 1974. A British publication issued six times per year which abstracts books, sections of books, journal articles, reports, studies, and documents. International in scope, it focuses on the sociological relationship between society and education. Issues are in alphabetical order by author with symbol cross-references to others in the same subject area. Each issue contains a subject area index with issue six containing a cumulative author index, a cumulated subject area index, and a list of sources abstracted in that volume.

U.S. Educational Research Information Center. *Educational Research Document Summaries*. The first of two governmental publications which abstracted research reports in education prior to *Research in Education (ERIC)*, this three volume set contains abstracts of reports numbered ED 001 001--ED 002 740. There are no indexes in this set, but the previous publication contains an author index to these documents. They are available on microfiche in the Documents Section.

U.S. Educational Research Information Center. *Office of Education Research Reports, 1956-1965*. The second of the two governmental publications preceding *Research in Education (ERIC)*, this two volume set indexes and abstracts research and related reports in education from ED 002 747--ED 003 960. The "Indexes" volume contains four indexes: author, institution, subject, and report number. Citations in each index are keyed to the ED accession number of the report. The "Resumes" volume contains a complete description of these reports in order by ED accession number. Each entry contains author, title, source, price, the descriptors used to index the report, and an abstract. Although these reports are not on the ERIC computer tapes they are available in the Documents Section on microfiche.

U.S. Educational Research Information Center. *Catalog of Selected Documents on the Disadvantaged: Number and Author Index*. Under the 1965 Elementary and Secondary Education Act (PL 89-10) the Educational Research Information Center was delegated the responsibility of making information about education research more readily available. This publication lists the 1740 documents collected by that agency in 1965 describing 23 innovative educational programs for the disadvantaged which, in their opinion, were of national interest. The entries are in order by accession number with an author index at the end. A full description with abstract may be found in *Educational Research Document Summaries*; and the documents themselves are available on microfiche in the Documents Section.
