ABSTRACT

This report, the seventh in a series, presents national adult basic education (ABE) and secondary level education statistics compiled from the annual reports submitted by the States and other areas receiving federal funds for ABE programs. The statistics cover enrollments, student characteristics, completions, separations, teachers, classroom facilities, and inservice training of teachers and other staff members. Following a brief introduction describing federal ABE program efforts, the content is presented in two sections. Section 1 consists of one table which summarizes the statistics for fiscal years 1970 to 1974. The second section reports the statistics for fiscal year 1974 in seven graphic charts and twenty-five detail tables. The adult education annual performance report form and instructions are appended. FOREWORD

Since 1967, the National Center for Education Statistics has cooperated with the Division of Adult Education of the Bureau of Adult and Occupational Education to prepare annual summary reports on adult education programs sponsored under provisions of Public Law 91-230, as amended.

This is the seventh in the series of these reports and, like the others, is based upon annual reports on adult education activities submitted to the U.S. Office of Education (OE) by each State, the District of Columbia, and participating outlying areas.

Each report presents statistics on adult basic and secondary level education enrollments, student characteristics, completions, separations, teachers, classroom facilities, and inservice training of teachers and other staff members. To facilitate comparisons, table formats have been made as consistent as possible with those of prior years. This publication includes a summary table covering fiscal years 1970 to 1974 and 25 detail tables on fiscal year 1974 programs (the period from July 1, 1973, to June 30, 1974).

Differing State laws and practices on the collection of data prevented some States from reporting specific items; each table so affected shows the total enrollment, a nonclassified total, and a total of those enrollees whom the States could classify by specific category. In editing the forms, NCES made every attempt to reconcile discrepancies within report forms, such as slight differences between totals for participants by age groupings and by location at which courses were held. Where telephone and other contacts could not reconcile those differences, the actual figures the States reported were retained and indicated by an asterisk.

This publication was prepared by the Adult and Vocational Education Surveys Branch under the supervision of Sylvester H. Cain. Major assistance was provided by Barbara Whalen. Nancy Buckley assisted with the tabulations, and Elaine Price typed the manuscript.

Key to the development of this publication has been the continued cooperation of Paul V. Delker, Director of the Division of Adult Education, and Morris L. Bown, Chief of its Program Development Branch. Sharon A. Jones provided expert help on the data and worked in liaison with the States as data were edited.

INTRODUCTION

The adult basic education programs administered by the U.S. Office of Education were established under the Adult Education Act of 1966. This program offers to persons 16 years¹ of age and older the opportunity to overcome English-language difficulties and attain reading, writing, and computational skills through the 12th-grade level of competence. The program also offers students the opportunity to acquire a high school diploma.

Adult basic education programs—established in and operated by each of the 50 States, the District of Columbia, and 5 outlying areas²—are funded, in part, by grants from the Office of Education. To participate in the programs, each State or other area except the Trust Territory of the Pacific Islands must provide at least 10 percent of program costs and retain total responsibility for planning, supervisory services, teacher training, curriculum development, evaluation, and all essential services for enrollees through the 12th grade. In fiscal year 1974, each State, the District of Columbia, and 5 outlying areas² conducted adult basic and secondary level education programs. As a convention, the United States together with the outlying areas are termed "aggregate United States."

The Office of Education also awards grants to schools, colleges, universities, and public and private nonprofit organizations for special projects and teacher-training projects. The act also authorizes direct contracts with institutions and organizations to develop new teacher-training techniques.

Most of the data were compiled from the annual program report (see appendix) submitted by each State or other area.³ Data are presented for the aggregate United States and each State and other area. While attempts were made to compare fiscal year 1974 data with those of previous years, revisions in the report form limited the comparisons.

¹On June 30, 1969, the minimum age limitation was reduced from 18 to 16 years by the Vocational Education Amendments of 1968. The collection instrument included the new minimum for the first time for fiscal year 1971.

²American Samoa, Guam, Puerto Rico, the trust Territory of the Pacific Islands, and the Virgin Islands.

The 1972 change lowering the minimum age of students served from 18 to 16 years complicated comparisons between data for the 1970-74 period and those for earlier 5-year periods. Also changed were race or ethnic groupings and the definition of grade equivalents for the three instructional levels. Researchers analyzing trends should note these changes.

Although teacher-training and special projects are part of the adult basic education program activities, data were obtained from approved grant awards, not from the annual report form.

Teacher-Training Projects

In fiscal year 1974, \$3,434,720 was allocated to support inservice and preservice training opportunities for 29,809 teachers, teacher trainers, counselors, paraprofessionals, and administrators. For these, 19 national training grants were awarded. Ten other projects were designed to increase the regional staff development capability.

Several national teacher-training projects aimed to provide inservice training with current techniques and curriculums in teaching adult basic and secondary education students. Program priorities for training adult education personnel included:

- (1) national adult education staff development programs for establishing more effective means of providing quality inservice education for adult education personnel while at the same time developing more effective systems of preservice education;
- (2) adult education programs for cultural and ethnic understanding, directed toward providing leadership development for representatives of minority groups and sensitizing teachers and administrators to the needs and values of culturally and ethnically different adults, and
- (3) support programs for national adult education program staff development, designed to provide direct support to the national adult education

staff development program and provide services that cannot feasibly be implemented by the individual regional staff development projects.

Programs for training adult-education personnel included: a project designed to increase ethnic and cultural awareness among adult-education administrators, teacher trainers, university adult education personnel, and local program directors; a project concerned with conducting training for adult education personnel in the training of community volunteer tutors and in the establishment of volunteer adult basic education tutorial programs, and a project designed to develop, demonstrate, and refine a futuristic participatory planning process and to develop and disseminate some alternative national goals and strategies which will have an impact on the educational and learning opportunities for adults throughout the 1970's and 1980's.

Special Projects

A total of nearly \$6.6 million was awarded in fiscal year 1974 to support 57 special experimental demonstration projects.

The major purpose of those projects was to assist State agencies to develop more effective adult education programs by demonstrating innovative practices, systems, and materials on a pilot basis. Effective models and products were then validated and disseminated to State and local agencies to be recommended for use where appropriate.

Public and private educational agencies and universities also conducted special experimental demonstration projects in fiscal year 1974. Program priorities included:

- (1) career-education projects for educationally disadvantaged adults;
- (2) adult right-to-read programs that design and demonstrate adult basic education models;
- (3) projects for improving State-administered adult education services; and
- (4) renewal of some projects funded in fiscal year 1973.

Special emphasis was given to projects designed to address:

- (1) the adult population that have fourth-grade or less capability in reading, writing, computational and communication skills, were welfare recipients, were living in rural areas and were over age 45; and
- (2) program component needs:
 - (a) recruitment and retention of participants in programs, and
 - (b) instruction, including prescribing learning activities to meet individual needs, fostering student participation in setting objectives and evaluating learning activities, evaluating the overall instructional program, diagnosing student learning needs, using adult basic education teachers to counsel adults, and using small-group instruction.

National Advisory Council on Adult Education

The National Advisory Council on Adult Education operates under provisions of Public Law 91-230, as amended, title III of the Adult Education Act, section 311. The Council consists of 15 members, including a chairman and vice chairman, and operates through working committees. The Council advises the Commissioner of Education on general regulations and policy in the administration of the adult education title. The Council also advises OE on policies and procedures governing the approval of State plans, ensures the coordination of adult education programs under the title, and examines other programs offering adult-education activities and services. The legislative charge to the Council includes a review of the administration and effectiveness of adult-education programs sponsored under the title, recommendations, and an annual report to the President. In fiscal year 1974, the Council developed a publication, entitled *A Target Population in Adult Education*, which provides evidence of the education, work, and economic needs of a large proportion of the nation's adult population.

Section I

FIVE YEARS OF ADULT BASIC EDUCATION, FISCAL YEARS 1970-74

This section presents a summary of statistics for the past 5 Federal fiscal years. Data for this section, and for the entire publication, come from annual program reports submitted by the States and other areas.

In these 5 years, 3.7 million persons received training under the Adult Education Act, as shown in table 1. Enrollments in the past several years were higher than in fiscal years 1970, and 1971. Over one-fourth of the participants during the 5-year period 1970-74 were recorded for 1974.

Women have consistently provided the majority of those served by adult basic education programs, with only slight deviations from year to year.

As might be anticipated, since the 1972 amendments to the Act made persons between 16 and 18 eligible for enrollment in federally aided programs, the percentage of those under 25 has been increasing. The largest cumulative decline in proportion of participants is for those aged 35 to 54. This decline also reflects the fact that many in this age bracket may have already been served by the program.

As the form for reporting fiscal data was changed, no attempt has been made to compare data for 1974 with those from earlier years.

Section II

ADULT BASIC EDUCATION, FISCAL YEAR 1974

Statistics in this section were obtained from the Adult Basic Education program report for fiscal year 1974. Each State or other area files this form annually with the U.S. Office of Education (OE) through its appropriate regional office.

As was shown in table 1, in fiscal year 1974 adult education programs funded under Public Law 91-230 served over 965,000 persons, an increase of 17.3 percent over the 822,000 participating in fiscal year 1973. Several States accounted for a high percentage of the enrollment. These included California, with 100,677, Florida, with 86,873, and Texas, with 74,149 enrollees. These totaled over 261,000 and probably included a high proportion of the 236,000 participants of Hispanic origin, as indicated in table 2. Both the Carolinas, North Carolina with 56,532 and South Carolina with 71,983 participants, reported considerably higher enrollments than many larger States, such as New York with 44,752 and Illinois with 21,759 participants.

Minority-group members have been a particular target of the adult basic education programs. Comparable statistics on their involvement in 1974 (from table 2) and 1973 follow:

¹In this tabulation and in many of the tables, details of numbers of participants do not add to the same totals as those in other tables. This is the result of certain States providing differing data. Several checks were made with these States to completely reconcile totals, but it was impossible to eliminate all errors.

Rather than change data at NCES in order to make all tables add to the same national totals, information is presented as provided by the States and other areas. To illustrate this point, in the above summary of data by minority group status, the column totals are 820,281 and 955,218. These are 1.00 percent different from the 822,469 and 1.01 percent different from the 965,116 reported by the States on their summary form. With the second-year use of the new reporting form, the size and frequency of these discrepancies should be reduced.

Utah did not enter data in the detail cells of the survey form, only totals were provided.

Chart 2 and table 4 present information on the ages of persons enrolled in adult basic education programs in fiscal year 1974. The two largest age groups are 16-24, with 362,580 (38 percent of all participants), and 25-34, with 260,753 (27 percent). For those wishing to compare fiscal year 1974 totals with those of the preceding year, these were the data for 1973:

Two charts present details on enrollment in adult basic education by age and race/ethnicity. In chart 3, the relative participation by age is shown by the five basic race/ethnicity groups. In every group but Oriental, the largest number of participants were from age group 16-24. The second largest for all groups, except Oriental (where it is largest) came from those aged 25-34. Thus, rates for racial/ethnic groups tended to correlate with national totals. Table 4 shows the proportion of total enrollment in adult basic education from each racial/ethnic group.

As in past years, women constituted considerably more than half (56 percent) of the adult basic education participants. Table 4 shows their participation by State, which ranges from a high of 88 percent in New York and 70 in Mississippi to 44 in North Carolina.

A series of tables presents information on enrollment totals of various race/ethnic groups: table 5 for American Indians, table 6 for Negro/Black participants, table 7 for Orientals, table 8 for Spanish-speaking participants, and table 9 for all others. These are structured differently from comparable tables (numbers 4 through 10) in the 1973 report: each now includes data for both men and women in a single table.

The reasons for which 353,495 persons (36.6 percent of those enrolled) left adult basic education programs before completing them are shown in table 10. Excluding the undefined "other" category, the two largest categories were "met personal objective" (42,369), and "took a job" (33,856). Both included persons likely to have benefited from programs even though they failed to complete them. Chart 5 shows the relationship between enrollments and completions/separations by level of education involved.

Table 11 shows participants' educational progress after entering adult basic education programs. It shows, for example, that 61,493 persons entered high school, 72,436 passed the General Educational Development (GED) test for high school graduation equivalency, and 63,685 enrolled in other education. Sharp variations by States are noted, depending upon the program involved—reflecting, not the particular emphasis of the State. Almost a third of the 79,426 national total for those who received an eighth-grade diploma came from the 25,508 enrolled reported by Florida. A sixth of the 61,493 who entered high school came from the totals for Texas. Texas, New Mexico, and North Carolina reported relatively high numbers for participants passing the GED test, while New York, Maryland, and New Jersey showed relatively low totals. Texas and New Mexico reported relatively high numbers for those who graduated from high school and North Carolina, Ohio, and Texas showed high numbers for those enrolled in other education.

The States were asked to provide answers for a series of questions. These required preparation of reports on program participants' personal achievements, including registering to vote for the first time, obtaining U.S. citizenship or a driver's license, and completing training in how to complete income tax returns. Table 12 shows the numbers of persons

reported to have attained these personal objectives.

A major goal of most educational programs is to assist in participants economic as well as personal development. Table 13 shows the job status of those who participated in adult basic education programs. Of those for whom this information was provided, 47.2 percent were employed, 39.8 percent unemployed, and 13.0 percent on public-welfare rolls. More important may be the 19,976 persons removed from public welfare rolls after participating in the program. Also aided were 52,477 persons who obtained employment after participating, and the 43,834 who had been employed but who received better jobs.

Most program enrollees for whom data were available were enrolled in urban areas. Table 14 shows that 74.0 percent of them were in urban programs, 22.2 percent in rural programs, and 3.8 percent were waiting to enter programs.

Table 15 shows the number of staff and the student-staff ratio. The 28,274 teachers were augmented by 5,432 paraprofessionals and 2,088 counselors. The national average student-teacher ratio was 34: ranging from 122 for Alaska to 18 for North Dakota, and New Hampshire. Chart 6 shows the relative numbers of State administrators, local administrators, counselors, paraprofessionals, teachers, and students.

Most teachers in adult basic education programs were part-time, as table 16 indicated. The full-time equivalency for the 28,274 teachers was 12,497. During the year, 30,058 teachers (both experienced and entering the field) received training in instructional methods in adult basic education. In some States, almost all of the teachers received some training (such as 100 percent in Kentucky), while in others the percentage was much lower (such as the 28 percent in Arkansas). Most teachers (21,158) received less than 16 hours of training.

A series of tables presents details on the numbers of persons working in the adult basic education program by total, full-time equivalency, number trained during the year, and the length of that training. Table 17 presents these data for State administrative and supervisory personnel, table 18 for paid local administrative and supervisory personnel, table 19 for paid local teachers, table 20 for paid local counselors, table 21 for paid local paraprofessionals.

States were also asked to categorize adult basic education training by its comparable level in elementary and secondary schools. These categories were

used:

Beginning level	grades 1 through 4
Intermediate level	grades 5 through 8
Advanced level	grades 9 through 12

Table 22 presents details on the numbers enrolled in each of these levels. Overall, 37 percent are at the beginning, 43 percent at the intermediate, and 20 percent at the advanced level. This is shown in chart 5.

Table 23 is a three-part table, showing the details on enrollment by level. Percentage figures used are the percentage of total completions and separations coming from each level.

The fact that a considerable number of adult basic education classes are conducted in other than traditional school settings is shown in tables 24, 25, and 26. Table 24 is a summary table and tables 25 and 26 present identical data for day-time and evening classes, respectively.

Readers of this series of reports should remember that they will not find fiscal data in the report for 1974. The inconsistencies between information provided by the various States and other areas were such that no statistically reliable series of tables could be developed. With the continued use of the new format for fiscal year 1975, more reliable reporting is anticipated for this area.

Chart 1.--Number of participants in adult basic and secondary education programs, by race/ethnicity of students: Aggregate United States, fiscal year 1974

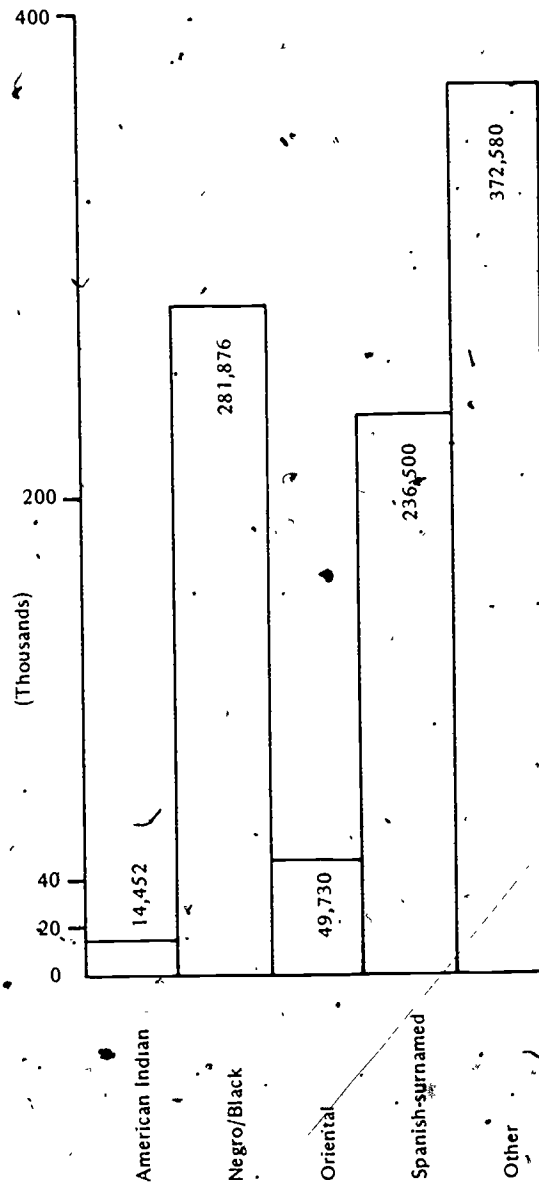
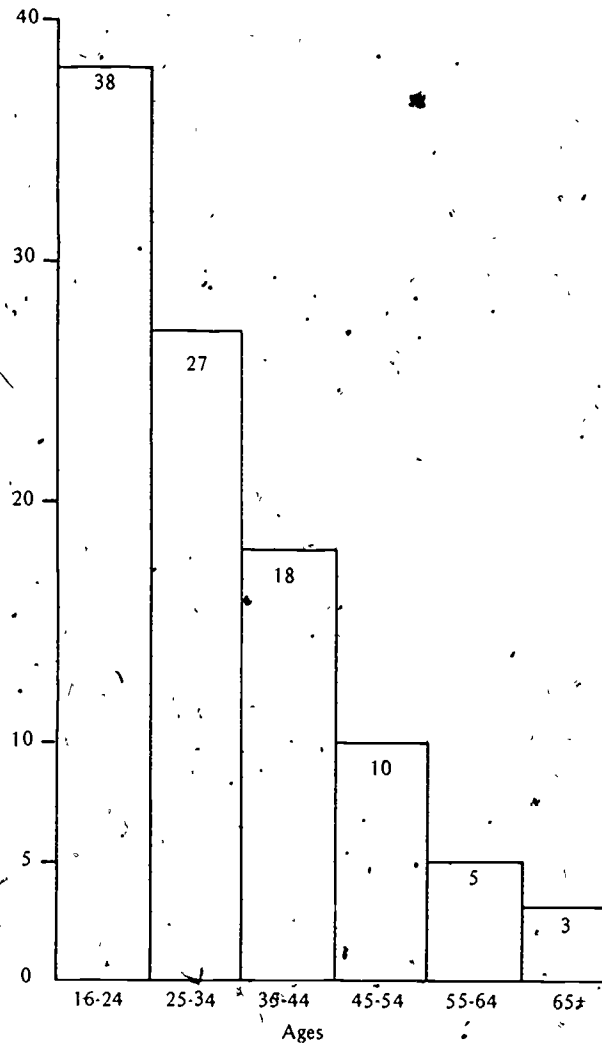


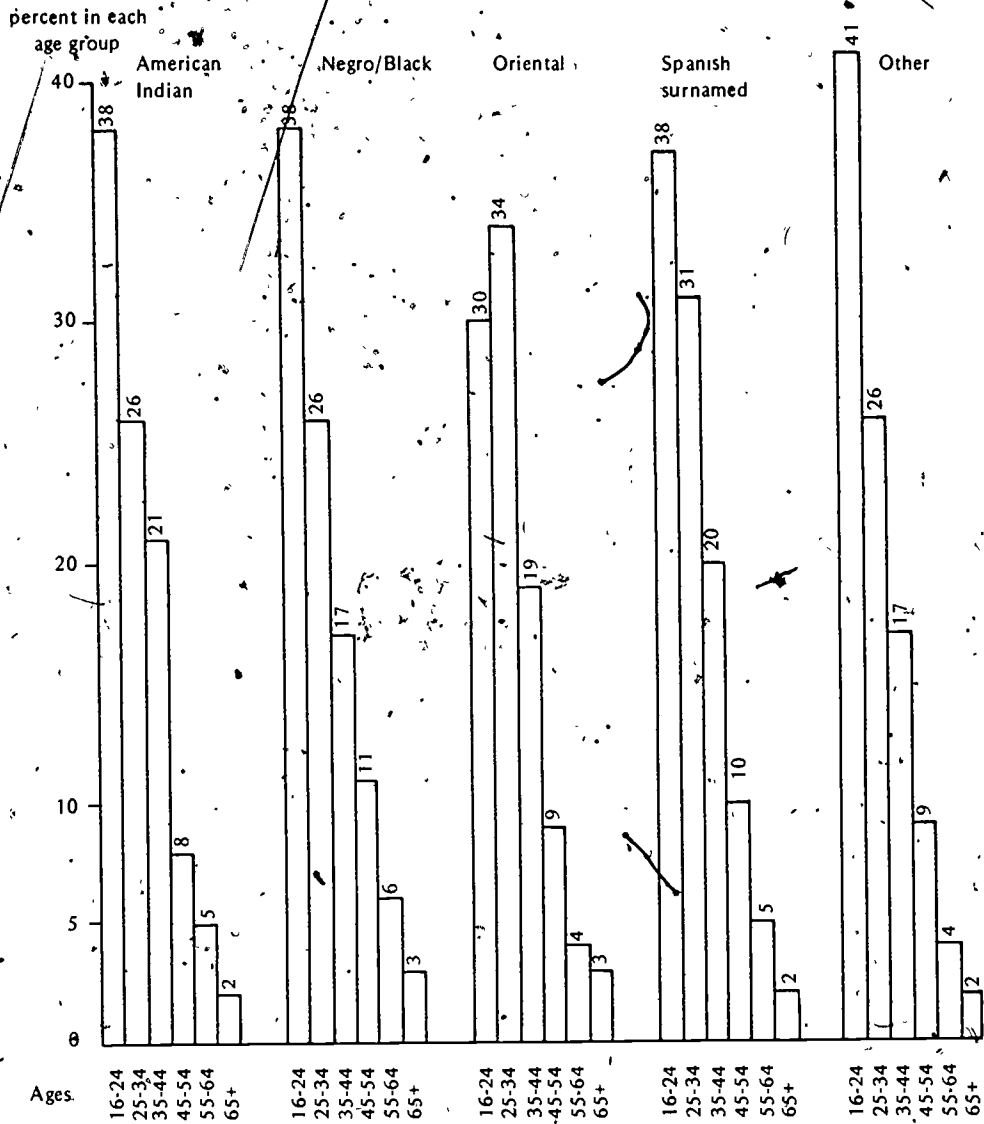
Chart 2.--Percent¹ of enrollment in adult basic and secondary education programs, by age: Aggregate, United States, fiscal year 1974

percent in each age group



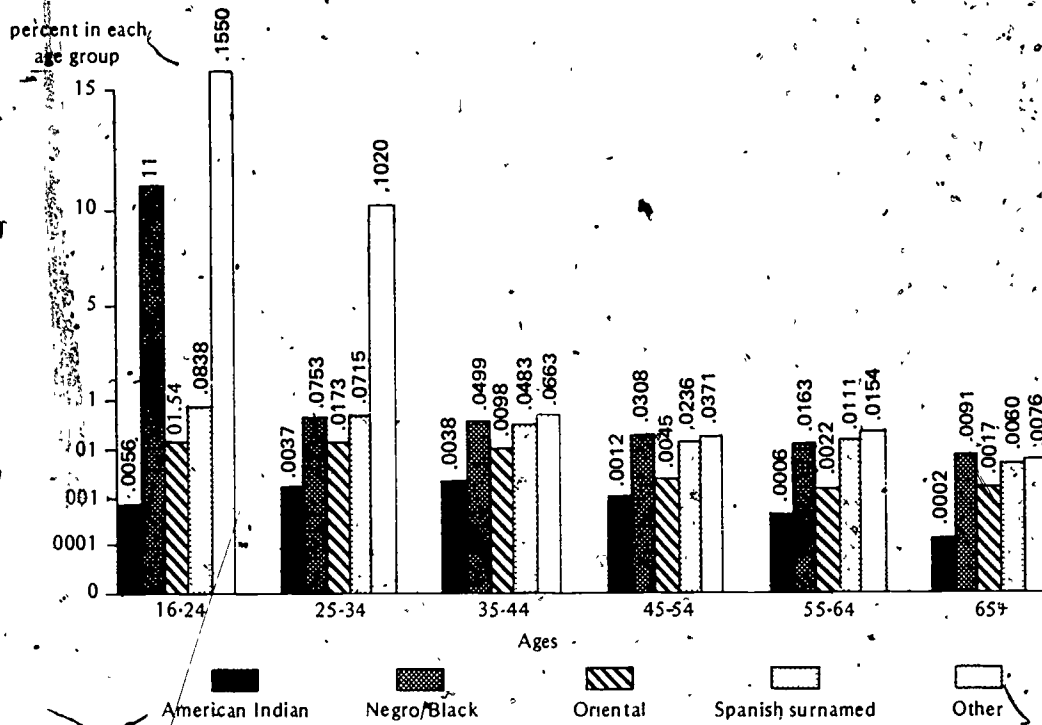

Aggregate United States, fiscal year 1974

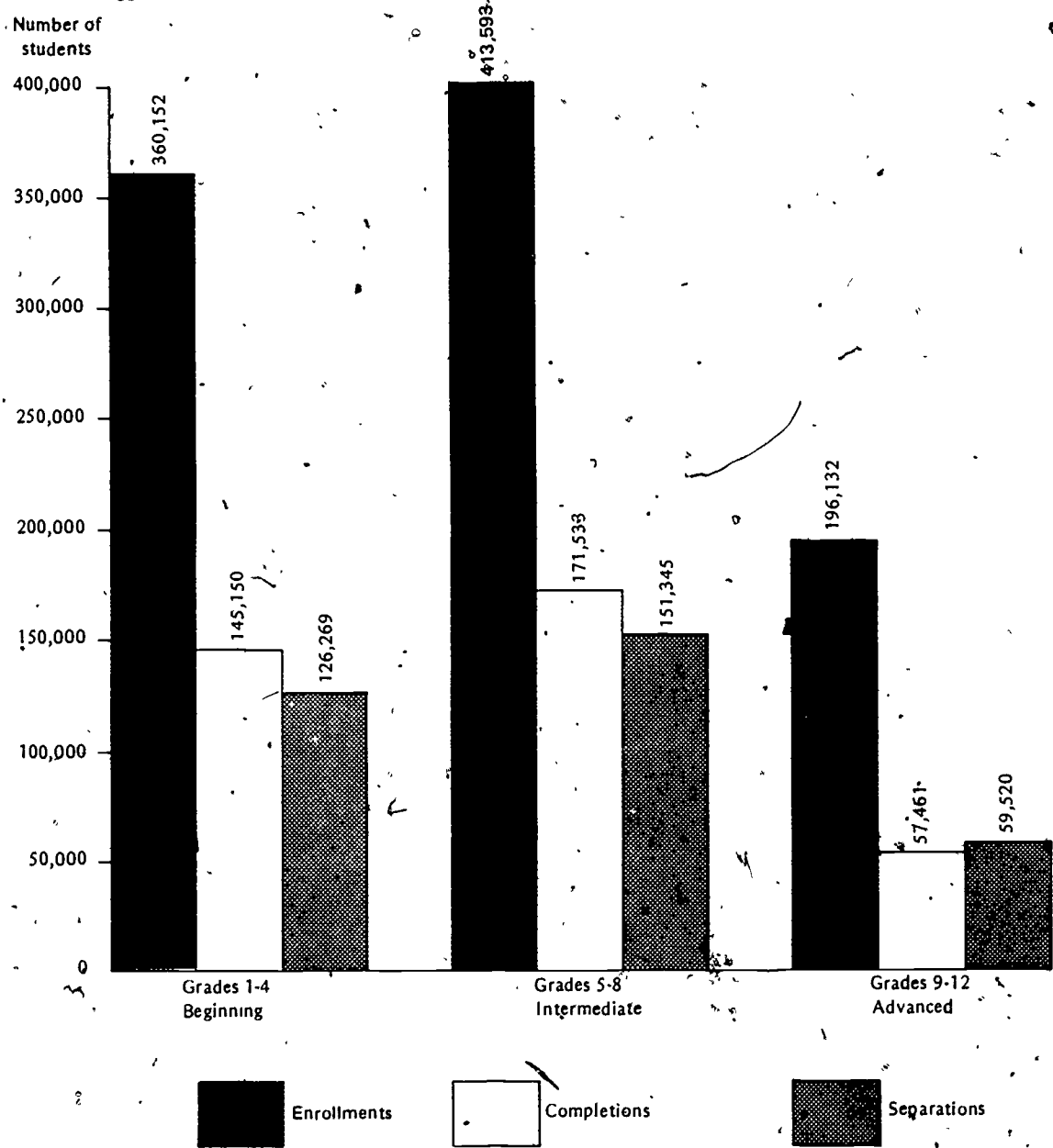


Chart 6.--Number of staff and students in adult basic and secondary education programs: Aggregate United States, fiscal year 1974

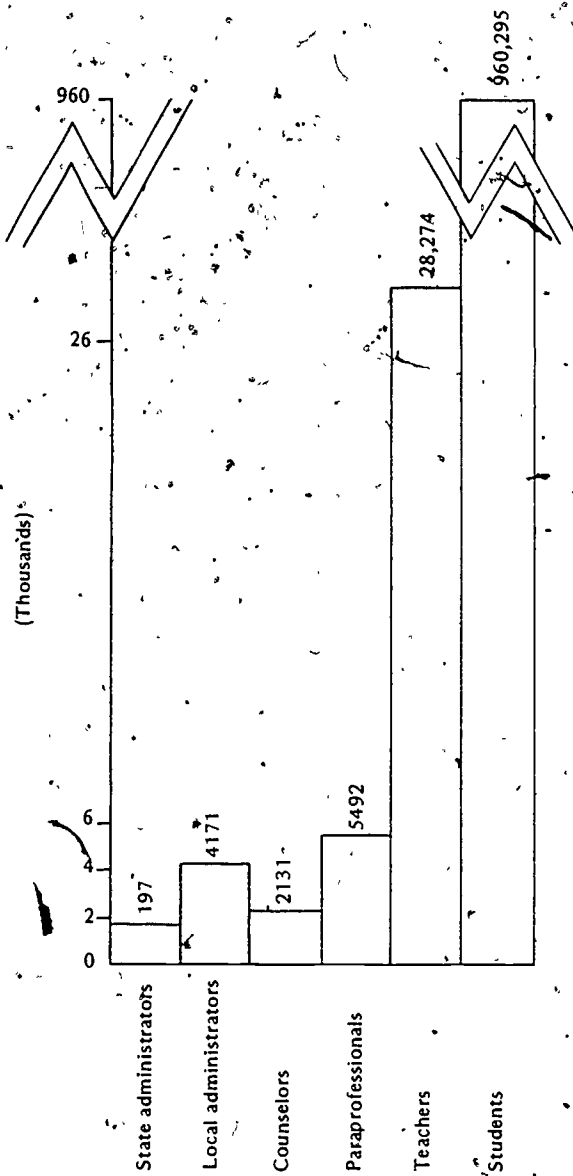
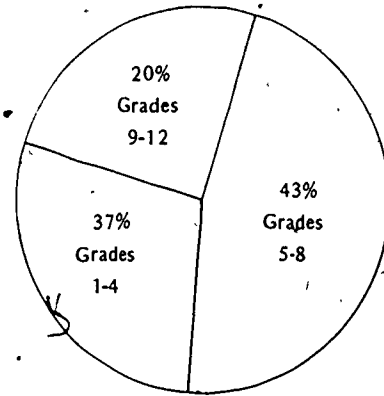


Chart 7.--Percent of enrollment in adult basic and secondary education programs, by grade level: Aggregate United States, fiscal year 1974

INSTRUCTIONS FOR PREPARING THE ANNUAL PERFORMANCE REPORT
FOR ADULT EDUCATION STATE GRANT PROGRAMS (13.400)

Table 1. Reports the population that is being served by adult education classes in the State with Federal, State and/or local funds under P.L. 91-230. It should include participants from other Federal programs such as Manpower and WIN for whom any direct services are being provided at clearly additional cost to the program (e.g., when an influx of 10 WIN participants would necessitate operating 2 or 3 extra classes). Every participant that completed 12 or more hours of instruction during the fiscal year July 1 through June 30 should be included in this table.

A participant's age is to be reported as age at time of first class attended during the fiscal year.

The total number of adult education participants reported in Table 1, Line 7, of Total Column (I) should agree exactly with the total figure reported in Table 2, Part A, Line 4, Column (c).

Table 2. Combines important data on starting levels, completions, and separations. As with Table 1, only participants who attended 12 or more hours of instruction during the fiscal year should be reported. Because of student advancement across instructional levels during the period of this report, the total number of students enrolled (i.e., the unduplicated count) reported in column (e) may or may not equal the total number of enrollees reported by instructional levels in column (b), Line 4. The total figure reported in Table 2, Part A, Line 4, Column (c) should agree exactly with the total reported in Table 1, Line 7, of Total Column (I).

Completions. In Table 2, Part A, column (c), report the number of students who completed the beginning, intermediate, or advanced level of instruction during the fiscal year. Students who left the program during the fiscal year because they completed the intermediate or advanced levels should not be counted as separations, but as completions. Count separations one time only. For example, a female who separates because she has a baby-sitting problem may be said to have a family problem. However, it is more accurate and useful to report her separation once under "child care problems."

Separations. Report in Table 2, Part A, Column (d) the number of students who separated from the program before completion of the beginning, intermediate, or advanced levels of instruction for one or more of the reasons identified in Table 2, Part B. Reasons for separations have been delineated to show "positive" type reasons indicating certain program accomplishments, as well as problem-related reasons which may be amenable to State and/or Federal influence. For example, if health problems show up significantly in a given State as a reason for separations, the State administrator might encourage curriculum of personal health care, hygiene and nutrition. The total figure reported in Table 2, Part A, Line 4, Column (d) should agree exactly with the total reported in Part B, Item 13.

Until such time as special definitions have been developed for measuring adult performance levels, "Beginning" level (to conform with census data) is equivalent to Grades 1-4. "Intermediate" is equivalent to Grades 5-8. "Advanced" is equivalent to Grades 9-12.

Table 3. Shows where participants attended classes and the number of day and evening classes by type of classroom location. As with Table 1, and Column (b) of Table 2, the State should report on every

participant that completed 12 or more hours of instruction during the fiscal year.

"School Building" can be either public or private. For purposes of this report, junior high buildings should be classified as elementary.

"Learning centers," for purposes of the adult education program and this report, and adult instructional settings featuring (1) extensive use of programmed instruction, (2) flexible participant scheduling and attendance, (3) being open for extended periods of time and on a daily basis, e.g. 9:00 a.m. to 5:00 p.m. In cases where learning centers are found in any of the other types of locations listed, participants should be counted as attending learning centers, not the other types.

"Correctional Institutions" can be Federal, State or local and include youth offenders 16 years of age or older as well as adults. Inmates are the only ones to be included in this category.

"Hospitals" can be Federal, State or local, mental institutions are included. Hospital in-patients and out-patients are the only ones to be included in this category.

"Work sites" can be public or private, as long as they are operating places of employment for the participants. If hospital or correctional employees are trained at their respective job locations, they would be counted under the "work site" category.

"All other locations" would include those that do not fit into one of the above categories. Church and storefront locations and four year colleges are among those that would generally fall into this category.

Table 4. Requires data on numbers of personnel and their full-time equivalence for five different personnel categories. It also provides for indication of the amount of State and/or local pre-service or in-service adult education program-related training received by paid personnel during the fiscal year.

In column (b) count one time only each employee of the State Department of Education who is being paid out of Federal, State and/or local adult education funds. Each employee should be placed in the personnel category where he does most of his work. "Administrative and Supervisory personnel" includes teacher trainers and curriculum, counseling and guidance specialist.

In column (c) convert the personnel in column (b) to an equivalent number of full-time personnel according to the formula or method used by the State in determining full time employment in each of the different job categories.

"State or Local Training" is not to include any "309(b) and (c)" funded training. It should include other training that is clearly related to the program effort under the personnel categories listed above. A "clock hour" refers to a period of instruction of at least 50 minutes in length.

Table 5. Provides for various impact information concerning the State adult education program. Supply accurate data if it is available on a Statewide basis for any of the listed items.

INSTRUCTIONS

The principal purpose of the report is to allow States to make better use, for planning purposes, of information found in the five tables. The report has several other purposes at the Federal level. It serves the Office of Education by providing a standardized data-collection format for use by all States. The collected information is used to publish reports and respond to inquiries. More importantly, the report is used as a program tool for the Office of Education to assess the impact of adult education at the State, Regional and National Levels. Such information provides a basis for changes in National policy, redirection of resources, and provision of various forms of assistance to States.

The first table is concerned with various characteristics of the population served, the second table with instructional levels and participant separations, the third table with number of participants by location of classes and number of day and evening classes by location. The fourth table is related to staffing patterns of paid State and local

personnel and the amount of program-related training in which they are participating. The last table is concerned with impact of the adult education program.

The new alignments of data in the tables permit the State Administrator to look at the overall performance of the State program. For this report to be of maximum value to both State and Federal Program officials it is better that figures which are considered unreliable not be included in the report. (Where no reliable figures are available, the appropriate spaces in the reporting tables should be lined through.)

To make the best possible use of this information system the State Administrator should insist upon timely and accurate reporting of data from local jurisdictions. For Federal purposes, a signed original and two copies of the report should reach the HEW Regional Office no later than November 1.
