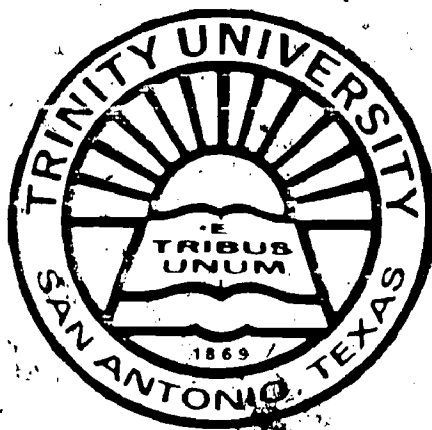

ABSTRACT

This bibliography was prepared to support the Urban Studies Program at Trinity University. This is a two-year master's program which provides professional level experience and intensive field work for persons preparing for employment in urban agencies. The bibliography is designed to aid students during the library instruction portion of the Urban Research Course. It lists basic reference sources in the Urban Studies field and gives their location within the library. Materials are divided into seven categories: (1) Indexes and Abstracts; (2) Bibliographies; (3) Dissertations and Theses; (4) Atlases, Encyclopedias and Dictionaries; (5) Directories, Handbooks, and Guides; (6) Statistics; (7) Sources of Congressional and Legislative Information. A listing of important periodicals in the urban studies field is also included.

An abstracting service covering periodical articles, books, pamphlets, unpublished reports, etc., mainly concerned with social problems and developments in the United States. Author, Subject indexes in each issue; annual cumulative index.

A very accurate subject index, giving exact date, page and column where the article can be located in the newspaper. Many cross references are provided, and the brief synopses of articles can often answer questions without referring to the paper itself.

A microfiche collection of articles from 150 leading newspapers in the U.S. which cover subjects of interest to students, teachers, researchers, and planners in the field of Urban Studies. The Newsbank is a unique reference source in light of the fact that very few newspapers are indexed. Some of the subjects included are: Education, Consumer Affairs, Employment, Housing and Urban Renewal, Political Development, Minority Economic Development, Social Relations, Health, Welfare, and Poverty, etc. Looseleaf index.

Supersedes in part SOCIAL SCIENCES AND HUMANITIES INDEX (1907-1974) formerly entitled INTERNATIONAL INDEX. Quarterly with cumulations.

Author and subject index identical in format to the READER'S GUIDE, but covering more specialized, scholarly periodicals in fields of anthropology, area studies, economics, environmental science, psychology, public administration, sociology, etc. Indexes 263 periodicals.

- J. SOCIOLOGICAL ABSTRACTS. Volume 1 - . . . 1952 - . . . New York, Sociological Abstracts. INDEX REF HM1 S67.
Published 9 times a year under the cosponsorship of the Eastern Sociological Society and the Midwest Sociological Society.

A classified abstract journal covering a broad range of sociological articles in periodicals in various languages. Some years are without cumulated indexes.

Weekly abstracting service that selects and abstracts articles in field of urban affairs using approximately 300 periodical publications. Useful for the public official and community planner. Annual cumulations are arranged by subject and include author, geographic indexes.

Contains 1500 annotated entries for books and nonprint materials arranged in 14 subject categories. Rating each entry on a scale from 1-4 is an unusual feature. Updated by supplements.

This bibliography of 1,500 selected references in comprehensive urban planning is useful to all persons involved in the field, especially researchers, students and teachers. Three categories of references are incorporated in this work: (1) those dealing directly with comprehensive urban planning; (2) references closely related to, or subsystems of comprehensive urban planning, for example, land use, transportation, or project planning; (3) environmental or other background materials generally underlying comprehensive urban planning and a higher order of municipal management. proceedings, government documents, and theses published in English, French, Portuguese, and Spanish dealing the several aspects of urbanization from the city in literature to pollution. Each topical section is arranged first by type of publication, then by country, then by author.

Part II provides a directory of (1) research centers and organizations; (2) "working organizations", i. e., departments of city, state, and federal governments; business and professional associations, foundations, and international organizations concerned with urbanization; (3) specialists in the field.

The atlas is volume 3 of the Comparative Metropolitan Analysis Project and is a highly recommended reference source for urbanologists and planners at the local, state, and national levels. The maps and text provide comprehensive information and data on 20 of the nation's largest urban centers. Volumes 1 & 2 of this set in order.

Not a mere revision of the Encyclopedia of the Social Sciences, but a completely new work. Planned to represent the social sciences in the 1960's, it reflects the development and recent rapid expansion in this area. Topical articles are devoted to concepts, principles, theories, and methods in the disciplines of anthropology, economics, geography, history, law, political science, psychiatry, psychology, sociology, and statistics. Biographical sketches have been limited to about 600 (in contrast to the 4,000 in the earlier set), and living persons born before 1890 were eligible for inclusion. Bibliographies are provided.

Charles Abrams, one of the world's leading urban planners and housing experts, completed this work just before his death in 1970.

The glossary is liberally cross-referenced and will be of interest to all city dwellers, be they laymen or professional planners and administrators.
