#### ABSTRACT

This quide is intended as an aid for historians interested in utilizing the computer as a resource for teaching undergraduate college level courses. Four types of information are listed. Part I lists computer based instructional packages which concetrate on data analysis (in contrast with simulations, games, or tutorials) and which use pre-1950 data. The second part lists historical datasets which are defined as non-survey data. The datasets cover periods before 1950. Part III lists archives, including addresses, whose holdings are extensive. The concluding section lists articles and papers which describe actual classroom use of quantitative historical data utilizing computers as an instructional mode. According to the author, this listing is not exhaustive. (Author/RM)

This <u>Guide</u> is intended as avaid for historians interested in utilizing the computer as a resource for teaching courses aimed at undergraduates. As such it includes four categories of information: (1) computer-based instructional packages already published or in preparation, which concentrate on data analysis (in contrast with simulations, games or tutorials) and which use pre-1950 data; (2) a list of all existing and archived historical datasets (defined as non-survey data and covering any period before 1950); (3) a list of those archives whose holdings are detailed, and to which potential users should address any questions about the nature of the datasets or their acquisition; and (4) a list of articles and papers describing actual classroom use of quantitative historical data utilizing computers as an instructional mode.

The list of historical data lies is by no means exhaustive: for every one which has been archived there probably exist ten or more which have not been made available for use by others. There are in addition other files which have not been included in this list because though archived restrictions have been placed on their use. The files listed below are thus the most readily accessible for potential instructional use. The author would be interested in knowing of any others, which have not been included herein, for future editions of this <u>Guide</u>.
