ABSTRACT

FOREWORD

Those who wish to learn more about minorities face two problems. The first is that not enough research is done on minorities in this country. The second is that what research has been done is often, for a variety of reasons, not readily available to the individual — whether graduate student, teacher, or college professor — who needs it.

This bibliography is an attempt to alleviate the second of these problems by publishing in this form a listing of available research in the area of counseling and minorities.

The bibliography is divided into the following sections: General References (165 entries), American Indian (54 entries), Asian American (14 entries), Black (280 entries), and Hispanic (178 entries). References were assigned to these categories on the basis of information contained in the title, in the abstract (where it was available to us), or other information in our possession. In those cases where our information did not indicate the specific ethnic group treated, or where several ethnic groups were treated, or where the discussion was of a generic nature, entries were placed under General References.

We have attempted to be as inclusive as possible in preparing this document on counseling and minorities. For this reason we have included all the references we could identify in such areas as mental health, psychotherapy, transcultural psychiatry, career counseling, and curanderismo.

We wish to thank Ms. María González for her excellent work and long hours spent preparing the many 3 x 5 cards required in this project. Ms. González also typed the entire manuscript.
