ABSTRACT

In this annual report to the nonpublic participant schools of Project PEP (Providing Equitable Participation), 39 exemplary instructional improvement programs written by the schools are described. Schools were encouraged to make long-range improvement plans by focusing on acquisition of Title IV-B supplementary instructional materials and library resources for students and curriculum areas showing the greatest need, and each program contains a rationale for needing the supplementary materials, an objective to be achieved, a plan for using the materials in the instructional program, and a plan for evaluating the degree to which the objective was reached. This booklet was designed to encourage schools to contact each other for additional information, as the programs described suggest models for other schools desiring to write instructional improvement programs. Part I provides brief descriptions of the 1981-82 projects in 12 categories: reading, science, math, social studies, language, study skills, library, art/music, map skills, computer, health, and other topics. Each project is explained with a 1-page format, showing target topic, grade level, target site, type of school, school name, contact person(s), school data, target group objectives, methods and materials used, and results. The second section presents statistical data on the growth of the project and its status through the 1981-82 school year, some data on 1982-83, and a map of service regions.

PART I

BRIEF DESCRIPTION OF EXEMPLARY PROJECTS

The first section (Part I) of this publication provides brief descriptions of exemplary 1981-'82 school-year instructional improvement programs under Project PEP - Title IV B in Missouri. The purpose of the brief remarks that follow is to describe the process used to select this year's exemplary programs.

Based on favorable response to previous publications of *Trailblazers*, this publication also features a wide cross section of projects in different subject areas. To provide examples of the numerous possibilities for projects, Project PEP Staff selected a total of 39 exemplary projects in 12 categories of subject areas, including an "other topics" ("at large") category. The 12 categories are as follows, with the number of exemplary projects described within that category shown in parentheses: reading (8); science (4); mathematics (8); social studies (2); language (4); study skills (3); library (1); art/music (2); map skills (2); computer (2); health (1); and other topics ("at large") (2).

The number of selections within each category corresponds rather closely with the proportion of projects in that particular category. During the 1981-'82 school year, there was a total of 664 target topics among the 453 participating schools. Of the 664 target topics, the percentage under each category that selections were made for this publication were as follows: reading (includes remedial and recreational reading and reading enrichment) = 23 percent; science = 10 percent; mathematics = 13 percent; social studies = seven percent; language = eight percent; study skills = four percent; library skills = seven percent; art/music = six percent; map skills = four percent; computer = four percent; health = two percent; and other topics = 12 percent.

Criteria in addition to subject areas that were considered in making the selection were clarity of initial program description, relationship of one's

evaluation plan to the objective(s) cited, degree of match between one's final project evaluation and the initial or revised objectives, and the reported success of program implementation. Considerations related to the last criterion must be addressed. Exemplary programs were not selected on the basis of high evaluations alone. All of the other criteria were also considered. On a ten-point evaluation scale with ten as the highest possible rating, a project with a five-point rating may have been selected over one with a ten-point rating, if the project with the lower rating were exceptional by the other criteria used in making the selections.

The Project PEP staff encourages you to call the school and ask the principal/contact person for more information about a specific project described in this or other *Trailblazers* publications. We also encourage you to call the Project PEP office for additional suggestions for design and materials for a particular Target Group program you may want to write.

SCHOOL DATA: Corpus Christi District School, located in Jennings in St. Louis County, is an elementary school with 218 students.

TARGET GROUP OBJECTIVES:

After attending a workshop the kindergarten teacher implemented a technique that appeared appropriate for enhancing the pre-reading skills of kindergarten students and reading skills of first-graders. In a pilot study the teacher found the students eager to try the new approach called "Success." The stated objective was to increase the vocabulary of kindergarten and first-grade students and to increase their attention span during silent reading time.

METHODS AND MATERIALS USED:

Title IV B funds were used to purchase dictionaries, word books and high interest story books for children on the K-1 levels. Sixty-four high-interest level books and "first dictionaries" were purchased from Follett Library Book Service. Books included the "Little Monster" series, "Richard Scarry's" series, and "Charlie Brown" series. These materials were used together with word charts to stimulate interest in vocabulary and reading. At various intervals (planned weekly) the amount of reading time was measured for kindergarten and first-grade students.

RESULTS:

Targeted kindergarten students increased their average reading time from two minutes at the beginning of the school year to eight and one-half minutes at the end. The teacher reported that the picture identification skills and basic vocabulary of these students had been strengthened. First graders increased their silent recreational reading attention span from 10 minutes to 30-45 minutes. They also achieved a class mean score of 84th percentile rank on the National Standard Vocabulary Examination.

This school gave its Title IV B Project in Reading a rating of "8."

SCHOOL DATA: Faith Lutheran, located in Kirksville in Adair County, is an elementary (K-5) school with an enrollment of 29 students.

TARGET GROUP OBJECTIVES:

Teachers at Faith Lutheran use the "Language Experience" approach to reading which encourages readings based upon student interest. Teachers viewed their reading materials as inadequate in meeting the interests and needs of the students. Teachers also observed a reluctance on the part of students to read independently. The stated objective was to increase the number of books read by targeted students and to have these students feel more positive about selecting books independently.

METHODS AND MATERIALS USED:

Title IV B funds were used to select books appropriate for the reading levels and interests of the targeted students. A wide selection of books on plant, and animal life, health, and other topics were obtained primarily from Follett Library Book Company and also from 17 additional publishers. Silent sustained reading time, as well as in class reading time, was provided for the students. All students kept records of the number of books read. Teachers observed the attitudes of students in selecting materials independently.

RESULTS:

Twenty-one students read a total of 428 books during 1981-'82, compared with 220 books that those same students read the year before. These figures reflect a 95 percent increase in the total number of books that were read by the same students from one year to the next. Every student increased the number of books that she/he read. The most dramatic changes occurred among the six and seven-year old students.

This school gave its Title IV B Project in Reading Enrichment a rating of "8."

SCHOOL DATA: Green Park Lutheran School is located in Mehlville in the Southern area of Metropolitan St. Louis and serves 476 students in grades K-8.

TARGET GROUP OBJECTIVES:

At least 50 percent of the third and fourth-graders were expected to increase their reading comprehension scores by a 1.2 grade placement over the school year by reading a variety of recreational selections.

METHODS AND MATERIALS USED:

The school chose books containing literature appropriate to grades 3 and 4 which they felt contained "good" literature. Students were exposed to the new selections in a "touch-n-see" session before the books were shelved or placed on mobile carts for use in the classroom. During the "touch-n-see" session, students sat on the outside of a large circle made with the new books. When a signal was given, each student picked up the book in front of him/her and thumbed through the book. Given another signal, students rotated to the next new book until they had the opportunity to examine each new book and learn a small bit of information about each book. Teachers take the students to the library for bi-weekly visits in addition to allowing them to select books from the mobile carts in the classroom.

RESULTS:

Attainment of the objective was measured by comparing the results of the Reading Comprehension Section of the Stanford Achievement Test at the end of this school year with the results from the previous school year. Such comparison showed that 56 of the Target Group gained the proposed 1.2 grade level of growth over the school year.

SCHOOL DATA: Holy Innocents, located in the City of St. Louis, is an elementary school with an enrollment of 178 students.

TARGET GROUP OBJECTIVES:

Administrators and teachers observed a need among fifth graders for supplementary reading materials. These students ranged from the 17th percentile rank to the 99th percentile rank on standardized reading tests. Teachers also observed a lack of student interest in and enthusiasm for outside reading, lack of interest in checking out books from the library, and poor book reports. The stated objective was to have each targeted student read at least one book per month and to have students at the 85th percentile rank or better in reading to read at least two books per month.

METHODS AND MATERIALS USED:

Title IV B funds were used to purchase library books which appeal to a broad range of interests and reading levels. Complete units of books on "Animals," "Adventure and Suspense," and "Frontiers" were purchased. These books were made available to students in the classrooms at all times. Each day 15 minutes was set aside for silent reading time for the students. During that time, teachers helped students to discover books to meet their interests and reading levels.

RESULTS:

Targeted students significantly surpassed the project objective at Holy Innocents. Each student read a minimum of two books a month and submitted book reports that were creative, interesting, and full of enthusiasm.

This school gave its Title IV B Project in Reading Enrichment a rating of "8."

SCHOOL DATA: Holy Rosary School, located in Monroe City in Monroe County,
is an elementary school with an enrollment of 163 students.

TARGET GROUP OBJECTIVES:

Reading scores of students in grades 5 and 6 on SRA achievement tests had been lower than teacher expectations. Teachers estimated that about one-sixth of the students in grades 5 and 6 were reluctant readers. The stated objective was to have targeted students in those two grades begin to enjoy reading and to read at least one book per month.

METHODS AND MATERIALS USED:

Title IV B funds were used to purchase library books with titles and reading levels that appeal to reluctant readers. A minimum of two 20-minute free reading periods were held weekly during the school year. Each targeted student was expected to keep a log of books read and a checklist of the level of enjoyment associated with reading each book (e.g. "very little," "fair," "pretty much," "a lot"). Sports and other human interest books were purchased from Golden Press, and mystery and adventure series were obtained from Educational Reading Services.

RESULTS:

All but one targeted student read at least one book per month. The student who did not achieve the goal was viewed as not wanting to be considered a reader but was "caught" several times with excellent reading materials nonetheless.

This school gave its Title IV B Project in Recreational Reading a rating of "9."

SCHOOL DATA: Lutheran School Association, located in Cole Camp in Benton County, is an elementary school with an enrollment of 83 students.

TARGET GROUP OBJECTIVES:

Based upon their own observations and scores of the Standard Evaluation Tests, teachers viewed students as needing help with basic reading skills, especially decoding skills. The stated objective was to have second-grade students show an improvement in reading skills, particularly decoding skills, by scoring at or above grade level on the Houghton Mifflin Standard Evaluation Tests.

METHODS AND MATERIALS USED:

Title IV B funds were used to establish a listening center so that small groups of students could learn the sounds of letters and words, the meanings of words, and the relationships between words in an interesting manner. A "Cassette Recorder" and a "Listening Center" were purchased from Audio Visual Educational Systems and dictionaries and books of fairy tales were obtained from Troll Associates. Targeted students met in small groups under the guidance of a teacher for one-half hour each day for six weeks to achieve the objectives discussed previously.

RESULTS:

Seventy-five percent of the targeted students showed a marked improvement in basic reading skills according to the scores on the Houghton Mifflin Standard Evaluation Tests. The class mean increased from 82 percent to 88.5 percent of the items correct on the standardized tests.

This school gave its Title IV B Project in Reading a rating of "7."

is an elementary school with an enrollment of 524 students.

TARGET GROUP OBJECTIVES:

Through teacher observation and/or mastery skills testing, it was determined that students were deficient in reading comprehension skills in grades 1-3. The stated objective was to increase the reading scores of students in grades 1-3 by 10 months between pretests (fall, 1981) and posttests (spring, 1982).

METHODS AND MATERIALS USED:

Reading kits, record players, records, and other reading aids were purchased with Title IV B funds. "Study Mats," a "Guinness Book Set," and "Reading Quizzes Filmstrips" were purchased from the Society for Visual Education. "Panasonic Cassette Recorders" and record players, a listening center, "Learning Centers," and a "Creature Teachers Set" were also purchased.

RESULTS:

Eighty-five percent of the targeted students achieved at least the expected 10-month increase in achievement level in reading. Thirty percent of this group showed an increase of 15 months or more in their achievement level.

This school gave its Title IV B Project in Reading Enrichment a rating of "8."

SCHOOL DATA: St. Joseph Croatian School, located in the City of St. Louis, is an elementary school with an enrollment of 152 students.

TARGET GROUP OBJECTIVES:

Due to the large numbers of students in grades 1 and 2, there was insufficient time to listen to the students read orally for a specific period of time each day. The stated objective was to have students in grades 1 and 2 read orally each day and manifest: (1) a mastery of the basic vocabulary words and (2) an improvement in the ability to read well orally.

METHODS AND MATERIALS USED:

Title IV B funds were used to purchase ten sets of "Special Practice Reading Books" from Scott, Foresman and Company. Small groups of targeted students in grades 1 and 2 read orally to each other daily for a 15-minute period, using supplementary readers. As students completed a supplementary reader, a teacher-made test was administered to each child to assess progress made in vocabulary-building and the ability to read orally.

RESULTS:

Teacher-made tests were administered twice weekly in March, April, and May. These tests were passed by 15 out of 17 first graders and were passed by 11 of the 12 second graders. The supplementary reading materials were viewed by teachers as having been very beneficial to the vast majority of students.

This school gave its Title IV B Project in Supplementary Reading a rating of "10."

TARGET GROUP OBJECTIVES:

Accurate and precise measurements in the chemistry laboratory have been major objectives of the chemistry program at this school. Chemistry teachers noted an error rate of approximately 10 percent in quantitative chemical measures prior to the Title IV B project. The stated objective was that students enrolled in chemistry courses would reduce error rates to within three percent of accuracy on quantitative measures.

METHODS AND MATERIALS USED:

Title IV B funds were used to purchase an "Ainsworth Balance" for electronic measurement. Chemistry students regularly used this instrument for their chemical measurements.

RESULTS:

For the synthesis of SnO_2 the experimental error was 1.35 percent for 60 students. For the mass - mass relationship of Fe to Cu the experimental error was 1.6 percent for 56 students. With the use of the electronic measuring device there was a substantial decrease in errors from previous years.

This school gave its Title IV B Project in science a rating of "10."

SCHOOL DATA: The Missouri Military Academy, located in the city of Mexico in Audrain County, is a special purpose school with an enrollment of 322 students in grades 4-12.

The stated objective was to increase class discussions and create more interest in science among the students through the use of filmstrips.

METHODS AND MATERIALS USED:

Title IV B funds were used to purchase filmstrips on such topics as optics, gravity, and waves sound. The purchased materials included: "Fundamental Concepts 'Optics' Cassette," "Fundamental Concepts 'Gravity' Cassette," "Quantum Theory: Particles and Waves Sound Filmstrip" and related program guides, all from Learning Arts. Filmstrips were shown in the ninth-grade Physical Science and the twelfth-grade Physics classes. Behavioral objectives and trimester tests were developed and/or revised to reflect the emphasis upon information gained from the filmstrips and upon discussion of scientific topics.

RESULTS:

Filmstrips and motion pictures were used as a practical way to simulate wave motion, falling bodies, projectiles, etc. A wider range of scientific content was presented and discussions of scientific topics were stimulated.

Recent events such as the Mt. St. Helena volcanic eruption and various space program launchings were video-taped for use in the science classes. Tapes that have been developed are kept in the school's science library. The science program for the current year and for future years has been enriched.

The Target Group completed the assigned packets which included pretests and posttests; a study of theory from the Houghton Mifflin supplementary algebra text, required assignments and worksheets, and one extra credit project.

RESULTS:

The math teacher reported that "...students have done beautifully on all work and tests. Entrance tests to high school also showed an amazing amount of above-level achievement in mathematics." Students achieved 90 percent accuracy on all their required work.

Title IV B funds were used to purchase a math kit, hand-held calculators, protractors, and compasses. Hand-held calculators were used throughout the school year with calculator exercises in the student text and with the problem-solving kit to eliminate the boredom and frustration of lengthy calculations, placing more emphasis on math concepts. Hand-held calculators also were used with advanced eighth-grade students in solving trigonometric ratios in the last quarter of the school year. Hand-held calculators were used by a small group of slower-paced students to strengthen their computational skills and to foster a successful experience with math computations.

RESULTS:

Students increased their skills in the use of hand-held calculators, protractors, and compasses. Teachers also observed that targeted students attacked word problems with more confidence.

On the posttest that was used to evaluate the gains that the students made in metric measurement, 92 percent of the students (24 students) were rated by the teacher as having done "very well." Only two students (eight percent) did poorly. The fourth-grade students also helped to teach the second graders how to perform metric measurements.

The Title IV B benefits used by these classes included "Living French" recordings from Crown Publishing Company, which were used in conjunction with a cassette recorder and listening station.

RESULTS:

This Target Group project was rated highly successful. The French language teacher made tests with which to measure student growth and reports that students increased their knowledge of the French language and also showed increased enthusiasm for the development of the language.

METHODS AND MATERIALS USED:

Title IV B funds were used to purchase a kit that contains a set of lessons and materials designed to promote cognitive and oral language development. The kit titled "Complete Peek Kit" ("Peabody Early Experience Kit" with seven records) was purchased from the American Guidance Service. Teachers used the kit on a daily basis. Teacher aides also used the materials in individual teaching sessions with each child to reinforce information presented in the class setting. The Portage Guide to Early Education Checklist was used, and behaviors/skills in each of the development areas were recorded on a separate checklist for each child at the beginning of the program year. At the conclusion of the program, students were again evaluated to measure the achievement of the sequential skills that were targeted.

RESULTS:

At least 75 percent of the students in the three targeted classrooms demonstrated at least six additional skills in the areas of cognitive and language development when assessed with the Portage Guide to Early Education Checklist at the completion of the program.

RESULTS:

Eighty-three percent of the kindergarten class scored at least average or higher on listening comprehension skills. A combination of teacher's observation and evaluation and the language area score of the Metropolitan Readiness Test (MRT) were used to make this evaluation. Sophomore World History students scored consistently higher on exams as the program continued. RESULTS:

Students in grades 3 - 8 performed before audiences on at least two occasions. Students in Grades 7-8 attended a Diocesan Music Enrichment Day and played their instruments there.

METHODS AND MATERIALS USED:

Title IV B funds were used to purchase maps and atlases. Reference atlases for individual students and wall maps were obtained from Nystrom. The use of student atlases and wall maps were incorporated into the sixth-grade World Studies curriculum. Map skills, basic geographical locations, historical information, current events, and visual relationships were studied through the use of individual student atlases. Individual outline maps, textbook materials, and teacher input were integrated to give students a well-rounded study of various areas of the world.

RESULTS:

On the posttest, 89 percent of the sixth graders were able to label the seven continents, major bodies of water, and 15 selected countries. More importantly to the teacher, students became familiar with maps, legends, scales of miles, and general information which is not included in the usual text coverage.

"Nutrition for You" by Educational Activities, "The Human Body," and "Beginning Health and Nutrition" by Rio Grande, and other supplemental reading materials were obtained with Title IV B funds. Teachers used the supplementary materials to reinforce the health science concepts being taught. Teachers conducted small group activities once a week for 30 minutes using either demonstrations, experiments, or discussion groups to teach the concepts.

RESULTS:

From pretests to posttests, students gained 48 percent in their ability to identify the four basic food groups and to plan a balanced menu.

PROJECT STATISTICS

The second section of the *Trailblazers* provides statistical data on the growth of Project PEP Title IV-B and its status through the 1981-'82 school year with some data on the upcoming year.

In the report to Washington in 1977-'78, the Missouri Department of Education reported that 13,000 nonpublic school students participated in Title IV B benefits. The table on page 44 indicates the change that has occurred since the "bypass" has been invoked. This *Trailblazers* '81-'82 reports on 453 schools serving 111,017 students and also provides some data on the '82-'83 school year.

In 1981-'82, 81 of the participating schools were classified as secondary, teaching grade levels 9, 10, 11, and/or 12 in their patterns of organization with an enrollment of 33,010 students. There were 29 different patterns of organization among the 453 participant schools; however, K-8 is the most frequently found pattern of organization at the elementary level and 9-12 at the secondary.

Eighty-five percent of the student participants are enrolled in Catholic schools which represent 77 percent of the schools. Thirteen percent are Lutheran schools and the other 10 percent are representative of five different denominational or religious groups or are independent and/or special purpose schools.

The map of Missouri (page 48) shows how the PEP Title IV-B staff has divided the state into six service regions. All data received from schools in a particular region are filed into colored folders which correspond to the color designation assigned to that region, i.e., data for St. Joachim School, Old Mines, Washington County, Missouri, within the St. Louis Archdiocese, are filed in an orange folder.

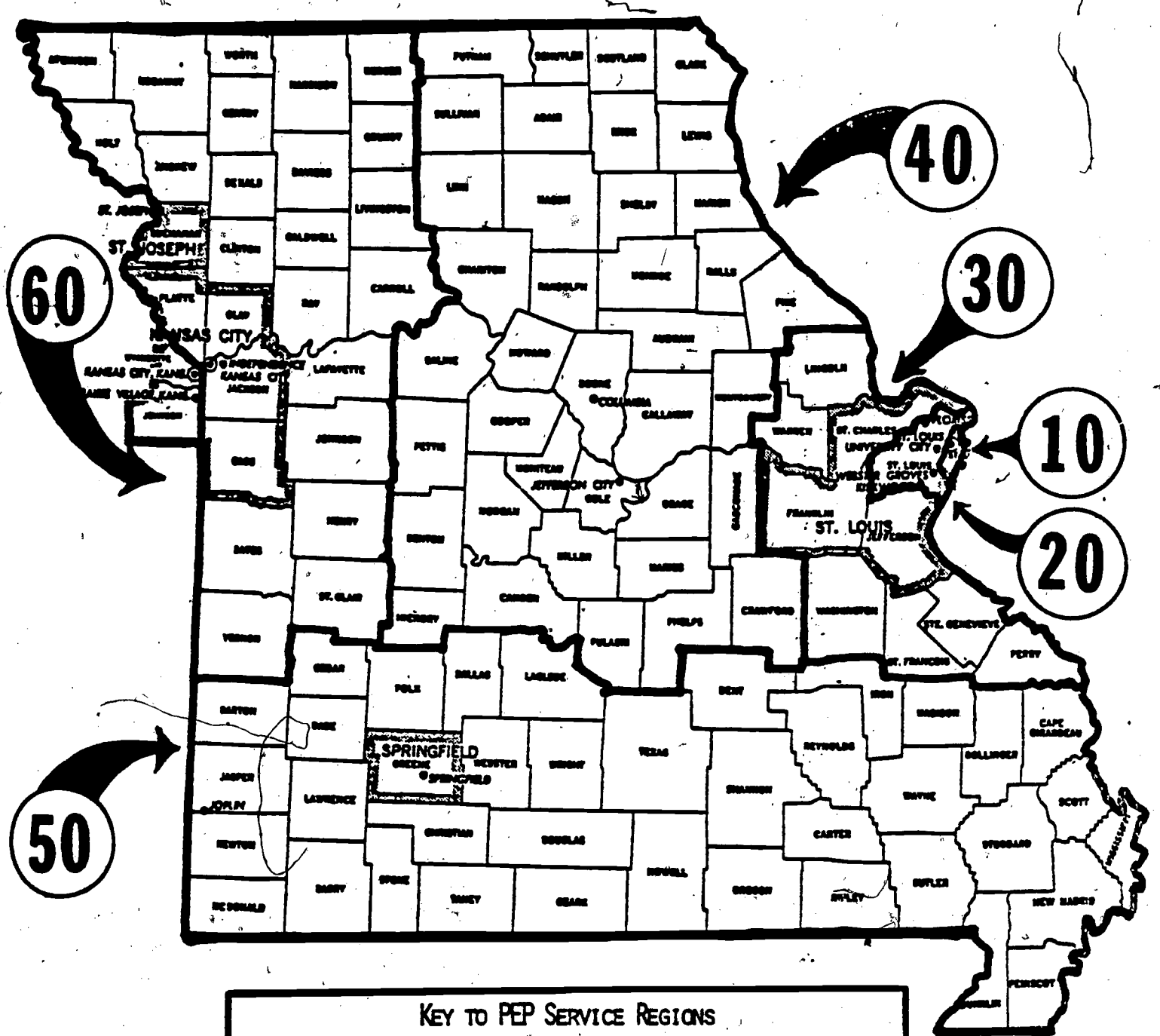
