ABSTRACT

A directory of 173 doctoral dissertations in progress or completed in the early 1980s at 36 universities is presented that covers 7 areas related to the study of higher education. The directory was compiled by the ASHE Committee on Graduate Students, based on a survey of U.S. and Canadian professors of graduate programs in higher education. Each entry identifies the title of the dissertation, the author, the sponsoring professor, the university, and the date. The topical areas are as follows: organizational forms and ethos, administrative behavior and factors, policy and planning, environmental/external factors, academic processes and factors, curriculum/learning and teaching, and educational foundations. The names and addresses of authors willing to provide copies of their research proposal are included, along with a list of institutions participating in the dissertation survey. Summary data are appended on the characteristics of graduate students responding to the survey. Responses were received from 173 students from 36 universities with advanced programs in the study of higher education. Of the 173 respondents, all except three were completing requirements toward the Ed.D. or Ph.D. (SW)

INTRODUCTION

New knowledge is rarely the product of solitary work. Researchers rely on one another in a variety of ways: they exchange ideas and data; they consult on methodology; they review and criticize each other's work before it is published.

This process of exchange and consultation serves many purposes. It creates bonds of support between researchers, it results in collaborative efforts; but most important of all, it serves as a source of stimulation that often leads the researcher to new insights and interpretations. Not surprisingly this process is more likely to take place between experienced researchers who have similar research interests.

For graduate students, opportunities to exchange ideas or consult with novice as well as experienced researchers are often limited. This directory, therefore, has been prepared by the Committee on Graduate Students of ASHE in an effort to encourage and stimulate greater collaboration and communication among graduate students and professors from universities across the country.

The directory includes the titles of 173 doctoral dissertations in seven areas related to the study of higher education that are in progress or were recently completed. For each entry we have included the author's name and the name of the sponsoring professor. Many of the students who responded to our survey expressed a willingness to make their dissertation proposal available; their names and addresses are included at the end of the directory.

We hope the directory will be useful. Moreover, since we anticipate that the directory will be published annually, we welcome any suggestions you

A Note about the Survey

The information included in this directory was collected through a survey prepared by Fannie Brown, former chair of the committee on graduate students. The survey was distributed to all professors of higher education included in ASHE's Higher Education Directory. Professors who received the survey assumed responsibility for its distribution among their graduate students.

Responses were received from 173 students from thirty-six universities with advanced programs in the study of higher education. Of the 173 respondents, all except three were completing requirements toward the Ed.D. or Ph.D. Characteristics of the respondents are summarized in Appendix A. The institutions from which responses were received are listed in Appendix B.
