ABSTRACT

Divided into three major sections, Information Policies, Legal Information, and Presidential Information, this bibliography provides full citations for a wide range of government publications. Call numbers and locations of the documents in the Syracuse University Library system are supplied. Within the Information Policies portion, there are sections on reference sources; domestic information policies; international information policies; information resources management; and computer security. The Legal Information section includes reference sources; legislative information; and regulatory information. The section on Presidential Information covers reference sources; monographs; and periodical articles. Monographs and periodical articles are listed for each section, and manuals, guides, series, indexing and abstracting services, and journals are listed when appropriate. (THC)
