ABSTRACT

A bibliography on financing the education of physicians for primary care is presented, based on a search of the "Index Medicus" primarily for the period 1971-1983. Selected articles from 1984 are also included. The approximately 65 references are listed alphabetically by the lead author's surname. Selected periodical articles have been grouped into five specific subject areas: primary care, costs and financing in educational settings, ambulatory care costs and financing, medical practice plans, and third parties and reimbursement. The remainder of the articles are located in the general bibliography. A selected list of nonperiodical references is also provided. (SW)

A BIBLIOGRAPHY ON FINANCING THE EDUCATION OF PHYSICIANS FOR PRIMARY CARE

This bibliography was developed as a resource document for those interested in the area of financing the education of physicians for primary care. The periodical articles were the result of a comprehensive manual search of the Index Medicus which was concentrated approximately on the period of 1971 through the middle of 1984, with the addition of selected articles through the first half of 1985. Non-periodical publications were identified primarily from library searches and references in the periodical literature. References were selected from approximately twice the number included here, after reviewing for applicability to financing physician education, especially in primary care.

Selected periodical articles have been grouped into five specific subject areas: Primary Care, Costs and Financing in Educational Settings, Ambulatory Care Costs and Financing, Medical Practice Plans, and Third Parties and Reimbursement. The remainder are located in the general bibliography, beginning on page 11. All references are listed alphabetically by surname of the lead author, within each subject group and again in the general bibliography. A separate list of non-periodical references follows, beginning on page 37 and again listed alphabetically by lead author surname.

Joel J. Alpert, M.D., of the Boston University School of Medicine is the inspiration for this project. He provided overall guidance and helped select references to be reviewed for inclusion. Appreciation for making the project possible is owed to Kenneth P. Moritsugu, M.D., Director of the Division of Medicine at the time the project was initiated, and to Daniel N. Masica, M.D., for his continued support when he became Director of the Division. Special thanks go to Gerald R. Hejduk, Chief of the Primary Care Graduate Medical Education Branch, Division of Medicine, who was most supportive of the project.
