ABSTRACT

This report updates recent trends in household and family characteristics and contains demographic data from the March 1986 "Current Population Survey." The population characteristics include household composition, household and family size, age at marriage, and unmarried couples. The document reports that the U.S. population characteristics are changing. These changes include an increased variety in the composition of households; a decrease in the size of families and households; an increase in married and unmarried couples; and men and women getting married at a later age. Figures and tables summarize the data and include "Average Size of Households and Families: 1950 to 1986"; "Number of Married and Unmarried Couples, 1986, 1980, and 1970"; "Household Composition: 1970 to 1986"; "Average Population per Household and Family: 1940 to 1986"; "Median Age at First Marriage, by Sex: 1890 to 1986"; "Persons Age 15 Years and Over and Percent Never Married, by Age and Sex: 1986, 1980, and 1970"; "Selected Characteristics of Unmarried Couple Households: 1986 and 1980"; and "Household and Family Units, by Type: 1940 to 1986." Household Composition

There were 88.5 million households in the United States in March 1986, a net increase of 1.7 million over the corresponding total for 1985. The increase in households during the past year was higher than the average net annual increase of about 1.2 million during the 1980-85 period, but was not significantly greater than the 1.6 million annual average for the 1970's.

The terms household and family do not necessarily describe the same type of living arrangement. Although most households consist of a family, many do not. A family household requires at least two persons: the householder and one or more additional persons related to the householder through birth, marriage, or adoption. Families accounted for about 72 percent of all households in 1986, compared with 74 percent in 1980 and 81 percent in 1970 (table 1).

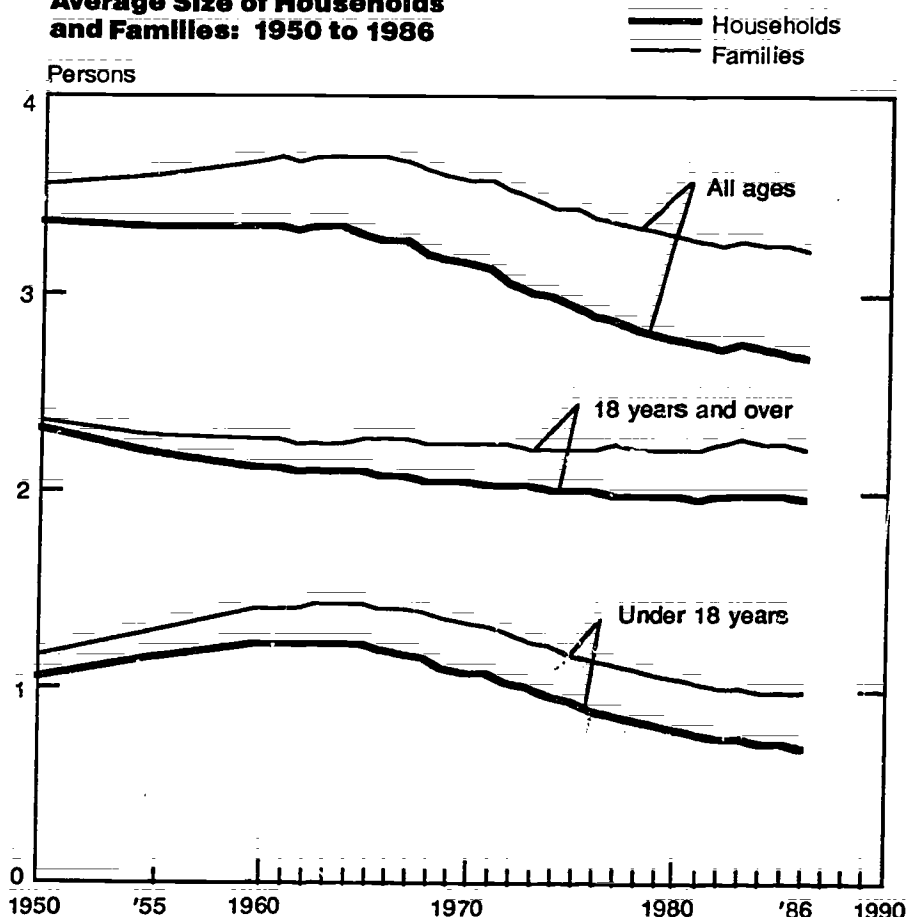
The three types of family households identified by the Census Bureau are married-couple families; other families with female householder (no husband present), and other families with male householder (no wife present). In 1986, married-couple families accounted for 58 percent of all households, and other types of families accounted for 14 percent; in 1970, these proportions were 71 and 11 percent, respectively. Thus, the decline since 1970 in the overall share of households consisting of families is attributable to the drop in the proportion of married-couple households, which was only partially offset by an increase in the proportion of households maintained by other types of families.

A nonfamily household is either a person living alone, or a householder living with one or more other persons

who are not related to the householder. Nonfamily households accounted for more than half (53 percent) of the total net increase in households between 1970 and 1980, and their contribution to household increase was not significantly lower during the 1980-86 period (48 percent). About 85 percent of nonfamily households in 1986 were persons living alone. The proportion of household

increase attributable to persons living alone was 43 percent for the 1970-80 period, which was not significantly higher than their 38 percent share of the net change from the 1980-86 period. About 3.7 million, or 15 percent, of nonfamily households in 1986 contained more than one person. About 1.8 million of these multi-person nonfamily households were unmarried couples.

Household and Family Size

Changes in the composition of households have contributed to the decline in the average number of persons per household. Fewer children per family, more one-parent families, and more persons living alone are all factors¹ in the decline in average household size, which fell to a new low of 2.67 persons in 1986, compared with 2.76 in 1980 and 3.14 in 1970 (table 2).

Average family size also reached a new low of 3.21 persons in 1986, down from 3.29 in 1980 and 3.58 in 1970. Household size and family size have fallen largely because of the decline since the mid-1960's in the average number of persons under 18. Compared with the past, households and families are more likely to contain fewer children, or no children at all.

Age at Marriage

In 1890 (the first year for which such data are available), the median age at first marriage was 26.1 years for men and 22.0 years for women. The median age at first marriage is that age by which half of the persons who will ever marry have done so. By 1956, the average age at which persons initially married had declined to 22.5 years for men and 20.1 years for women. During the period of roughly the past 30 years, the trend has reversed, and by 1985 the estimated median age at first marriage had reached 25.5 years for men and 23.3 years for women (table 3). The rise in the median was especially rapid between 1975 and 1985. In 1986, the median stood at 25.7 years for men and 23.1 years for women. Although the median age at first marriage for men during the 1980's has not been quite as high as that recorded for men in 1890, the median for women over the period since 1980 has been as high or higher than any previously recorded level.

Many of today's young adults are apparently choosing to remain single for a longer period prior to entering their first marriage, at least as compared with their predecessors in the

1950's. The recent general trend toward postponing marriage may reflect a greater tendency among some young adults to pursue advanced education, or to establish themselves in a career prior to assuming family responsibilities.

Another indication of the extent to which people are delaying marriage is the increase in the percentage of persons in their twenties and thirties who have not yet married. For example, about 58 percent of women 20 to 24 years old had not married in 1986—a 22-percentage point increase from the corresponding proportion in 1970 (table 4). While many women marry in their early twenties, about 28 percent of women 25 to 29 years old in 1986 had not yet married; this figure is up from 11 percent in 1970.

The 1986 data indicate that only about 5 percent of women age 40 or older had never married. It is not yet known whether today's young adults, after a period of delay, will eventually marry in as high a proportion as their predecessors, but it is likely that the vast majority of men and women who have not yet married will do so at some point in their lives.

Unmarried Couples

In 1986, about 2.2 million persons were maintaining living quarters which they shared with one unrelated adult of the opposite sex. About 1.4 million or 61 percent of these "unmarried-couple" households consisted of a

male householder with an unrelated woman sharing his household, and the remainder were women sharing their household with an unrelated man (table 5).

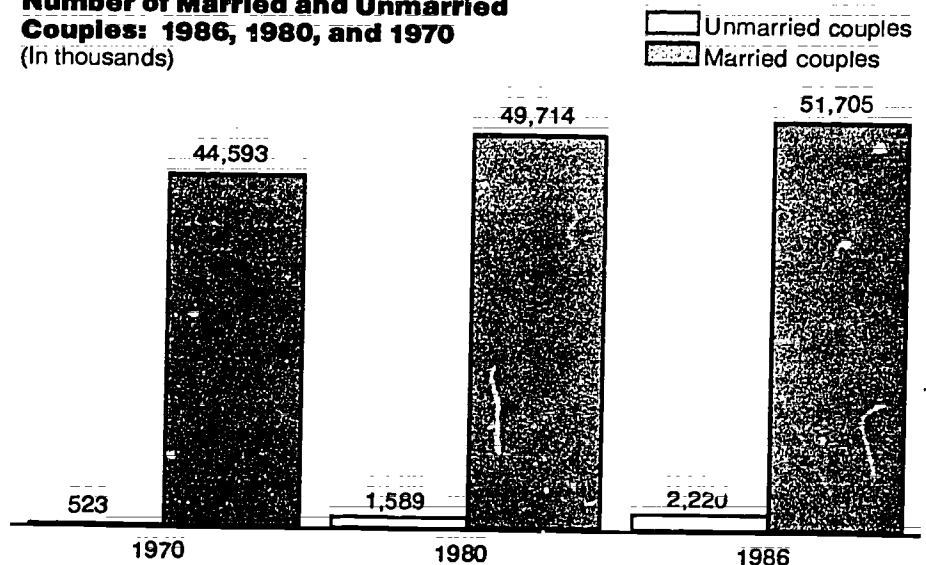
Although the term "unmarried couple" can be interpreted as implying some sort of intimate relationship between the two adults in a household, the Census Bureau does not ask questions concerning the nature of the couple's relationship. Many of the unmarried-couple households may be made up of boyfriends and girlfriends, but others involve situations such as owner-tenant relationships or paid employees of the householder.

Seventy percent of unmarried-couple households contained only two persons in 1986, while the others had one or more children present. By Census definition, an unmarried couple consists of no more than two persons, unless children are present.

About 52 percent of unmarried-couple householders in 1986 were persons who had never been married, and an additional 34 percent were divorced. About 93 percent of the net increase in unmarried couples during this decade is attributable to householders that were in one of these two categories.

As shown in figure 2, there were about four times as many unmarried couples in 1986 as there were in 1970. Although there is widespread interest in the quite substantial increase in this type of living arrangement, the fact that unmarried couples represented

only about 4 out of every 100 couples in the Nation in 1986 provides some perspective on the magnitude of the numbers. In addition, the rate of increase in the number of unmarried couples has dropped from 11.1 percent per year during the 1970's to 5.6 percent annually over the period since 1980.²

Revised Estimates

The survey weighting procedures for persons of Spanish origin have been revised. The effect of the new weighting methods can be seen in table 6, which shows estimates for 1984 based on both the original and revised methodology. Prior to 1984, the estimation procedures used in the survey controlled to independent

estimates of the population by age, sex, and race, but not to independent estimates of the Hispanic population. Since 1984, the weighting procedures have included controls for the Hispanic population by sex and age, and beginning in 1986 these population control totals also include estimates of undocumented aliens.

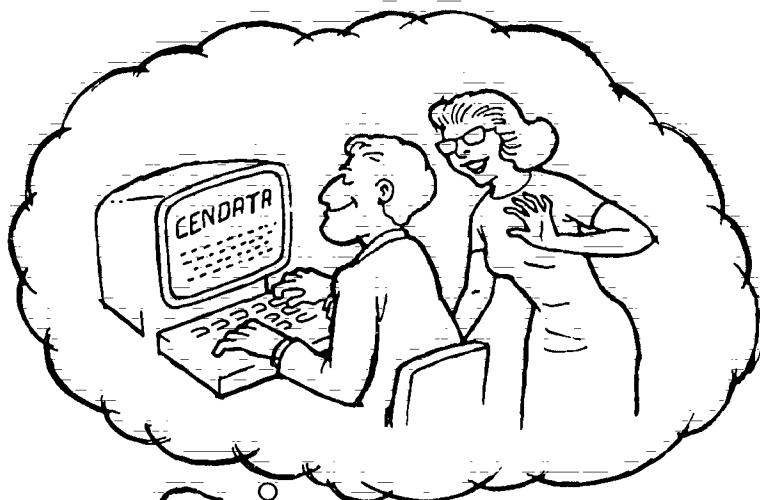
