ABSTRACT

This guide is a selective introduction to the major research tools in Canadiana found in the Fogler Library at the University of Maine. A brief description and explanation of the card catalog, Library of Congress Subject Headings, Library of Congress Classification System, and the Dewey Decimal System precede the annotated listing of specialized library reference sources on Canadiana. These materials are listed in 17 categories: general reference works; almanacs and annual guides; archives and manuscript collections; atlases; bibliographies; biographical sources; dictionaries; directories; dissertations; encyclopedias and handbooks; guides to instructional materials; indexes and abstracts; microform research collections (in process); newspapers; statistical references; government documents; and special collections. Concluding remarks inform students of the availability of a computer print-out of periodical holdings in Canadiana; computer researches; a collection of current Canadian telephone directories; and the services and activities of the Canadian-American Center, Canada House, on the Orono campus. GUIDE TO SOURCES: CANADIANA

This guide is a selective introduction to the major research tools in Canadiana found in Fogler Library. A companion publication in this series, Guide to Sources: Franco-American Studies, may also be of interest.

The card catalog functions as an index to a major portion of the resources found in Fogler Library. Each book or item included in the card catalog has an author card, a title card, and one or more subject cards.

Library of Congress Subject Headings is a guide to the headings used in the card catalog. A Reference Librarian will show you how to use it. Knowledge of this tool may save time and open new avenues of approach to your subject. Copies of these volumes are located near the card catalog and the Information Desk.

Most of the books in Fogler Library are classified in the Library of Congress system based upon letter and number combinations. A few, however, are classified in the Dewey Decimal System used prior to 1967. The latter books, though older, may still be useful. An example of each classification is shown below:

All call numbers are on the upper left hand corner of the catalog card. The first line of the call number is particularly important. It indicates whether the material is in the general collection or in a special area. Copy the entire number. Large charts near the card catalog give the stack location of books bearing these numbers and designations.

Lists publications of Canadian origin or interest, including material written by Canadians and published in other countries. Coverage of types of material is very comprehensive: monographs, pamphlets, serials (annuals, directories, periodicals, newspapers), federal, provincial, and municipal government publications, theses on microform. Monthly, with annual cumulations.

There are also compilations of specialized Canadian dissertations on history, literature, political science, etc. in the Information Services area.

Canadiana. Many Canadian Universities are not covered in Dissertation Abstracts International. However, 80% of all master's theses and doctoral dissertations are eventually microfilmed and cataloged by the National Library of Canada which also sells microform copies. These appear in Canadiana. To see if a particular thesis or dissertation has been filmed, look under the author's name in the Canadiana index vols.

INDEXES
AND
ABSTRACTS

The most recent information on most topics and often the only information on recent developments will be found in periodical literature or related publications. Indexes and Abstracts are the keys to this literature.

An Index is usually arranged by subject and provides a citation to the article. This includes the title of the article, author's name, title of journal, vol. number, pages, and date. An Abstract citation provides similar information, plus a summary of the article. Subject headings used in the Indexes and Abstracts are similar to those used in the card catalog.

Fogler Library's collection of Canadian newspapers on microfilm includes newspapers of the Atlantic Provinces and Québec printed in the 18th and 19th centuries. Current Canadian newspapers are shelved in the Oakes Room.

Fogler Library is a regional depository for U.S. federal government
publications and a selective depository for Canadian federal documents.
This collection represents a major resource for history, foreign relations,
political studies, statistics, maps, public administration, law, and social
studies.

Most government publications circulate overnight. Questions concerning
government documents should be directed to the librarians at the
Information Desk. The following titles may be helpful when consulting
Canadian documents.

An extensive "card file" compiled by the Canadian Documents Librarian at
Fogler Library. Useful for research in Canadian-American relations up to
the early 1980's. It chronologically indexes publications involving both
Canada and the United States (treaties, fisheries and boundary agreements,
import-export trade, etc.).

Canadiana.

Listed in the Bibliographies section of this guide, this monthly
bibliography includes a section of official publications. Cumulates
annually.

IC 6-11 (Index Table - Information Services Area)

Canadian Government Publications Catalog.

A monthly listing of most government publications by author, title, and
subject. There are two sections, the General Index and the Periodical
Index, listing publications in French and English. Quarterly, with annual
cumulations.

Microlog Index. 1979-

Privately published index to Canadian federal, provincial, municipal, and institutional literature. Monthly, with annual cumulations.

**SPECIAL
COLLECTIONS**

The Special Collections Department on the 3rd floor houses the State of Maine Collection, the Clinton Cole Maritime History Collection, Maine State government publications, the University of Maine Archives, and the University Collection. These collections contain much of interest to students of Canadian Studies. The Maine Collection includes materials on fisheries, the Aroostook Wars, Indians, and early coastal explorations. The Cole Collection is strong in modern Canadian shipping and naval operations, while the University Collection houses the papers of the Canadian-American Center and theses on Canadian-American relations by University of Maine faculty and students. Maine and Canada: A Bibliography of Materials Located in the Special Collections Department of Fogler Library by Charlotte Huntley (Maine Z 1291 .M25 1984) is a helpful guide to Canadian materials in this area and is available for consultation.

You may want to know...

that the Library subscribes to over 100 journals and newspapers covering Canada and related fields. A computer printout indicating Fogler's periodicals holdings in Canadiana may be consulted at the Information Desk.
