37. Adler, Mortimer J. WE HOLD THESE TRUTHS: UNDERSTANDING THE IDEAS AND IDEALS OF THE CONSTITUTION (New York: MacMillan Publishing Company, 1987). Foreword by Harry A. Blackmun, Associate Justice of the U.S. Supreme Court. Hardcover, 278 pages, \$16.95.

This book is an exploration of the Constitution, the Declaration of Independence, and the Gettysburg Address to commemorate the bicentennial. The author believes these documents set forth the beliefs we hold as a nation -- the beliefs that make the United States a unique country. Mr. Adler explains significant passages of these texts and poses questions that address the future of the Constitution. The book includes the three aforementioned cocuments and annotated excerpts from historical documents including notes from the Constitutional Convention, the Federalist and Anti-Federalist Papers, commentaries on the Constitution, and summaries of important Supreme Court cases.

The creation of the U.S. Constitution by the delegates to the convention in 1787 has often been called a "miracle." These men debated, argued, and compromised -- eventually crafting what is now the oldest written constitution still in use. This book examines who the framers were. A major part of this book first appeared in SIGNERS OF THE CONSTITUTION, published by the National Park Service in 1976. This new edition includes essays on the 16 delegates who contributed to the creation of the Constitution but did not sign the document, as well as a brief essay on the constitutional holdings of the National Archives.

42. Collier, Christopher, and Collier, James Lincoln. DECISION IN PHILADELPHIA: THE CONSTITUTIONAL CONVENTION OF 1787 (New York: Random House Reader's Digest Press, 1986). Hardcover, 331 pages. (Paperback version: Ballantine Books, 1987, \$4.95.)

A well-written, highly readable book about the people involved in the Constitutional convention. The character sketches, comments and insights of the authors are fascinating. They believe that if we understand the background of the founders and how they felt about such matters as power, liberty, truth, God, and life itself, we can better understand the forces that shaped our Constitution and ultimately, our own lives.

43. Coulter, E. Merton. ABRAHAM BALDWIN: PATRIOT, EDUCATOR, AND FOUNDING FATHER (Arlington, VA: Vandamere Press, 1987). A U.S. Constitution Bicentennial Pr ject of the District of Columbia Daughters of the American Revolution, hardcover, 304 pages, \$24.95.

Merton Coulter has written a detailed biography of Abraham Baldwin, whom he calls "one of America's long-neglected and least known founding fathers." It is his role as a founding father and his service to his adopted state of Georgia and the young nation that Coulter focuses on. Baldwin wrote the charter for the University of Georgia and served the state ably as a representative to the Confederation Congress and the Constitutional Convention. He served with distinction as a representative and later senator from Georgia to the U.S. Congress. Coulter's book provides more than a biography, it is the history of the young nation.

44. Ketcham, Ralph, ed. THE ANTI-FEDERALIST PAPERS AND THE CONSTITUTIONAL CONVENTION DEBATES (New York: Mentor, 1986). Paperback, 406 pages, \$4.95.

An easy to use reference book on the development of the Constitution and its ratification. The introduction includes a general discussion of the background of American political thought, political currents, Federalist and Anti-Federalist principles. Part I on the convention is arranged by subjects such as "Debate on Veto of State Laws" or "Slavery and the Constitution" and covers the significant area of debate at the convention. It also includes the text of the U.S. Constitution, its amendments, and the Declaration of Independence, as well as a chronology of dates from the American Revolution to ratification of the Bill of Rights.

46. Mitchell, Ralph. CQ's GUIDE TO THE U.S. CONSTITUTION: HISTORY, TEXT, INDEX, AND GLOSSARY (Washington, D.C.: Congressional Quarterly, Inc., 1986). Softcover, 108 pages, \$9.95.

The story of the three men who were witnesses at the creation of the Constitution and instrumental in its ratification. The author examines their correspondence, notes, memoranda, and speeches along with the papers of their adversaries. The result is a vivid account of how these three men, so different in personality and temperament, came together to champion the cause of the Constitution.

48. Riemer, Neal. JAMES MADISON: CREATING THE AMERICAN CONSTITUTION (Washington, D.C.: Congressional Quarterly, Inc., 1986). Approximately 200 pages, hardcover, \$11.95.

The intellectual evolution of James Madison is examined as a means to understand the government ne was instrumental in creating. The author identifies and discusses four issues Madison addressed. They include the sheer size of the new republic, threats to its unity, the "disease" of factionalism, and anti-republican dangers.

He is successful in his effort.

The book describes the drafting of the Constitution at Independence Hall in Philadelphia. It includes color photographs of the hall and a text by Richard B. Morris on the framing of the Constitution illustrated with drawings of the framers.
