ABSTRACT

This is a bibliography of works about women in the discipline of geography and geographic studies of women in society. Conference papers, journal articles, books, and references to additional bibliographies are cited. Comprised of 658 citations, this document is an ongoing project that is periodically updated, and the 1988 supplement contains 159 new references. The guidelines used for selecting materials are all works appearing in a known geography publication which make reference to women or gender issues and works dealing with women which are written by geographers. An index of names and an index of subjects are included. (GEA)

WOMEN AND GEOGRAPHY: A COMPREHENSIVE BIBLIOGRAPHY

David Lee ✓

This bibliography is the culmination of more than a decade of research on the scholarship of women and geography. It grew from pioneering efforts of Bonnie Loyd (*Women and Geography: An Annotated Bibliography and Guide to Sources of Information*. Monticello, IL: Council of Planning Librarians Exchange Bibliography no. 1159. 1976 (17pp); and "Women and Geography: A Resource List." *Transition* 6, no. 1 (Winter 1976-77): 2-9). These were followed in 1982 by *Women and Geography: A Bibliography*, by David Lee and Bonnie Loyd, published by The Socially and Ecologically Responsible Geographers. Subsequent updates to the latter have been provided each year, two of which were published in *Transition* (Winter 1984, pp. 20-26, and Fall 1985, pp. 24-31).

In the mid '70s, when Loyd compiled initial lists, works on women in the discipline of geography and geographic studies of women in society were few. Such scholarship as had been done was primarily unpublished papers, symposia proceedings, and mimeographed newsletter items. The geography of gender lacked theoretical underpinnings, and there were few empirical investigations of spatial patterns of women. By the 1980s, however, this changed. Papers at professional meetings on women and geography continued to appear on the program, but in addition, journals published more and more accounts of spatial distributions, movement patterns, environment perception, and landscape issues relating to women. Books appeared which treated the geography of women as a separate subject in geographical thought. The bibliography of works on women and geography, which reached seventeen pages in Loyd's first work, has expanded to forty-nine pages in this compilation.

The guidelines followed to determine if a work should be included in this bibliography need explaining. All works appearing in a known geography publication which make reference to women or gender issues would merit inclusion. Works dealing with women which are written by individuals identified as geographers likewise are included irrespective of where they appear. The compiler tries to keep up to date by reviewing the principal geography publications and the programs of the meetings of major geographical associations. Additionally, he uses standard abstracts and indexes, which are especially helpful for foreign titles. Through networking, many titles are submitted for inclusion by authors themselves.

Obviously the titles of a large number of works which might concern geographers are omitted because they do not fall within these guidelines. Works on agriculture and women, for example, may interest geographers, as would women in business, women in architecture, and women in politics. However, there would be no end to the number of works dealing with gender issues if one included all the social sciences, sciences, and humanities. Such an all-encompassing bibliography would be massive and quite useful, but quite beyond the scope of this project.

This bibliography is made available by the Specialty Group on Geographic Perspectives on Women of the Association of American Geographers. However, neither the Specialty Group on Geographic Perspectives on Women nor The Association of American Geographers is responsible in any way for the contents of this bibliography. Errors of any kind are the responsibility of the compiler. Since this bibliography is project is ongoing, updates will continue to be provided, as they have been in the past.
