
ABSTRACT

This bibliography consists of 72 publications related to agricultural development, community development, rural development, economic development, and rural sociology. The entries, all published in the 1980s, and available from the National Agricultural Library's (NAL) Rural Information Center, are broken down as follows: 32 journal articles; 15 books; 14 journals; 6 articles of international interest, 5 audiovisual resources; 4 bibliographies; and several indexes and abstract sources. Each entry includes author, title, publication date, publication source, paging, the NAL call number, and, in some cases, a brief abstract. (TES)

ANNOTATED BIBLIOGRAPHY/PATHFINDER: RURAL DEVELOPMENT

SCOPE: Because rural development is a broad topic, it is best to illustrate the scope by including the following definitions. The first four are by Lawrence W. Libby (from "Natural Resource Linkages to Agricultural and Rural Development" in <u>Interdependencies of Agriculture and Rural Communities in the Twenty-First Century; the North Central Region: Conference Proceedings</u>, ed. Peter F. Korsching and Judith Gildner, 79. Ames, Iowa: North Central Regional Center for Rural Development, c1986.)

Agricultural Development: Community development resulting from changes within agriculture, defined to include all activities from production to retail sales. Community of interest is not limited to rural areas; "improvements" involve more than traditional economic variables.

Community Development: Focused change where indicators of improvement include more than economic variables. Feelings of well-being among community members, however that community is defined, might involve a more responsive government, greater opportunity for political access, a sense of having some impact on community change, improved services, or improved economic circumstances.

Economic Development: These directed actions designed to alter economic circumstances of people. Success is measured in per capita incomes, gross national or state product, market share, income share, or some other monetary indicator of economic change.

Rural Development: Community development in nonmetropolitan areas designed to enhance the options for people living there.

The final definition is from Wilkinson, K.P. "In Search of the Community in the Changing Countryside." <u>Rural Sociology</u>. v. 51 (1) p. 13. Spring 1986.

Rural Sociology: Sociology applied toward understanding rural life, and . . . science applied for the purpose of improving the well-being of people in rural areas.

CALL NUMBERS

Call numbers for browsing are found under two classification schemes. The NAL classification scheme was used until 1966. Call numbers in the area of rural development are 1-6, 100, 148-173, 275-278, and 281-287. Under the Library of Congress classification system used since 1966, the call numbers are found in HB, HC, HD1401-2210, HT401-485, and S. Prospective browsers are reminded that a pass, available at circulation and in work areas, is required for admission to the stacks.

A large section of Sociological Abstracts (NAL Call No.: 241.3-So12) is devoted to Rural Sociology and Agricultural Economics. Agrindex, a publication of the Food



and Agriculture Organization, also contains information in the applicable categories. Its call number is 25073.A34. The last source valuable enough to be included is <u>United Nations Documents Index</u>, by the Dag Hammerskold Library, found at 26481.U524.
