AUDIO-VISUALS

Born Free. (9 Units) Video Beta, 30 minutes each, The Education Development Center.

1. **A World of Options.** Presents an overview of the series and is designed to raise awareness of the changing roles of women and men. The tape explores the concept of career socialization and factors that may facilitate or inhibit career choices.
2. **Men: Choices and Change.** Focuses on the way men's development has been limited by sex-role expectations that urge them to be breadwinners, strong, active, and unemotional. The tape shows men moving toward sharing roles.
3. **Women: Choices and Change.** Explores the different social messages females and males receive about sex-role expectations and how these influence career development.
4. **Joy of Choosing.** Presents women and men discussing the choices and decisions that have influenced their lives at various stages. One section features a panel of female scientist considering the implications of non-traditional careers.
5. **Parenting: Three Generations.** Examines child-rearing from different perspectives.
6. **Parents as Influencers.** Considers the messages mothers and fathers convey to their children. Parents comment on the complexities of parenting and the far-reaching effects of their actions and behavior on their children.
7. **Schools are Influencers.** Presents students who have encountered sex-role stereotyped messages at school. Educators comment on positive ways to overcome career-related stereotyping. The video tape is intended to stimulate discussion of how sex-role attitudes are influenced by school personnel.
8. **Colleges as Influencers.** Examines how post-secondary educators often limit career choices by sex. Individuals comment on sex bias during their college experiences and a panel of community college faculty presents their perspectives.
9. **Why Change?** A summary presenting a dialogue between Sunny Hansen (the project director) and author Warren Farrell. The tape highlights issues of changing gender roles including resistance to change, fears of demise of the family, and fears relating to sexual preference.

Career Decisions: Finding, Getting, and Keeping a Job. Filmstrips (3) and Cassettes (3), J.C. Penney Company, Inc., Consumer Education Services, Career Education.

Depicts choosing a career as a process that includes analyzing and evaluating career choices in relation to personal interests, goals, and opportunities.

Introduces the concept of career development in three parts: (1) Changing Work Values. (2) What Is Work? and (3) You and Your Career.

Unit includes picture cards, master worksheets, overhead transparencies, and teacher guides.

Children Deserve Equity. Filmstrip and Cassette, 12 minutes, Women's Educational Equity Act Publishing Center, Sex Equity.

Explains the rationale behind Title IX and some steps to take to overcome sex-role stereotyping.

It's Her Future. Video Beta, 17 minutes, The Education Development Center, Gender Expectation/Stereotyping.

Addresses a key factor in sex-role stereotyping in vocational education: parental attitudes about their daughter's educational pursuits.

Jill and Jack/Fiction and Fact. (8 Units) The Education Development Center, Gender Expectation/Stereotyping.

1. **The Masculine Mystique.** Video VHS and Beta, 30 minutes.

Outlines some of the restrictions men experience because of sex bias which may inhibit their emotional growth and trap them in unsatisfying careers.

2. **The Feminine Mystique.** Video VHS and Beta, 30 minutes.

Examines the changing role of women as increased options and opportunities influence personal choice in careers and family relationships.

3. **Language and Textbooks.** Video Beta, 30 minutes.

Explores the images of women and men that children absorb through everyday language and sex bias of many textbooks.

4. **Classroom Practices.** Video Beta, 30 minutes.

Discusses strategies teachers can use to help eliminate sex stereotyping in their classrooms. It also outlines procedures that schools must follow to comply with Title IX.

5. **Early Childhood.** Video Beta, 30 minutes.

Presents ideas for developing non-sexist environments that encourage the full development of all young children.

6. **Athletics and Physical Education.** Video Beta, 30 minutes.

Focuses on schools that have developed successful sports programs that provide increased opportunities for all students to gain a greater appreciation of themselves and their bodies.

7. **Career Guidance.** Video Beta, 30 minutes.

Examines how sex-role stereotyping influences that often limits career choices and suggests ways counselors and teachers can combat that bias.

8. **Cultural Values.** Video Beta, 30 minutes.

Explores how societal traditions and family expectations often strictly define roles for women and men and the conflict that may result as individuals expand their role options.

Judge Me, Not My Shell. Video Beta, 15 minutes, The Educational Development Center, Discrimination/Prejudice.

Features two narratives, enacted in one-woman dramatizations, which illustrate the consequences of belonging to a minority group.

Masculinity and Femininity. Filmstrips (2) and Cassettes (2), 21 minutes, Guidance Associates, Gender Expectations/Stereotyping.

Part I: Explores how much of the masculine or feminine stereotype is biological and how much is cultural. Students are asked to face their own stereotypes.

Part II: Changing cultural patterns are discussed and the theme developed that, the more fluid the society, the greater opportunity for personal freedom.

The 100 women included in this unit have made their reputations, and usually their livings, by their skillful command of the English language. Following an historical introduction to each specialized field, one-paragraph biographies introduce students to each wordsmith and encourage further investigation. Decade of Achievement 1977-1987. National Women's Conference Center, 1988.

This booklet documents the accomplishments of the women's movement since its rebirth in the early 1970's. Filled with statistics and valuable resource information, the report addresses issues such as battered women, child care, employment, media, older women, rape, sexual preference, welfare, education, credit and a host of other topics documenting the needs of women and the organizations and services which have been created to address those needs. Domestic Revolutions: A Social History of American Life. Steven Mintz and Susan Kellogg, The Free Press, New York, 1989.

The authors, an historian-anthropologist team, analyze how and why the American family - black and white, American Indian and immigrant - has changed over the last 300 years. P.316

The Equal Rights Amendment. Sharon Whitney, Franklin Watts, New York, 1984.

An exploration of the dynamic, controversial personalities and organizations on both sides of the issue from Abigail Adams and Mercy Otis Warren in the 1700's to the present time. P.102

Foreign and Female: Immigrant Women in America, 1840-1930. Doris Weatherford, Schocken Books, New York, 1986.

Spanning the peak immigration years, profiles from every major ethnic group are included. After negotiating the obstacles of the immigration system, the women wrote home about their experiences, of the houses they lived in, the food they ate, their work in factories and on farms, their feelings toward men, courtship, marriage, children and divorce. P.288

From Working Girl to Working Mother: The Female Labor Force in the United States, 1820-1980. Lynn Y. Weiner, The University of North Carolina Press, Chapel Hill, North Carolina, 1985.

Changes in social attitudes, women's self-image and economic necessity over the decades are skillfully traced in this narrative of women's involvement in the labor force. The author follows the entry of single women into the labor force in the 1820's, then married women and finally women with children following WWII. P.187

Hidden Hands: An Anthology of American Women Writers, 1790-1870. Lucy M. Freibert and Barbara A. White, Rutgers University Press, New Brunswick, New Jersey, 1985.

The most popular authors in their own times, many of the women included here are all but forgotten now. Among them: Lydia Maria Child, Sarah Joseph Hale, Susan Warner. This anthology of excerpts from their writings makes these materials available in concise form. Biographical sketches, annotation, introductory material, and excerpts from critical articles furnish a framework for understanding the works themselves. P.408

Inventing the American Woman: Perspective on Women's History.
Glenda Riley, Harlan Davidson, Inc., Arlington Heights, Illinois,
1986.

This overview combines recent scholarship, biographical data, social narrative and statistical information to present a clear depiction of women in American society from 1607 to the present. P. 286

The Ladies of Seneca Falls: The Birth of the Woman's Movement.
Miriam Gurko, Schocken Books, New York, 1974.

Focusing on the origins, early years and personalities of the woman's suffrage movement, this straightforward and comprehensive history of the movement is essential reading for those interested in what is and what is not in our Constitution, and the enormous effort women undertook to pass the 19th Amendment. P.328

The Legacies Book. Elizabeth H. Pleck and Ellen K. Rothman with Paula Shields, The Annenberg/CPB Project, Washington, D.C., 1987.

A companion volume to the audiocourse "A History of Women and the Family in America, 1607-1870." P. 273

Mothers of Invention: From the Bra to the Bomb, the Forgotten Women and Their Unforgettable Ideas. Ethlie Ann Vare and Greg Ptacek, Quill, New York, 1987.

Discoveries, from the momentous to the mundane, are arranged by categories. Readers are encouraged to do their own inventing. Appendices include a list of patents granted to women 1905-21, child inventors, and how to obtain a patent. P.248

Never Done: History of American Housework. Susan Strasser, Pantheon Books, New York, 1982.

This book offers a lively and authoritative history of American household technology and ideas about housework. Strasser's analysis of housework and the housewife's role includes its relationship to the economic and demographic changes in our nation's development, the social ideology of women's roles and the influence of advertising and other commercial interests. The Norton Anthology of Literature by Women. Sandra M. Gilbert & Susan Gubar, W.W. Norton & Company, New York, 1985.

Organized chronologically, this readable volume is encyclopedic, full of excellent notes and thumbnail biographies that increase the scope of its reference far beyond its stories, essays and poems. This collection demonstrates that women have participated vigorously in every period, trend, fashion, experiment and genre of writing in English. P.2457

Notable American Women 1607-1950. Edward T. & Janet Wilson James, The Belknap Press of Harvard University Press, Cambridge, Massachusetts, 1971.

A three volume set, including the life stories of 1359 women who influenced their time and society. Written in an informative and lively style describing the life and work of each woman in the context of her historic period. P.2075

Notable American Women: The Modern Period. Barbara Sicherman & Carol Hurd Green, The Belknap Press of Harvard University Press, Cambridge, Massachusetts, 1980.

A companion to the three-volume Notable American Women, this resource contains biographies of 442 women significant in American history who died between 1951 and 1975. P.773

On the Move: American Women in the 1970's. Winifred D. Wandersee, Twayne Publishers, Boston, Massachusetts, 1988.

From its hopeful origins in the 1960's to its more embattled days in the early 1980's, this concise overview of the complex issues, the major actors, and the landmark moments of the 1970's women's movement gives the real inside story. P.337

Portraits of Our Mothers. Frances Arick Kolb, Ph.D., The Network, Inc., Andover, Massachusetts, 1983.

Describes in thorough detail how teachers and students used oral history to learn about women in their families and community. Student projects became part of a city-wide celebration of National Women's History Week. Beautifully illustrated, the book includes classroom activities. Materials and resources can be used as a guide to planning a Women's History Month event or creating a classroom activity or unit in oral history. P.74

Tatterhood and Other Tales. Ethel Johnston Phelps, ed., The Feminist Press, New York, 1978.

All of the central characters in these 25 international folk tales are spirited females - decisive heroines of courage, wit and achievement who set out to determine their own fate. These tales were chosen for their positive themes which are still pertinent today. P.166

Thousand Pieces of Gold. Ruthanne Lum McCunn, Beacon Press, Boston, Massachusetts, 1981.

Polly Bemis, as Lalu Nathy came to be known, was brought to America on a slave ship from China, auctioned to a saloonkeeper, then won in a poker game before marrying and settling in Idaho in the late 1800's. P.308

The Ways of My Grandmothers. Beverly Hungry Wolf, Quill, New York, 1980.

The Author, a Blood Indian of the Blackfoot nation, collected the stories and traditions of her grandmothers to pass on to future generations of women. The book brings to life the legends, traditions, dances, stories of camp life, and the wisdom of the elder women of the tribe. She also gives specific information about the daily tasks of Indian women: preparing food, tanning hides and various crafts. P.256

When and Where I Enter: The Impact of Black Women in Race and Sex in America. Paula Giddings, Bantam Books, New York, 1984.

This book offers a moving description of how black women transcended the double discrimination of sexism and racism from the first African slaves to the present. The Black women's club movement as well as many individuals of note are brought to life for the reader. P.408

With Wings: An Anthology of Literature By and About Women with Disabilities. Marsha Saxton & Florence Howe, eds., The Feminist Press, New York, 1987.

More than 30 writers capture the physical and emotional experiences of disability and chronicle the daily striving of women from all social and ethnic groups for love, self-expression and independence. P.167

The Woman's Encyclopedia of Myths and Secrets. Barbara G. Walker, Harper & Row, San Francisco, California, 1983.

Over 1350 entries reveal the answers to intriguing questions. Word origins, traditions, legends, and superstitions whose meanings have all but been forgotten, magic, fairies, witchcraft, goddesses, gods, mystical meanings, and ancient attitudes are included. P.1123

Women and Indians on the Frontier, 1825-1915. Glenda Riley, University of New Mexico Press, Albuquerque, New Mexico, 1984.

This book, which revises conventional melodramatic pictures, is the first account of how and why pioneer women altered their own self-images and their views of American Indians. P.336

Women and the U.S. Constitution Curriculum Unit. Molly Murphy MacGregor, National Women's History Project, Windsor, California.

This curriculum unit provides a narrative on how women's lives were affected by the Constitution and court cases during the past 200 years which have impacted women's legal status. The unit also covers women's involvement in movements to amend the Constitution, focusing on the abolitionist movement and the 13th, 14th and 15th Amendments, the temperance movement and the 18th Amendment, the suffrage movement and the 19th Amendment, and the movement for passage of the ERA. Also includes historical documents, lessons, activities and resource bibliography. P.60

Women in Colonial and Revolutionary America. Bonnie Eisenberg, The Mid-Atlantic Equity Center, Washington, D.C., 1989.

Includes introductory material on the lives of colonial, black and Indian women and short biographies of ten women of the period, including Phillis Wheatley, Abigail Adams, Mary Brant and Mary Katherine Goddard. Discussion questions, activities and an annotated bibliography are included. P.52

Women in the World: An International Atlas. Joni Seager & Ann Olson, The Scarecrow Press, Inc., Metuchen, New Jersey, 1987.

Three and a half years of research went into this full-color volume which makes use of vivid, interesting maps and graphics to cover forty topics of crucial relevance to women around the world: work, marriage, contraception, motherhood, health, wealth, the media, the military and the government. A significant reference work for anyone interested in the status of women in this country and around the world. P.219

Women of the West. Cathy Luchetti & Carol Olwell, Antelope Island Press, Berkeley, California, 1982.

Homesteaders, school teachers, slaves, entrepreneurs, gold miners and more, this book offers a revealing account of what life was like for women in the western United States between 1830 and 1920. Includes information and photographs on American Indians, Mexican, Chinese and black women, as well as white settlers coming from the east. Many illustrations and unique photos throughout. P.240

Women's Roots: Status and Achievement in Western Civilization. June Stephenson, Diemer, Smith Publishing Company, Inc., Napa, California, 1981.

Women's roles and common experiences and the outstanding contributions of individuals from pre-history to the present are portrayed in this survey of European and U.S. history, focusing on topics of greatest import to women in each historical period. P. 335
