ABSTRACT

Designed to assist the Nebraska Coordinating Commission for Postsecondary Education (NCCPE) in the development of a statewide policy for transfer of credit from two- and four-year postsecondary institutions and a smooth transition from secondary to postsecondary learning, this report describes articulation agreements and cooperative programs in place at the state's colleges and universities. The document begins with a two-page status report on articulation in Nebraska, highlighting the role of the state's community colleges in providing affordable entry-level postsecondary education. The bulk of the report consists of brief descriptions of agreements relating to articulation or cooperative programming in place at Nebraska postsecondary institutions. Institutions are categorized by the six divisions in Nebraska higher education (i.e., community colleges, state colleges, the University of Nebraska system, independent colleges and universities, federally supported institutions, and proprietary institutions), and for each, the nature of the arrangement and the participating institutions are provided. Three appendixes are included, of which the first discusses goals and funding for Tech Prep programs in Nebraska, designed to prepare secondary students for technologically advanced careers by course sequences and experience from the secondary to postsecondary levels; the second describes Tech Prep and other cooperative ventures between community colleges and secondary schools; and the third provides the articulation agreement of the Nebraska Association of Collegiate Registrars and Admissions Officers. 1993 Status Report Articulation Agreements

A student's ability to transfer from one institution to another without having to lose credits already earned and money already spent has always been a concern in higher education.

Articulation has been emphasized as a priority by the Legislature during the establishment of the former Nebraska Coordinating Commission for Postsecondary Education (LB459)

(a) insure improved curriculum articulation among the public postsecondary education institutions in Nebraska, specifically to enable any student of a public postsecondary education institution in Nebraska to obtain immediate information on the transferability of any course offered by such institution to any other public postsecondary education institution in Nebraska:

and the current Coordinating Commission for Postsecondary Education (LB663)

(a) The establishment and maintenance of a statewide transfer of credit policy....The statewide transfer of credit policy shall be designed to facilitate the transfer of students among public institutions. The statewide transfer of credit policy shall not require nor encourage the standardization of course content and shall not prescribe course content or credit value assigned by any public institution to the courses.

One of the goals of the Coordinating Commission for Postsecondary Education as listed in the Comprehensive Statewide Plan for Postsecondary Education is to increase academic transfer programs at the community colleges, thereby permitting a student to utilize the community college for two years and then transfer to a four-year institution as a junior having met general education requirements.

Two- and four-year institutions must continue development of a broadly accepted articulation policy where an AA and AS degree from a community college will be accepted to meet the lower division general education requirements of the State Colleges, the University of Nebruska, and the independent colleges and universities.

Currently, the University of Nebraska-Lincoln and the University of Nebraska at Kearney have a Transfer Credit Handbook between the University and the Nebraska community colleges. This handbook provides course equivalency information and is targeted for use by the academic advisors to assist students intending to transfer and complete their four-year degree at the University. The University of Nebraska at Omaha does have agreements with five of the six community college areas. Chadron State College has also implemented a Transfer Guide with the Nebraska community colleges. From the independent sector, Nebraska Wesleyan University also has compiled a transfer handbook of courses accepted from community colleges.

The 2 + 2 programs are joint programs between participating institutions which allow students to continue their education and study leading to a four-year degree. Students in the 2 + 2 programs have the benefit of earning two degrees (example: Metropolitan Community College/Bellevue: Two years of study at Metro for an A.A. Degree + two years of study at

Bellevue College for either a B.S. or B.A. Degree.) Besides the two degrees another benefit for the student is both the community college and four-year college experience.

Throughout this report you will find the NACRAO Articulation Agreement listed for 21 schools. It should be noted that NACRAO (Nebraska Association of Collegiate Registrars and Admissions Officers) is continually addressing the issue of transfer of credit. The intent of the NACRAO Agreement is to ensure that a student who completes all NACRAO General Education (GE) Core requirements at a participating institution may transfer these core requirements toward satisfying the GE Core for an undergraduate degree at a participatory receiving institution. (A copy of the NACRAO Articulation Agreement is included as page 40.)

Tech Prep is a federally funded program implemented to prepare students for technically advanced careers. Secondary and postsecondary institutions work together to provide a coherent sequence of courses and experiences to help the student successfully make the transition from secondary to postsecondary education or directly to the workplace. A summary of Tech Prep activities in the community colleges is listed in this report starting on page 29.

In additional to Tech Prep agreements, there are other programs in place to aid the student in a smooth transition between secondary and postsecondary learning. A listing of these arrangements starts of page 34.

The Commission wishes to thank the institutions for their cooperation in compiling this report. We also wish to thank the individuals and groups responsible for the good work already done in the area of transferability of credit. With clear and concise articulation agreements between institutions, communication between the institutions and students will continue to improve. This is a win/win situation for both the students and the institutions.

The voluntary agreements and countless hours of work of Nebraska postsecondary education institutions are to be commended. It is this strong progress which lays a sound basis for more cooperation between Nebraska institutions. As the community colleges are called on to furnish more of the entry-level postsecondary education for Nebraskans through upgraded academic-transfer programs, it becomes even more critical to assure a smooth transition in a seamless system of higher education accessible to all Nebraskans. The Commission will use this report as a guide in its work to establish a statewide transfer-of-credit policy.

TECH PREP AT NEBRASKA COMMUNITY COLLEGES

Tech Prep was funded through federal funds appropriated by Congress under Public Law 101-392, the Carl D. Perkins Vocational and Applied Technology Education Act Amendments of 1990.

Tech Prep is an education plan designed to prepare secondary students for technologically advanced careers by secondary and postsecondary institutions working together to provide a coherent sequence of courses and experiences to help the student successfully make the transition from secondary to postsecondary education or directly to the workforce.

According the *Tech Prep Executive Summary*, 1992, provided by the Nebraska Department of Education, the formula used for distribution of federal funds to Nebraska Community Colleges contains two parts.

The first part is a foundation base amount for each Community College. This amount is calculated by dividing half of the funds available by the number of public Community Colleges statewide. The second part of the distribution formula compensate the Community Colleges for enrollment differences. This amount is calculated by dividing the remaining half of funds available by the same percentage used in Title II(C) funding under the Carl D. Perkins Vocational and Applied Technology Education Act Amendments of 1990.

Nebraska Tech Prep is administered by Mr. Richard Campbell, Division of Education Services, Nebraska Department of Education.

The following is a listing of the Tech Prep cooperative ventures between the Community Colleges and secondary schools in the state. Articulation agreements referred to in the report generally mean preparatory coursework at the secondary level in disciplines of math, science and communications. The intent of integrating these courses with the vocational/technical offerings and integrating applied academics into existing courses is to provide a strong applied academic foundation for students pursuing study at a postsecondary institution.

This information was provided to us by the Community Colleges. We thank them and Mr. Campbell for their cooperation in helping the Commission report current information about their projects.



Tech Prep in Nebraska

Central Community College

Central Community College and five area high schools comprise the Central Nebraska Tech Prep Associate Degree Consortium. The participating high schools include: Kearney Public Schools, Sandy Creek Schools, Centura Public Schools, Northwest High School and Gibbon Public Schools.

Kearney Public Schools and Central Community College articulated in accounting. Approval is pending for articulations in the following programs: office technology, data processing, business and management, and allied health.

Northwest High School has recommended that articulation first occur in the industry/engineering cluster of occupations. Sandy Creek, Gibbon and Centura have not yet selected a cluster or programs.

Workplace Readiness, a course dealing with employability skills will be a course offering at Kearney and Northwest in the 1993-94 school year.

All consortium schools have been provided with curriculum materials in applied mathematics, communication, science, and employability skills.

Metropolitan Community College

Metropolitan and eight local school districts form the Metropolitan Community College Tech Prep Consortium. The participating high schools include: Bellevue Public Schools, Blair Public Schools, Fort Calhoun Schools, Logan View Schools, Omaha Public Schools, Papillion LaVista Public Schools, Ralston Schools and Westside Schools.

Metro started to work with local high schools in 1985 with advanced standing arrangements in various vocational areas. In 1989, Metro and the Omaha Public School district received a Carl Perkins grant for work in articulation. This work became the foundation that was built upon under the national Tech Prep Program.

NOTE: Curriculum Development for the Consortium was aided by an Eisenhower Grant from the Coordinating Commission for Postsecondary Education. On June 29-July 2, 1992, Metro presented an Applied Math Workshop for members of the Consortium and other schools in the area. This Workshop was funded by a Eisenhower Math/Science Grant, Metropolitan Community College and Omaha Public Schools.

Mid-Plains Community College

Mid-Plains Community College is working with area high schools developing articulation programs common to the industrial/engineering work cluster. Area high schools can articulate programs that lead to an associate degree or two-year diploma in the vocational areas to include Auto Mechanics, Building Construction, Diesel Mechanics, Drafting, Electronics, Heating/Air Conditioning and Welding/Machine Shop.

Local high schools working with Mid-Plains include North Platte, Ogallala, McCook and Broken Bow.

In addition, the following schools have expressed interest in working with Mid-Plains in 1993-94: Sutherland, Hershey, Maywood, Chase County, Benkelman and Curtis Medicine Valley.

Northeast Community College

During the 1992-93 school year the Northeast Community College Consortium included Norfolk Public School, Wayne Public High School, Elgin Public High School, and Crofton Public High School.

Vocational programs which are articulated include Office Technologist, Medical Office Technologist, Legal Office Technologist, Accounting/Finance, Automotive Technology, Diesel Technology, and Auto Body Technology.

Southeast Community College

Southeast Community College is currently working with five high schools to implement Tech Prep. These schools are Milford Public Schools, Dorchester Schools, Malcolm Schools, Lincoln Public Schools and Beatrice High School.

The Agreement with Milford, Dorchester and Malcolm initially focuses on Manufacturing and Fabrications. Programs in this area include Welding and Metallurgy, Nondestructive Testing, Manufacturing Engineering & CAD and Machine Tool and Design. Additional occupational areas will be added as the program advances.

The Agreement with Lincoln Public Schools initially focuses on Business, Industrial Technology, and Home Economics. Programs in this area include Accounting, Child Care, Machine Tool, Drafting, Welding and Electronics. Additional occupation areas will be added as the program advances.

The Agreement with Beatrice High School focuses on Business and Mass Media Communications (SCC-Beatrice Campus Programs). Programs in these areas include Accounting, Computer Science, Business Administration, Administrative Assistant, Executive Secretary, Legal Secretary, Medical Secretary, Marketing, Broadcasting and Communications. Additional occupation areas will be added as the program advances.

Scottsbluff High School

Western Nebraska Community College (Sidney and Scottsbluff campuses) has joined with seven area schools to form the Western Nebraska Tech Prep Consortium. The participating schools include Scottsbluff, Gering, Sidney, Alliance, Leyton, Minatare and Kimball Public Schools.

The following articulation agreements are effective for Fall, 1993:

The Tech Prep Program goals included in each articulation agreement include increasing the percentage of high schools students to pursue higher education and training, to focus 75 percent of all students in grade level or above instruction, improve technical knowledge and skills of work force entrants, and to decrease the drop-out rate.

Western Nebraska Consortium is providing staff development for personnel, particularly in the areas of integrated education, applied academic, counseling, career exploration and technology education.



ARRANGEMENTS BETWEEN SECONDARY AND POSTSECONDARY INSTITUTIONS

In addition to the Tech Prep arrangements developed between secondary and postsecondary institutions, there are many other programs in place to aid the student in a smooth transition between secondary and postsecondary learning.

Most of the programs listed in this report are targeted for and used by the top academic performers. Some of these programs were designed for seniors who had finished their high school requirements by first semester of their senior year. High school administrators sought an alternative to early graduation. In recent years a decrease in participation has been seen due to the changes in high school graduation requirements.

It should be noted that while these programs are an excellent opportunity for high school seniors, the programs that are offered on-campus benefit only a small portion of the student population.

The Commission thanks the institutions for their cooperation in compiling this report.



Bellevue College

Qualified high school students may apply to take courses while still attending high school. Applications must be accompanied by written permission of a parent/guardian as well as certification from an appropriate high school official stating that the high school official agrees to the student's program. Credits earned in this status may not be transferred until the student has graduated from high school.

Students who desire to obtain credits at Bellevue College for the purpose of transferring them to another college or university or for personal or career enhancement may enroll as non-degree students.

Bellevue also has an *Emerging Scholar Program* whereby a graduating senior with a GPA of 3.0 or above can apply for a \$200 scholarship to take courses during the summer at Bellevue College. Bellevue will send a free transcript to the student's college of choice. This program is on a first-come-first-serve basis.

Central Community College

Central Community College has formed the Central Nebraska Education Articulation Consortium (CNEAC). The purpose of this Consortium includes facilitating student progress from area high schools to Central Community College. Fifty-six area high schools are current members of CNEAC.

Programs include Accounting, Automotive Technology, Drafting, Machine Shop, Office Technology and Welding.

Chadron State College

Chadron State College offers an Early Entry Program for high school seniors who have maintained a cumulative grade point average of 90% or above. Seniors not maintaining 90% GPA or an exceptional high school junior may be considered for enrollment with the recommendations of the high school principal and the Dean of the appropriate school at Chadron State College. All students taking part in the Early Entry Program must have prior approval by the high school counselor or principal and written permission of a parent or guardian.

Courses offered in the Early Entry Program are regular college courses listed in the current Chadron State College General Bulletin. Emphasis is placed on selecting courses which are basic to a student's subsequent college career.

Courses may be taught on Chadron's Campus, as off-campus courses, or on the high school campus during the regular class day.

College of St. Mary

Students still attending high school are permitted to enroll in certain classes provided they have permission of the high school officials.

Creighton University

Creighton and Creighton Preparatory School offer a 4/3 program. This accelerated program allows selected highly motivated students to earn a high school diploma and a college degree in a total of seven years. Creighton offers the following courses at Prep: Calculus, Chemistry, College English, Physics and Theology. The following advanced placement examination courses are offered at Prep: Biology, Calculus, Chemistry, Computer Science, English Composition, English Literature, European History, United States History, Physics, Government, Psychology and Latin.

In addition, Creighton University offers college courses to students at Daniel Gross and Mount Michael High Schools and Duchesne Academy of the Sacred Heart. These courses may include (but vary from year to year) English, Chemistry, Mathematics or Physics. The courses are taught by high school faculty at the high schools.

Dana College

Dana College allows cross enrollment with Blair High School if approved by both the high school and college. There is no limit to the number of classes that can be taken, however classes must be taken during regular day class hours during the Spring and Fall semesters. There is a substantial tuition discount as Dana charges 50% tuition for high school students. At the present time, the student pays half of the charges and the other half is paid by the school district.



Hastings College

Hastings College allows high school seniors to take one class per semester (maximum six hours earned).

Midland Lutheran College

Midland Lutheran College offers the *High School Scholarship Program*. This program is offered during the summer months between the student's junior and senior years. This program is offered to students all over the state. Students attend at the recommendation of their high school counselor. The cost is \$100 a course for a maximum of two classes a semester.

During Fall/Spring Semester, area students can take college classes only during the day so they must arrange their high school schedules accordingly.

Nebraska Wesleyan University

Qualified high school students may be admitted to Nebraska Wesleyan University prior to graduation from high school.

With permission, advanced students may enroll for up to six credit hours each semester while attending high school. These credits may be applied toward a degree after the student has been admitted to a Nebraska Wesleyan degree program. No tuition is charged high school students selected to enroll at Nebraska Wesleyan prior to their high school graduation. Regular tuition must be paid before any credits in this program may be transferred to another institution. Most courses are open to eligible high schools students as space and prerequisites allow. Certain courses in music, art and laboratory sciences are not available without permission and payment of tuition and fees.

Peru State College

Peru has early entry access agreements with some area high schools. Such agreements generally permit accedemically advanced high school students to enroll in a limited number of courses and earn college credit prior to the completion of their high school programs. In some cases, such credit can be applied simultaneously to high school graduation requirements and a college degree program. High Schools participating in this program include Auburn, Syracuse, Arlington, Falls City, Pawnee City, Conestoga, Fairbury, Ralston, Fort Calhoun, Louis Center in Council Bluffs, Iowa and Rockport High School in Rockport, Missouri.



University of Nebraska at Kearney

The University of Nebraska at Kearney offers high school seniors the opportunity to seek early admission. The program will provide an accelerated educational opportunity with college credit being granted upon verification of a high school diploma. Acceptance is contingent upon a recommendation from a high school official. Students are limited to a maximum of six hours per semester and a total accumulation of 16 semester hours prior to completion of their high school requirements. Courses are offered on the Kearney Campus.

University of Nebraska-Lincoln

UNL has no formal agreements, however there are a number of circumstances under which credits taken in high school do transfer for college credit:

- 1. High school students may take Advanced Placement (AP) courses in high school and, following successful completion of a nationally-standardized exam, may receive university credit in selected areas (e.g. accounting, economics, mathematics).
- 2. High School students can receive university credit for calculus courses if they complete the next calculus course at UNL with a grade of C of better for the first time they take the course. Credits for multiple calculus classes may be granted this way if all the requirements are met. The University does not charge students for this retroactive awarding of credit. This is not really an articulation agreement, but a UNL policy which is applied with domestic (United States) high schools in general.
- 3. Students may receive college credit within the College of Business Administration for Accounting taken in high school under the following circumstances: upon coming to UNL, students who go directly into Accounting 202 and complete the course with a grade of C or better may retroactively be awarded credit for Accounting 201. There is no charge for this retroactive awarding of credit. Analogous to the math credit assignment, there is no specific agreement with a particular high school, but students coming from any high school who fulfill the above requirement may be awarded credit for work done in high school.
- 4. High school students may take college classes at UNL either during the day if their schedule permits or in the evening. Since the students are taking the college class at the university, no transfer of credit is required.

University of Nebraska at Omaha

The University of Nebraska at Omaha participates in the Advanced Placement Examination of the College Entrance Examination Board and, based upon a student's performance (minimum score of 3), may grant credit toward graduation up to a maximum of 32 hours.

UNO also participates in Early Entry allowing currently enrolled high schools students to take college courses concurrently with the school program.



Wayne State College

Wayne State College offers high school students an opportunity to take freshman-level courses in a field of interest or ability not offered by the high school. They may complete some of the general course requirements before enrolling as a full-time student at Wayne State, or they may complete general course requirements needed for transfer to another college. The student must have authorization from the high school counselor or principal before enrollment.



NACRAO Articulation Agreement

A Transfer Statement for Nebraska College Students Effective August 1, 1988

The intent of The NACRAO Articulation Agreement (hereinafter referred to as The Agreement) is to ensure that a student who completes all NACRAO General Education (GE) Core requirements at a participating institution may transfer these core requirements toward satisfying the GE Core for an undergraduate degree at a receiving/participatory institution, except as may be noted by that institution on its signed NACRAO Articulation Agreement Commitment.

- I. NACRAO GENERAL EDUCATION CORE Basic academic requirements must be satisfied in the areas of Communications, Natural Sciences, Social Sciences, and Humanities. Courses (applied and developmental courses are excluded) and semester credit hour minimums required for NACRAO GE certification are as follows:
 - - 1. English Composition I (3 semester hours); and
 - 2. Speech Communication (3 semester hours); and,
 - 3. English Composition II or Literature (3 semester hours)
 - - 2. College-level Mathematics (one course required)

 - TOTAL NACRAO GE CORE REQUIREMENTS.....31 Semester Credit Hours
- II. The inclusion of specific courses within a given category is determined by the sending institution; for example, a course entitled Western Civilization might (depending on the content) be appropriately designated by the sending institution as either Social Science or Humanities.
- III. Technical, vocational or developmental courses will not be included in the NACRAO GE Core requirements at the signatory institutions.
- IV. Each receiving institution will determine the equivalence and applicability of NACRAO GE courses in meeting other (non-General Education) graduation requirements.
- V. Transfer students who have not completed ALL NACRAO GE Core requirements must meet the General Education requirements of the transfer signatory institution as determined by an individual evaluation at the receiving institution.
- VI. Foreign language requirements for individual Baccalaureate degree programs will be the prerogative of the signatory institution.
- VII. Special provisions or exceptions to The Agreement listed on a receiving institution's NACRAO Articulation Agreement Commitment will be honored.
- VIII. A transfer student must be admissible to a participating institution in order to benefit from the NACRAO Articulation Agreement.



NACRAO Articulation Agreement Guidelines

- I. An institution signing the NACRAO Articulation Agreement will honor its provisions, subject to the special provisions/exceptions, if any, that an institution specifies at the time of signing.
- II. An institution desiring to modify its commitment to The Agreement must do so PRIOR TO JUNE 1 of any calendar year by written notice of the NACRAO Executive Committee. Such modifications become EFFECTIVE August 1 of that year.
- III. The Agreement applies to the basic General Education (GE) Core requirements only and does not excuse transfer students from meeting specific course requirements for an area of study (e.g., Business Administration, Elementary Education, etc.) while enrolled at a community college or a four-year institution.
- IV. Signatory institutions will develop and implement a process to: (1) Advise transferring students of The Agreement; and, (2) Certify students who meet the GE Core requirements of The Agreement. (Transcript Notation: "This Student Meets All General Education Requirements of the NACRAO Articulation Agreement.") NOTE: No Partial certifications.
- V. A "D" grade received by a student in a NACRAO GE course area satisfies the NACRAO GE requirement at a receiving institution if the "D" grade satisfies the requirement at the sending institution. THE DECISION TO ACCEPT CREDIT HOURS EARNED THROUGH THE 'D' GRADE RESTS WITH THE RECEIVING INSTITUTION.
- VI. NACRAO shall create a standing committee known as the NACRAO ARTICULATION COMMITTEE composed of the following members to be appointed by the appropriate representative group.

1 Member - NACRAO Executive Committee

2 Members - Nebraska Private Colleges/Universities

1 Member - NACRAO Admissions Officer

2 Members - Nebraska State Colleges

1 Member - NACRAO Registrar

2 Members - Nebraska State University System

2 Members - Nebraska Community Colleges

VII. If differences develop between institutions in interpretation of The Agreement and/or the special provisions/exceptions noted on an institutional commitment:

A. A representative from each of the two institutions involved will hold an informal discussion

to resolve the differences.

- B. If the differences are not resolved by "A," it will be the responsibility of the institution who initiated the discussion to report the problem in writing to the President of NACRAO.

 A copy of the report will be sent to the Chairperson of the NACRAO Articulation Committee, who will arrange (within one month) for a date, time, and location for a meeting of a representative from each of the two institutions involved and an impartial representative from the NACRAO Articulation Committee. It will be the responsibility of this NACRAO Articulation Committee member to report in writing the outcome of the meeting to the Chairperson of the NACRAO Articulation Committee. If needed, the Chairperson then will call a meeting (within one month) of the NACRAO Articulation Committee to recommend a solution to the problem and immediately report the recommendation to the institutions involved.
- C. If the differences still are not resolved as the result of "B" within two months after receipt of the recommended solution, the institutions involved: (1) Must reexamine their institutional commitment to The Agreement and modify their signed commitments to The Agreement prior to June 1 (and effective August 1); or, (2) Cease participation in The Agreement.
- VII. Signatory institutions will publish in their academic catalogs and semester class schedules a statement regarding participation in the NACRAO ARTICULATION AGREEMENT. Signatory institutions will maintain copies of The Agreement, Guidelines, and a list of participating institutions (with special provisions/exceptions, if any, noted by the participants on their Commitments) in their Admissions Offices, Registrars' Offices, Academic Advising Offices, and/or appropriate Instructional or Student Services Offices.
