ABSTRACT

This document presents the first statewide master plan for Nevada literacy, called Nevada Literacy 2000, as developed by the Literacy Coalition Advisory Council. It begins with the mission statement of the council. These 11 goals with concomitant objectives are then presented: needs assessment, Nevada Literacy Coalition, adult basic education, student capacity, expanded program access, training for literacy providers, public information, coordination and cooperation, workplace literacy, family literacy, and institutional literacy. The action plan follows. For each objective, a chart lists two to five actions. For each action, the chart designates Office of Primary Responsibility (lead agency), Office of Collateral Responsibility (secondary agency), and date by which the action should be taken. A glossary of abbreviations is appended. (YLB)



Preface

February 4, 1992

The Governor's Literacy Coalition Advisory Council established by Executive Order of Governor Bob Miller in 1988 consists of twenty-five members representing state agencies who expend state or federal funds for adult literacy programming; schools; community colleges; universities; business; labor and non-profit organizations which provide adult literacy programs. It is the duty of the Advisory Council to:

1. Examine and make recommendations regarding the programs for literacy in this State, and
2. Establish a plan for coordinating programs and activities and for promoting and increasing literacy in the State.

The Council has developed a plan in cooperation with the national plan for education America 2000 and the state plan Nevada 2000.

The Governor's Literacy Coalition Advisory Council is happy to present the first statewide masterplan for Nevada literacy. We call the plan Nevada Literacy 2000 as a reflection of our support for the National Goals for Education as outlined in America 2000. Goals 1 and 5 relate directly to the literacy plan.

Goal 1: Readiness for School

By the year 2000, all children in America will start school ready to learn.

Objectives:

- * Every parent in America will be a child's first teacher and devote time each day helping his or her preschool child learn; parents will have access to the training and support they need.

Goal 5: Nevada Literacy and Lifelong Learning

By the year 2000, every adult American will be literate and will possess the knowledge and skills necessary to compete in a global economy and exercise the rights and responsibilities of citizenship.

Objectives:

- * Every major American business will be involved in strengthening the connection between education and work.

- * All workers will have the opportunity to acquire the knowledge and skills, from basic to highly technical, needed to adapt to emerging new technologies, work methods, and markets through public and private educational, vocational, technical, workplace, or other programs.
- * The number of quality programs, including those at libraries, that are designed to serve more effectively the needs of the growing number of part-time and mid-career students will increase substantially.
- * The proportion of those qualified students, especially minorities, who enter college; who complete at least two years; and who complete their degree programs will increase substantially.
- * The proportion of college graduates who demonstrate an advanced ability to think critically, communicate effectively, and solve problems will increase substantially.

Mission Statement

It is the mission of the Governor's Literacy Coalition Advisory Council to provide coordination, evaluation and promotion of programs and activities to successfully reach our goal of a literate adult society by the year 2000.
