ABSTRACT

This report assesses the need for and availability of child care services in the metropolitan area of Louisville, Kentucky, including Jefferson County and six surrounding counties in Kentucky (Bullitt, Henry, Oldham, Shelby, Spencer, and Trimble) and three counties (Clark, Floyd, and Harrison) in southern Indiana. This assessment focused on 1990 census demographics and the anticipated child care needs of the communities. The findings from the study showed that the: (1) highest density of children is located in the Inner City of Louisville and in Southeast and West Central Jefferson County; (2) highest percentage of female-headed households was found in the Inner City, and in West Central and East Central Jefferson County; (3) highest number of children below poverty is located in the Inner City; (4) lowest median income was in the Inner City; (5) lowest availability of vehicles was in the Inner City; and (6) range of weekly cost of child care was \$12.65 to \$124.50. All areas studied showed high numbers of women with children in the work force (over 56%) and households headed by females showed the higher percentage of poverty rates. Among the recommendations made were: the development of additional before and after school slots in areas where none or few exist; an increase in the number of subsidized slots for low income areas; and encouragement of an increase in non-traditional child care with greater flexibility of operation. An extensive appendix provides statistical information by locality. (MDM)

INTRODUCTION AND ACKNOWLEDGEMENTS

Community Coordinated Child Care (4-C), Inc. of Louisville and Jefferson County, Kentucky, is a private non-profit Metro United Way Agency dedicated to quality child care in the hope that every child in our community may have the opportunity to achieve his/her maximum potential. In pursuing this purpose, 4-C will (as stated in its By-Laws):

- (a) Coordinate and develop resources for young children,
- (b) Gather and disseminate information on early childhood, and
- (c) Serve as an advocate for children and families.

In keeping with these goals and recognizing that we are experiencing many changes in our society that have led to an increased awareness of the importance of an adequate supply of affordable, high quality child care for our community, we felt it was important to update the Child Care Needs Assessment based on the latest census information.

This Needs Assessment follows very closely the 1975 study (Murrell, Woodard, 1978) and the 1985 study (Nunnelley, Grever and Zimmer, 1985) with adjustments made as needed to obtain the necessary information to plan for the needs of the community for the next decade.

In 1973 and 1985 a parent survey was a major part of the Needs Assessment. After careful consideration this portion of the study was eliminated. It was felt that the information obtained did not warrant the additional time and cost and several recent national studies have been conducted that provide the necessary information. These studies will be referred to in this report.

As before we have attempted to answer the following questions:

1. What are the demographics related to child care in Jefferson and surrounding counties?
2. Based on the above information, what are the current and anticipated child care needs in various areas of Jefferson County, in the county as a whole, and in the surrounding counties?

The following pages will present the current statistics for specific localities in Jefferson County, Kentucky. We have also included in this report the counties of Bullitt, Henry, Oldham, Shelby, Spencer, and Trimble in Kentucky, and the Southern Indiana counties of Clark, Harrison, and Floyd. Due to the proximity of these counties we felt we should include the entire metropolitan region.

Since the publication of the 1985 Needs Assessment there have been many major changes that are very encouraging, such as the passage of the Federal Child Care and Development Block Grant and the Family Support Act, that significantly increased the amount of the subsidies available to low-income families. Discouraging, however, is the increase in the number of children living in poverty in every area and the significant increase in the number of single parent (predominantly female) headed households who are most likely to be living in poverty.

These factors make it imperative that all levels of government, business, social service agencies, organizations and educational institutions work together to plan for and to develop programs that meet the needs of our children and their families. This Needs Assessment attempts to quantify the reality of many of these factors.

We are especially grateful for the assistance we have received from Beverly Daly, Senior Research Analyst at the KY State Data Center and David Britt, Director of Community Problem Solving at Metro United Way. They are both very knowledgeable and were willing to devote many hours to this project. We are also grateful to Jeanette Nunnelley who carried out the 1985 Needs Assessment and who advised and edited the text for this report.

Throughout the study the 4-C Board of Directors and especially the Planning and Research Committee provided support and encouragement.

Many 4-C staff members contributed in some way to the study. Marillyn Southerling converted the existing facilities from zip codes to correspond to census tracts. The resource and referral staff including Carlotta Palmer, Dolly Williams and Sue Chandler tabulated the information on providers and availability according to age groups as well as the range of cost.

Special thanks and congratulations go to Kent Chrisman who very capably carried out this project. Thanks also go to Brenda Withrow, 4-C Secretary, for her patience in typing and retyping this study. We are also grateful to Terance Delahanty for his volunteer service to input data and tabulate many of the tables.

It is our sincere hope that all those involved will continue to work with us in the future to meet identified needs.

EXECUTIVE SUMMARY

In 1993, Community Coordinated Child Care (4-C) performed a child care needs assessment for Jefferson County, six surrounding counties in Kentucky and three counties in southern Indiana. The two major aspects of the current needs assessment focused on the 1990 census demographics and on the anticipated child care needs in the communities studied.

Two basic methods of analysis were used. First, an analysis of the 1990 Census Data was performed to obtain the demographics related to child care. The major categories selected for analysis from the Census were: number and density of children, percentage of female-headed households, number of children below poverty, median family incomes, transportation, and regulated child care. The second method used involved tabulating the type of regulated care by age, cost and capacity.

Findings:

The findings from this Needs Assessment showed the following:

- Highest density of children is located in the Inner City of Louisville, in Southeast Jefferson County and West Central Jefferson County.
- Highest percent of female-headed households was found to be in the Inner City of Louisville, West Central Jefferson County and in East Central Jefferson County.
- Highest number of children below poverty is located in the Inner City of Louisville.
- Lowest median income was found to be in the Inner City of Louisville.
- Lowest availability of vehicles was found to be in the Inner City of Louisville.
- The range of weekly cost of child care was \$12.65 to \$124.50.

Conclusions:

The 1990 Child Care Needs Assessment concluded that:

- All areas studied showed high numbers of women with children in the work force (over 56%).
- Single parent households headed by females consistently showed higher percentages of poverty rates.

Based on the 1990 U.S. Census information and on the data collected from the 4-C survey of regulated care this report recommends the following:

- Develop additional before and after school slots in areas where none or few are available.
- Encourage an increase in non-traditional child care with greater flexibility in hours of operation.
- Increase the number of subsidized slots for low income areas.
- Develop more transportation from home to child care in Inner City Louisville.
- Coordinate the creation of more regulated child care in Southwest, Southeast and West Central Jefferson County. Additional child care may be needed in specific areas of the Inner City. Each locality should be studied individually.
- Determine work-site locations in counties surrounding Jefferson and analyze with current information to assess child care needs.

BACKGROUND INFORMATION: THE CHILD CARE SYSTEM

Child care is an important social and educational support system in communities. The major players in a child care system are providers, parents, children, and various public and private agencies; all seeking availability, affordability, and quality in early education and care arrangements. There are, however, trade-offs as providers and parents weigh their options. The trade-offs arise from conflicting priorities including protecting children's well being, expanding the supply of affordable care, and minimizing the cost of care (Mathematica Policy Research, INC., 1990). To fully understand these trade-offs, to effectively make personal decisions, and to formulate public policy, the players must be informed about the child care system. The information below highlights (1) recent national developments concerning child care, (2) local developments in child care needs, and (3) general factors affecting the child care system.

Recent National Developments Concerning Child Care Needs

The need for nonparental early education and care has increased dramatically in the last 20 years. The labor force participation of mothers of young children has nearly doubled, so that currently more than half of mothers with children under age six are employed (Kisker, Hofferth, Phillips, & Farquhar, 1990). According to 1990 census information (CDF, 1992) 57.2% of mothers with children younger than 6 were in the national work force. In 1991, 53% of women with an infant (younger than one year) were in the labor force. Another vital statistic which affects the complexity of the problem is that 18.3% of families with children under five years old are below the poverty level. Often these families are headed by a single female parent. Of female headed households with children under five years of age, 57.4% live in poverty.

To meet these changes in our society, recent federal legislation has invested significantly more money in child care and early childhood education (CDF, 1992). In 1988, the Family Support Act was passed which mandates financial assistance for child care for welfare families. In 1990, the nation's first federal comprehensive child care legislation was passed allowing for increases in tax credits and subsidies to help low-income families pay for child care. Additionally, monies are available for families "at risk" for utilizing AFDC. To summarize, federal sources of child care funding now include: Head Start, The Child Care and Development Block Grant, The "At-Risk" Child Care Program, The Family Support Act Child Care Programs, The Social Services Block Grant (previously known as Title XX), The Dependent Care Block Grant, and The Dependant Care Tax Credit.

Local Developments in Child Care Needs

The number of women in the labor force in the areas studied has increased. For the population age group 16 years and over, there were 140,443 women employed in 1970 (U.S. Census, Summary Tape File 3, 1970). In 1990 there were 232,446 women working, a 65.4 percent increase (U.S. Census, Summary Tape File 1, 1990). Approximately 16.9% of the total population in the ten counties studied are children under 12 years of age (U.S. Census, Summary Tape File 1, 1990). Approximately 15.3% of the children in the area under study, live below poverty.

Families in the area may access the approximately eleven million federal dollars through the programs described briefly above (not including Head Start). In addition, there are approximately one million dollars in child care subsidy programs available through 4-C and funded by: Job Training Partnership Act (JTPA), Metro United Way - Direct Voucher Program, City of Louisville, Jefferson County Government, and Volunteers of America (4-C, 1993). A percentage of United Way subsidy and JTPA monies is available in Jefferson and surrounding counties. These funding sources represent only funds used in direct voucher payments of child care services. Funds that have been received by various child care programs as well as direct grants are not included. In October 1992 (for example), 3,143 families with 5,535 children received child care subsidy. Approximately 2,508 children were on waiting lists to access the funds.

Table 1 shows the recent increases in child care subsidy usage and the increases in waiting lists for one month in 1990 and 1992. Total monies available in 1990 were \$2,828,453 compared to \$12,316,952 for the 1993 fiscal year.

1992 Community Coordinated Child Care Information

In 1985 when 4-C released its Child Care Needs Assessment there was a total of 40 licensed child care homes serving approximately 448 children. There were 163 child care centers serving 10,963 children.

At the time of this report there are 126 regulated (licensed or certified) family child care homes with a capacity of 761. There are 367 licensed child care centers with a capacity of 26,907.

A major factor contributing to this increase is the development of large numbers of programs to serve school-age children. Since the 1985 Needs Assessment many public and private schools have started programs to provide for the needs of school-age children whose parents are working.

It is interesting to note the growth of child care in Louisville and Jefferson County since the first Needs Assessment was carried out in 1973. The table below shows that growth from 1973 to 1985 and from 1985 to 1993.

The above information is not available for the six counties in Kentucky and the three Southern Indiana counties since they were not included in previous reports.

General Factors Affecting the Child Care System

The market for early education and child care consists of demand and supply and interrelationships between them (Willer, Hofferth, Kisker, Divine-Hawkins, Farquhar, & Glantz, 1991). Demand is reflected in the quantity and characteristics of services parents buy at a given price; supply in the quantity and characteristics that providers offer at a given price. The number and ages of children and the number of mothers who are employed outside the home are key determinants of child care demand. But demand is also affected by a variety of other factors: marital status, family income, number of children in the family, parents' career goals and opportunities, whether relatives live nearby, educational goals for children, the types of care available in the community, and how accessible or affordable a potential option might be (Willer, et al., 1991).

Additionally, the factors above are complex and intertwined. For example, some mothers remain at home when children are very young, then return to the labor force when the youngest child reaches a certain age. Mothers may also move from part-time to full-time employment as children grow older. Many parents juggle their work schedules, using full-time and part-time employment, flextime, or shift work to reduce the need for supplemental care. Children may be enrolled in programs for child development purposes even though parents are available to care for them (Willer, et al., 1991). Child care may also be utilized for a variety of other reasons such as protection purposes or as a means of integrating children with special needs.

Finally, a major factor which affects caregiving arrangements is the income of the family. In a recent publication by the Children's Defense Fund (1992) it was shown how real income for families has declined since 1973. Table 3 depicts the decline of median real family income in the U.S. by type of family.

Closely linked to the issue of income is employment. The Children's Defense Fund (1991) has published information showing how workers in the age group of 16 to 24 years of age have been hardest hit by the recent recession. Younger workers are more likely to have children, thus making unemployment more critical to the well-being of families. Table 4 shows that 86.3% of the total job losses from January to May in 1991 were among workers who were 16 to 24 years of age.

The Need For Study

As stated, child care is one of the most critical issues facing our society today and the need for information encompasses many facets of our community. Families need knowledge about the various options of child care. Such access enables them to be knowledgeable consumers and informs them about possible assistance to meet their individual needs. Child care providers require training, technical assistance, and support to help them remain in the very demanding and not highly rewarding delivery system. Local governments and planners seek facts on which to base the allocation of resources to meet the changing needs of families. Businesses want assistance in planning to meet the child care needs of their employees. Thus, accurate data and analysis of data in the form of a needs assessment are warranted.

Gwen Morgan (1992), a nationally recognized expert on child care, states:

"Regional planning data on supply and demand should be available on a regular basis. We have come to expect that data on the rate of unemployment is regularly available to employers and the community; we can also access data on numbers and percentages of working mothers. But there is no infra-structure to produce needed data on child care supply and demand. If there were an ongoing source of planning data, the community could track fluctuations and plan action accordingly."

This Needs Assessment attempts to provide that type of analysis and data for planning.

Components of a Child Care Needs Assessment

The three major components of a child care delivery system are availability, affordability, and quality of care. Each could be examined in a needs assessment. For the purposes of this report which is based on census analysis, availability and affordability are explored.

Availability

In order for a community to provide the appropriate number of available child care slots, estimates can be made by applying consumer data on current patterns of utilization. National percentages of utilization of different types of arrangements (by age group) are available from the Census Bureau and from a new study by the Urban Institute (Hofferth, Brayfield, Deich, Holcomb, 1991). Local percentages are possible when local studies are done, or by analysis of Census data or Urban Institute data collected in a particular geographic area. Applying national percentages to the numbers of children in a geographic area will give a conservative estimate of what the number of spaces should be if the national pattern is applied locally. Comparing these numbers to the known spaces in licensed care and in preschool programs not required to be licensed gives a basis for a conservative estimate of supply and demand.

Census data for a particular geographic location which are related to availability are: general population statistics (number of persons, percent under 12 years, number of children in particular age groups), family information (number of married couples, males with children, females with children), and access to transportation.

Affordability

The type of child care a parent chooses is directly related to the amount of money the family has to spend (Reisman, Moore, & Fitzgerald, 1988). The amount of money available to spend is dependent upon such factors as type of employment and income. Depending on the type of care chosen, families may spend from \$1,500 to \$10,000 per year for paid child care. The best estimate for a national average is approximately \$3,000 per child. In the hierarchy of child care costs, center-based care is more costly than family child care. Care for infants and toddlers is more expensive than care for preschoolers and school-age children.

The quality of child care is closely related to the affordability of care. In low-income areas, the need for subsidized child care is essential for facilities to maintain affordable fees while ensuring high quality programs. High quality indicators such as low child-staff ratios, well trained staff, and developmentally appropriate environment and materials are costly. Unfortunately, in many low-income areas, high quality programs are not always available.

Census data for a particular geographic location which are related to affordability are: employment data (number of employed and unemployed, number of females in the work force with children under six), median income, and poverty status.

Recent National Studies

There are other studies on child care needs assessment which are worth mentioning in terms of their findings or methodology. In the National Child Care Survey (Hofferth, et al., 1990), a nationally representative sample of U.S. families with children under age thirteen was interviewed by telephone. The purpose was to gain scientifically valid, reliable, and useful information on current use of child care and early childhood programs which could also be generalized to other areas.

Statistics from this survey revealed that the primary source of child care for most families is parents, followed by relatives, center-based care, lessons (e.g. music, soccer practice), family day care, and non-relatives in the child's home. However, the use of center-based programs has increased consistently over the past twenty-five years. Among families in which the mother works outside the home, center-based programs in 1990 cared for three out of ten preschool aged children, compared with one out of twenty in 1965. Half of all three and four year olds are in such programs, regardless of whether or not the mother is employed.

This same study found that in 1990, 5.1 million preschool children (prior to kindergarten entry) were enrolled in centers and 2.5 million school aged children were enrolled. These figures total an estimated 7.6 million children younger than 13 who were enrolled in centers in 1990.

METHODOLOGY

In 1973 (Murrell & Woodward) and in 1985 (Nunnelley, Grever, & Zimmer) 4-C conducted extensive child care needs assessments in Louisville and Jefferson County. The results from these needs assessments have been the basis for much of the child care developed over the past 20 years in the Louisville metropolitan area. Data was gathered by geographical locations on such variables as density of children, employment of mothers, and income of families. This information was then coordinated with existing child care facilities to indicate specific areas for further development of child care. Also in the previous needs assessments, in-home interviews were conducted to gather information on parental preferences and needs in relation to variables such as location and type of household. Other child care issues such as "quality" were also addressed.

Because of previously mentioned national and local developments and the availability of the 1990 census information, an updated assessment was conducted. An advisory committee was formed to steer the project and a consultant was retained to coordinate the study and report the findings.

Purpose and Main Questions

The main questions to be answered by this report through analysis of 1990 census data are as follows:

1. What are the demographics of child care in Jefferson and surrounding counties?
2. Based on the above information, what are the current and anticipated child care needs (number of available slots, subsidy, etc.) in various areas of Jefferson County, in the county as a whole, and in the surrounding counties?

Definition of Terms

In the following section the terms which are most frequently used in this report are defined.

Child care needs - those services which are currently being offered to specific populations and those which will be deemed necessary after the analysis of the obtained data.

Family - two or more persons related by blood, marriage, or adoption living in the same housing unit (a type of household).

Female-headed household - family with a female head of household and no spouse present.

Household - includes all the persons who occupy a housing unit. Persons not living in households are classified as living in group quarters. In sample tabulations, the count of households may differ from the count of occupied housing units as a result of the weighting process (may be either family or non-family).

Householder - includes, in most cases, the person or one of the persons in whose name the home is owned, being bought, or rented and who is listed in column one of the census questionnaire. If there is no such person in the household, any adult household member 15 years old and over could be designated as the householder.

Income - total money received in 1989 from wages and salaries; self-employment income; Social security or railroad retirement income; retirement or disability income; and public assistance.

Labor force - all persons 16 years and older either employed or actively seeking work.

Median income - The number used is the actual midpoint so that exactly half the workers earned more and exactly half earned less than this amount.

Mode - the most frequently occurring rate in a range of child care costs.

Poverty level - the level at which persons and families are classified as above or below the poverty level by comparing their total 1989 income to an income cutoff or "poverty threshold." The threshold varies by family size and number of children.

Regulated child care - any child care facility (home or non-dwelling unit) which regularly receives children for care and which is duly licensed or certified for such care by the State of Kentucky (includes types I and II facilities and certified family day care homes).

School-aged child - refers to a child attending school for any part of the regular school hours. Children attending kindergarten and public school preschool are, therefore, considered school-age.

Special children - means any children with handicapping or other conditions serious enough that the child care must in some way be altered to meet their needs.

Subsidized child care - any agreement between a child care facility and any funding group under which the facility is reimbursed for part or all of the cost of care for a child.

Unemployed - civilians 16 years old and over who are (1) neither "at work" nor "with a job but not at work" during the reference week, (2) were looking for work during the last four weeks, and (3) were available to accept a job. Also included as unemployed are civilians who did not work at all during the reference week and were waiting to be called back to a job from which they had been laid off.

Assumptions

In using the 1990 census information as part of the study (as in the 1985 analysis), some basic assumptions about child care needs were made.

Demand for child care would be greater in areas where:

- 1) High numbers of families with children reside;
- 2) High numbers of children under six reside;
- 3) High numbers of mothers who work outside the home (particularly single heads of households) reside; and
- 4) High numbers of families whose incomes are below poverty level reside.

General Design

The general design of this needs assessment was similar to the ones performed in 1973 and 1985. First, there was the analysis of relevant 1990 census data gathered by census tract and combined into larger localities and further combined into areas and then summarized for each county as a whole. Second, information available to 4-C from providers of child care and from public referrals was incorporated into the census analysis. Recommendations were based on conclusions drawn from both data sources.

Locations Studied

As with the previous 4-C studies, Jefferson County was divided into seven areas reflecting certain homogeneous characteristics such as income and other demographics. Each of the seven areas was further divided into localities. Also included in this present study were six additional counties in Kentucky and three counties in Southern Indiana closest to Jefferson County.

Listed below are the seven areas in Jefferson County, the six adjacent Kentucky Counties, and the three counties in Indiana which were included in the study.

Type of Census Data Gathered

Census tracts making up each of the larger areas studied were identified and data gathered for each tract. This data was then combined according to the locations described above (by each locality in Jefferson County and combined into the seven areas, each of the six adjoining Kentucky counties, and each of the three Indiana counties). Totals for all of Jefferson County, all of the six surrounding Kentucky counties, and all of the Indiana Counties were also tabulated. The following variables were utilized and reported:

Type of 4-C Data Gathered

The number of licensed child care slots available in either homes or centers, and the range of costs were gathered for the locations described above. This information was based on surveys mailed to all regulated child care providers (child development centers, family child care homes, Head Start, mother's day out, preschools, and school age programs) during the period of August 1, 1992 to November 16, 1992. The mailing was followed by a telephone call to facilities not responding. The survey asked questions pertinent to the needs assessment such as fee range and capacity by age groups. Each responding program was located on a map and assigned census tract locations utilized for the census data analysis.

Data Analysis

Census Data. The data was analyzed to provide a description of families and children and the child care needs in each of the locations described above. In most cases, frequencies in each variable were recorded and percentages were figured where appropriate.

4-C Data. A commercial database program* was utilized to run statistical reports on cost comparisons and capacity by age groups for each locality and county.

Conclusions and recommendations were based on analysis of both data sources.

*The commercial database program was Carefinders®.

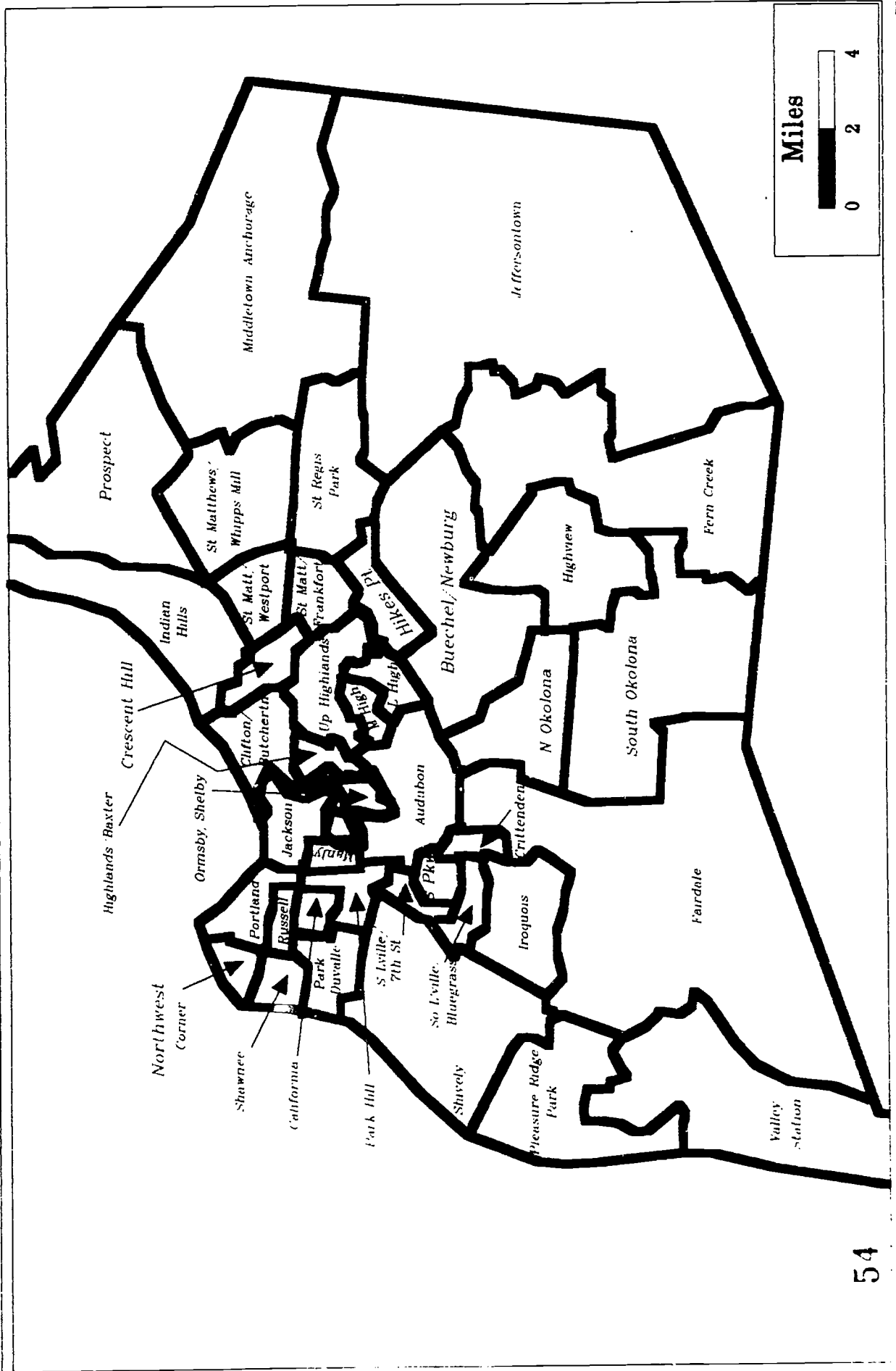

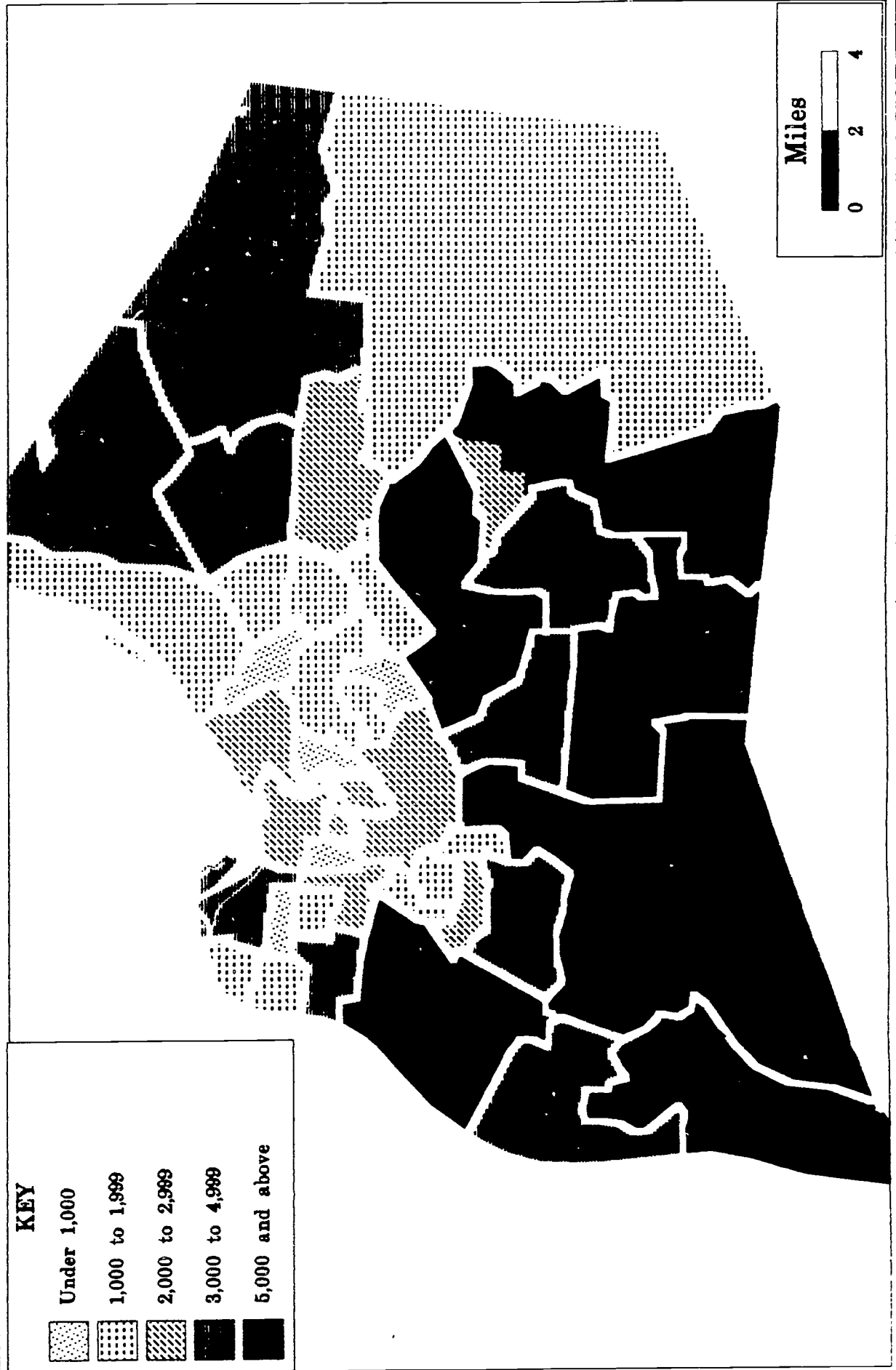

Map 1: Community Coordinated Child Care



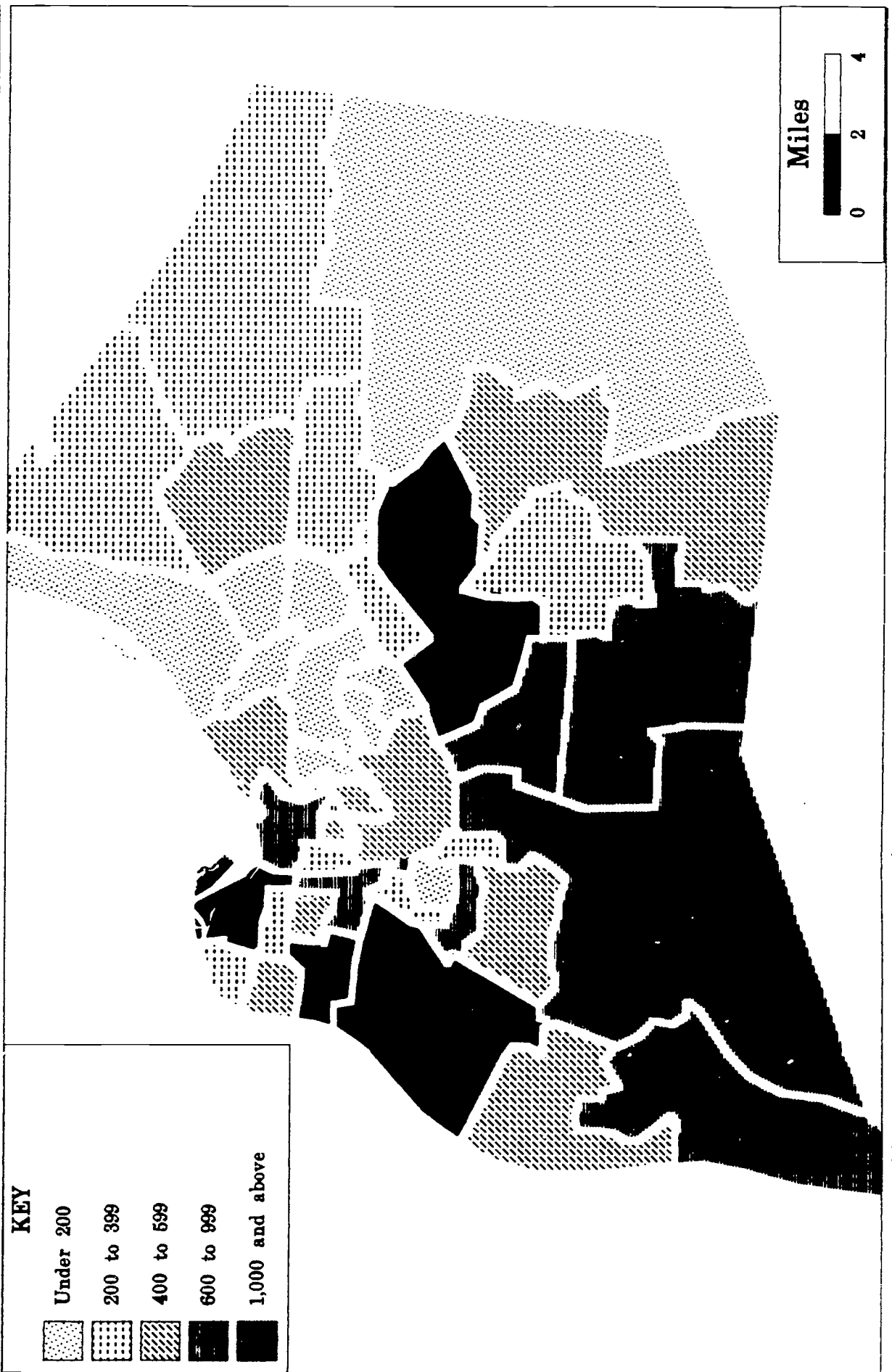

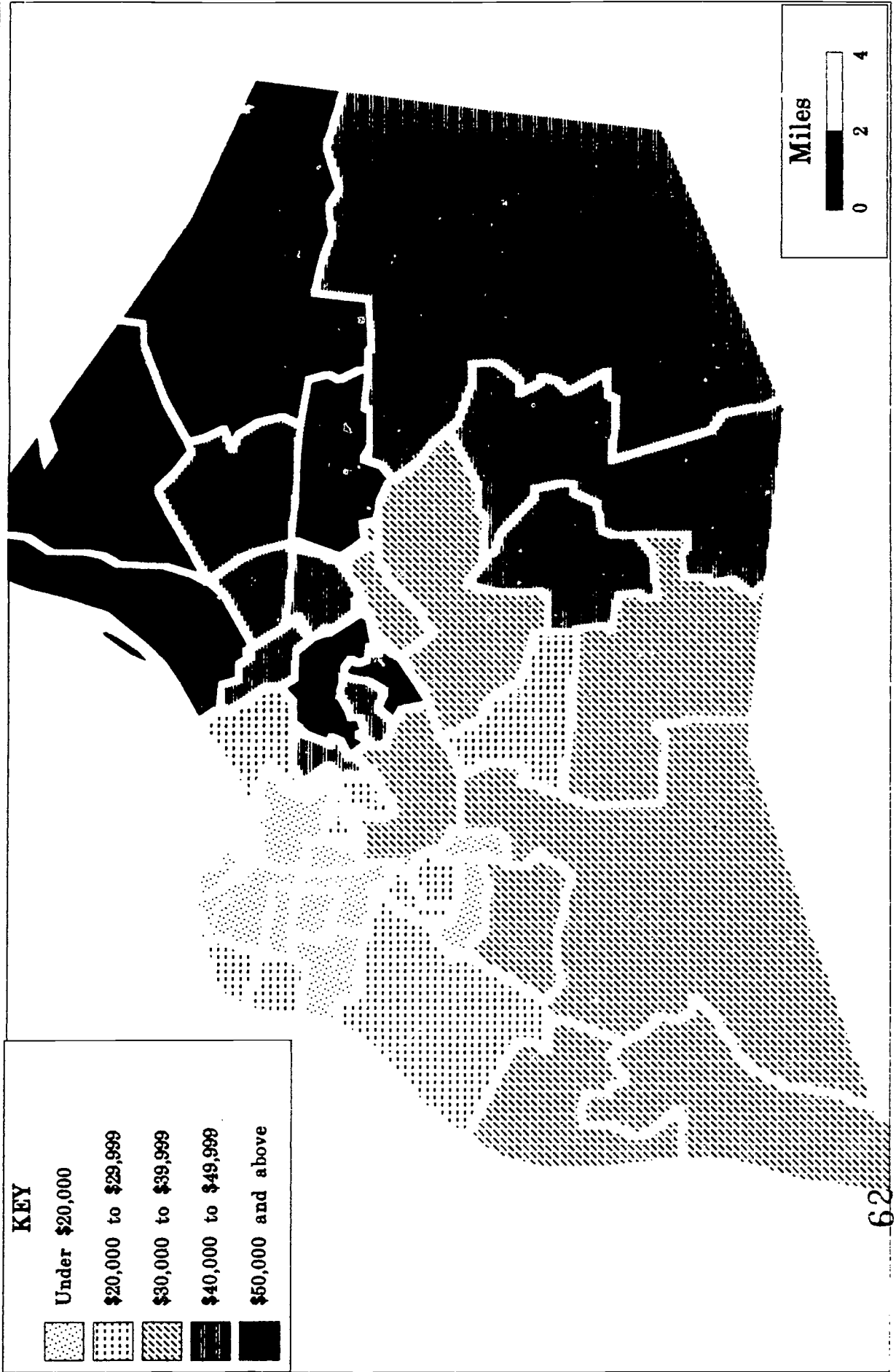

Map 3: Community Coordinated Child Care



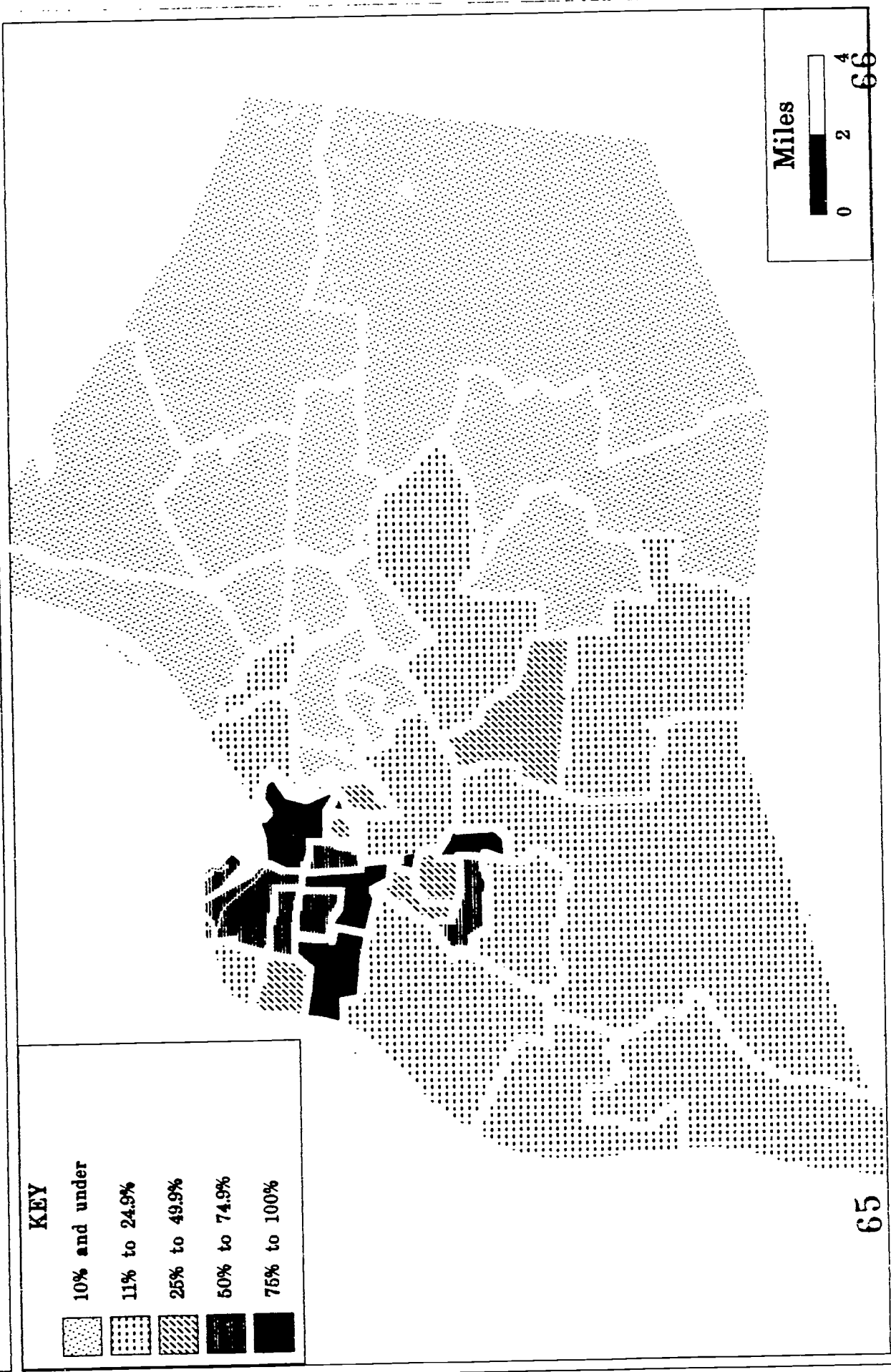

Map 4: Community Coordinated Child Care



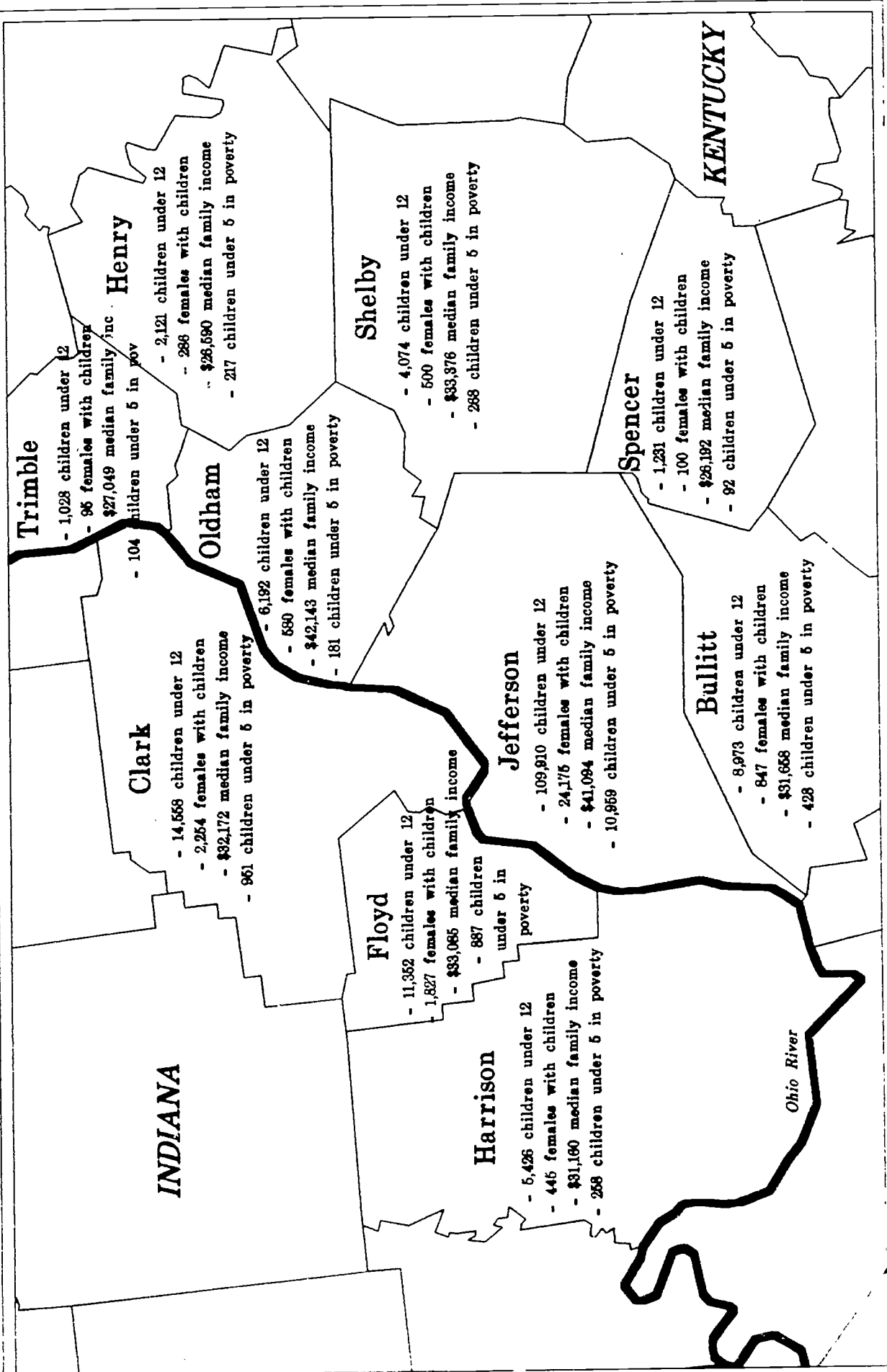
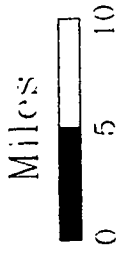

FINDINGS, CONCLUSIONS & RECOMMENDATIONS

FINDINGS

The analysis of the census data for seven areas in Jefferson County, the six counties surrounding Jefferson County in Kentucky and the three counties in Indiana yielded information which can be used by the community to make decisions about the future of child care resources. The census data for this study was organized according to localities and areas in Jefferson County and the other nine counties as a whole. This discussion will consider the differences and implications of the information in the general geographic area studied.

There are several points to be made concerning number and density of children, percentage of female-headed households, mothers in the work force who have children under six, and children below the poverty level. Indicators of the need for various types of child care will be discussed from this analysis.

Refer to Table 10, page 72 for a comparison of density, percentage of female-headed households and percentage of women in the work force between 1985 and 1990.

NUMBER AND DENSITY OF CHILDREN

The number of children was used for several aspects of this study. The number of children, as stated in Table 6, was used to calculate the percent of available regulated child care. Percent of available care was calculated by multiplying the percent of women in the work force with children under six, by the number of children. The result was then divided into the capacity of regulated child care to give the percent of available care for that area or county.

The number of children is shown on Map 1, pages 52-53.

Percentage of children in the population of the seven areas in Jefferson County ranges from 13.6% in North Central to 19% in the Inner City of Louisville. The three highest areas, in terms of density of children, are the Inner City of Louisville (19%), Southeast Jefferson County (17.4%) and West Central Jefferson County (17%). Of the surrounding counties studied, Bullitt and Oldham Counties had the highest density of children under 12 at 18% each.

PERCENTAGE OF FEMALE-HEADED HOUSEHOLDS

The percentage of female-headed households with children is another indicator of the need for child care in a community. The percentage of female-headed households ranged from 17% in North Central Jefferson County to 65% in the Inner City of Louisville. The three areas in Jefferson County with the highest percentage of female-headed households are the Inner City of Louisville (65%), West Central (54%) and East Central Jefferson County (39%).

Information regarding the number of female-headed households is included on Map 2, pages 54 and 55. Poverty rates for female-headed households with children under six is summarized for each locality, area and county in Table 5, page 64.

In the nine other counties: the following is a ranking from highest to lowest showing percentages of mothers in the labor force who have children under six for the surrounding counties:

NUMBER OF CHILDREN BELOW POVERTY

The number of children below poverty level is another indicator of need for child care. The number ranges from 60% in the Inner City of Louisville to 5% in Eastern Jefferson County. The numbers of children below poverty are listed for each locality, as well as for each county studied (see areas and county statistics pages 75 to 154). The number of children under five below poverty is shown in Map 4, pages 58 and 59.

MEDIAN FAMILY INCOMES

The median incomes for families in Jefferson County ranged from \$11,363 (the lowest) in the Inner City of Louisville to \$83,747 (the highest) in Eastern Jefferson County. Harrison County, IN had the lowest median household income \$17,238 and Oldham County, KY had the highest \$32,416 of the counties, surrounding Jefferson County, studied.

Median family income, which may be used as one indicator of child care affordability, is shown in Map 3, pages 56 and 57.

TRANSPORTATION

Availability of transportation is a factor in child care location, use and development. No vehicle availability ranged from 40% in the Inner City to 4% in Eastern Jefferson County. In the surrounding counties the range was from 2% in Harrison County to 9% in both Spencer and Henry counties.

Transportation availability is included for each locality in the seven areas of Jefferson County studied and in the nine surrounding counties. (See localities, areas and county information pages 75 to 154.)

REGULATED CHILD CARE

Regulated child care is categorized by age, capacity, weekly costs and type of care for each locality, area and county. (See pages 75 to 154. Table 6 also shows the capacity for each of the seven areas in Jefferson County, as well as for each county as a whole.)

The weekly cost in localities in Jefferson County ranges from \$12.65 in Buechel/Newburg to \$124.50 in Indian Hills. In the counties surrounding Jefferson County, the weekly cost ranges from \$35 (in Harrison, Clark & Shelby) to \$85 in Floyd County.

CONCLUSIONS

All of the counties studied showed high numbers of women with children in the work force (Oldham at 56.5% was the lowest and Shelby at 72.6% the highest). All areas in Jefferson County showed an increase in the percent of women in the work force with children under six. The conclusion: poverty rates showed the continuing need for subsidized care in the Inner City of Louisville and West Central Jefferson County.

Another demographic trend, apparent in the family information, is the large number of female-headed households with children. Single parent households headed by females outnumbered male-headed households by large numbers in every county. Single parent households headed by females consistently showed higher percentages of poverty rates across areas and counties. The conclusion: continued and/or increased support systems for mothers who provide the sole support is needed.

It was concluded that the need of transportation, as it relates to child care, is clearest in the Inner City of Louisville area where 40% of households showed no vehicles available.

Another focus for continued analysis, is the relationship of work location and the need for child care. This is especially important as employers of large numbers of workers change work patterns add shifts or change sites.

To determine current availability of child care the capacity of regulated care in programs was totaled. This tally was then divided by the number of children under six whose mothers are in the work force. The results of this analysis revealed a range of available care in the seven areas of Jefferson County (See Table 6 on page 65). West Central Louisville had the lowest percentage of available care (32%) while the Eastern area had the highest (69%). Conclusion: only certain areas need an increase in regulated care.

In conclusion, the major result of this analysis indicates increased need for child care for working mothers with children under 6 who are heads of households. This need is particularly evident in areas where income levels are at or near the poverty level.

RECOMMENDATIONS

The following recommendations are derived from the analysis of the 1990 census information and the summary of information regarding regulated child care, capacity, weekly costs and type of care.

NUMBER OF CHILDREN

1. Given the number of school age children and the number of available slots for school age child care it is recommended that additional before and after school programs be developed in localities with the fewest available slots available.

PERCENTAGE OF WOMEN IN THE WORK FORCE

2. Given the high percentage of women in the work force, with children under six, a need for wider ranges of non-traditional child care is indicated. A review of hours of operation indicated that family day care homes seem to show greater flexibility in scheduling for non-traditional care than center-based programs. (See Table 9, this page.) The increased need for child care for extended hours including weekends and for part-time care is evidenced by the increase in requests for information from 4-C.

CHILDREN IN POVERTY

3. The increase in the number of slots has not kept pace with the increase in children in poverty needing child care. As of October, 1992 the State of Kentucky stopped serving additional children in the Purchase of Care Program due to lack of funds. Given the number of children in poverty and the available number of subsidized spaces it is recommended that more slots be purchased for this population.

TRANSPORTATION

4. The greatest number of centers which provide transportation are in the east end. The lowest number of centers providing transportation is in the inner city. Therefore, development of transportation in the inner city is indicated. Since the inner city has the greatest number of homes with no vehicle available there is a clear need for center transportation.

REGULATED CARE

5. Only three areas (Southwest, Southeast, and West Central) appear to show a need for more regulated child care. In the inner city there is an indication that some programs do not serve the inner city population but rather serve the business community which then commutes out of the inner city. The inner city may need more regulated care than the number of slots indicates.

RECOMMENDATION FOR SURROUNDING COUNTIES

This study has reported the capacity of regulated care, the number of children and the percentage of children (density) in the counties surrounding Jefferson County. However, no recommendation can be proposed without more information about the work site location of parents. The work site location is important information in determining child care needs in the counties surrounding Jefferson County.

Since work site location is not included in U.S. Census information, another data-gathering technique would need to be utilized.
