ABSTRACT

This publication is designed to assist career program planners in collecting the data needed to plan career technology, adult learning, higher education, apprenticeship, and training programs for persons living in Maryland. Profiled in the publication are local, state, and federal agencies and programs capable of providing career program planners with information pertaining to population, public school enrollment, employment demand data, business/industry data, wage information, career paths, and educational paths. The following are among the agencies/programs listed: Maryland Office of Planning, Maryland State Department of Education, Maryland School Performance Program, Office of Labor Market Analysis and Information, Department of Economic and Employment Development, Baltimore Metropolitan Council, Maryland Occupational Information Coordinating Council, Maryland Higher Education Commission, Maryland Apprenticeship and Training Program, Job Opportunities and Basic Skills Training Program. Also included are sections on Job Training Partnership Act training programs, Maryland service delivery areas, and a directory of local education agency supervisors of guidance. Where appropriate, descriptions of available information services/products are supplemented with price information and the name/address of a contact person/department. USE OF THE "DATAFUSION" WORKSHEET

This "Datafusion" Resource book is organized by the seven major data components identified by the participants in the "Datafusion" Project as the major components of a labor market analysis for educational program development. The components are POPULATION DATA, PUBLIC SCHOOL ENROLLMENT, EMPLOYMENT DEMAND DATA, BUSINESS/INDUSTRY DATA, WAGE INFORMATION, CAREER PATHS, AND EDUCATIONAL PATHS.

The worksheet on the following page was designed to assist the program planner in compiling and analyzing pertinent data and information from the seven components.

The seven components, on the left side of the chart, form a comprehensive view of labor market supply and demand from an educational planning perspective. The current and future status of the labor market, as identified through employment demand data, is enhanced through the analysis of population patterns, school enrollments, and wage data. Specified student educational needs are addressed through the overlaying of career preparation of career and educational paths information on the supply and demand data.

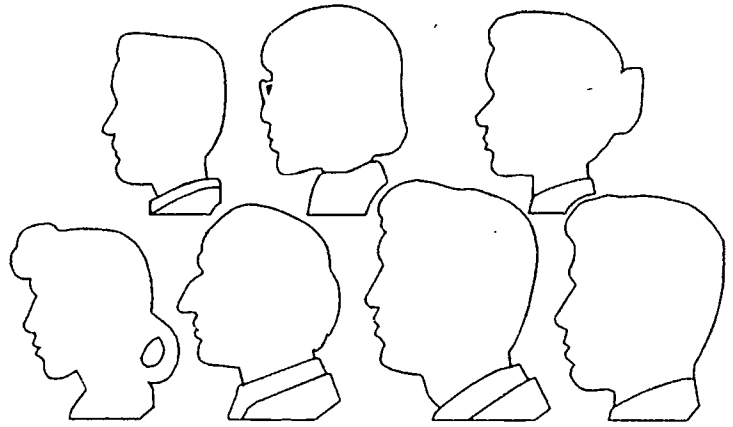
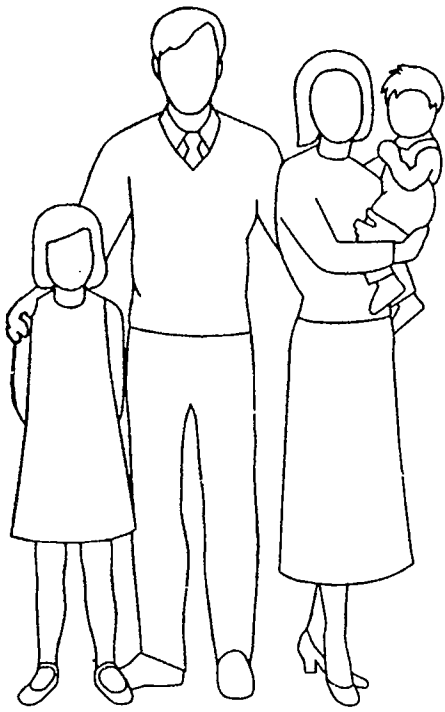

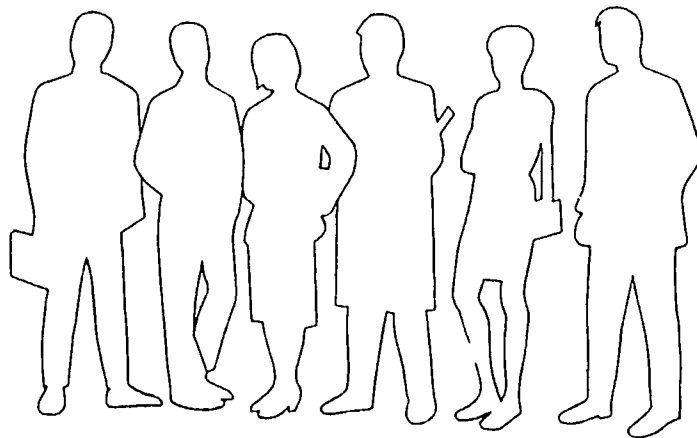

GUIDE TO PRODUCTS AND SERVICES

This report describes the Maryland Office of Planning's Planning Data Services' (PDSs) data products and services available to local governments, state agencies and other data users.

It reveals the sources of our planning information and the array of media on which we make products available. It explains how data users may obtain our reports on such fundamental economic and social factors as: **Population; Employment; Labor Force; Land Use/Land Cover; Housing; and School Enrollment.** It also describes the special records we use to monitor development. These records are based on such files as building permits, land parcels, and migration, and are also available to data users.

Many products are related to U.S. Bureau of the Census data, or data from other federal and state agencies. We use these statistical resources to create the statewide planning database essential for planning projects and research endeavors.

Our three functional components; **Research and State Data Center Program, Geographic Information Systems, and Systems Support,** integrate data collection and analysis with user-specified requirements. Services we provide include:

1. **Data Collection and Dissemination**
2. **Demographic, Economic, Land Use and Social Analysis**
3. **Technical Assistance to Data Users**
4. **Thematic Mapping**

For data users requiring additional information on products described inside, we publish **Product Announcements.** **Product Announcements** are a comprehensive technical description of individual data products and services. DISSEMINATION MEDIA

Planning Data Services' data products are disseminated on several media. These include the traditional means of printed reports, and technically advanced means such as diskettes and on-line information systems.

Printed Census Reports

The printed report is the major medium of data presentation PDS uses. Our publications are widely available in most public libraries and represent an easy to use source of data. Printed reports provide basic data for many geographic areas, particularly at the state, county and place level.

Computer Tape

We make tape copies for data users requiring census summary tapes. Data users interested in other files available on computer tape should call us at (410) 225-4450.

Diskettes for Micro-Computers

Micro-computer diskettes are used by a large segment of the data user community. This is due to the relatively high storage capacity compared to size. PDS uses diskettes as the primary means of disseminating data for small sub-county geographic areas. We release data files formatted in Lotus 1-2-3, or Quattro Pro spreadsheet software, and dBase database management software.

State and county level printed reports may also have diskette versions available showing data for small geographic areas.

Specified products are only available on diskette.

On-Line Information System

The Office of Planning invites the planning community to link up to our on-line electronic bulletin board service. The role of the on-line system is two-fold. First, it provides up-to-date information about new products, planning issues and data release dates. Second, it carries summary tables for frequently requested information.

Data users interested in more information on electronically transmitted data products should request a **Maryland Office of Planning's State Data Center Bulletin Board Product Announcement.**

Microfiche

We maintain microfiche of selected 1980 Census data files released by the Census Bureau and other federal agencies. We have also prepared microfiche of small area data previously available only on computer printouts. Although most small area data transmission is conducted via diskette, many historic databases for small areas are only available on microfiche.

Facilities for preparing paper photocopies of microfiche (blowbacks), are available. Requests for small quantities of blowbacks are easily accommodated.

Thematic Mapping

Planners and other data users find it advantageous to display information on a map. Mapped data quickly identifies characteristics about an area, summarizes the results, and displays opportunities and potential conflicts.

We have developed a series of databases and corresponding computer mapping boundary files for thematic mapping. Maps displaying census and land use information for various applications, are customized media disseminated by PDS.

We provide consulting services to persons and organizations requiring customized maps. Data users interested in data graphically displayed on maps should contact PDS.

One-Page Profile

This is a one-page summary of population and housing characteristics. The data items on this summary include total population, age, sex, households, race, tenure, contract rent of specified renter-occupied housing units, and value of specified owner-occupied housing units.

Eight-Page Profile

(Price - \$1.00 per geographic area; \$.25 per page; discount applied to uniform sets)

This is an eight-page summary of population and housing characteristics. The summary presents 37 population tables and 63 housing tables grouped by subject. Added analytic data such as percentages and averages enhance the data's usefulness.

User-Defined Area Profile

Cost determined on an individual basis

The User-Defined Area Profile is a one-page population and housing summary report. The profile is custom-made for any group of 1990 Census blocks that form a user-defined study area. This may be a neighborhood, a development district, or a market area.

1990-1980 Comparison Report

(1990 and 1980 Population and Housing Characteristics for State, Counties and Baltimore City Price - \$5.00)

This is a 50-page report comparing population and housing characteristics from the 1990 and 1980 Censuses. Data represented for the State, each of the 23 counties and Baltimore City. There is a two-page summary for each jurisdiction.

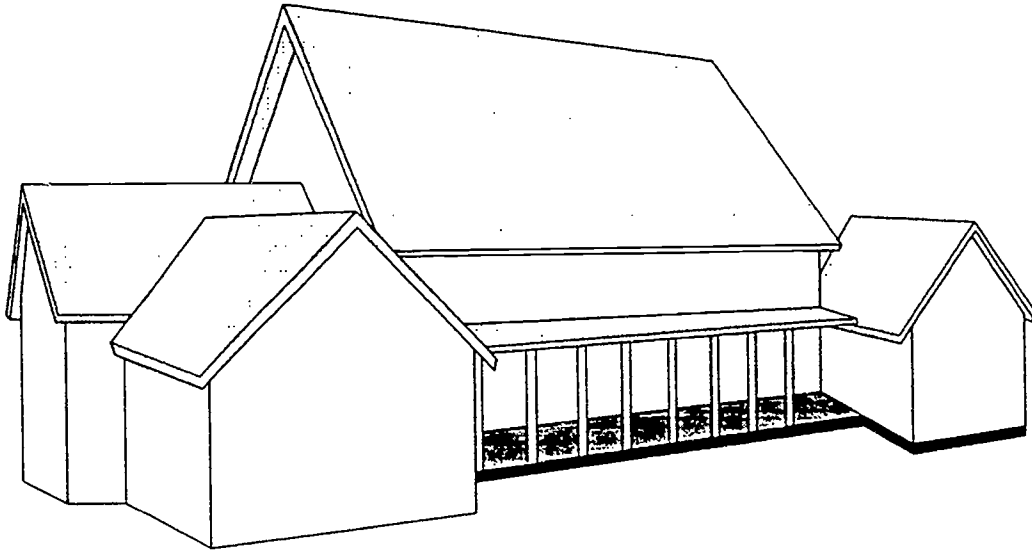

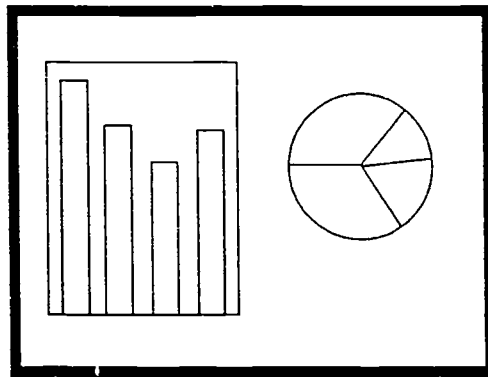

DESCRIPTION OF PUBLICATIONS

- Title:** *AFFIRMATIVE ACTION DATA*
- Summary:** A series of tabular reports containing the most current labor force statistics available by race and sex. Included also are population estimates, occupational data, and statistics on women and minorities seeking employment through the Maryland Job Service. The reports are designed to provide the information required for federal compliance.
- Geographic Coverage:** State, Baltimore Metropolitan Area, Baltimore City, Counties
- Frequency:** Annually
- Title:** *CIVILIAN LABOR FORCE, EMPLOYMENT AND UNEMPLOYMENT BY PLACE OF RESIDENCE*
- Summary:** A one-page table of estimates for labor force, employment, and the unemployment rate, counted by place of residence. Included are current and previous month's estimates along with unemployment rates for a year prior. Historical statistics back to 1970 for the state and to 1980 for regions and counties, are also available. This data series is a product of Maryland's Local Area Unemployment Statistics (LAUS) program, produced in cooperation with the U.S. Department of Labor, Bureau of Labor Statistics.

Summary: An analysis of projected employment trends in Maryland from 1986 to 2000. Using data from the Occupational Employment Statistics (OES) and the ES-202 report, this study forecasts growth in major industry and occupational divisions, as well as detailed industry classes and specific occupations. Jobs with the most openings (growth and separations), largest numerical growth, and fastest growth rates, are highlighted. The report includes data tables, bar charts, and written analysis to explain trends.

Title: *MARYLAND HIGH TECHNOLOGY*

Summary: A detailed analysis of the performance of the private sector industry groups that comprise the high technology industry and their relationship to the total economy. Data on employment and wages are furnished. Detail industry statistics are presented for the state, along with summary figures for the counties. An occupational analysis and forecast of jobs commonly associated with high tech industries are also included.

Geographic Coverage: State, Counties, Baltimore City

Frequency: Updates Annually

Title: *CURRENT EMPLOYMENT STATISTICS (CES) SURVEY*

Summary: This monthly survey of business establishments, a federal-state cooperative effort, is conducted to obtain current data on employment trends around the state. Statistics collected through this survey are used in producing various labor market estimates and form the basis for the two data series described below. These statistics appear in a number of labor market reports.

NONAGRICULTURAL PAYROLL EMPLOYMENT BY INDUSTRY BY PLACE OF EMPLOYMENT comprises the most recent estimates produced for at-place employment. At the regional level, data are published for employment in major industry divisions, while detailed industry statistics are produced for the state. Estimates dating back to 1970 for the state and to 1980 for sub-state regions are also available.

GROSS AVERAGE HOURLY AND WEEKLY EARNINGS AND HOURS WORKED BY PRODUCTION WORKERS IN SELECTED MANUFACTURING INDUSTRY GROUPS includes the number of hours worked and the hourly and weekly wages paid during the survey period for manufacturing production workers, reported by industry group.

Geographic Coverage: State, Regions, Baltimore City, Baltimore Metropolitan Area

Frequency: Monthly, Annually

Title: *EMPLOYMENT AND PAYROLLS OF MARYLAND*

Summary: A tabular report of industry employment statistics compiled from contribution reports submitted by employers taxable under the Maryland Unemployment Insurance Law. Monthly, quarterly, and annual average employment figures are published, along with total and average weekly wages paid, by industry. Also known as the "ES-202 Report", this is generally considered to be the most comprehensive tabulation available of nonagricultural payroll employment and wages.

At the county level, data are published for major industry divisions. For Baltimore City, the Baltimore Metropolitan Area and Maryland, statistics for specific industry classes are supplied. (More detailed data may be available upon request).

Frequency: Quarterly, Annually

Title: *MARYLAND INDUSTRIAL PROFILE*

Summary: Based on data compiled from employers' unemployment insurance tax reports, this study tracks payroll employment trends in Maryland from 1980 through the most recent year available. Detailed industry statistics for the state on the number of jobs, business establishments, and wages paid are analyzed. Limited data is presented by size class of establishments. For the state's political subdivisions, summary and major industry statistics are covered.

Geographic Coverage: State, Counties, Baltimore City

Frequency: Periodically

Title: *MARYLAND MONTHLY LABOR REVIEW*

Summary: A news bulletin intended to provide data users with an up-to-date picture of Maryland's job market situation. Monthly labor force and nonagricultural payroll employment statistics from the LAUS and CES programs are presented, along with data on claims filed for unemployment insurance compensation. A brief written analysis examines the trends behind the numbers.

Geographic Coverage: State, Regions, Counties, Baltimore City

Frequency: Monthly

Title: *MARYLAND RURAL MANPOWER REPORT*

Summary: A review of labor market developments in the state's rural areas. Statistics on farm workers and wages, with emphasis on migrant and seasonal workers, are included. Activities of Maryland's Rural Manpower Program, and services provided to rural workers and employers engaged in agricultural production are cited.

Geographic Coverage: State, Major Agricultural Areas

Frequency: Periodically

Title: *UNEMPLOYMENT INSURANCE ACTIVITIES REPORT*

Summary: A summary of unemployment insurance activities during the state fiscal year in reference. Contained in the report are data on the number of claims filed, claimants exhausting benefits, and average and total amounts of benefits paid. Administrative claims decisions and statistics on special federal assistance programs are also covered. Receipts and disbursements of the Maryland Unemployment Insurance Tax Fund are detailed. Information on employer accounts and contributions made are included.

Geographic Coverage: State, Baltimore Metropolitan Area, Local DEED Offices

Frequency: Annually

NONPUBLISHED STATISTICS

Data from the following statistical series, some of which are available form in LMI reports, can be obtained upon request.

Title: *MARYLAND JOB SERVICE STATISTICS*

Summary: Current and cumulative statistics compiled on activities of the Maryland Job Service. Information is available on job applicants by race, sex, age, veteran status, occupation, and services provided. Data is also produced on job openings placed and filling by occupational title. Limited wage data for job openings may be obtained.

Geographic Coverage: State, DEED Local Offices

Frequency: Monthly, Quarterly, Annually (Program Year)

Title: *OCCUPATIONAL EMPLOYMENT STATISTICS (OES)*

Summary: A federal-state program that produces occupational staffing patterns data by industry group. One-third of all industries are surveyed each year, resulting in an updated economy-wide occupational profile every three years. Additionally, OES data is used in forecasting job trends. Statistics are available on the estimated number of jobs by occupation, and the occupational composition of two-digits SIC's.

GLOSSARY OF LABOR MARKET INFORMATION TERMS

AT-PLACE EMPLOYMENT

This employment measure, which is derived from unemployment tax records submitted by employers on a quarterly basis, represents a count of jobs stratified by geographic areas.

EMPLOYMENT (BY PLACE OF RESIDENCE)

A count of all civilians who, during the survey week, did any work at all a paid employees in their own business or profession or who worked 15 hours or more as unpaid workers in an enterprise operated by a member of the family. Workers temporarily absent from a job due to illness, vacation, labor disputes, bad weather, or personal reasons are also considered employed.

INDUSTRY

An industry designation indicates the primary type of goods or services that an establishment produces. Industries are defined by descriptions in the Standard Industrial Classification (SIC) Manual.

LABOR FORCE (CIVILIAN)

The sum of all employed and unemployed persons aged 16 or older counted by place of residence. State and local area statistics include the civilian population only; national data is available for both civilian and total (including the Armed Forces) labor force.

LABOR FORCE PARTICIPATION RATE

The proportion of the noninstitutional population 16 years and older that is in the labor force:

$$\text{Labor Force Participation Rate} = \frac{\text{Labor Force}}{\text{Population 16+}}$$

METROPOLITAN STATISTICAL AREA (MSA)

A title, assigned for statistical purposes, to a geographic area that meets certain demographic and economic criteria as determined by the U.S. Office of Management and Budget. In general, an MSA is a large, densely populated, economically-integrated area, defined by political boundaries.

PAYROLL EMPLOYMENT

A count of both full and part time wage and salary jobs by place of work. Self-employed, unpaid family workers, persons on unpaid leave or involved in labor disputes, and members of the Armed Forces, are excluded.

PRODUCTION WORKERS

In manufacturing includes working supervisors and all nonsupervisory workers closely associated with production operations.

STANDARD INDUSTRIAL CLASSIFICATION (SIC)

The statistical classification system developed by the U.S. Office of Management and Budget to categorize all industries in the U.S. economy, according to the activity in which they are engaged. Businesses are grouped into divisions and further classified into specific industries identified by numerical codes. Standard Industrial Classification (SIC's) may be expressed in two, three, or four digit codes, depending on the level of industry detail used. All LMI business establishment data is classified according to the 1987 revision of the *Standard Industrial Classification Manual*.

SURVEY PERIOD

The reference period for all state and national economic statistics programs. It covers the pay period that includes the 12th of the month.

TARGET GROUP

A group of persons sharing common characteristics who have been identified as being at a disadvantage in the job market and/or in need of training, placement assistance, or other job-related services aimed at improving their employability. Such groups may include: youth, minorities, women, handicapped, veterans, economically disadvantaged, or others.

UNEMPLOYED

All persons 16 years or older who are not working for pay or profit but are available for work and have looked for sometime during the preceding four weeks. Also included are persons who did not look for work by are on temporary layoff or are waiting to start a new job within 30 days. This is a person county by place of residence.

UNEMPLOYMENT RATE

The proportion of the labor force that meets the criteria for being considered unemployed, expressed as a percentage.

$$\text{Unemployment Rate} = \frac{\text{Unemployment}}{\text{Labor Force}}$$

WORK FORCE

Employed persons counted by place of work.

WORKING-AGE POPULATION

The noninstitutional population aged 16 years and older.

NURSES (REGISTERED) care for the sick and help people stay well. Types of nurses include:

- hospital nurses, who provide bedside nursing care to patients in collaboration with physicians
- private duty nurses, who care for those needing constant attention
- public health nurses, who care for patients in schools, clinics, and homes, and who may instruct patients and families in health care
- office nurses, who assist physicians in private practice, and may do laboratory and office work
- head nurses, who direct nursing activities, plan work schedules, and assign duties to nurses.

Work Setting

NURSES (REGISTERED) work for:

- visiting nurse associations
- hospitals, nursing homes, and clinics
- private offices and clinics of doctors and dental surgeons
- private and public schools and colleges
- government agencies and the military
- themselves in private practice in their own offices and clinics
- their own business of providing home health-care, teaching home kidney dialysis, and providing wellness and health education programs.

Special Requirements

All NURSES (REGISTERED) are required to be licensed in order to practice. Applicants must have graduated from an approved school of nursing and pass a national examination given by each state. Licenses must be renewed periodically, and, in some states, continuing education is a requirement for renewal.

Career Ladder

With experience and ability, NURSES (REGISTERED) may advance in management to assistant head nurse or head nurse. From there, advancement to assistant director, director, and vice president positions is possible. Graduate programs preparing executive level nurses usually last 1 or 2 years.

Within patient care, advancement may mean becoming a clinical nurse specialist, nurse practitioner, nurse clinician, nurse midwife, or nurse anesthetist. For these, 1 or 2 years of graduate education leading to a certificate or master's degree is required.

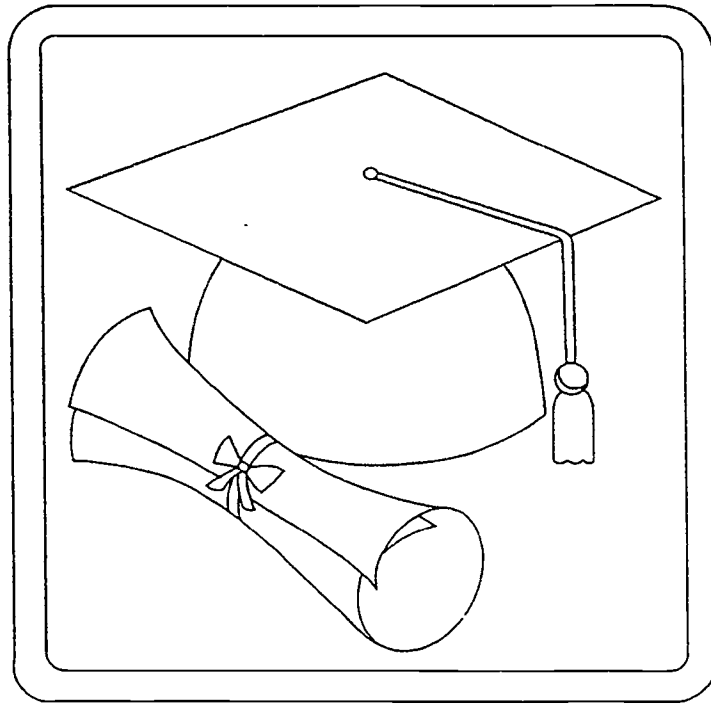

SELECTING A PRIVATE CAREER SCHOOL

This guide suggests some basic questions students should ask before signing up at a private career school, and tells students about their rights as students under Maryland law.

STATE OUTCOME ACHIEVEMENT REPORT (SOAR)

This document is a report of high school graduates who entered institutions of higher learning as freshmen. This is an ongoing effort. Information provided by the institutions includes general demographics, attendance, and cumulative grade point average (GPA). SOAR provides a set of data relating high school characteristics to college performance and persistence. This data is only Maryland high school graduates who go to Maryland Public institutions.

SOAR provides information that can assist better communication between secondary and postsecondary education. In the next few years, SOAR will be beneficial to the public colleges and universities, providing each campus an assessment of how students are performing over time.

Within each region is summary information on the percentage of high school graduates attending Maryland public institutions, the types of institutions attended, admissions exemptions, retention, students enrolled in remedial courses, pass rate for first math and English courses, and cumulative GPA. The regions of Maryland are based on the definition established by the Governor's Regional Task Force, with the exception of Baltimore City. SOAR for Baltimore City is reported separately.

For each institution, summary information on admissions exceptions, remediation, retention, average first math and English grades and cumulative GPA is presented.

PROGRAM DATA MANAGEMENT

Provides a summary of each community college program including detailed information on enrollment, degrees, employment, transfer and discipline costs.

GRADUATE FOLLOW-UP SURVEYS

Community college degree recipients are surveyed annually regarding their activities after completion of their programs.

SURVEY OF EMPLOYERS

Information surveys employers in the State to learn their perceptions of the skills and job performance of bachelor's degree recipients from public four-year campuses. Academic specialties and job-related attributes for which employers have the greatest demand are identified.

ENROLLMENT BY PLACE OF RESIDENCE IN MARYLAND INSTITUTIONS OF HIGHER EDUCATION

Provides enrollment data by place of residence for students enrolled in all public two- and four-year institutions of higher education and those independent institutions providing data to the Commission.

Apprenticeship programs are established and operated by sponsors, which may be a single employer, an association of employers, or a joint apprenticeship committee consisting of employees and union representatives.

Apprenticeship programs are developed to ensure sponsors that their industries will continue to have the highly skilled workforce required to perform specific trades and crafts. Apprenticeship positions become available based on economic conditions, a changing workforce, and/or new technologies.

Apprenticeship programs registered by the State of Maryland must meet the guidelines and standards set by the:

- * Maryland Apprenticeship and Training Council in accordance with the Maryland Apprenticeship Act of 1962
- * United States Department of Labor's Bureau of Apprenticeship and Training
- * Participating industries

Positions similar to those offered through registered apprenticeship programs may be available with employers who are not a part of Maryland's apprenticeship system. A registered apprenticeship program, however, establishes a relationship between the employer, apprentice, government, and a community college where specific guidelines of conduct are laid out in advance. They cover agreements regarding the duration of training; the quality of training; and other considerations, including wages.

Upon completion of a registered apprenticeship program, the apprentice earns a Certificate of Completion and continues on the job with the status of journeyman -- an individual recognized throughout the world as being fully skilled in a trade or occupation.

Technical assistance in establishing and operating registered apprenticeship programs is provided to sponsors by staff of the Maryland Apprenticeship and Training Program, a unit of the Maryland Department of Economic and Employment Development's Office of Employment Training. The office works with the Maryland State Department of Education, Maryland's community college system, and labor and employer communities statewide to support related instruction and on-the-job training for apprentices.

APPRENTICESHIP: "MARYLAND IS TRAINING FOR TOMORROW" MANUAL

This manual was developed by the Maryland Department of Economic and Employment Development (DEED) to provide information about the apprenticeship system in Maryland.

The manual is organized in sections to assist: career counselors, students, job seekers, employers, apprenticeship sponsors and others seeking general information on apprenticeship. Readers may review the section designated specifically for them or may review the entire manual to get a full picture of Maryland's apprenticeship system.

Apprenticeship occupations and training programs are uniquely varied. The manual provides basic information to help you understand apprenticeship and the process for getting involved. Hopefully, your questions will be answered. A number of resource contacts have been listed for further inquiry.

VIDEOS

Two videos have been developed for students and job seekers who want an overview of apprenticeship and how to get involved. Hands on Your Future offers information on the wide range of apprenticeship occupations in Maryland. Building the Future Your Way features the building and construction trades.

Organizations need to send a written request to borrow the videos. Individuals may ask to review a copy of the videos at career counseling offices at local high schools, community colleges, and job training agencies.

BROCHURES

A brochure, "Apprenticeship -- Maryland is Training for Tomorrow" (accompanies the manual) is directed to students and job seekers who want an introduction to apprenticeship and the process for getting involved.

The mission of the Federal Job Training Partnership Act (JTPA) is to establish employment programs to train and prepare economically disadvantaged adults and youth for entry in the labor force, and to address the retraining needs of those individuals who are unemployed as a result of worker dislocation.

JTPA programs in Maryland are intended to develop a well trained workforce which meets the needs of our changing economy. Programs are also intended to assist the citizens of Maryland to obtain gainful employment and thereby reduce dependency on public assistance and unemployment insurance.

The JTPA program is viewed as a training program. Job training programs are an investment in human capital resulting in fewer dollars expended on public assistance programs, reduced unemployment insurance costs, and increased tax revenue to the State.

Programs funded by this federal act provide a vast array of services to Marylanders, including assessment, remedial education, occupational skills training and retraining, resume preparation and job search assistance. The chief elected official in each Service Delivery Area (SDA) selects the agency or unit of local government to administer the federal job training program, and appoints a Private Industry Council (PIC) comprised of a majority of private sector business leaders to provide policy guidance and oversight in the management of these programs.

JTPA major efforts are in preparing the future skilled workforce. Because of concerns over the mis-match of skilled labor and available jobs, a major focus of the JTPA has become addressing Workforce 2000 issues. Workforce 2000 includes issues such as the demand for higher skill levels in service industries, a workforce that is older, more female, and more disadvantages, and the shrinking pool of young workers entering the labor market. In order to address these issues, the program as significantly increased its coordination with other agencies and programs.

JOB OPPORTUNITIES AND BASIC SKILLS TRAINING PROGRAM

Each state is required to establish a Job Opportunities and Basic Skills (JOBS) program that provides a variety of employment, training, and support services to help eligible Aide to Families with Dependent Children (AFDC) recipients gain employment. In Maryland JOBS began operating on July 1, 1989.

With some exceptions, all welfare recipients with children over the age of three may be required to participate. The target population are families where the parent is under 24 and has not completed high school or had little or no work in the preceding year, families in which the youngest child is within two years of being ineligible and families who have received assistance for more than thirty-six months during the preceding sixty months. Of this group, the state is required to serve at least 7% yearly. The law also required that one parent in at least 40% of all two parent families that receive AFDC participate at least 16 hours per week in a work activity.

For each enrollee, an employee development plan is required. Specific services include educational activities, job training, job readiness activities, job development and placement. Each state must also provide two of the following four services: job search activities, on-the-job training, work supplementation, and community work experience.

ACCESS: Entry in this program is through the local Department of Social Services.

Students are identified for Maryland's Tomorrow in the eighth grade on the basis of low academic achievement, histories of retention in grade, and other characteristics associated with being at-risk of dropping out of school. Although local programs vary in design and intensity, each jurisdiction has a year-round approach and specific components for students: skills development, personal development, and transition services.
