## NEWSLETTER OF NEWSLETTERS 1973 - 1993

The first Newsletter (Volume 1, Number 1) of the National Center for the Study of Collective Bargaining in Higher Education (our name at that time) appeared on September/October 1973. With this Newsletter (Volume 21, Number 4), the National Center completes its 21st year of publication. This issue is the 97th we have published during our history at Baruch College. We thought it might be interesting and fun to print a **NEWSLETTER OF NEWSLETTERS** in which we list the article titles from each of our 97 editions over the past 21 years. We hope that by perusing these titles the reader will gain an important sense of the evolution of higher education collective bargaining during that period of time.

From its earliest days, the National Center has published research findings as well as practical "how to" articles for the higher education collective bargaining community. In Volume 1, Number 1 (September/October 1973), the National Center reported the presence of 224 faculty collective bargaining agreements in the United States. In Volume 21, Number 1 (January/February 1993) we reported 464 faculty collective bargaining agreements and 483 faculty collective bargaining agents, remarkable growth for any sector of the economy, but especially for one that has suffered a major legal roadblock, the Yeshiva decision of the Supreme Court of the United States, placed in its way.

The National Center's Directors and Newsletter Editors (Maurice Benewitz, Thomas Mannix, Ted Lang, Aaron Levenstein, Joel Douglas, Frank Annunziato) wrote most of the Newsletter articles. However, noted higher education scholars such as Clark Kerr, Clara Lovett, Myron Lieberman, Irwin Polishook, Ann Franke, and others also contributed.
