ABSTRACT

Data on student enrollments in the 12 regional community-technical colleges in Connecticut are provided for fall 1994-95. Following an executive summary, student data by institution are presented showing full-time equivalent (FTE) enrollments by fund category, full-/part-time status, age distributions, gender, ethnicity, and program enrollments. Additional information is provided on the number of associate degrees and certificates awarded in 1994-95. Highlighted findings include the following: (1) in fall 1994, the community- technical colleges (CTC's) served 52% of the undergraduates in Connecticut public institutions; (2) the fall 1994 CTC enrollment was 44,583 and 21,718 FTE, representing a 2.1% decline from fall 1993; (3) minority student enrollment increased from 20% in 1993 to 22% in 1994, with Blacks and Hispanics representing 19.5% of the student enrollment; (4) 61.9% of the students were women; (5) in fall 1994, 75.2% of all CTC students attended part-time; (6) the average age of the student population was 30, with full-time students averaging 23 and part-timers averaging 32; (7) in fall 1994, 42.8% of all students were enrolled in occupational programs, while liberal arts and sciences and general studies programs accounted for an additional 31% of students; and (8) the CTC's awarded 3,947 associate degrees in 1994-95, a 4.8% decrease from 1993-94, and 707 certificates, a 16.3% increase from the previous year. 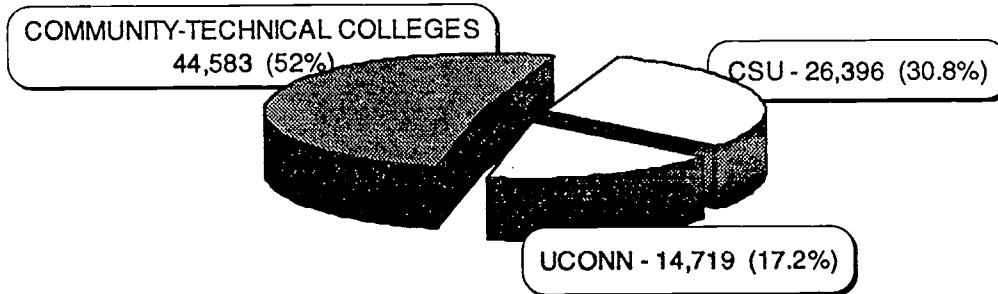

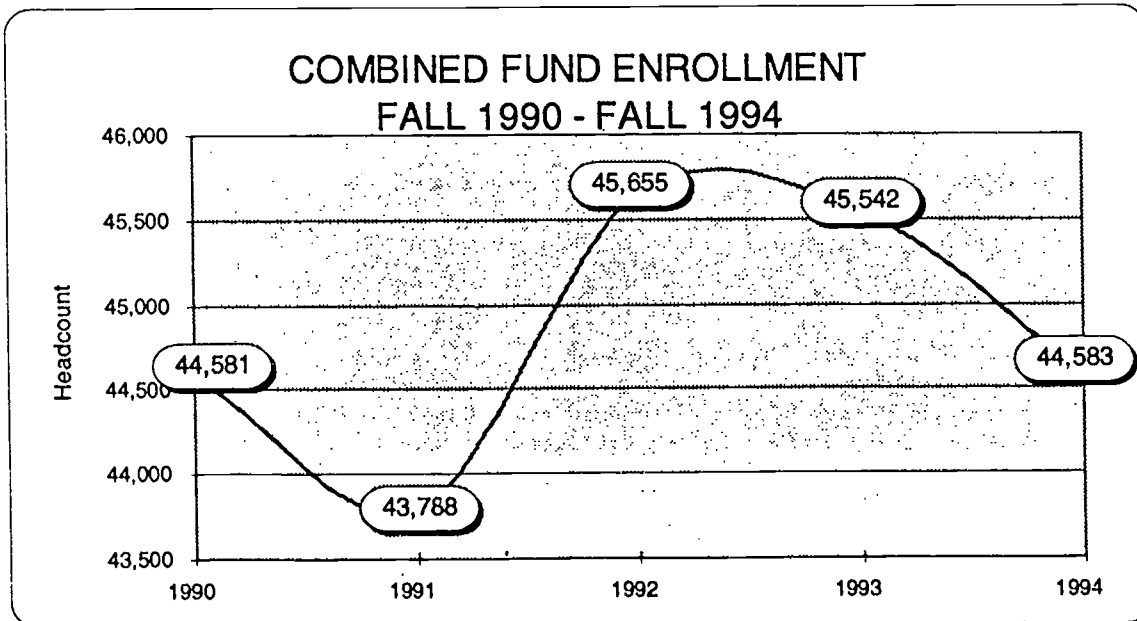
**STUDENT ENROLLMENT STATISTICS

Academic Year 1994-95**

The Community-Technical Colleges (CTC), the largest unit of undergraduate higher education in the state, served 52% of all undergraduates in Connecticut public institutions in the Fall of 1994.

**UNDERGRADUATES AT PUBLIC INSTITUTIONS  
FALL 1994 HEADCOUNT ENROLLMENT**

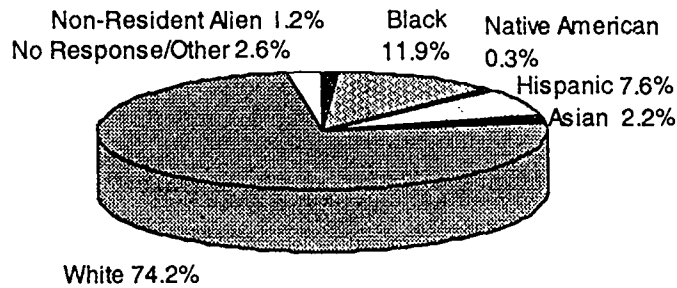


The Fall 1994 enrollment was 44,583 students, and 21,718 FTE. Compared to Fall 1993, this represents a 2.1% decline in headcount and FTE enrollment. In the Spring of 1995, enrollment was 41,850 with an FTE of 19,963. This represents a 2.8% decline in enrollment as compared to Spring 1994, and a 3.5% decrease in FTE.



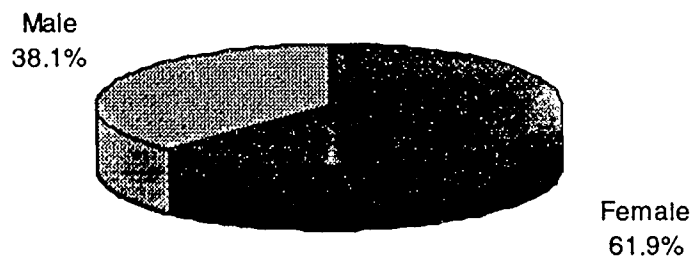
The CTC minority student enrollments increased from 20% in 1993 to 22% in 1994 with Blacks and Hispanics representing 19.5% of the student enrollment. Of all Black and Hispanic undergraduates enrolled in Connecticut public higher education, 68.4% attend the Community-Technical Colleges.

### ETHNIC DISTRIBUTION FALL 1994



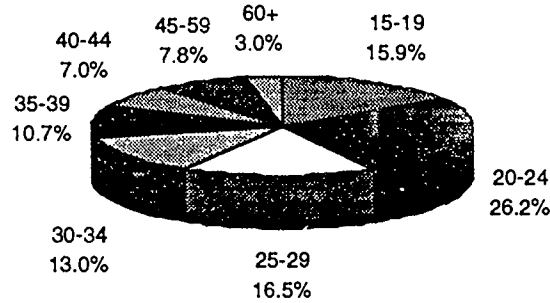
The system's gender composition in the Fall of 1994 was virtually the same as last year, with 61.9% women and 38.1% men.

### ENROLLMENT BY GENDER FALL 1994



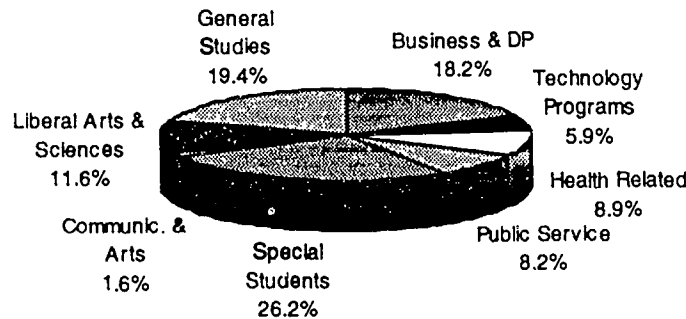
In the Fall 1994 semester, 75.2% of all CTC students attended part-time, which is the same percentage of part-time students attending in Fall 1993. The average age of the student population was 30 -- 23 for full-time students and 32 for part-timers. Of all CTC students, 26.2% fall into the 20-24 year age bracket, while 40.8% are age 30 or above.

### AGE DISTRIBUTION FALL 1994



In the Fall of 1994, 42.8% of all CTC students were enrolled in occupational programs. Liberal Arts and Sciences and General Studies programs accounted for an additional 31% of all CTC students, and the remaining 26.2% of the students were not enrolled in a specific degree or certificate program.

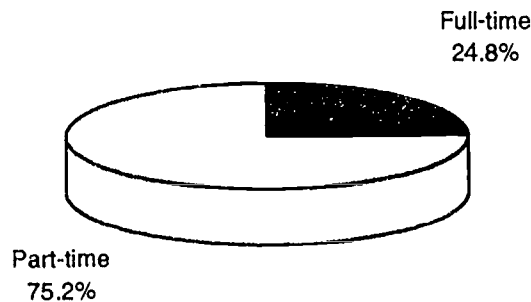

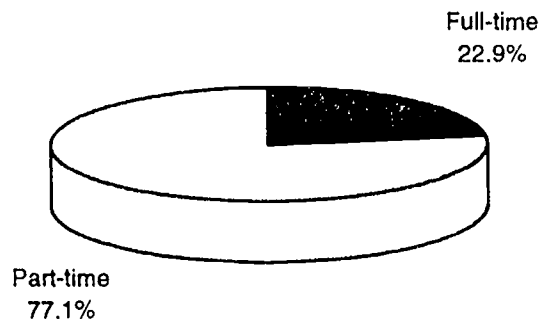
**FULL-TIME/PART-TIME**

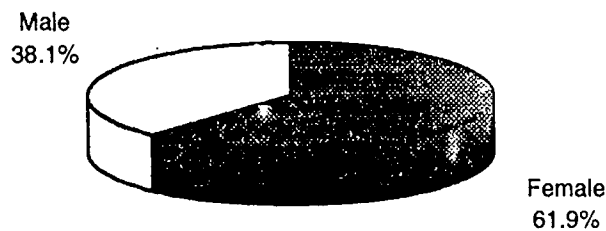

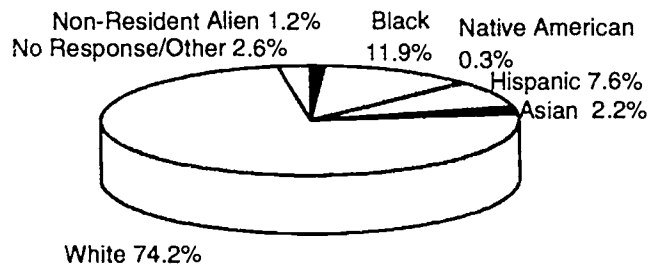
**ENROLLMENT BY GENDER

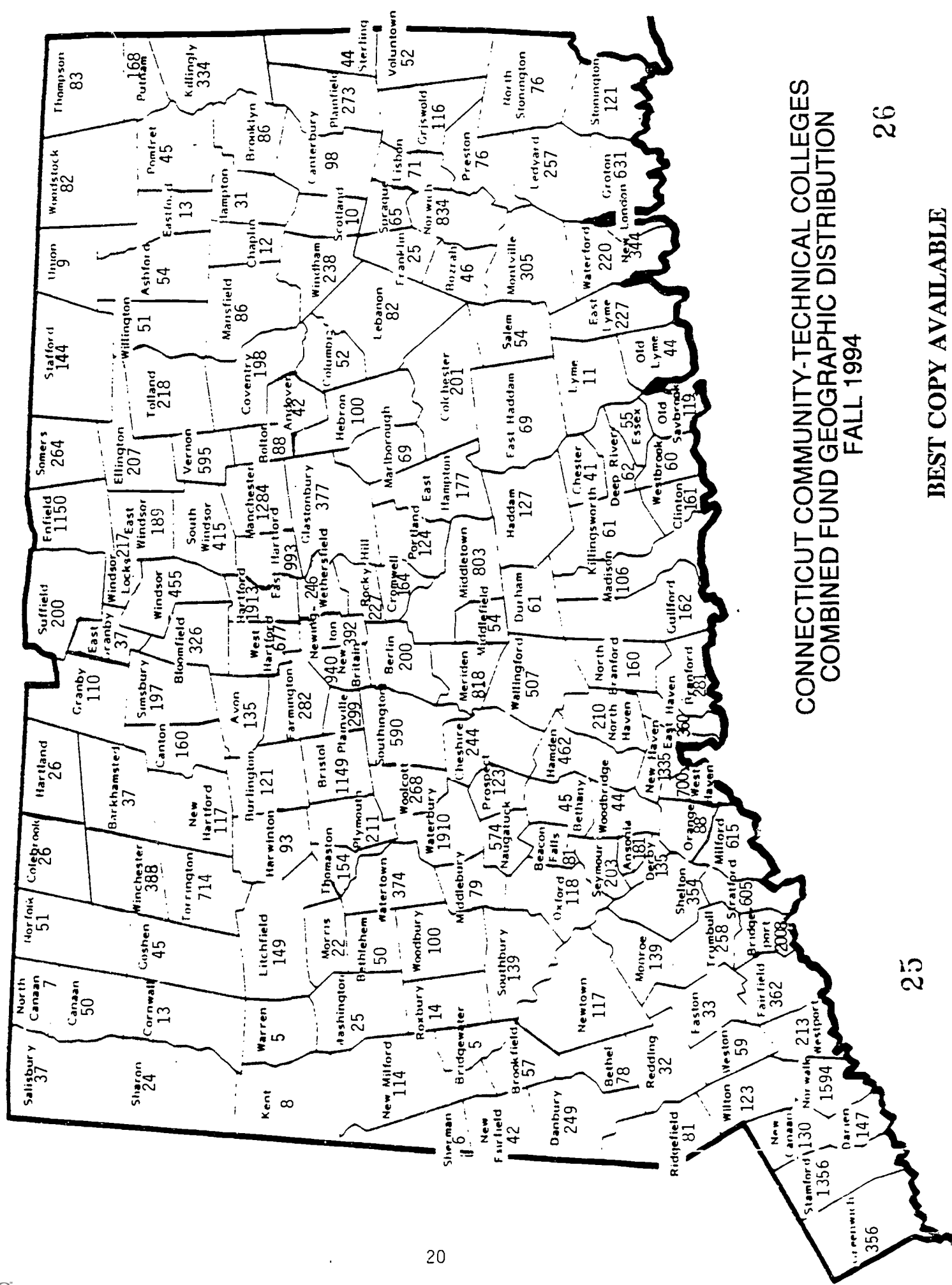
**ETHNIC DISTRIBUTION

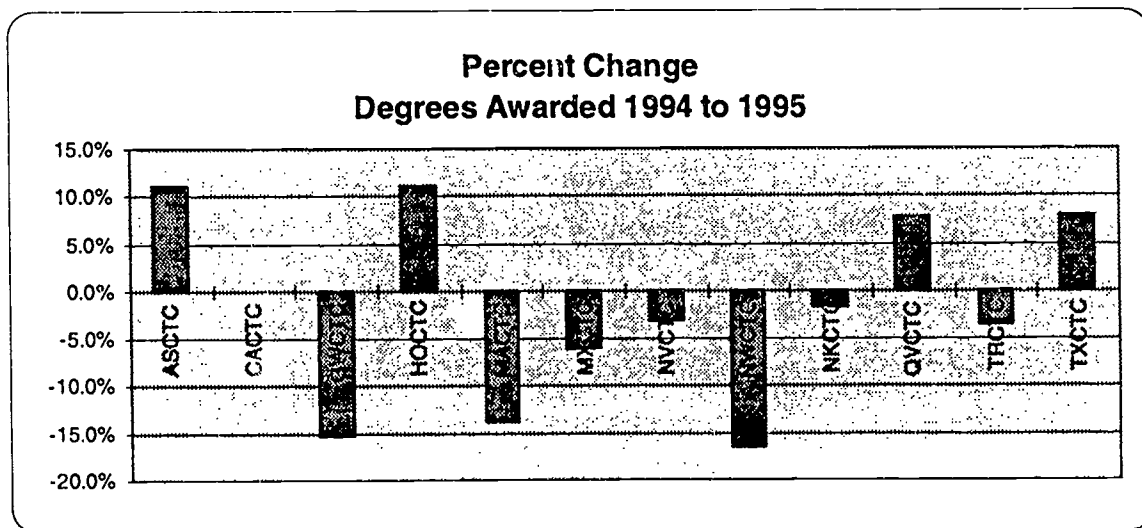
CONNECTICUT COMMUNITY-TECHNICAL COLLEGES

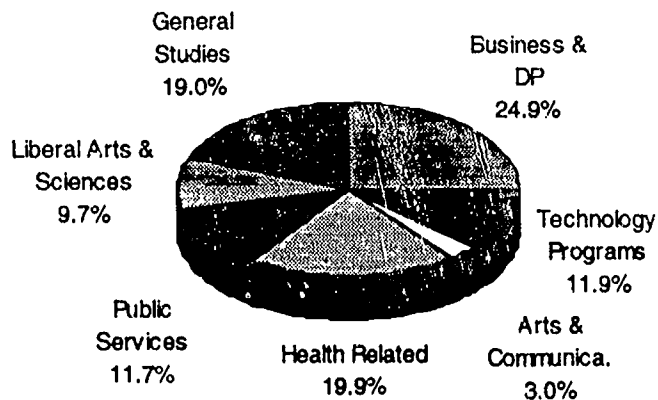
A comparison of the number of degrees awarded to women and to men indicates that degree awards by gender are proportional to enrollments by gender. Women earned 64% of the degrees awarded, and men earned 36%.

Minority students earned 16.9% of the degrees awarded by the system in 1994-95, up from the percentage awarded last year to minorities of 14.9% and reflecting the ongoing increases in minority representation in the system.

Occupational programs account for 71.3% of all degrees awarded; the remaining 28.7% are in Liberal Arts and Sciences, and General Preparation programs. This distribution of degrees among program areas has been fairly stable for the past several years. Business and Data Processing programs continue to provide the single largest group of graduates (24.9%). Engineering Technology programs account for 11.9% of the graduates.
