ABSTRACT

Each fall, Illinois community colleges report their preliminary fall enrollment figures to the Illinois Community College Board. Data from the 49 community colleges for fall 1995 indicate that the number of students enrolled in credit courses as of the end of registration for the term was 336,690, a decrease of 10,289 students (-3.0%) from fall 1994, while total full-time equivalent (FTE) enrollment was 176,969, a decrease of 3,865 students (-2.1%) from 1994. This continues a decline in headcount enrollments witnessed over the last 4 years, following 4 years of growth that peaked in fall 1991. It also continues a decline in FTE since 1992, when it peaked at 192,540. However, 13 of the 49 colleges experienced increases in headcount from 1994 to 1995, while 11 experienced increases in FTE. The report includes tables providing a summary of opening fall enrollments from 1991-95, including headcount and FTE figures; a comparison of fall 1991-94 opening headcount enrollments with fall 1995 preliminary opening enrollments for the colleges; and a comparison of fall 1991-94 opening FTE enrollments with fall 1995 preliminary opening FTE enrollments for all colleges. ## FALL 1995 ENROLLMENT SURVEY REPORT

### BACKGROUND

Based on preliminary counts, both headcount and FTE decreased for fall 1995. The number of students enrolled in credit courses at community colleges as of the end of registration for fall term 1995 was 336,690, a decrease of 10,289 students (-3.0 percent) from the fall term of 1994. The total fall 1995 FTE enrollment was 176,969, a decrease of 3,865 (-2.1 percent) from 1994. Preliminary counts are based on the Fall Enrollment Survey and are subject to verification upon receipt of fall computerized enrollment (E1) data.

Table 1 contains comparative fall tenth-day enrollments for the last five years. This is the fourth year the Illinois Community College System has experienced a decline in headcount enrollments, following four years of growth which peaked in fall 1991. FTE enrollments mirror this trend, peaking in fall 1992, but have decreased less than headcounts in the past year.

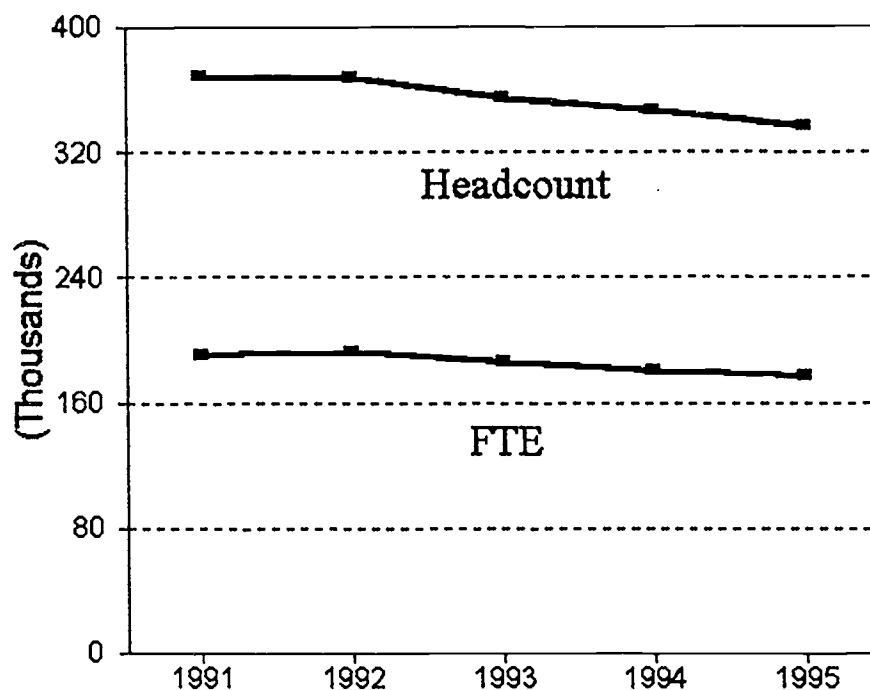


Figure 1. Opening Fall Headcount and FTE Enrollment, 1991-1995

Figure 1 on the next page illustrates a comparison of headcount and FTE trends from 1991-1995.

Table 2 provides a comparison of fall 1991 through fall 1995 headcount enrollments for each community college. Of the 49 community colleges, thirteen colleges experienced increases in headcount, while 29 exhibited decreases during the past year. Seven colleges experienced little or no change (less than one percent) over the last year. Table 3 contains a comparison of FTE enrollments for the five-year period. FTE increases were reported by eleven colleges, decreases by 30, and eight colleges indicated little or no change.
