ABSTRACT

This report summarizes special item funding for public universities, health-related institutions, technical colleges, and community colleges in Texas for fiscal years (FYs) 1996 and 1997, as provided by House Bill 1, 74th Legislature (General Appropriations Act). "Special items" are defined as appropriations made to selected institutions that are identified by a separate line in the appropriations act. The report provides tabular data on general, educational opportunity, research, public service, debt retirement, system support, and health care funding items by institution, by principal purpose category, by Border/South Texas Initiative, and by Northeast Texas Initiative. For FY 1996 and 1997 special item funding totals \$524 million and constitutes approximately 7.9 percent of all education and general state support appropriated to Texas institutions of higher education. Although comparisons with prior biennia are not possible because of changes in the general appropriations bill pattern, it is clear that special item funding is increasing at a higher rate than funding for higher education as a whole. # OVERVIEW

## Background

Universities, health-related institutions, the Texas State Technical College System, and university systems receive funds appropriated by the State of Texas. These appropriations, referred to as education and general state support, are a combination of state general revenue and income collected locally by the institutions from tuition, fees, and other sources. With the exception of health-related institutions, most of the total appropriation is allocated to institutions through a group of formulas based on different elements of cost. Some elements of cost – such as utilities – are allocated by individual justification for all institutions. All appropriations to health-related institutions are by individual justification. Only general revenue, primarily allocated through academic and vocational-technical formulas, is appropriated to community colleges.

Included in the appropriations are amounts institutions use to meet special needs, special opportunities or to fund statutory units. These funds are generally referred to as special items, and they are the subject of this report. For purposes of this report, special items are defined as appropriations made by the Legislature to selected institutions, but not all institutions in a given sector, that are identified by a separate line in the appropriations act and are not intended to supplant formula-driven appropriations made to other institutions for the same purpose.

Using this definition, appropriations for formula elements of cost such as faculty salaries, departmental operating expense, and building maintenance are not special items. Similarly, appropriations for non-formula activities such as Public Education Grants (TPEG), indirect cost recovery for research-related activity, utilities, and staff group insurance are not special items because they apply to all institutions. Finally, appropriations such as those for Texas State Technical College-Sweetwater's Abilene and Brownwood Extension Centers are not considered special items because they are provided in lieu of formula funding provided to all other institutions in the sector.

The amounts shown in this report are those included in the Appropriations Act. The reductions specified in Article IX, Section 153 of the Act are not reflected in the amounts listed.

This report summarizes special item funding for public universities, health-related institutions, technical colleges, and community colleges for fiscal years 1996 and 1997, as provided by H.B. 1, 74th Legislature (General Appropriations Act).

## Special Item Funding by Sector and Institution

For FY 1996 and FY 1997, special item funding totals \$524 million and constitutes approximately 7.9 percent of all education and general state support appropriated to Texas institutions of higher education. Table 1 shows the special item

funding for each sector of higher education and the percentage of appropriations provided through special items in each sector for the current and the previous biennia.

Comparisons with prior biennia are not possible because of changes in the general appropriations bill pattern. However, it is clear that special item funding is increasing at a higher rate than funding for higher education as a whole.

For purposes of this report, special items have been placed in eight categories, as listed on the next page. The General Appropriations Act includes goals for each institution, and these categories correspond to the goals under which the special items are found. The categorizations used in this report correspond to the Appropriations Act, even though these categorizations are not always consistent.

It is important to note that while each special item was placed in a single category for purposes of this report, most special items have multiple purposes. For example, a museum may support research activities and may also be viewed as a public service activity or a research program may have a significant economic development or public service mission in addition to its primary mission of generating new knowledge.

## Special Item Funding by Purpose



## Border/South Texas Initiative


Section C of this report contains a list of special items for the Border/South Texas Initiative. More than \$138 million (including debt service on revenue bonds authorized in 1993) was appropriated to institutions in South Texas and along the Texas-Mexico border to enhance educational opportunities in that region.

The following three charts indicate how the categories of special item funds are allocated in each sector of higher education. No chart is provided for community and junior colleges because all of these funds provide general instructional support.


