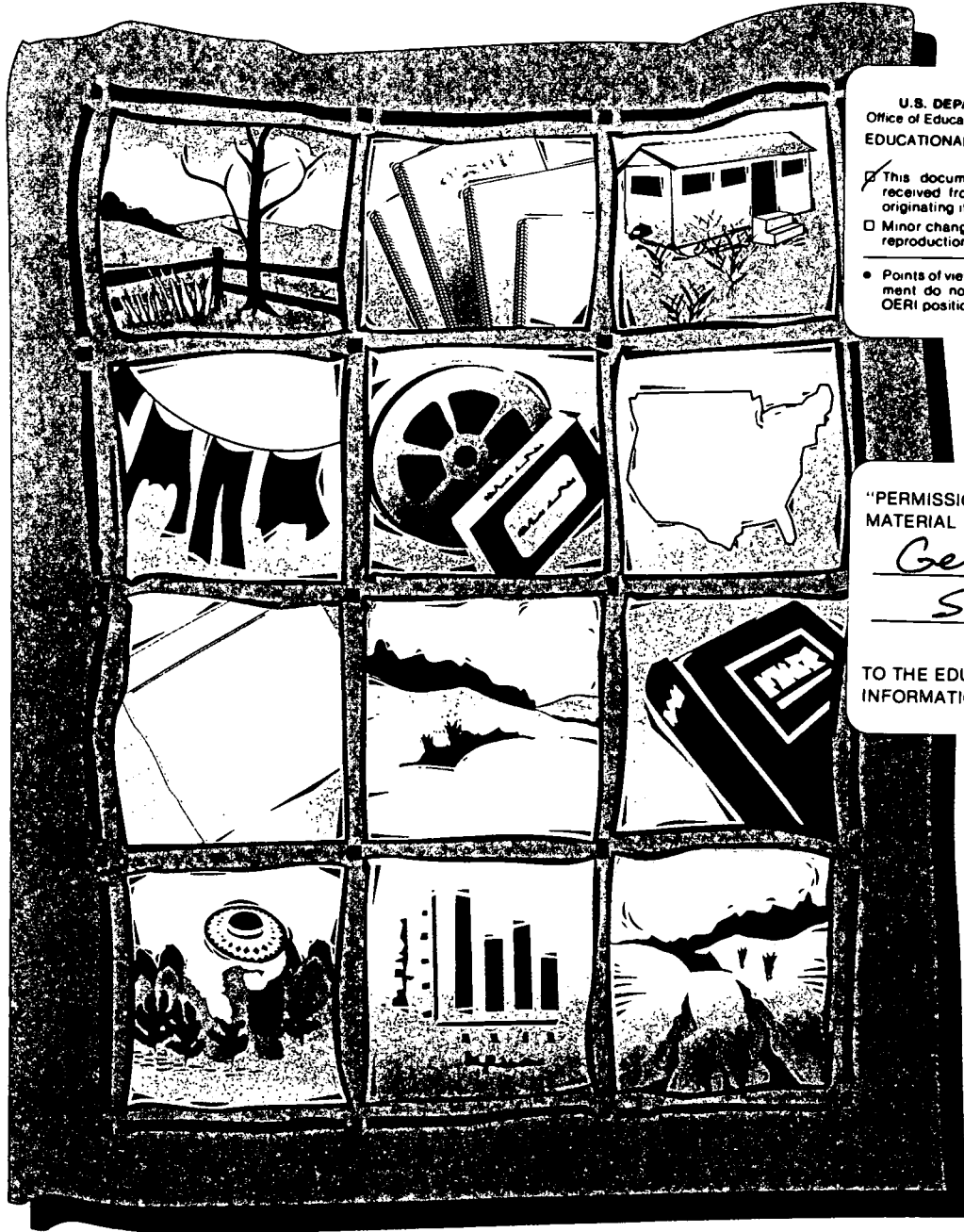

ABSTRACT

This directory contains names and contact information for over 50 social scientists who are available for consultation on policy issues related to poverty in rural America. Part I is organized by topics that are relevant to rural poverty policies and legislation. Under each topic heading are the names; university affiliations; addresses; and E-mail, telephone, and fax numbers of specialists whose research focuses on the particular topic. Entries also indicate the types of services specialists provide: briefings, hearings, analysis, or phone consultations. INTRODUCTION

The **Rural Poverty Resource Directory** contains the names and contact information for over 50 social scientists who are available for consultation on a variety of policy issues related to poverty in rural America.

All are experienced researchers who have worked with policy architects and administrators. They are recognized leaders in their academic disciplines. Each of them is dedicated to the goal of making social science research results available to all who seek to reduce poverty in rural America.

The **Rural Poverty Resource Directory** is a result of our working with legislative aides and assistants of members of the U. S. Congress. Over the past two years aides and assistants have selected topics related to rural poverty that were of interest to them. As Chair of the Rural Sociological Society's Task Force on Persistent Rural Poverty, I have arranged for social scientists to respond to their needs by making presentations at *The Congressional Colloquium* in Washington, D.C. A dozen such meetings have been held and aides have found them useful. However, the demand for information has become greater than can be accommodated through meetings of *The Congressional Colloquium*.

In order to respond to the volume and diversity of requests, and the need for more immediate responses, we have developed the **Rural Poverty Resource Directory** to augment *The Congressional Colloquium* series. The directory allows aides, and others, to make immediate and direct contact with appropriate poverty specialists. All persons listed in the directory have expressed their willingness to be contacted on the topics and for the services indicated in the directory.

To assist you in using the directory, it has been arranged in two parts. Part I is organized by topics that are relevant to rural poverty policies and legislation. Under each topic are the names of available resource persons and the types of services they can provide. In Part II the resources persons are arranged alphabetically and additional information about them is provided.

Professor Kodras specializes in the study of poverty, low-wage work, and welfare programs across the diversity of individual labor markets in the United States. As a geographer, she studies the linkages between global, national, and local processes that combine to intensify poverty in some places and alleviate problems in other places. Thus, to understand poverty in a particular locality requires investigation of multiple forces operating at different levels, such as global restructuring that alters the prospects for work in the locale, shifting priorities and regulations of national- and state-level welfare programs that alter the type of government assistance available, and local political cultures that can motivate or obstruct a sense of shared commitment to address problems in the community. Professor Kodras works from the position that poverty and hunger in the United States cannot be addressed as problems in the aggregate. Effective poverty policy must be defined and coordinated at the national level, because places with the greatest problems have the least resources at their disposal, yet are sufficiently flexible to address the very different reasons for poverty in different places.
