ABSTRACT

Each fall, Illinois community colleges report their preliminary fall enrollment figures to the Illinois Community College Board. Data from the 49 community colleges for fall 1996 indicate that the number of students enrolled in credit courses as of the end of registration for the term was 338,122, an increase of 406 students (.1%) from fall 1995, while total full-time equivalent (FTE) enrollment was 179,051, an increase of 1,611 (.9%) from 1995. Of the 49 community colleges, 18 colleges experienced increases in headcount, while 23 exhibited decreases during the past year and 8 experienced little or no change. Sixteen colleges reported increases in FTE enrollment, while 23 reported decreases and 10 colleges indicated little or no change. The report includes tables providing a summary of opening fall enrollments from 1992 to 1996, including headcount and FTE figures; a comparison of fall 1992-95 opening headcount enrollments to fall 1996 preliminary opening enrollments for each college; and a comparison of fall 1992-95 opening FTE enrollments with fall 1996 preliminary opening FTE enrollments for each college. FALL 1996 ENROLLMENT SURVEY REPORT

BACKGROUND

Fall opening enrollment (E1) data for credit-generating students are recorded by the colleges at the end of the regular fall registration period, which is usually the 10th day. Historically, these data have provided a "snapshot" of fall term enrollment for year-to-year and institution-to-institution comparisons and are used for comparison to fall enrollment data in postsecondary institutions nationwide. However, the diversities of the community college system and its students are not fully captured in these opening enrollment data. The expansion in module and late-starting classes along with the colleges' efforts to provide flexibility in scheduling from year to year increases the difficulty in reporting and comparing fall data. Enrollment trend data are best captured through the use of annual enrollment data.

Based on preliminary counts, both headcount and FTE increased slightly for fall 1996. The number of students enrolled in credit courses at community colleges as of the end of registration for fall term 1996 was 338,122, an increase of 406 students (+0.1%) from the fall term of 1995. The total fall 1996 FTE enrollment was 179,051, an increase of 1,611 (+0.9%) from 1995. Preliminary counts are based on the Fall Enrollment Survey and are subject to verification upon receipt of fall enrollment (E1) data.

Table 1 contains comparative fall tenth-day enrollments for the last five years. This is the first year the Illinois Community College System has experienced a growth in headcount enrollments in the five-year period. Enrollments had peaked in fall 1991. FTE enrollments mirror this trend, peaking in fall 1992, but have increased more than headcounts in the past year.




Figure 1. Opening Fall Headcount and FTE Enrollment, 1992-1996

Figure 1 illustrates a comparison of headcount and FTE trends from 1992-1996.

Table 2 provides a comparison of fall 1992 through fall 1996 headcount enrollments for each community college. Of the 49 community colleges, eighteen colleges experienced increases in headcount, while 23 exhibited decreases during the past year. Eight colleges experienced little or no change (less than one percent) over the last year. Table 3 contains a comparison of FTE enrollments for the five-year period. FTE increases were reported by sixteen colleges, decreases by 23, and ten colleges indicated little or no change.
