# A Guide to Reference Sources

The following bibliography has been compiled to introduce students to the reference resources of political science including international relations and to suggest useful bibliographic tools to facilitate literature searches. Since this list is limited to general reference works, readers who are interested in specific political topics or area studies are advised to search MUSE using the S = command for topics such as: TERRORISM, POLITICAL PARTIES, PARTIES, COMPARATIVE GOVERNMENT, SOCIALISM etc. The Reference collection also contains many specialized subject bibliographies on people (e.g. Marx), their ideas (e.g. Marxism) and political philosophies, concepts and systems (e.g. Communism).

Government publications are an important source of material for political science. The Government Documents Department, 2nd floor, McLennan Library has a large collection of documents including special indexes and bibliographies not covered in this guide. McGill is a depository library for the following: Canadian Federal Government, Quebec Provincial Government, the United Nations and the European Union. In addition, representative collections from the other provinces, the United States, and Great Britain as well as smaller collections from various other countries are maintained.

Machine Readable Data Files (MRDF) are made available through the collaboration of the Faculty of Arts Computer Lab (FACL), the library and the Computing Centre. Data have been acquired through McGill University's membership in the Inter-University Consortium for Political and Social Research [ICPSR]. More detailed information can be found on InfoMcGill under Libraries: Electronic Data Resources Machine Readable Data Files. There is also an ICPSR Guide to Resources and Services (Ref Z7163 I58x) in the McLennan Reference collection.

Other bibliographic guides which may be relevant to research in political science are available at the Reference Desk: Africa, South of the Sahara; Canadian Biography; Canadian History; Canadian Politics and Government; Communism, Marxism & Socialism; Quebec Studies and Latin America.

All locations for items cited have not been indicated. If you wish to obtain additional locations, consult MUSE.

Chapters, in the form of bibliographical essays present resources, for the study of politics in the UK and other countries of the world. This work combines bibliographic sources with substantive reflection on topics such as comparative politics, political behavior and political thought. There is a subject index but best access is through the table of contents.

Chapter nine is an annotated bibliographical essay on political science.

Short and concise annotations make it an excellent starting point.

Social Science quotations arranged alphabetically by author are found in volume 19.

The aim of this work is to serve as a guide to international relations and national domestic politics world wide. 650 signed articles are arranged alphabetically and grouped in ten substantive areas. The entries vary in length from a few hundred words to major essay length (4000 words). It is a good source, well organized and with information clearly presented.

A subject specific encyclopedia dealing with the area of nationalism. Entries vary in length from a few paragraphs to pages and cover topics like music and nationalism, German nationalism, Charles de Gaulle, the FLQ etc. Some entries include bibliographic references to other readings and there is a separate bibliography at the end of the volume.

Its aim is to provide a guide to the people and their ideas that shaped the politics and thought of the twentieth century. The volume has a biographical approach. Each entry gives biographical information about the person and follows with a discussion of the ideas or political movement or writings of the person. Each entry also provides a list of works and further readings.

Aims to provide the definition of political terms and include clarification of the terminology if necessary. Short to medium length entries, are alphabetically arranged, and cover the fields of political science, philosophy, sociology, economics and law.

Alphabetical order, describes people places and events including major political events of the 20th century. Entries vary in length from 1-2 paragraphs to a few pages. There is an appendix of key concepts arranged by subject. Includes photographs and cartoons. Presents a chronology of events in the formation of the European Union, the League of Nations or events like the how the Berlin air lift was started. Provides a social and political view of events in the 20th century.

This volume brings together the discipline of Political Science as a profession. It focuses on American political scientists. A group of contributors chose 171 scholars from the late 19th century to the present for inclusion in the dictionary. Alphabetically arranged entries each about one page in length provide not only brief biographical information and a short list of selected works but more importantly an overview of their works and the theoretical contributions of each scholar.

The 219 signed main entries of varying lengths are alphabetically arranged. They cover people, places, and events in the study of foreign policy with emphasis on the geographical aspects. Cross references are found both in the text and at the end of the entries. A list of bibliographic references and a subject index are included.

Plano, Jack C. and Olton, Roy. International Relations Dictionary. 4th ed. Santa Barbara, California, ABC-Clio, 1988.

The 570 numbered entries are arranged within subject (12) chapters, dealing with foreign policy, ideology, diplomacy, international law etc. There is a guide to major concepts which allows for access to more specific terms. Each entry has a definition and a significance section which explains the historical roots and modern importance of each term.

Alphabetically arranged it describes the human rights performances of countries, based on a questionnaire covering some 40 indicators from major UN treaties. There is a general introduction and then each country is dealt with in turn and ranked for each of the indicators. Alphabetical arrangement.

19 chapters alphabetically arranged cover countries such as Canada, Cuba, Chile, Spain, Japan, South Africa, etc., for human rights violations. It is interested in national human rights, that is the way states treat their own people. Each chapter is quite lengthy and includes notes and suggested readings. There is a selected bibliography and a separate index.1



Parliaments of the World: A Comparative Reference Compendium. 2nd ed. New York, Facts on File Publications, 1986. 2v.

This two volume work compares the structure and operation of parliaments throughout the world. Information is arranged in tabular form which allows for quick comparison and cross reference of topics. A personal name and geographic index are included.

There is statistical information concerning economics, industry, and agriculture; the directory information describes the judicial system, religion, press and radio etc. A reliable and comprehensive source.

The first part of this work provides information on the history, structure and purpose of international and national organizations. Statesman's Yearbook, 1864- New York.

Each chapter in this chronologically arranged work focuses on a time period from the French Revolution (1789) to the Fifth Republic (1989). Entries give birth and death dates, the government ministries held in chronological order and a description of the time period.

Part 1 has biographical information on over 8,000 persons from both Western and Eastern Europe. Short entries provide biographical information as well as a contact address and phone number. Persons must be heads of government, legislative member, political party member, or trade union official. Part 2 is a political directory about countries. For each country information about political parties and the organization of the government is provided. There are also cross references to the biographical section. A glossary of terms and a list of abbreviations is included.
