ABSTRACT

This document provides materials developed by Iowa's community colleges in establishing the Iowa Community College Consortium for Study Abroad, as well as materials from a Consortium study abroad program in England. First, a timeline is presented of actions taken between April 1994 and November 1996 in the development of the Consortium, including meeting dates, mailings to Iowa college presidents, the creation of a brochure, site visits to London, and the determination of colleges with students enrolled in the program and those interested in participating in the Consortium. Next, 16 guidelines for participating colleges are presented, reviewing methods for voting, responsibilities of the Consortium, methods for developing curricula, and minimum requirements for student participants. Following an overview of the Consortium, including a mission statement and description of goals, information is provided on a semester abroad program in England developed by the Consortium and Kirkwood Community College (KCC). Information is provided on the length of the program, available courses, travel, housing, and the cost per participant, indicating that charges for the program fee, a damage deposit, airfare, and KCC tuition total \$5,745. Next, a sample mid-program evaluation instrument developed for the KCC program is presented, including questions on courses taken; instructional quality; satisfaction with housing, classrooms, and transportation; and students' best and worst experiences. Finally, sample responses are presented from a fall 1996 mid-program evaluation. (HAA)

IOWA COMMUNITY COLLEGE STUDY ABROAD CONSORTIUM

GUIDELINES

1. Colleges that wish to join the Iowa Community College Study Abroad Consortium, hereinafter referred to as the Consortium, after the date of execution of this document must be approved by a majority vote of the Consortium members.
2. Each Consortium College shall appoint one person to serve on the Consortium. The Chair shall call meetings as needed and a quorum shall require the presence of two-thirds or more of the members who make up the Consortium.
3. The Consortium shall function as a policy advisory unit in the administration of the program and, among other responsibilities, shall be charged with determining the curriculum content of the program, staffing needs, and other activities necessary to maintain a quality instructional program.
4. In the initial start-up period, Kirkwood Community College will provide administrative coordination, in consultation with consortium members. The consortium members will jointly decide these arrangements in future years.
5. The Consortium will try to maintain a goal of a ratio of 15 students to one instructor each semester.
6. The lead school shall have the prerogative to appoint the first instructor, who will serve as on-site coordinator, with the approval of the Consortium. All other instructors will be selected by the Consortium from a competitive pool.
7. The Consortium shall develop each semester's curriculum. The curriculum, including disciplines and courses to be taught, shall be based on the desire to provide curricular breadth and shall capitalize on the strengths of appointed instructors. Standards for courses, instructors, texts, out-of-classroom assignments and grading practices shall, as a minimum, be equivalent to those required at the home institution.
8. The salary of the instructors in the Study Abroad Program shall be paid by their respective institutions. Each school with a faculty member participating shall be responsible for paying fringe benefits and any non-salary pre-requisites of that person with the other institutions in the program paying a percentage of the instructor's salary. This percentage is based upon the number of students from that institution participating.
9. All students shall be enrolled through their own institution.

10. Instructors remain employees of their respective employer college and remain generally subject to the rules and regulations of their employer college as may be reasonable and appropriate considering the foreign study program itself and its locale. Instructors shall be entitled to sick leave and fringe benefits otherwise provided when serving on campus, subject to appropriate sick leave verification by the on-site coordinator.
11. Instructors must sign the attached agreement from the Consortium regarding their instructional responsibilities while teaching abroad. Instructors must meet State of Iowa credentialing.
12. To be considered for the program, students must have completed four semester hours with a 2.0 GPA by the time they begin the semester program. Students who do not meet these criteria may petition the Chief Academic Office of the sending college.
13. Students shall be required to enroll in and maintain a minimum of 12 semester hours, including 3 units of the British Life & Culture class offered by AIFS.
14. The Fall Semester for the Study Abroad Program shall normally commence on or about Labor Day and the Spring Semester on or about January 4.
15. This Consortium shall continue until rescinded by a quorum of the members. Agreement regarding the continuation of the Consortium will be contingent upon sufficient enrollment to maintain an effective program.
16. In order to allow adequate marketing, recruiting and planning, schools wishing to participate in the program will maintain membership for a minimum of two years.

Overview Document

Mission Statement

- * The consortium will act as a core group for the planning and marketing of study abroad programs.
- * The consortium will assist with the development of both long and short-term international academic exchanges.
- * The founding colleges are Eastern Iowa Community College District, Kirkwood Community College, Des Moines Area Community College, and Iowa Central Community College. Other currently participating colleges are Indian Hills Community College, Ellsworth Community College, NIACC, and Northeast Iowa Community College.
- * The objectives are to offer various levels of participation for the Iowa community colleges and to support the growth of international academic exchanges.

Rationale

According to the 1992-1993 edition of "Open Doors: Report on International Educational Exchange," the number of American students earning credit for international academic experiences have been increasing. Currently, 71,154 American students are enrolled abroad, including 1,673 students from Iowa colleges.

Individual community colleges often have difficulty recruiting enough students to allow study abroad programs to occur. By forming a consortium, the Iowa community colleges can collectively facilitate the expansion of successful study abroad opportunities.

Definitions

Short-term programs: These will consist of any study abroad activity that is less than a semester in length. Short-term programs may occur during interim periods or during scheduled academic terms, and may be for credit or non-credit.

Long-term programs: These will consist of a study abroad activity of at least a semester in length, and may be for credit or non-credit.

Lead school: Community College which is organizing the study abroad program.

Goals

- * The participating colleges will advertise consortium activities in their published schedule of classes and in other marketing materials.
- * Each year members will notify the consortium of the international exchange programs they wish to share.
- * In short-term programs, it is likely that the lead school offering the study abroad activity will award the credits and will receive the tuition.
- * If the short-term program is non-credit, it is likely that the lead school will claim reimbursable contact hours.
- * For long-term programs students will enroll for credit or non-credit at their own institution. Those campuses with students enrolled would pay a percentage of the instructor's salary.
- * The lead school offering the program will provide the faculty member. If enrollment in the activity warrants more personnel, the consortium will determine from which college the additional faculty will come.
- * The consortium will only work with experienced, bonded, educational travel organizations. If this is not the case it should be clearly stated in the promotional material.
- * In the initial start-up period, Kirkwood Community College will provide administrative coordination, in consultation with consortium members. The consortium members will jointly decide these arrangements in future years.
- * For marketing and organizational purposes, the planning cycle will be at least one year ahead of the current academic year.

Kirkwood Community College

Semester in England
Fall 1997

General

The program is currently organized in conjunction with the American Institute for Foreign Study (AIFS), who have a thirty year record of providing this type of program. They arrange the classrooms, transportation, ground support, homestays, hotels, bus/train passes, etc.. The academic part of the program is provided by Kirkwood and the other colleges in the consortium.

Academic Program

You will be taking Kirkwood credits while studying IN Cambridge. You are NOT studying AT Cambridge University. Students from the other Iowa colleges will be taking credits from their institutions.

The program will last for 12 weeks. Five in Cambridge, two in London, and the remaining five in Cambridge again.

Depending on the Instructor, courses will be offered in the Arts and Humanities/Social Sciences (Course selection will be made after the instructor is chosen).

Courses being offered in Cambridge during the Fall 1997 academic semester:

Students will be required to take minimum of 12 credits.

Travel

The land and air components are arranged for us by AIFS. Students will have optional return dates and locations. For example, although the official program finishes in early December, a student may opt to return home from another European location such as Paris, Prague, Rome, etc.. There will be a small additional charge for this.

During the London component of the program, students will have ample opportunity to visit the museums and art galleries/theaters, sites, etc.. Reduced price tickets will be available. Underground (metro)/bus passes will be included in the program cost.

Special trips and visits over weekends are built into the program cost. They may include trips to the Roman city of Bath; Stratford-upon-Avon; Stonehenge; Cathedral City of York.

Housing

In Cambridge the housing is currently with homestays. In London, students stay in a tourist class hotel. We are currently researching some alternative housing arrangements in Cambridge. If this becomes available we will inform students.

Cost

Study abroad programs are eligible for Financial Aid. Students should talk to Peg Julius, Director Financial Aid, Rm 205 Kirkwood Hall. Ext: 5682. We will make arrangements for her to visit with students during a special meeting.

A limited number of scholarships (\$300.00) will be available.

Comments from the students studying in Cambridge with the Semester Abroad program Fall 1996. These questionnaires were completed approximately five weeks into the twelve week program (September 12 - December 7 1996).

If you had to describe this program for someone, what would you say?
