ABSTRACT

This report presents tables, graphs, and text detailing special education statistics for the state of Colorado for the school year 1994-95. The first section of the report includes the following information: (1) the number of children with disabilities served by disability category; (2) the number of students with disabilities served by disability and percent of each disability; (3) the age of students with disabilities; (4) the number of students with disabilities served in various settings; (5) the number of students with disabilities served in home schools by disability; (6) the percent of students with disabilities by disability and gender; and (7) the exit status of students with disabilities. Additional sections of the report include data on the number and different occupations of special education staff, special education expenditures, and special education revenues. A chart includes the number of special education students served in each individual administrative unit, the cost per student, and the total special education expenditures for each unit. The report's data indicate there was a total of 67,419 children with disabilities served in the school year 1994-95, 82 percent of students with disabilities were served within their home school, and the total special education expenditure was \$294,160,335. Education of Children with Disabilities

The Exceptional Children's Educational Act (ECEA) directs the Department of Education to prepare an annual report concerning special education programs. In 1994, this Act was amended to stipulate that the report should be based on information required by the Federal Government, and that no additional information should be collected by the Department. As a result, data presented in this report cannot be compared to information published previously. Specific changes in the data are addressed below.

Children Served

Prior to 1994-95, administrative units submitted unduplicated counts of the numbers of children with disabilities served in each unit throughout the entire school year. This data reflected only children served by public schools, and did not include those served in eligible facilities such as child placement agencies, hospitals, residential child care facilities, and day treatment centers. Information in this report is based on a statewide unduplicated count of children served on December 1, 1994, and includes children with disabilities that were served in public school programs, as well as in eligible facilities. It also includes children in private schools and Head Start programs if the administrative unit contracted and paid for services in those settings. It does not include children served by the Colorado School for the Deaf and the Blind (CSDB), the Department of Corrections, Youth Corrections, or the mental health institutes at Fort Logan and Pueblo. Previous data collection included hours of special education services provided to each child, and was used as a measure of severity. This information is no longer available.

Special Education Personnel

Through 1993-94, administrative units reported individual staff data on all special education salaried and contracted personnel employed throughout the school year, including summer school. Information included FTEs, salaries, and assignments. Data is now collected for licensed personnel employed on December 1, and does not include information on salaries for specific assignments.

Revenues and Expenditures

Expenditures are still collected at the end of the fiscal year, and therefore this data is comparable to information previously reported. However, the average cost per student will be higher because financial data is cumulative for the year, while student data is based on a one-day count. Total instructional and total support services salaries are available, but cannot be delineated for teachers, paraprofessionals, related services personnel, or administrators. No average salary data is available.

The 1993-94 fiscal year was the last year that public school special education programs were funded on a cost reimbursement basis. Also, because of the changes in the funding system, as well as changes in data collection requirements, the statute was changed to eliminate the requirement for the Department of Education to determine the portion of General Fund dollars available for students who were served in self-contained programs. As a result, the State contribution to special education for 1994-95 only reflects categorical funds under the Exceptional Children's Educational Act and the School Finance money for special education preschool programs.

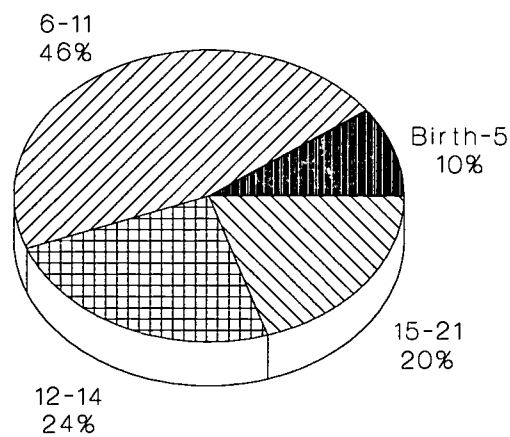
- On December 1, 1994, administrative units reported 67,419 children with disabilities, ages birth through 21. An additional 668 children with disabilities were reported by the five state operated programs at CSDB, the Department of Corrections, Youth Corrections, and Fort Logan and Pueblo Mental Health Institutes.
- According to recent figures published by the U.S. Department of Education, Colorado ranks 42nd among the 50 states in the percent of its resident school aged population served in special education.

- Ten and one-half percent (10.5%) of the total school membership was served in special education programs. This percentage varied across administrative units, from a low of 7.6% to a high of 13.9%. Children with disabilities were 8.8% of the state's total 3-17 population.
- Almost half (49.9%) of the children in special education had a perceptual or communicative disability.

Age of Students with Disabilities December 1, 1994



- Forty-six percent (46%) of the special education students were ages six through 11. Forty-nine percent (49%) of these elementary aged students were learning disabled, and 25% had a speech/language disability. At the secondary level, the number of learning disabled students increased to 62%, while speech/language students decreased to 6% of the total number of children with disabilities.
- The vast majority of children with disabilities were served within their administrative unit of residence (96.7%); .3% were served by other administrative units; 2.2% were served by facilities with approved on-grounds schools; and .8% received their special education services from Head Start, private schools, or other service providers. Only two of Colorado's special education students were placed out of the state.

- Eighty-two percent (82.0%) of special education students were served within their home school; 7.7% were served in center-based programs; 1.4% received their special education services in separate day facilities; .9% were in residential facilities; .7% received their special education program in a community placement, home, or hospital; and 7.3% were in infant or preschool settings.

- The percentage of special education students that were males was 67.5%, compared to 51.4% of the total public school membership. This percentage was consistent throughout all grade levels.

- Each administrative unit reports the number of children that leave its special education programs from one year to the next, along with the reasons for the exit; but individual children are not tracked from one administrative unit to another. On December 1, 1994, there were 17,715 children that had exited special education programs at some time during the previous twelve months. Almost half of these students (45.9%) were known to be continuing in special education in another administrative unit; 23.6% had completed all the objectives of their special education programs and were continuing in the administrative unit full-time in regular education; 9.7% graduated from high school; 9.0% moved, and were not known to be continuing in special education; 5.4% dropped out of school; and the remainder left for various other reasons.

- On December 1, 1994, administrative units employed 8,340.5 FTE salaried and purchased services staff. Eighty-one percent (81%) provided direct instructional services to children with disabilities. Only 1.6% were administrators.
- The ratio of students to special education teachers and speech correctionists was 17.0. When paraprofessionals and tutor interpreters are added, this ratio drops to 10.0. There was an average of .7 FTE paraprofessionals and tutor interpreters for every special education teacher and speech correctionist, and there was an administrator for every 38.7 professionals.

- During the 1994-95 school year, special education and related services in Colorado public schools cost \$294.2 million. This was an 8.9% increase from the previous year's special education costs, but special education expenditures as a percent of the total cost of education remained at 7.4%.

- Salaries comprised 74.6% of the total cost of public school special education programs; benefits were 15.4%; purchased services, which included tuition to other administrative units and to eligible facilities, was 8.2% of the total cost of programs; and supplies, equipment, and other expenditures were 1.8%.
- The average cost per student in 1994-95 was \$4,363. This varied across administrative units from a low of \$2,528 per student to a high of \$5,836.

- Local school district funds supported 67.9% of the total cost of public school special education programs in 1994-95; State dollars accounted for 21.8% of special education revenues; the Federal Government covered 10.2% of the cost of the programs; and .1% of the cost was supported by other funds.
