

ABSTRACT

Selected Federal government publications on the homeless and homelessness are listed. One section of this bibliography covers definitions, prevalence, and causes, and the second section covers programs and solutions. Each citation contains information on where to find the source in the Auburn Library system, the call number, and a brief description. In all, 74 sources are listed. They range from statistical information on the problem across the country to specific information on housing.
